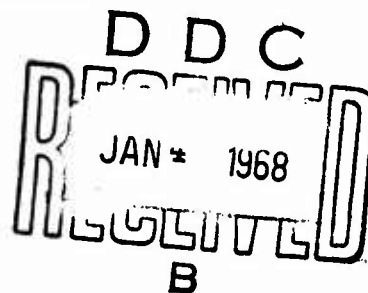

SECTION I

SIGNIFICANT ORGANIZATIONAL AND UNIT ACTIVITIES

1. (U) GENERAL:

a. During the reporting period (17 November 1966 to 31 July 1967) the following units were assigned to the battalion.

HQ and HQ Btry, 7th Bn, 15th Arty

Btry A, 7th Bn, 15th Arty

Btry B, 7th Bn, 15th Arty

Btry C, 7th Bn, 15th Arty

SVC Btry, 7th Bn, 15th Arty

b. The battalion is organized under TORG's 6-416E, 6-447E, and 6-449E as modified by TUSA CO 645, dtd 21 Nov 66. The CO adds a metro section and an extra liaison section and directs that the aviation section be organized at zero strength in personnel and equipment.

c. The battalion was alerted for overseas movement on 17 Nov 66 and the following phases of readiness established:

(1) Personnel On Station Date (POSD) - 3 Mar 67

(2) Equipment Readiness Date (ERD) - 15 May 67

(3) Personnel Readiness Date (PRD) - 4 Jun 67

d. At the time of alert, the battalion was attached to XVIII Airborne Corps Artillery, Fort Bragg, North Carolina.

e. POM preparation and movement overseas was conducted according to the following schedule:

a. (C) Prior to overseas departure, disposition of classified material was made as follows:

(2) Remaining classified material not in the overseas theatre was destroyed or turned over to HQ, XVIII Airborne Corps Artillery for appropriate disposition.

b. During overseas movement classified material was secured by a field safe located so as to be under a 24 hour a day surveillance. Crypto material was secured by a 24 hour a day armed guard and placed in a locked safe inside a locked stateroom without portholes.

c. At the time of overseas movement, more than 70% of assigned personnel had received final clearances of CONFIDENTIAL or higher.

3. (C) OPERATIONS AND TRAINING ACTIVITIES

a. Operations

(1) On 3 July, the battalion was attached to IFFORCEV Artillery and further attached to 41st Artillery Group. Mission assigned was general support of US, ARVN, and FVMAF forces operating in the ARVN II Corps Tactical Zone.

(2) On 5 July, the battalion received a mission of general support reinforcing the fires of 1st US Air Cavalry Divarty with the fires of Batteries A and B and reinforcing the fires of the Capitol ROK Infantry Divarty with Battery C.

(3) On 12 July, the battalion occupied a daylight psn vic LZ Hammond (BR 884525) and conducted an absolute fall of shot calibration of howitzers.

(4) On 16 July, the battalion less Service Battery and Headquarters administrative elements departed the Phu Cat Camp area and occupied tactical positions as follows:

(a) Btry A occupied position at Landing Zone ENGLISH (BS 878015) in the 1st Bde, 1st US Air Cav Div area of operations and received a modified mission of general support reinforcing the fires of the 2/19th Arty (105 towed).

(b) Btry B occupied position at LZ UPLIFT (BR 918750) in the 2nd Bde, 1st US Air Cav Div Area of Operations and received a modified mission of general support reinforcing the fires of the 1/77th Arty (105 towed).

(c) Bn HQ (-) also occupied position at LZ UPLIFT and established a forward CP.

(d) Btry C reinforced by 1 liaison party occupied position vic Binh Khe (BR685430) in the Capitol ROK Infantry Division TAOR and received a modified mission of general support reinforcing the fires of the 61 ROK Arty Bn (105/155 towed).

(5) From 16-31 July, Batteries A and B supported 1st Air Cav Division Operation PERSHING by fire.

position at LZ IVY (BR 8963) where it engaged known and suspected enemy targets to the west and southwest. At 1800 hours the same day, Btry B displaced to LZ CRYSTAL where it remained until the morning of 19 July continuing to engage targets to the west and southwest. On 19 July, Btry B returned to its LZ UPLIFT position.

(7) On 18 July, under the operational control of the 2/19 Arty, Btry A displaced to firing positions in the upper AN LAO valley via BS 7411 where it engaged known and suspected enemy positions to the west. On 20 July, Btry A returned to its LZ ENGLISH position.

(8) On 31 July, with no change of mission, Btry C displaced to a position in the Vinh Thanh Valley via LZ JUPITER (BR 616606) where it engaged known and suspected enemy positions to the west, north and east. Btry C returned to its Binh Khe position the same day.

(9) During operations during the reporting period, the Battalion fired a total of 8345 rounds in 1251 unobserved and 284 observed missions. The battalion received credit for 48 known enemy KIA.

b. Training

(1) During the POM period, the battalion conducted Advanced Individual, Basic Unit and Advanced Unit Training in accordance with ATP 6-100. Battery Tests were administered in accordance with ATT 6-586, and the Battalion ORT in accordance with ATT 6-415 modified.

(2) In addition to the POM training required by AR 220-10. and USCONARC Directive, the battalion conducted the following special POM training:

(a) Additional mines and booby traps training conducted with the assistance of technically qualified personnel of the 7th Special Forces Group (Abn).

(b) Vietnamese Village training conducted by personnel of the USA Special Warfare School.

(c) Additional small arms and crew served weapons training to include familiarization of all personnel with the M60 Machine gun and the familiarization of more than 50% of personnel with the 50 cal machine gun and the M79 grenade launcher.

full tracked cargo carrier, and operation of RAWIN metro equipment (through cooperation with adjacent units).

(f) Cross training of the battalion survey section and selected battery personnel in FDC procedures.

(g) Training of selected personnel in the Vietnamese language, history, and culture through cooperation with the Fort Bragg Army Education Center.

(3) Shipboard training emphasized daily physical training, care and cleaning of weapons, fire direction center training, and training in radio telephone procedures for selected personnel.

(4) Training during the reporting period after arrival in Vietnam has emphasized FDC organization and procedures, cannoners' drill, maintenance of vehicular and radio equipment, and local security procedures. Weapons safety has been emphasized and all small arms and crew served weapons were proof fired before departure of firing elements from the Phu Cat Base Camp.

4. (U) LOGISTICS: The following major events not mentioned in paragraph 1 occurred in the logistics field during the reporting period.

- a. On 17 Nov 66, the Battalion was alerted for deployment to SEA.
- b. On 25 Nov 66, Special Project Code IPJ and COA 060D was assigned to the Battalion. All outstanding Requisition without firm delivery dates were cancelled and Requisitioned on 7 December 1966.
- c. On 7 December 1966, Showdown Inspection of all sets, kits and outfits was conducted as directed by XVIII Abn Corps, CMRI Inspection SOP. Shortages were placed on Requisition.
- d. On 5 Jan 67, new PLL was approved and requisitions submitted.
- e. On 9 Feb 67, turn-in of Aviation Section equipment completed.
- f. On 20 Feb 67, initial CMRI Inspection conducted consisting of Record Inspection and PLL records inspection. Submitted listing of major items due out and secondary items to Customer Assistance Section Director of Supply.
- g. On 28 Mar 67, turn-in of howitzers to post for annual service and installation of product improvement kits began.
- h. On 30 Mar 67, all Special Weapons equipment was turned in to 26th Ordnance.

b. During the voyage overseas, the following personnel actions took place:

- (1) Personnel records closed out and re-opened.
- (2) Foreign service tour dates entered on all personnel records.
- (3) June pay-rolls made up.
- (4) Completed Geneva Convention Cards - issued to all personnel.

c. Significant personnel activities since arrival in-country have included:

- (1) 21 June - Requisition for local regulations submitted.
- (2) 7 Jul - Requisition for replacement of early ETS personnel submitted.
- (3) 15 Jul - Requisition for local blank forms submitted.

SECTION II

COMMANDER'S OBSERVATIONS AND RECOMMENDATIONS

1. (C) OBSERVATIONS:

a. Item. Organic Aviation Support

Discussion. This unit currently depends on higher and adjacent headquarters for the provision of aviation support for artillery observation and command and control. This poses difficulties in that the road distance between batteries is 110km and aviation support is frequently unavailable. A letter has been submitted requesting this unit be authorized to fill its organic aviation section.

Observation. Lack of an organic aviation section hampers the effectiveness of command and control of heavy artillery when distances between deployed batteries is extensive.

b. Item. FM Communications Over Extended Distances

Discussion. During the 18-20 July operation of Btry A in the An Lao Valley, direct FM Communications between the battery and battalion headquarters was not possible because of large hill masses. A radio

relay was achieved by stationing personnel and radio equipment on an intermediate crest but this solution was not completely satisfactory because of the time loss, increase of radio traffic and increased possibility of misinterpretation associated with voice relay. An MTOE requesting the addition of automatic FM retransmission equipment is being prepared by this organization.

Observation. Automatic retransmission FM radio equipment would enhance the efficiency of command and control of heavy artillery during operations over extended distances in mountainous terrain.

c. Item. Training of AM Radio Operators.

Discussion. During the early weeks of tactical operations in country, this organization experienced several failures of AM radio communications. Although some equipment failures were involved, investigation of the problem revealed that operator error and failure was the cause of much of the difficulty. Although the operators had received the normal training program and had participated with the organization in field training exercises prior to deployment, the relatively short distances involved in the training area led to primary radio communication reliance being placed on FM.

Observation. Units deploying to Vietnam should place emphasis during field training exercises on the activities of AM radio personnel to include message handling procedures and installation of specialized antennas.

d. Item. Extensive howitzer deadline in support maintenance.

Discussion. The howitzers of this organization were turned in for annual servicing and installation of a product improvement kit on 28 Mar and were not returned to the battalion until 16 May, the day prior to rail shipment to the Charleston Outport. The cause of this extended deadline lay in large part in the fact that the sudden workload overwhelmed the shop facilities of Fort Bragg, a post of low tracked vehicle density. The extended deadline had adverse impact on battalion operations and training in that no section training was possible between the end of March and the in-country receipt of the howitzers on 9 July, a period of 15 weeks. Further, no opportunity for pre-deployment calibration of howitzers existed.

Observation. The establishment of a maintenance task force at an appropriate command level to assist tracked vehicle shop installations forced into sudden overload by requirements of deploying units would minimize the adverse effects described above.

e. Item. Late Arrival of Officer Fill.

Discussion. The bulk of the company grade officer fill did not arrive in the battalion until 3 March, two weeks after the battery tests and less than three weeks before the battalion ORT. This late arrival had adverse impact on the early stages of POM preparation and training and did not give the officers themselves an opportunity to familiarize themselves thoroughly with their duties before entering a significant phase of the battalion training cycle.

Observation. If possible, the POSD for alerted units should be established at least 120 days prior to PRD instead of the 90 days established for this organization.

f. Item. Arrival of Voyage Staff.

Discussion. This unit was designated to provide the initial voyage staff of 250 personnel for the trip overseas. The Bn XO was selected as the Senior Unit Commander. Official notification was not received until 2 days prior to movement date. The voyage staff embarked aboard the USNS Walker only six hours prior to the arrival of the first of the remaining units. Insufficient time was available to organize the voyage staff to adequately prepare for the receipt of the remaining units.

Observation. That the Senior Unit Commander be selected at least two weeks prior to embarkation to allow for adequate planning time. A nucleus of the voyage staff to include the Senior Unit Commander, Executive Officer, Adjutant, Sergeant Major, PMO, and Mess Officer should arrive at port at least two days prior to embarkation.

g. Item. Non-receipt of Mail

Discussion. This unit was originally scheduled for deployment to Pleiku, but was diverted to Phu Cat approximately ten days prior to departure from CONUS. Apparently the APO at San Francisco and Seattle were not aware of this change and continued to send the unit's mail to Pleiku. The Pleiku APO received the mail but held it because they did not know the unit's location. Numerous phone calls were made to in-country APO's and letters forwarded to the APO's in San Francisco and Seattle. It was approximately three weeks before mail began to flow to the correct APO.

Observation. The APO's at Seattle and San Francisco should be notified immediately when a unit is diverted so that mail to the unit will not be delayed.

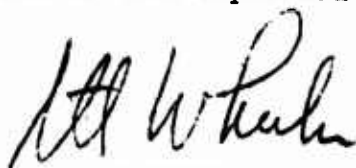
