1. (C) Section I, Operations: Significant Activities:

a. Personnel:

(1) The 5th Battalion, 42d Artillery remained assigned to the 54th Artillery Group, APO 96491, with the mission of General Support, II Field Force Vietnam. (2) A Battery Activities: At the beginning of the reporting period, A Battery (three howitzers) was located vicinity YT 174003 (Bearcat) with the mission of GS IIFV and A Battery Platoon (three howitzers) was located vicinity YT 096093 (FSB Megan) with mission of General Support II Field Force. On 6 June 1969, one howitzer was moved from Bearcat to FSB Megan, increasing the howitzers in that location to four. On 8 June 1969, a platoon of two howitzers was road marched to Cu Chi and further airlifted (12 sorties) to Tra Cu with an assigned mission of General Support II FFV with priority of fires to the 5th Special Forces Group. On 10 June 1969, (minus) (four howitzers) road marched to vicinity YT 489354 (LZ Rock) with assigned mission of General Support Reinforcing C Battery, 1st Battalion, 21st Artillery. On 22 June, A Battery (minus) returned to FSB Megan with mission of General Support II Field Force. While at LZ Rock A Battery (minus) was resupplied daily by airlift with a total of 26 sorties. The platoon at Tra Cu had been resupplied by air with a total of 234 sorties by the end of the reporting period. From the last reporting period to 25 May 1969, A Battery furnished an FO Party to the 36th RVN Ranger Battalion and from 25 May 1969 to 28 June 1969 an FO Party to the 6th RVN Marines.

(3) B Battery Activities: B Battery was located vicinity XS 826716 (Can Giouc) during the entire reporting period with the mission of General Support Reinforcing the 9th Infantry Division Artillery. On 28 July 1969, a platoon of 3 Howitzers was road marched to vicinity of XS 654620 (FSB Steiner) with assigned mission of General Support Reinforcing the 9th Infantry Division Artillery. B Battery furnished an FO Party to 18th ARVN Division during the period 3 June 1969 to 21 June 1969 and an FO Party to the 6th RVN Marines during the period 28 June to 31 July 1969. On 18 and 19 May 1969 the battery received and passed the semi-annual Combat Readiness Evaluation conducted by the 54th Artillery Group.

(1) Mandatory training was conducted in the following subjects: Character Guidance, Command Information, Clandestine Surveillance, Code of Conduct, Riot Control, Helicopter Load Preparation, Counter Sapper and COMSEC training.

(3) All batteries are continuing on-the-job training and cross training.

(4) During the period 2 - 5 May 1969, the gunner's test was administered to firing battery personnel who did not take the test during the last ORLI reporting period.

(d) During the period 28 June 1969 thru 9 July 1969, ten enlisted men attended the Projector Operator School conducted by the 221st Signal Battalion, Long Binh Post. All personnel passed the course and were licensed.

(e) On 3 and 4 July 1969, a course of instruction on maintenance of the M-16 rifle was presented at Headquarters, 54th Artillery Group to battery supervisory personnel and armorers.

2. (C) Section II, Lessons Learned, Commander's Observations, Evaluation, and Recommendations:

a. Personnel: None.

b. Operations:

(1) Construction or Improvement of Howitzer Parapet Floors:

(a) Observation: Much of the fill used for construction of parapet floors is unsuitable. During periods of heavy rain, surface forms a layer of slippery mud resulting in poor footing and difficulty in maintaining clean equipment and ammunition. Surface water does not readily drain off unless a system of culverts or ditches is constantly maintained. The replacement of these types of fill with sand eliminates many of these problems. During heavy rain, the sand retains a firm footing and surface water will run off rapidly. This works particularly well with a gravel base under the sand.

(b) Evaluation: The use of sand in the gun pit results in safer working conditions and improved maintenance and cleanliness of equipment and ammunition.

(c) Recommendation: Sand and gravel should be used in construction of parapet floors when available.

(2) Battery Life:

(a) Observation: Life expectancy of lead-acid batteries used as radio power supplies can be increased by using them in such a manner that they are neither completely discharged nor overcharged. The preferable type is 12 volt used in the 2½ ton or 5 ton multifuel trucks. Two of these batteries supplying two VRC-12 series FM radios will work well with a 0.5 KW or 1.5 KW D.C. generator on a cycle of 15 to 20 minutes of charge every 2½ to 3 hours. This cycle will conserve both generator and batteries. The cycle can be varied depending on size of batteries and amount of transmitting in a given time block.

(b) Evaluation: Battery life can be extended by the simple expedient of limiting charge to short periods and use between charges to 2½ to 3 hours.

(c) Recommendation: That battery charging be conducted on a timed schedule rather than continuous charging or waiting for the battery to run down between charges.

(3) Night Lighting Device for Gunners:

(a) Observation: Since the majority of artillery firing occurs during the hours of darkness flashlights must be used in large numbers. A problem is presented when the crewman must hold the light and work with one hand. The ammo handlers are handicapped by having to hold a flashlight while selecting proper lots of fuzes to be fired.

(b) Evaluation: Speed and efficiency would be greatly increased if some sort of lighting device could be developed that would free the use of both hands while working at night. This type of lighting device would also reduce the number of accidents caused by improper lighting.

(c) Recommendation: Recommend that a light be developed similar to those used by miners. This light should be designed for placement on the steel helmet.

f. Other:

(1) Prevention of skin diseases:

(a) Observations: During the past several months we have had a number of personnel develop serious skin rashes, which were treated with many medications without success. The rashes became infected and caused a loss in man hours.

(b) Evaluation: The rash was caused and sustained due to perspiration and lack of circulation of air under clothing, particularly under the arms and around the legs of the individuals.

(c) Recommendation: That all individuals be encouraged to wear shorts and sandals during off duty hours or whenever possible in order to prevent rashes from occurring.



1. (U) This headquarters has reviewed the Quarterly Operations Report - Lessons Learned from the 5th Battalion, 42d Field Artillery and considers that it adequately reflects the operations and lessons learned during the reporting period.
2. (C) Reference Section II para b(1), Construction or Improvement of Howitzer Parapet Floors. The 54th Field Artillery Group concurs. The use of sand in the gun pit with a gravel base will eliminate many safety hazards for personnel in the operation required in artillery firing of a 155mm Towed Howitzer plus improving the maintenance of equipment and ammunition, especially during the rainy season.




