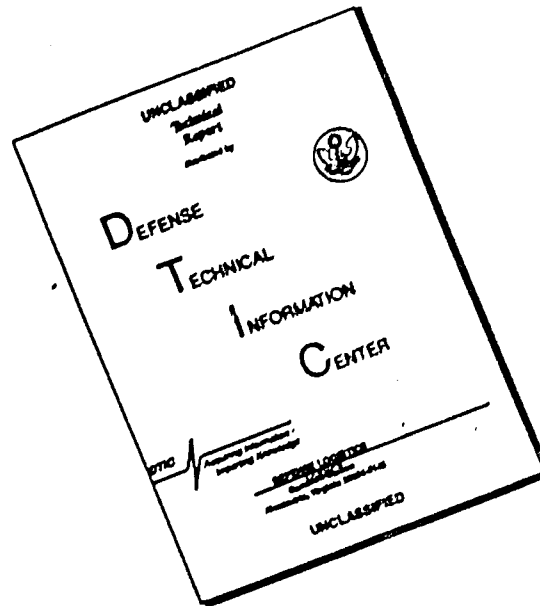

1. SECTION I: (C) Significant organization or unit activities.

a. General: During the reporting period, I FFORCEV Arty continued support of ARVN, RF/PF, ROK, US and USSF/CIDG forces in II CTZ. The I FFORCEV Arty organization as of the close of the period is as outlined in inclosure 1. Three groups, one separate battalion, one separate battery and thirteen radar detachments supported operations conducted by allied maneuver units in areas of operations (AO)¹ indicated below:

The 4th Bn, 60th Arty (AW)(SP), with attached Btry B, 29th (SLT) and Btry E, 41st Arty (MG), and HHB, 8th Bn, 26th Arty (TAB) with eleven attached counter-mortar radar detachments continued operation in support of allied forces throughout II CTZ.

b. Intelligence:

(1) Hostile artillery attacks during the period reached a high point on 12 August when the enemy conducted 60 attacks and expended 457 rounds in conjunction with the reported initiation of the autumn offensive. However, the

offensive did not materialize and activity returned to a low level shortly thereafter. Enemy activity was not concentrated in any one area during the period and the vast majority of the attacks were of low intensity. The Highland Provinces received the largest percentages of activity with attacks occurring primarily in the vicinity of Kontum City, Pleiku City, and Ban Me Thuot City. The 28th, 66th, and 40th NVA Regiments remained unlocated in Cambodia; however, they are believed to have moved to Southern II CTZ with intentions unknown. The majority of enemy activity in the Coastal Provinces occurred in Binh Dinh Province, where attacks were scattered throughout the Province and were directed primarily against the Allied Pacification Program. Several of the enemy units in the Coastal Provinces have reportedly broken down into smaller size elements to operate with and as guerrilla forces. The Phan Thiet area of Binh Thuan Province continued to witness a cyclical pattern of activity as enemy attacks increased during the last two weeks of August and the first two weeks of October. Blackhorse in the Southern Provinces, Dalat received considerable activity, particularly during the month of August, with activity being scattered and of low intensity in the remaining provinces. Enemy artillery activity increased sharply in the Bu Prang area (Quang Duc Province) during the last week of October which was targeted against US firebases. There was no sustained offensive and activity was spread throughout II CTZ.

(2) The enemy artillery capability remained the same as the previous quarter. No new enemy artillery units were identified.

(3) Enemy artillery attacks and expenditures (Daily Average) throughout II CTZ for the reporting period are indicated below:

(4) The enemy did not employ any field gun or howitzer fire within II CTZ during the reporting period.

(5) During the quarter, there were 53 rounds of 107mm rocket and 79 rounds of 122mm rocket fired at friendly installations in 26 separate attacks. There were no new weapons nor variations of the standard enemy munitions employed in II CTZ.

(6) During the period, there were 3 attacks in which 7 rounds of 140mm rocket were employed in the Highland Provinces.

(7) Radar Operations:

(a) During the month of August 1969, the radar section and the survey information center of First Field Force Artillery were formed into a combined operation. This office is designated the Target Acquisition Information Center and is the coordination and information agency for radar, survey, crater analysis, and duffle bag operations for First Field Force Vietnam Artillery. The rationale for combining these two offices was to consolidate and expedite the accumulation and analysis of all target acquisition information and recommend procedures that would insure optimum utilization of all target acquisition assets in I FFORCEV Artillery area of operations.

(b) During the quarter, six radar moves were conducted, a total of 47 enemy weapons locations were made and 637 ground surveillance sightings were made. Fifty-seven percent of all ground surveillance sightings were engaged representing total artillery expenditures of 7,669 rounds.

(8) Survey: Extension of survey control to all fire support bases in II CTZ continued during this quarter. To date, 483,857 meters of fourth order survey have been completed, to include the establishment of 77 fourth order SCPs. The most recent survey was the completion of the Kontum to Ben Het survey which extended 173,000 meters into a previously unsurveyed area and added 21 SCPs to the list of I FFORCEV Artillery SCPs.

c. Operations and Training Activities:

(1) Operations:

(a) During the reporting period, artillery units with I FFORCEV continued support of ARVN, ROK, US, RF/PF, RD Teams and USSF/CIDG forces in II CTZ. I FFORCEV Artillery units continued support of I FFORCEV maneuver forces in providing maximum participation in pacification, fire planning, and artillery protection for the greatest number of villages and hamlets in the II CTZ.

(b) Areas of responsibilities remained unchanged with the groups continuing to operate in their AOs.

(2) Fire Support Coordination Element:

(a) Naval Gunfire Support for II CTZ was provided by an average of two ships each day. In all a total of 21 different ships, representing two countries, saw action in II CTZ during the three month period. The following is a summary of Naval Gunfire Support:

(b) During the reporting period, a daily average of 62 immediate reaction and hangfire targets were developed. Of these, a daily average of 42 were fired. Of those that were not fired, most could not be cleared or had been pretargeted. The following is a summary of targets developed and fired:

(c) The Area Harassment program continues to be an effective means of harassing the enemy in those sanctuaries and base areas which are out of range of friendly artillery. Thirteen areas which change as the enemy moves within the Corps are constantly monitored. Every five days the best seven areas are selected in priority and targeted twice daily for tactical air, spooky and shadow missions. This provides current, lucrative targets throughout the Corps that can be struck as aircraft become available. Summary of missions in support of the area harassment program:

(d) A daily average of 6 suppression orders were issued to 175mm guns throughout the Corps.

(f) In order to implement uniform ARC LIGHT procedures throughout II CTZ which are compatible with current MACV requirements, a comprehensive regulation covering all aspects of the ARC LIGHT program was published in September. FSCE personnel also made frequent field trips to assist new personnel in the ARC LIGHT program. These visits included a detailed security inspection to insure that all units are complying with proper security requirements. During the latter part of October, an ARC LIGHT conference was sponsored by the FSCE to discuss planning and requesting techniques contained in the new regulation. Results of the security inspection were also reviewed at the conference.

(g) One new Artillery Warning Control Center was added to the II CTZ Artillery Warning System. There are now 24 operational centers. On 05 Aug, an AWCC conference was held at HQ, I FFORCEV to discuss the proposed changes to MACV Dir 95-13. Subsequent to this conference, an unclassified listing of II CTZ AWCC frequencies was developed and published. In October, the Assistant Chief of Staff, MACV J3, released the proposed MACV Dir 95-13, Artillery and Air Strike Warning System, for concurrence. The FSCE examined this document and forwarded it to the I FFORCEV Chief of Staff recommending several changes. The major change introduced by the proposed directive is the requirement to post air strike warnings in addition to normal artillery advisories. There are no foreseeable difficulties in complying with this major change. The FSCE is currently drafting a directive which will implement the MACV directive and establish standing procedures for the II CTZ Artillery and Air Strike Warning System.

(3) Training:

(a) The I FFORCEV Arty Forward Observer Training Course (FOTC) and the Fire Direction Officer Training Course (FDOTC) continued to train artillery lieutenants and other US and RVNAF personnel.

(b) RVNAF Assistance Programs:

1 RVNAF Assistance Programs continued to show progress during the reporting period. As a result of training assistance furnished by US artillery units,

the proficiency of ARVN units has shown continual improvement. Frequently, ARVN artillery has been used in support of US maneuver units in conjunction with US artillery support.

2 Greater emphasis has been placed on the artillery assistance program for Civilian Irregular Defense Group camps. The 105mm howitzers, organic to the CIDG Camps and heretofore used in the direct fire roll for perimeter defense, can now be used in the indirect fire support roll of maneuver elements. This has been accomplished by I FFORCEV Arty units providing teams to train CIDG personnel in firing battery, fire direction and forward observer procedures.

3 Training assistance to Territorial Force (RF/PF, RD) units has shown continual improvement. Forward observer training and technical assistance for the implementation of District Fire Support Plans have been rendered by I FFORCEV Arty units.

4 As a part of the accelerate Phase II plan for RVNAF Improvement and Modernization, property of 6th Battalion, 84th Artillery, was scheduled for turnover to the ARVN 45th Arty Battalion. Approval of the turnover was granted by MACV on 2 April 1969. This action was completed during the reporting period. A complete resume follows:

(3) There exists a critical shortage of Radar Technicians, MOS 211A0, in this command. HHB, 8th Bn, 26th Arty is authorized a total of nineteen 211A0s. At present, only ten warrant officers and qualified lieutenants with this MOS are assigned. Two more warrant officers with related MOSs have also been assigned. Additionally, the command has a shortage of 38 lieutenants which restricts the effectiveness of Forward Observer sections throughout the II Corps Tactical Zone.

(7) Morale and discipline continued to be excellent throughout the period.

2. SECTION II: (C) Lessons Learned - Commander's Observations, evaluations, and recommendations:

a. Personnel: None.

b. Operations: Use of Long Range 40mm Ammunition, B558.

(1) Observation: Recently VC/NVA units have been setting up mortar, recoilless rifle and rocket positions just outside the maximum range of regular 40mm ammunition.

(2) Evaluation: An effective counter measure for targets located beyond the range of B559 is to load one gun on the M42A1 with regular range (B559) and one gun with long range 40mm ammunition (B558). Upon observing the mortar, recoilless rifle or rocket flashes, the crew adjusts on the enemy

location by tracer observation with B559 as close as possible then switches to the other gun and delivers fire on the enemy with B558 ammunition. This method results in a savings of B558 ammunition during adjustment yet provides for instantaneous response.

(3) Recommendation: That commanders use this tactic when enemy firing locations can be located by flashes - adjusting on the target with B559, giving the enemy a false sense of security during the adjusting period, then switches to B558 for quick, positive results.

c. Training: None.

d. Intelligence: None.

e. Logistics:

(1) M60 Machine Gun Brass Catcher for M42A1s.

(a) Observation: Empty shell casings and linkages from the M60 machine gun mounted on the turret of the M42A1 can foul 40mm gun automatic loaders and main engine components.

(b) Evaluation: Two incidents have occurred in which spent casings and links from the M60 machine gun mounted on the turret of the M42A1 caused equipment failure. In one incident, an empty shell casing fouled the automatic loader on one of the 40mm guns rendering it non-operational until the gun could be torn apart. In the other incident, a spent link fell through the track grillwork into the main engine compartment and was thrown by the engine fan into the oil breather, later resulting in a fire and total loss of the M42A1.

(c) Recommendation: That a catcher bag, such as the one used on the M73 machine gun system on UH-1 gunships, be added to the BILL for the M42A1 and used on the M60 machine gun mounted on the turret of the M42A1. A slight modification, a fabricated pin, is necessary to adapt the bag, FSN 1005-903-1088, to the M60 machine gun.

(2) Heliotropes:

(a) Observations: It has been found, in survey work recently performed, that a heliotrope results in greater accuracy and less time than an ordinary mirror for pin pointing forward and rear stations.

(b) Evaluation: Before the Survey Platoon obtained the heliotropes, an ordinary vehicle mirror was used to mark stations which were too far away for the instrument operator to see a range pole. This flashing mirror was difficult to sight on and many times resulted in errors in horizontal and vertical angles. The heliotrope on the other hand sends out a small constant beam of light. It is easier to sight on and results in greater speed and accuracy.

1. (U) This headquarters has reviewed the Operational Report-Lessons Learned for the quarterly period ending 31 October 1969 from Headquarters, I Field Force Vietnam Artillery.

2. (C) Comments follow:

a. (U) Reference item concerning "Personnel", page 7, paragraph 1c(4)(c)(3). A critical shortage of warrant officers qualified in MOS 211A0 does exist. I FFV is authorized 18. The 30 November AG19 report from I FFV indicates a total of 14 assigned. Six are warrant officers and eight are school trained lieutenants. Based on input projections all 211A positions will be filled with either warrant officers or school trained lieutenants by the end of January. Based on the 20 November AG19, I FFV reported the following: Field Artillery Lieutenants - Authorized 191; Assigned 189. Air Defense Lieutenants - Authorized 20; Assigned 28. These figures indicate 6 artillery lieutenants over authorized. There will be a December DEROS loss of 29 lieutenants, but ORD USARV is filling these anticipated vacancies with an average input of one artillery lieutenant per day.

b. (C) Reference item concerning "Use of Long Range 40mm Ammunition, B558", page 9, paragraph 2b; concur. Although this method is an effective countermeasure for targets beyond the range of B559(HEIT-SD), the use of B558 (HEIT-HSD) is limited by its availability. USARV G4 Ammunition Division, stated that when the present theater supply of B558(HEIT-NSD) is exhausted it will not be replenished.

c. (C) Reference item concerning "M60 machine gun brass catcher for M42A1s", page 10, paragraph 2e(1); concur. Adaption of a catcher bag (FSN 1005-903-1088) to the M60 machinegun will help to keep spent brass from damaging M42 equipment. Additionally, consideration should be given to using the machine gun brass deflector kit (FSN 1005-221-7392). This deflection curtain prevents expended brass from falling into the vehicle.

d. (C) Reference item concerning "Heliotropes", page 10, paragraph 2e(2). The recommendation that the heliotrope be adopted as a TOE item of equipment for all artillery 4th order survey parties appears to have merit. Recommended changes to TOE will be prepared by I FFV Artillery and submitted through command channels to the US Army Combat Developments Command IAW AR 310-31 and AR 310-44.

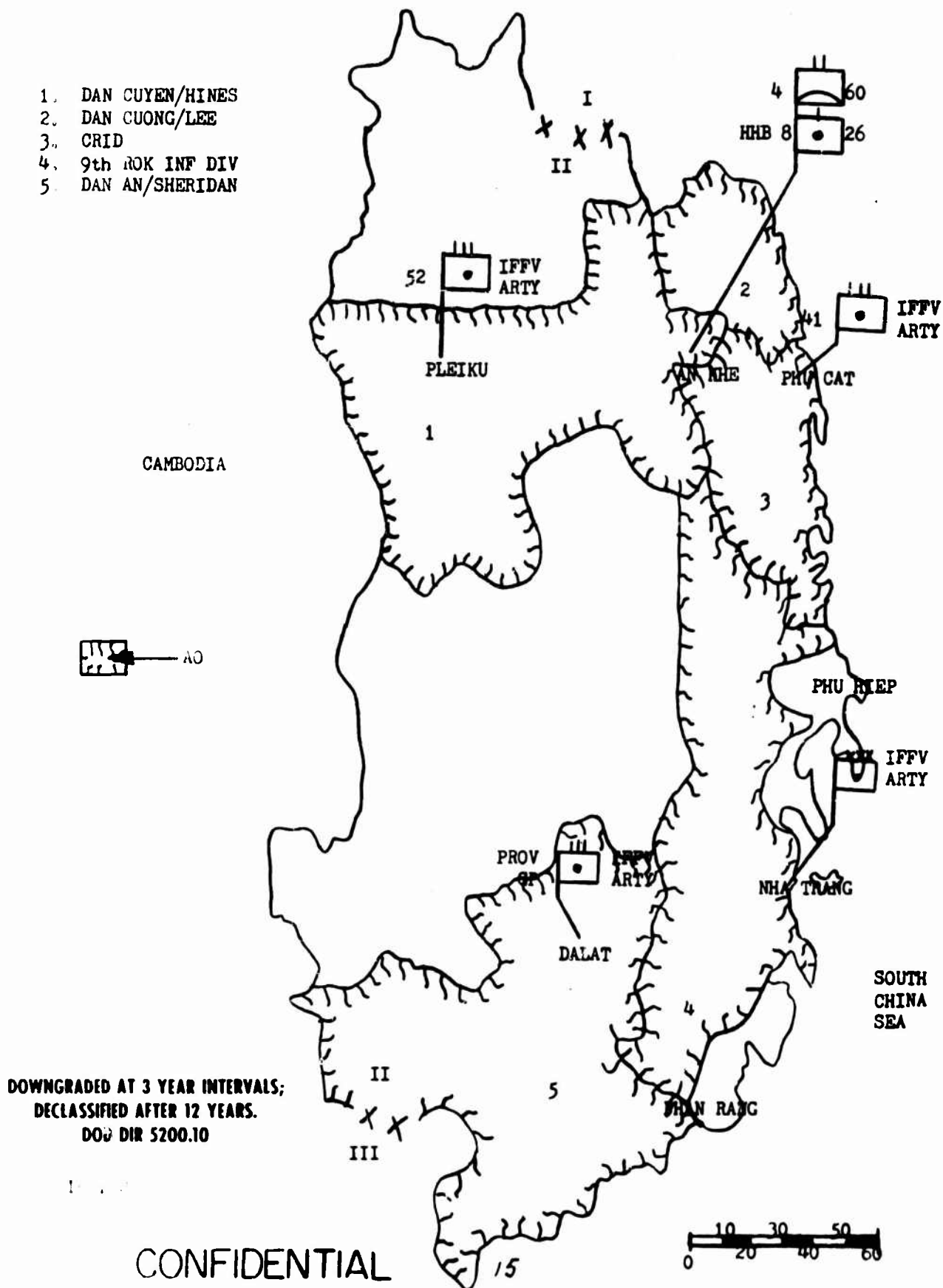
