SECTION I

SIGNIFICANT ORGANIZATIONAL ACTIVITIES

1. During the reporting period the 184th Ordnance Battalion (Ammunition) (Direct Support) continued performing its mission as a conventional ammunition battalion.

2. Capabilities:

a. The battalion's capabilities remained the same as no new units have been assigned or attached and there have been no units reassigned. Two of the three Ammunition Companies and one of the two Detachments changed unit commanders during this period. The battalion was engaged in operations for all ninety-two days of the reporting period.

3. Mission:

a. The battalion's primary mission is the operation of the Qui Nhon Army Base Depot. The Qui Nhon Army Sub Depot was in the process of phase-out and all U.S. Ammunition has been removed from the sub-depot. The current activity at the sub-depot is the segregation and shipment of serviceable expanded artillery shell cases back to CONUS. All assigned/attached units are functionally organized in direct support of the Depot Mission.

This total figure is almost twice the number reported for the previous report period.

5. Equipment Maintenance and Dispatch:

a. In May, The Battalion Consolidated Wheeled Vehicle Motor Pool deconsolidated and each unit became responsible for their own motor maintenance and management. The Materials Handling Equipment Motor Pool remains consolidated and continues operations in the Ammunition Base Depot.

b. With the responsibility placed directly on the Unit Commanders for maintaining and managing their vehicles, the previous nebulous area of responsibility was solved and all units embarked on a sound plan of improving their maintenance program. New maintenance buildings were constructed and unit pride was very evident in the attitude and spirit displayed in bringing the maintenance standards up to a desirable level.

c. Recent CMMI and Command Inspections have made it factual that the maintenance and dead-line rate has improved considerably since the deconsolidation. Progress is continuing in the motor pools and the concern is not to maintain the sense of urgency that operators and mechanics have acquired.

6. Construction:

a. The renovation facility construction which began in May was completed and the renovation unit commenced operations in the new building on 14 July 1967.

b. The new Brass Segregation Yard was completed on 30 June and the 46th Ordnance Detachment was given the responsibility for operational control.

c. All companies have completed new maintenance facilities during this period. All units have completed at least one permanent troop billets and are engaged in constructing Mess Hall, Orderly/supply rooms, and the remaining billets. This is strictly a self-help program and much of the construction is accomplished after normal duty hours.

SECTION II

COMMANDERS OBSERVATIONS AND RECOMMENDATIONS

Part I - Observations (Lesson Learned)

1. Personnel:

Item: Shortage of Personnel

Discussion: On 31 July 1967, this battalion had 789 personnel assigned out of a total of 920 authorized which is 86%. Of the 789 assigned, 104 personnel were on task force or other ammunition details outside the battalion. This figure equals 13% of assigned personnel detailed out of the battalion.

Observation: The manpower shortage is becoming a significant factor to the successful accomplishment of the mission.

2. Operations: None

3. Training and Organization:

a. Item: Driver Training

Discussion: Replacements coming into the battalion fresh from basic and school training are not qualified or familiar with military vehicle operation. To familiarize, train, and license these personnel as operators is time consuming and often keeps key personnel away from their primary duties.

Observation: A driver training program could be initiated during AIT phase to qualify these personnel on Army motor vehicles.

b. Item: Shortage of School Trained Ammo Personnel

Discussion: In hand with the shortage of personnel is the lack of school trained ammunition handlers. With the requirement to send only MOS qualified ammunition personnel on task force operations, a serious shortage of ammunition personnel is being experienced. An extensive OJT program has been established and units are conducting technical training classes to familiarize non-trained personnel.

Observation: Being short personnel in general is one factor, but having to OJT non-ammunition MOS personnel under these conditions emphasizes the shortage even more so. Due to the very nature of the commodity handled, the training given these personnel must be complete with safety integrated throughout their training cycle.

4. Intelligence: None.

5. Logistics:

a. Item: Unit Turn-ins of Suspended Ammunition

Discussion: During July 1967, a lot of 105mm HE, LS27-23, was suspended. When this ammunition was retrograded to QNABD, it was discovered the the components were mismatched i.e., the projectile, cartridge case, fiber container, and wooden box were all different lots in some instances. In many cases, only one component was the suspended lot, LS27-23. A 100% inspection was required before the suspended ammunition could be returned to storage.

Observation: Using units must exercise caution in mixing components of different lots of ammunition. Differences in ballistic characteristics could be a potential hazard to friendly troops if the mixed round is fired. In addition, a monetary loss is experienced as the mismatched ammunition cannot be returned to storage and later reissued if the lot is released from suspension. The mismatched ammunition must be placed on ACR pending disposition instruction. Using units must keep unpackaged ammunition to a minimum.

b. Item: Unitized Pallet for Artillery Ammunition and Rockets

Discussion: The method of palletizing certain items of artillery and rocket ammunition using two 4x4 skids is unsatisfactory. Such units will withstand only slight handling before skids slip out and bands loosen. Many pallets must be rebanded prior to storage and/or shipment. In cases where the direction of boxes must be considered, such as rockets, forklifts cannot be utilized for placing the pallets in storage. The units must be placed in storage using a crane and slings.

Observation: Pallets with a four-way handling facility are required for all types ammunition. It is recommended that the unitized pallet method be discontinued in favor of four-way pallets.

Part II--Recommendations

1. Personnel: Recommended that filling personnel shortages be made an item of command interest.

2. Operations: None.

3. Training and Organization:

a. Recommend that driver training be made a mandatory requirement for replacements coming to Vietnam.


b. Recommend that emphasis be placed on sending school trained ammunition handlers to Vietnam.

4. Intelligence: None

5. Logistics: (Ammunition)

a. Recommend that using units be made aware of the hazards and problems encountered in mixing ammunition components.

b. Recommend that the unitized pallet method be discontinued in favor of four-way pallets.

1. The attached Operational Report for Quarterly Period Ending 31 July 1967 has been reviewed by this headquarters and is considered adequate with the following comments in paragraph 1, Part II Section II.

2. Personnel shortages will continue to exist in this command for the following reasons:

a. Personnel authorizations are less than requirements. As long as the MTOE and TDA moratorium is in effect this situation cannot be corrected.

b. USARV policy of maintaining tactical units at above authorized strength to insure "foxhole" strength is maintained at 100 per cent. The troop strength to maintain tactical units at above authorized strength is taken from logistical units.

c. Adequate security forces are not provided to this command to protect vital and vulnerable logistical installations. This security must be provided out of this command's personnel assets and reduces personnel assets for accomplishing the primary logistical mission.

3. Every reasonable effort has been and will continue to be made to maintain this command and the 184th Ordnance Battalion at maximum strength; however, until the above circumstances, which are beyond the control of this command, are changed, this command and its subordinate units will have a shortage of personnel.


4. This headquarters concurs with the recommendations contained in paragraphs 3 and 5 of Part II Section II.

1. The Operational Report - Lessons Learned submitted by the 184th Ordnance Battalion for the quarterly period ending 31 July 1967 is forwarded.

2. Reference page 4, paragraph 1, and page 5, paragraph 1: Comments in paragraph 2, 1st Indorsement, are appropriate.

3. Reference page 5, paragraph 5a, and page 6, paragraph 5a: Concur. Ammunition turned in by using units must be closely inspected for discrepancies such as those indicated. When discrepancies are of a substantial magnitude and indicate that serious safety hazards may exist within the using unit, this headquarters notifies USARV. Ammunition unit commanders, by close liaison with supported units, can do much to eliminate this problem.

4. Reference page 5, paragraph 5b, and page 6, paragraph 5b. Concur. This headquarters has made recommendations to appropriate CONUS agencies that all ammunition be palletized on a 4-way pallet and that a new pallet be designed for separate loading artillery projectiles.

5. Reference 1st Indorsement, paragraph 2a: This headquarters has received unconfirmed information that the moratorium on submission of MTOE and MTDA is no longer in effect. It is recommended that higher headquarters advise subordinate commands as to the status of subject moratorium.

6. The 184th Ordnance Battalion engaged in combat service support for 92 days during the reporting period. The UIC of the reporting unit is W506A.M.

7. Concur with basic report as modified by indorsements. The report is considered adequate.

1. This headquarters has reviewed the Operational Report-Lessons Learned for the period ending 31 July 1967 from Headquarters, 184th Ordnance Battalion (AMMO) (BO6A) as indorsed.

2. Pertinent comments follow:

a. Reference item concerning shortage of personnel, paragraph 1, page 4; paragraph 1, page 5 and paragraphs 2 and 3, 1st Indorsement: Concur with the recommendation contained in paragraph 1, page 5. To alleviate the personnel shortage existing in the US Army Support Command, Qui Nhon, of which the 184th Ordnance Battalion is a part, the 1st Logistical Command has diverted replacements to that command from other subordinate commands which have a higher ratio of operating strength over authorized strength.

b. Reference item concerning authorized strength, paragraph 2b, 1st Indorsement: The allocation of personnel resources is a command prerogative based on the commander's assessment of the Combat requirements and the tactical situation in RVN.

c. Reference item concerning unitized pallet, paragraph 5b, pages 5 and 6 and paragraph 4, 2d Indorsement: Concur. MACV has gone to DA with an official statement that the skidded unit loads are unsatisfactory. The standard 40" x 48" four-wall pallet was requested. USAMUCOM has requested, and MACV has concurred in a test of a modified skidded unit load with slots for four way entry. Test units are due in at Da Nang, Qui Nhon and Cat Lai in the near future. If this load is unsatisfactory the four-way pallets will be used.

d. Reference item concerning personnel shortages, paragraph 2a, 1st Indorsement and paragraph 5, 2d Indorsement: 1st Logistical Command has been verbally notified the moratorium is not considered applicable to SEA by DA. This is an interim notification.

3. Unit will be notified of actions and comments by routine indorsement which returns this report.

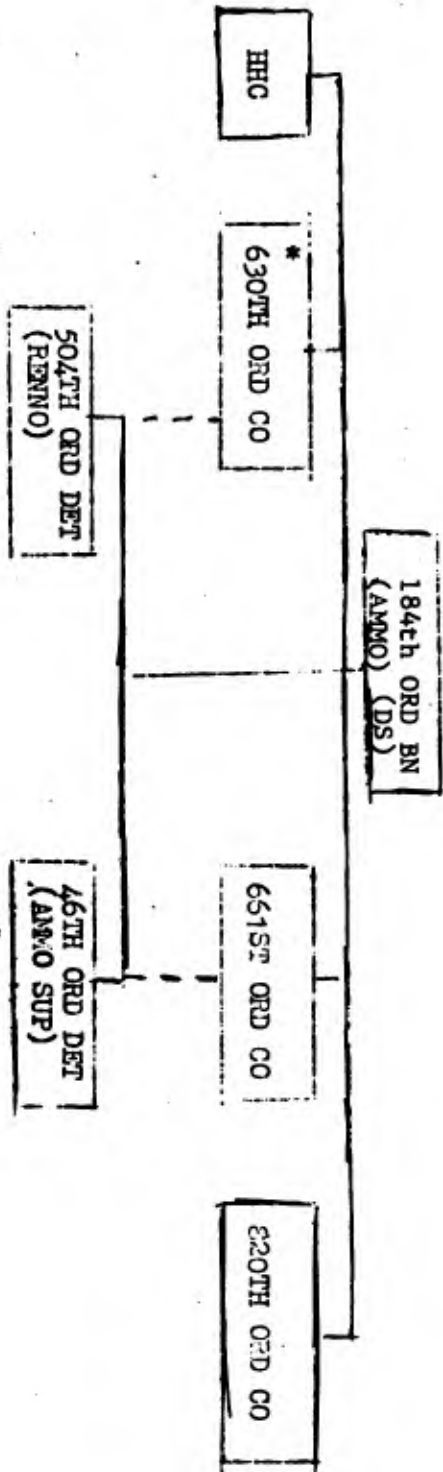
