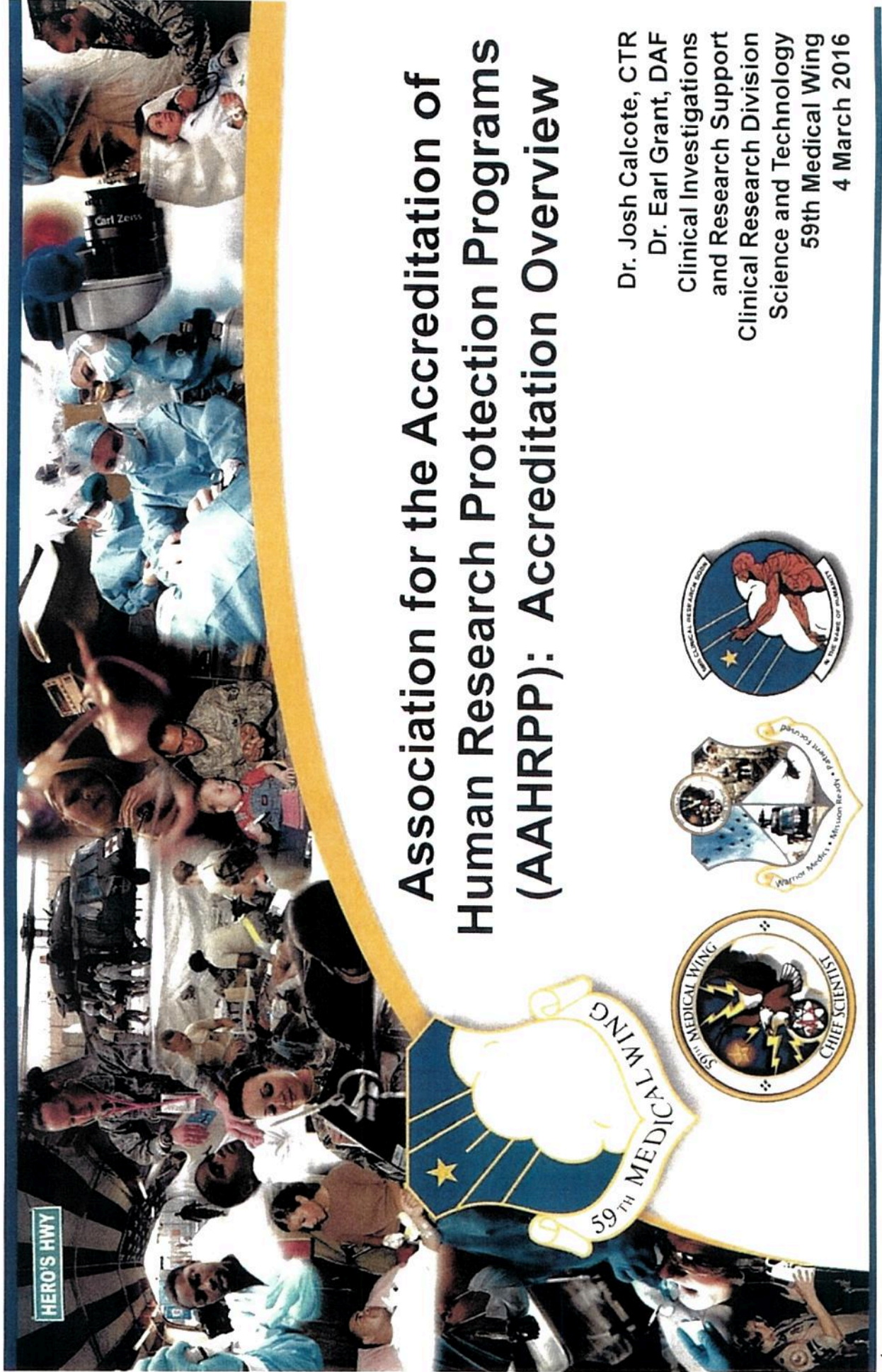

*Warrior Medics – Mission Ready – Patient Focused*

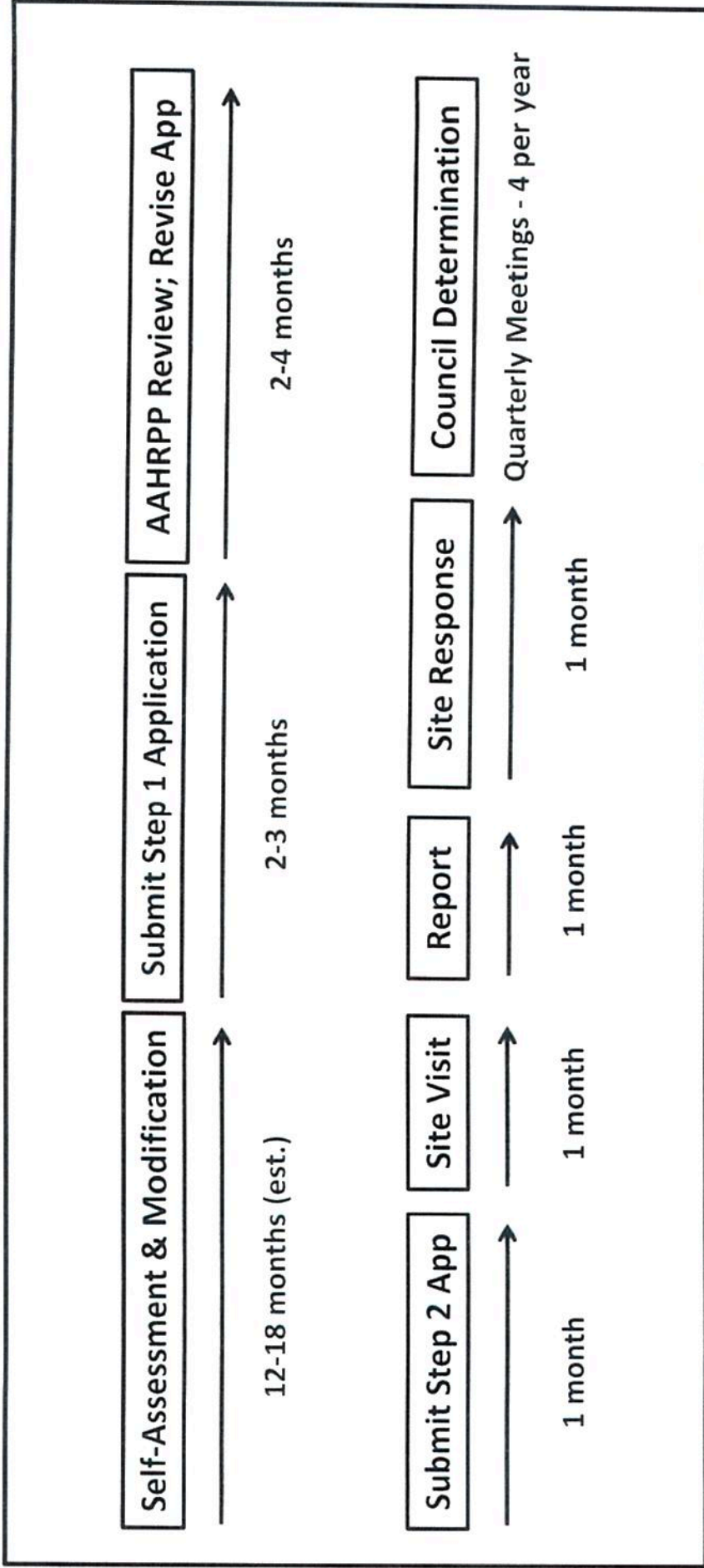
- **Self-Assessment** to identify gaps and make improvements
- **Submit Step 1** – an itemized, referenced document detailing how the organization meets each of the accreditation standards (~1,000 pgs.)
  - Reconcile issues identified by AAHRPP’s Step 1 reviewer
- **Submit Step 2** and prepare for onsite evaluation by HRPP experts
  - Reconcile issues identified by AAHRPP’s Site Visitors
- **AAHRPP Council review and determination** of accreditation status
  - Full Accreditation
  - Qualified Accreditation
  - Accreditation Pending
  - Accreditation Withheld

# The Way Forward

## Create “HRPP Plan” (MDWI + Submission Document + IRB OIs)

- **Step 1:** Prepare Draft HRPP MDWI
- **Step 2a:** Domains prepare **Chs. 1-17** of AAHRPP Submission Document
- **Step 2b:** Incorporate Domain II IRB **OIs** into the Submission Document
- **Step 3:** HRPP Steering Cmte review of cover letter. **Start: 13 Jan 2016**
- **Step 4:** Receive comments/edits from Steering Cmte by: **1 Feb 2016**
- **Step 5a:** Submit HRPP MDWI for Wing approval. **Start: 14 Feb 2016**
- **Step 5b:** Submit all chapters and OIs to Steering Cmte. **ECD: Apr 2016**
- **Step 6:** Submit HRPP Plan for BOD review. **ECD: May 2016**
- **Step 7:** Submit HRPP Plan for 59 MDW/CC approval. **Target: Jun 2016**
- **Step 8:** After CC approval, submit AAHRPP Step 1 application. **ECD: Summer 2016**
