INTRODUCTION

This *Special Bibliography Series*, Number 118, "The U.S. and Southern Africa: Progress, Potential, and Stable States?" was developed by the McDermott Library's Social Sciences Bibliographer and Reference Librarian, Frances K. Scott, in support of the 57th Academy Assembly to be held at the United States Air Force Academy, 1 – 3 February 2016.
