Meeting convened at 1100 hours

KPA/CPV:

I will make a statement concerning the serious violations by your side of the Armistice Agreement which have occurred of late in succession.

Escort Patrol Vessel No. 65 of your side appearing from the south at about 0940 hours on October 30, 1961, intruded into our coastal waters in the vicinity of 38 degrees 39 minutes North, 128 degrees 31 minutes East and after cruising about there disappeared to the south at about 1240 hours passing the waters in the vicinity of 38 degrees 39 minutes North, 128 degrees 38 minutes East.

The above Escort Patrol Vessel No. 65 again intruded at about 0730 hours on October 31, 1961 into our coastal waters in the vicinity of 38 degrees 39 minutes North, 128 degrees 31 minutes East and after cruising about there disappeared to the south at about 0900 hours on the same day passing the waters in the vicinity of 38 degrees 38 minutes North, 128 degrees 28 minutes East.

On the morning of November 1, 1961, a high-speed transport of your side, which had been sailing about the vicinity of the extension of the Military Demarcation Line, intruded into our coastal waters in the vicinity of 38 degrees 39 minutes North, 128 degrees 32 minutes East at about 0930 hours that day and after cruising thereabout disappeared to the south around 1400 hours.

Your high-speed transport No. 81 appearing from the south at about 0600 hours on November 3, 1961 intruded into our coastal waters in the vicinity of 38 degrees 39 minutes North, 128 degrees 29 minutes East, and after cruising thereabout disappeared to the south around 0905 hours passing the waters in the vicinity of 38 degrees 38 minutes North, 128 degrees 30 minutes East.

Escort Patrol Vessel No. 65 of your side appearing from the south at about 0500 hours on the same day passed our coastal waters in the vicinity of 38 degrees 38 minutes North, 128 degrees 33 minutes East, intruded as far as into the waters in the vicinity of 38 degrees 39 minutes North, 128 degrees 30 minutes East at about 0800 hours and after cruising thereabout disappeared to the south at about 1800 hours passing the waters in the vicinity of 38 degrees 37 minutes North, 128 degrees 37 minutes East.

Escort Destroyer No. 71 of your side appearing from the south at about 1900 hours on November 12, 1961 passed the waters in the vicinity of 38 degrees 36 minutes North, 128 degrees 31 minutes East, intruded into our coastal waters in the vicinity of 38 degrees 39 minutes North, 128 degrees 30 minutes East at about 1915 hours and after cruising thereabout disappeared to the south at about 1945 hours passing the waters in the vicinity of 38 degrees 36 minutes North, 128 degrees 29 minutes East.

Escort Vessel No. 52 of your side appearing from the south at about 0900 hours on November 14, 1961 passed the waters in the vicinity of 38 degrees 36 minutes North, 128 degrees 26 minutes East, intruded into our coastal waters in the vicinity of 38 degrees 40 minutes North, 128 degrees 31 minutes East at about 1005 hours and after cruising thereabout disappeared to the south at about 1115 hours passing the waters in the vicinity of 38 degrees 36 minutes North, 128 degrees 27 minutes East.

Escort Destroyer No. 71 of your side appearing from the

south at about 0900 hours on the same day passed the waters in the vicinity of 38 degrees 37 minutes North, 128 degrees 27 minutes East, intruded into our coastal waters in the vicinity of 38 degrees 41 minutes North, 128 degrees 31 minutes East at about 0945 hours and after cruising thereabout disappeared to the south at about 1615 hours passing the waters in the vicinity of 38 degrees 37 minutes North, 128 degrees 36 minutes East.

Your medium landing craft No. 602 appearing from the south at about 0945 hours also on the same day passed the waters in the vicinity of 38 degrees 36 minutes North, 128 degrees 35 minutes East, intruded into our coastal waters in the vicinity of 38 degrees 39 minutes North, 128 degrees 31 minutes East at about 1005 hours and after cruising thereabout disappeared to the south at about 1500 hours passing the waters in the vicinity of 38 degrees 37 minutes North, 128 degrees 35 minutes East.

Your medium landing craft No. 602 appearing from the south at about 1800 hours on November 15, 1961 passed our coastal waters in the vicinity of 38 degrees 38 minutes North, 128 degrees 32 minutes East, intruded as far as into the waters in the vicinity of 38 degrees 41 minutes North, 128 degrees 31 minutes East at about 2115 hours and after cruising thereabout disappeared to the south at about 2130 hours passing the waters in the vicinity of 38 degrees 39 minutes North, 128 degrees 35 minutes East.

Escort Destroyer No. 71 of your side appearing from the south at about 1115 hours on November 16, 1961 intruded into our coastal waters in the vicinity of 38 degrees 39 minutes North, 128 degrees 32 minutes East. While cruising thereabout, she intruded as far as into the waters in the vicinity of 38 degrees 40 minutes North, 128 degrees 31 minutes East at about 1700 hours and disappeared to the south at about 1800 hours passing the waters in the vicinity of 38 degrees 37 minutes North, 128 degrees 35 minutes East.

Your sub-chaser No. 707 appearing from the south at about 1800 hours on November 16, 1961 passed the waters in the

vicinity of 38 degrees 37 minutes North, 128 degrees 29 minutes East, intruded as far as into our coastal waters in the vicinity of 38 degrees 39 minutes North, 128 degrees 31 minutes East at about 1945 hours and after cruising about there disappeared to the south at about 2030 hours.

As you are also aware, Paragraph 15 of the Armistice Agreement provides that naval forces QUOTE shall respect the waters contiguous to the Demilitarized Zone and to the land area of Korea under the military control of the opposing side. UNQUOTE

This notwithstanding, your side has failed to take any measures for the enforcement of the Armistice Agreement, thereby causing in succession hostilities such as those I have just mentioned above.

The dispatch by your side of its naval craft into the coastal waters of our side again recently to conduct reconnaissance constitutes a vicious challenge against our side and a flagrant violation of Paragraph 15 of the Armistice Agreement.

I have been instructed to lodge a protest with your side against its serious violations of the Armistice Agreement by dispatching its naval craft into the coastal waters of our side.

At the same time, I demand that your side severely punish in accordance with Sub-paragraph 13e of the Armistice Agreement all of its personnel involved in the recent violations of the Armistice Agreement and that it take responsible measures to prevent a recurrence of similar sea intrusions.

UNC:

Your side's charges of sea violations will be investigated in accordance with the terms of the Armistice Agreement, and the result of these investigations will be reported.

I go to another subject.

At the 236th Secretaries' meeting of the Armistice Commission, your side charged that two United Nations Command F-86 aircraft intruded 110 kilometers into the territory under

the military control of your side, crossing the Demilitarized Zone at coordinates 37 degrees 55 minutes 50 seconds North, 126 degrees 40 minutes 35 seconds East, around 1311 hours 31 August 1961.

A complete investigation has been conducted by the United Nations Command of this alleged violation. The United Nations Command has not found any evidence of an air violation on this date. A review of all flight manifests at the time and date reported by your side of this alleged violation shows that no United Nations Command F-86 aircraft were flying at the time of the alleged violation.

Therefore, your side's charge that two United Nations Command F-86 aircraft violated the Armistice Agreement on 31 August 1961 at 1311 hours is denied.

KPA/CPV:

I have noted your statement that your side will make investigations and take appropriate action into the repeated sea intrusions by its naval vessels which have just been brought up by our side.

Nothing is more frivolous, indeed, than your action designed to ignore with a few words the glaring violations by your side of the Armistice Agreement.

As is well known, at the 236th Secretaries' meeting our side lodged a strong protest with your side against the provocative act by the military aircraft of your side having conducted military reconnaissance of a hostile nature flying a total length of more than 110 kilometers in the territorial air space of our side.

This incident was a patent fact personally observed by the personnel of our side and confirmed with up-to-date scientific instruments.

This notwithstanding, your side is trying to reject flatly this glaring fact. This shows that your side has not the

slightest intention to observe the Armistice Agreement, that it will continue to perpetrate provocative and hostile acts in the future too in order to intensify tensions and promote war preparations in Korea.

If your side has the slightest concern for the safeguarding of the armistice in Korea and for peace, it should not have committed such violation of the Armistice Agreement at all.

Since your side is a guilty party who has committed a hostile act in violation of the Armistice Agreement, it should bear the responsibility for it and give an assurance at this table to prevent a recurrence of similar violations.

Our side resolutely denounces the unwarrantable attitude of your side against the faithful discharge of its duty assumed under the Armistice Agreement, and demands again that your side observe and implement the Armistice Agreement in a responsible way.

Our side will continue to call your side to account for the violation until your side complies with our demand.

I have a statement to make on another subject.

Around 1350 hours on October 29, 1961, two military personnel of your side with automatic weapons moved around the vicinity of 38 degrees 18 minutes 15 seconds North, 128 degrees 02 minutes 30 seconds East in the southern portion of the Demilitarized Zone and fired 8 shots toward the vicinity of 38 degrees 18 minutes 35 seconds North, 128 degrees 02 minutes 33 seconds East in the northern portion of the Zone.

And around 1100 hours on October 30, the following day, two military personnel of your side who appeared in the vicinity of 38 degrees 18 minutes 40 seconds North, 127 degrees 59 minutes 10 seconds East in the southern portion of the Demilitarized Zone committed the hostile act of firing 12 shots with automatic weapons toward the vicinity of 38 degrees 19 minutes 00 seconds

North, 127 degrees 59 minutes 25 seconds East in the northern portion of the Zone on two occasions.

Such hostile acts on your part were also committed by your military personnel who appeared in the vicinity of 37 degrees 58 minutes 40 seconds North, 126 degrees 46 minutes 20 seconds East in the southern portion of the Demilitarized Zone around 1830 hours on September 2, 1961 and in the vicinity of 38 degrees 19 minutes 10 seconds North, 127 degrees 33 minutes 15 seconds East in the southern portion of the Zone around 0937 hours on September 12, 1961.

In disregard of our repeated warnings, your side has kept on committing such provocative acts. Could they be only considered to have been caused through the ill-advised actions taken by your personnel who are undisciplined, disorderly, and untrained? They constitute deliberate and prearranged provocations by your side.

At the direction of the Senior Member of our side, I lodge a stern protest with your side against the recent hostile acts committed by your side against our side in violation of the Preamble of the Armistice Agreement and Paragraphs 6, 12, 14, and 17 thereof.

At the same time, I demand that your side severely punish the personnel of your side who are engrossed in committing provocative acts and take thorough-going measures to prevent a recurrence of similar hostile acts in the future.

UNC:

As regards to your charges of firing with automatic weapons into the northern part of the Demilitarized Zone, they will be investigated and a report submitted.

I go to a new subject.

Your side's disregard for the provisions of the Armistice Agreement have again been shown in the past few weeks.

UNC: (CONTD)

On 3 November 1961 between the hours of 0930 and 1030 hours, Korean Standard Time, four persons were observed hunting with shotguns in the Headquarters Area "B" of the Demilitarized Zone just north of the Joint Security Area. About eight rounds were fired from these weapons.

Again on 15 November 1961 between 0800 and 0840 hours, Korean Standard Time, one person was observed hunting with a shotgun in the Headquarters Area "B" just north of the Joint Security Area. Seven rounds were fired.

The introduction and the firing of shotguns in the Demilitarized Zone is a violation of Paragraph 10 of the Armistice Agreement.

It is requested that your side conduct an investigation into these violations of the Armistice Agreement and take steps to preclude further violations of this nature. The illegal introduction of and the firing of these weapons, particularly in the vicinity of the Joint Security Area where personnel of both sides are present, constitutes a serious safety hazard as well as a most serious violation of the Armistice Agreement.

KPA/CPV:

I have noted your statement that investigations will be conducted into the provocative firings committed by the personnel of your side.

As has been laid bare at this meeting, it is precisely your side that has incessantly fired rifles in the Demilitarized Zone in an undisciplined and disorderly manner.

Being consistently faithful towards the requirements of the Armistice Agreement, our side will inquire into the cases you have just referred to.

UNC:

I note your agreement to investigate and take necessary action concerning your side's firing of weapons in the DMZ near the Joint Security Area.

UNC: (CONTD)

I now go to another subject.

Clear delineation of the Military Demarcation Line in all areas of the Demilitarized Zone is necessary to prevent inadvertent Armistice violations. Maintenance of this line is one of the specific and important provisions of the Armistice Agreement.

Our side is conducting a detailed inspection of Military Demarcation Line markers across the entire Demilitarized Zone within our area of responsibility. We are taking the necessary measures to replace and repair markers and clear the area of the heavy underbrush sufficiently so that each marker can be seen from the adjacent markers. In areas where the maintenance of markers is the responsibility of your side, our side will report such deficiencies as are found.

It is hoped that your side will cooperate with our side in this essential project and will take action to fulfill its Armistice responsibilities in this regard.

At this time we call your attention to that portion of the Military Demarcation Line between markers 0205 and 0225 for which your side is responsible. Most of these markers are missing or in need of repair. Also in this area, the heavy undergrowth around and between markers needs to be removed to facilitate the identification of the Military Demarcation Line.

Do you agree to investigate and take necessary action in this matter?

KPA/CPV:

The Military Demarcation Line markers, the maintenance and repair of which are in the charge of our side, have been maintained by our side and will be properly maintained in the future as well.

I have a statement on another subject.

Your side submitted lists of alleged QUOTE violations UNQUOTE by our side of the Armistice Agreement at the 235th and 236th Secretaries' meetings.

KPA/CPV: (CONTD)

Our side has made detailed and careful investigations on the basis of the so-called lists submitted by your side and the supplementary information your side subsequently sent to our side through the Joint Duty Officers.

As a result, it has been established that all of your charges were out-and-out falsehoods. I now cite a few examples.

The list submitted by your side at the 235th Secretaries' meeting contains an item that 25 civilians of our side supported by one tractor who were engaged in farming on June 20, 1961 wore no distinctive insignia.

I refer you to the provision of the QUOTE Agreement on Entry into and Departure from the Demilitarized Zone by Civilians UNQUOTE agreed upon between both sides on February 22, 1954.

It is prescribed in the Agreement that the crossing of the northern or southern boundary of the Demilitarized Zone by civilians who were bona fide residents of the Demilitarized Zone or who were engaged in farming in the Demilitarized Zone on the effective date of the Armistice Agreement shall be permitted by the Military Armistice Commission.

Our personnel referred to in your list are our farmers with specific permissions issued by the Military Armistice Commission whose names have not only been registered with the Secretariat of the Military Armistice Commission but also passed to your side.

Neither provision nor necessity is there for those farmers who have been accorded full freedom of movement by the Military Armistice Commission through legal procedures to wear any sort of distinctive insignia while they are engaged in farming.

Your charges are, therefore, utterly absurd. They are nothing but a base trick of those cursed people who are only intent on harming others.

The so-called list of your side also contains several preposterous charges alleging that our personnel fired rifles in the Demilitarized Zone.

KPA/CPV: (CONTD)

Your side however said in your additional information passed our side through the Joint Duty Officers on September 23, 1961 that even the directions of fire and impact areas were unknown.

If your personnel had personally observed the firings, they should have known the directions of fire, shouldn't they? Yet your side does not know even the directions of fire. What is this but a proof that your allegation that your personnel had observed the firings was a lie?

These facts prove that the so-called lists passed by your side are false papers which were forged with the wicked aim of slandering our side and deceiving the world public.

In truth, your side has manufactured so far a great number of the lists thereby compelling our side to waste precious time and hindering the work of the Military Armistice Commission considerably.

I have been instructed by the Senior Member of our side to lodge a protest against the repeated unwarrantable acts of your side which run counter to the requirement and spirit of the Armistice Agreement.

At the same time, I categorically deny all the cases contained in the so-called lists submitted by your side at the 235th and 236th Secretaries' meetings and strongly demand that your side stop committing such frauds in the future.

UNC:

I am pleased to hear that you will take steps to maintain those MDL markers which are the responsibility of your side and which are in need of replacement or repair.

Your denial of every one of the 207 ground violations charged by the United Nations Command and reported on the list passed to your side at the 235th meeting of the Secretaries on the 26th of July 1961 was expected.

The impression that your side was conducting a thorough investigation by requesting further information at the 236th

Secretaries' meeting on certain specific violations fooled no one. It is obvious from your statement denying the 207 ground violations that your side has not conducted any investigation as required. This is a repeat of the same deplorable attitude adopted by your side on more than 1,000 other violations which the United Nations Command has charged your side with in the past 8 years.

Your charges that the information on the list of violations furnished your side by the United Nations Command was insufficient, inadequate, and incorrect are denied. This is the same type of information furnished by the United Nations Command on previous lists of violations passed to your side. Your side was able to deny all violations on every previous list without additional information. The type of information shown in the lists of alleged violations passed by your side to the United Nations Command is no different from the information furnished by the United Nations Command.

Your side has not admitted a single violation in nearly 8 years. Your denial of every violation completely refutes any statement you make at these and other meetings that your side is faithful to the Armistice Agreement.

Likewise, concerning the list of 105 violations committed by your side in the Demilitarized Zone during the 43-day period from 20 July through 31 August 1961, your denial of these violations is indicative of your continued insincerity toward the Armistice Agreement.

At no time since the Armistice Agreement was signed, more than eight years ago, has your side indicated any willingness to abide by its provisions. The records of these meetings and those of the Military Armistice Commission provide conclusive evidence of your side's insincerity. Instead of negotiating in good faith at these meetings, your side has made every effort to limit the effectiveness of these negotiations. As long as

your side continues such a nefarious program, tension will remain high in Korea.

KPA/CPV:

It is because your side is continuing war preparations, is deliberately violating the Armistice Agreement, and because your side trumps up false incidents for the purpose of slandering and defaming our side groundlessly that tensions are continuously intensified in Korea.

Your side should give up its improper attitude of hurling random slanders at our side by cooking up unfounded incidents instead of charging our side which has recorded facts as facts in strict conformity with the spirit and requirement of the Armistice Agreement.

All facts go to prove that the charges you have levelled at our side are out-and-out lies, and show that the so-called lists submitted by your side at the last 235th and 236th Secretaries' meetings were also false documents fabricated on the table.

For what are you bickering over the fact that our farmers are engaged in farming in accordance with the Agreement made between both sides and with the specific permission of the Military Armistice Commission?

What violation does it constitute?

However desperately your side may try, you cannot disguise the true colors of your side as an impostor.

Notwithstanding the incessant violations of the Armistice Agreement, you have posed as a QUOTE defender UNQUOTE of the Agreement. This behavior of yours well explains your insincere attitude and position towards the Armistice Agreement.

It is just because of such a position of your side that violations of the Armistice Agreement by your side on the ground, at sea, and in the air have been committed incessantly. Those violations by your side which our side has formally brought up against your side since the cease-fire up to this date number

1,875 cases. Yet your side feels no sense of responsibility for those serious crimes.

Such a position of your side cannot be tolerated any longer.

I demand that your side prove its QUOTE sincerity UNQUOTE through its own actual deeds of thoroughly complying with the provisions of the Armistice Agreement and of the Agreements and Understandings and of taking complete and prompt measures for ceasing the irresponsible and fraudulent actions of trumping up unfounded incidents, instead of paying lip service to your so-called QUOTE sincerity. UNQUOTE

UNC:

At the 236th Secretaries' meeting on 8 September 1961, your side passed a list of 241 violations allegedly committed by the United Nations Command in the Demilitarized Zone during the period 21 July - 31 August 1961.

The United Nations Command has conducted a thorough investigation into each of these alleged violations and has determined that all 241 were falsely charged. They are, therefore, rejected.

KPA/CPV:

The violations by your side of the Armistice Agreement and subsequent Agreements and Understandings amounting to 241 cases which occurred in the Demilitarized Zone during the period from July 21 to August 31, 1961 were all confirmed through careful observation by our personnel on the scene.

If your side had the slightest intention to comply with the Armistice Agreement, it would have in no way denied the above-mentioned incidents.

Your side has denied the violations of the Armistice Agreement committed by your personnel under preposterous pretexts. This only serves to show again your insincere attitude and position toward the Armistice Agreement.

KPA/CPV: (CONTD)

I resolutely denounce the improper attitude of your side.  
Has your side anything else to offer at this meeting?

UNC:

Regarding your charge that the United Nations Command is not sincere with regards to the Armistice Agreement.

The fact is that for the past 8 years your side has denied every violation charged by the United Nations Command. In many cases your side has denied the United Nations Command charges without any pretense of an investigation. It is quite evident that inadvertent violations are bound to occur but even these you do not admit.

It is not the United Nations Command that shows insincerity toward the Armistice Agreement. Our side admits to those charges which investigation proves to be true. This is not the case with your side.

I have a statement to make.

I now place before you a list of 151 ground violations committed by your side in the Demilitarized Zone during the period 2 September through 15 November 1961. These charges are all supported by valid evidence. The United Nations Command demands that your side conduct a thorough investigation of each violation, punish those personnel responsible, and take positive steps to prevent their recurrence.

I have no further business.

KPA/CPV:

It is incomparably ridiculous for your side which had consistently wrecked and violated the Armistice Agreement to palaver as if it had any QUOTE sincerity UNQUOTE towards the implementation of the Armistice Agreement.

If your side has the slightest sincerity towards the spirit and the provisions of the Armistice Agreement as you have alleged, your side should not have repeated violating the Armistice Agreement.

KPA/CPV: (CONTD)

As the records of the proceedings of the Military Armistice Commission and its subordinate agencies show, your side has committed as many as 1,875 violations of the Armistice Agreement and the subsequent Agreements and Understandings on land, at sea, and in the air which our side formally brought up during the 8-year armistice period.

Despite the fact that the Armistice Agreement demands, in particular, the prohibition of any reinforcement of military strength during armistice, your side has not only shipped in continuously large numbers of manpower and various new-type weapons including atomic weapons and guided missiles, but also run amuck to prepare for another war of aggression launching mass-destruction weapons in succession.

Thus, the facts stringently condemn your side for having systematically undermined and infringed the Armistice Agreement. Yet how can your side pose itself as the QUOTE defender UNQUOTE of the Armistice Agreement?

And, if your side values the Armistice Agreement and is sincere in its implementation as you stated, it must frankly admit its criminal acts and apologize to our side for them, desisting from such despicable behavior as to slander at will our side which has consistently been faithful in the implementation of the Armistice Agreement.

Up to this date since the cease-fire, however, your side has either denied without foundation glaring facts or attempted to reverse right and wrong, and been engrossed in only shameless acts of slandering our side by framing up unfounded incidents.

Let me cite only a few recent facts out of numerous ones.

On April 7, 1961 your side dispatched a sub-chaser into the coastal waters of our side in the vicinity of 38 degrees 40 minutes North, 128 degrees 25 minutes East three miles from the coast of our side and three miles from an extension of

the Military Demarcation Line to perpetrate such a piracy as to assault the fishing boats of our side which were then engaged in fishery in the nearby waters. When the true facts came to be exposed, your side attempted to shift the responsibility for the incident onto our side by distorting the true facts saying as if our personnel had attacked the sub-chaser of your side sailing on the high seas.

And, on June 6 last, your side also dispatched a sub-chaser into the coastal waters of our side in the vicinity of 38 degrees 39 minutes North, 128 degrees 24 minutes East to perpetrate savage bombardment towards the coastal areas of our side, and then your side distorted the fact alleging that our vessel had QUOTE intruded UNQUOTE into south Korean coastal waters.

Furthermore, your side charged our side at the 227th Secretaries' meeting with the fact that our personnel had carried automatic weapons at the spot 38 degrees 31 minutes 13 seconds North, 127 degrees 45 minutes 20 seconds East, allegedly in our portion of the Demilitarized Zone on January 18, 1961 in an attempt to cover up its criminal acts of having fortified the Demilitarized Zone as part of its preparations for another war and to slander and defame our side which had invariably been faithful in implementing the Armistice Agreement.

But the spot, 38 degrees 31 minutes 13 seconds North, 127 degrees 45 minutes 20 seconds East, on which your side had doggedly insisted was not located within the Demilitarized Zone but in the area under the military control of our side some 20 kilometers away from the Demilitarized Zone.

A few examples as mentioned above alone are enough to prove that all QUOTE violations of the Armistice Agreement UNQUOTE which your side clamored about are pure lies without any factual grounds at all.

As can be seen in the above, whatever ruse and means your side use can neither cover up the true colors of your side having made frenzied efforts to prepare for another war in

continuous disruption and infringement of the Armistice Agreement nor help your side to evade the responsibility for them.

I demand that your side give assurance for a strict compliance with all the terms of the Armistice Agreement desisting from taking an improper attitude.

I go to another subject.

As is clearly shown by the records of past meetings, and as is proved by the numerous fresh data at the disposal of our side now, it is precisely your side that has violated the rules for the control and maintenance of the Demilitarized Zone.

This notwithstanding, your side has again submitted a list of the alleged QUOTE violations UNQUOTE by our side with a view to covering up its own violations such as mentioned above and deceiving the world public.

I remind you of my statement substantiating the fact that the lists submitted by your side at the 235th and 236th Secretaries' meetings were false papers replete with pure fabrications.

I demand that your side desist from such hoaxes and frauds in the future.

Proceeding from the consistent position of our side which is faithful toward its obligations assumed under the Armistice Agreement, our side will examine the list presented by your side just now and comment on the results later.

UNC:

I note that you will investigate the list of violations passed by our side.

The rest of your statement is not business for this meeting but rather the same old propaganda line that I realize you are required to endlessly repeat by your authorities.

Contrary to your lengthy and provocative statement the record of past meetings clearly shows that all charges you

have made against the United Nations Command have been investigated and answered in accordance with the Armistice Agreement. Have you anything else appropriate to a Secretaries meeting?

KPA/CPV:

If your side is afraid of the legitimate charges made by our side, your side should cease violating the Armistice Agreement.

It is very foolish and despicable of you to try to seek for a means of escape by sophism since your crime is so serious as to find yourself at a loss for words.

Since your side has stated that it has nothing further to present, I propose to recess.

UNC:

I accept your proposal for a recess.
