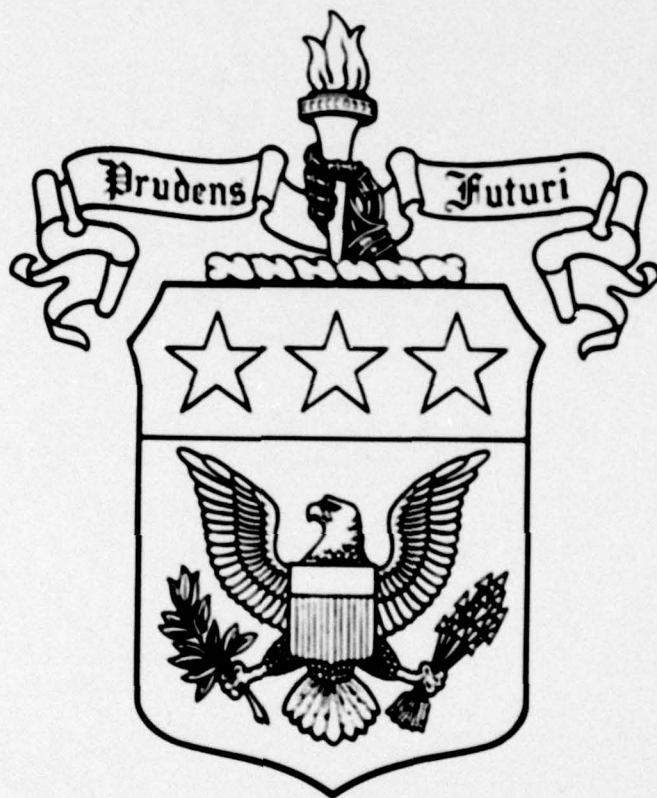

Publication of the special bibliography series of the US Army Military History Research Collection has had the primary purpose of providing information regarding the holdings of the Research Collection to the scholar and historian. Six of the previous bibliographies are related to special interest subjects or to a specific time period of American history, and one relates to the manuscript holdings of the Research Collection.

This, the eighth of the special bibliographic series, differs from previous publications in many ways. It relates to the curricular materials and studies of an academic institution, the US Army War College, and covers the period from the founding of the War College in 1903 until its closing in 1940 on the eve of World War II. Because several thousand papers are included in this collection, it was decided that publication in normal bibliographic format was inadvisable and infeasible. This bibliography, instead, is actually an essay defining the major categories of materials in the War College collection and illustrating the categories by citing examples in the various categories. The lectures presented to the War College during these years are in themselves a significant source for historical research for the lectures were presented, not only by distinguished military leaders and other governmental officials, but also by leading industrialists, educators, labor leaders, diplomats, economists, and sociologists. The War College collection must be considered a true barometer of the period.

Dr. B. F. Cooling, Chief of Research Studies for the Military History Research Collection, has carefully selected typical examples of these papers in developing his bibliographic essay. He has carefully avoided selecting the "unusual" or the "outstanding," but has instead used the "typical" paper, lecture, or study to provide an illustrative example of various categories and types of materials included in the Army War College collection. All of the materials referred to in this bibliography can be found in the Army War College collection, a part of the holdings of the US Army Military History Research Collection.

INTRODUCTION

↙ The assigned mission of the United States Army War College since its inception in 1901 has been to prepare selected officers for high command and staff duty. The honor roll of its graduates reflects accomplishment of this mission. But as the names and tasks of those graduates have changed through the years, so have the curricular offerings which spawned their professional abilities. Thus, it becomes fundamentally important for understanding twentieth century military events, institutions, and personalities that we comprehend the multifaceted educational approach which produced the Pershings, the Eisenhowers, and the Ridgways--nay, even the countless thousands who remained unknown beyond the cloister of Mars. Such necessity leads to the historical value of the curricular archives of the Army War College.

↖ Colonel George S. Pappas in his premier study of the institution--Prudens Futuri; The US Army War College, 1901-1967 (Carlisle Barracks, The Alumni Association of the U.S. Army War College, 1968)--suggests three periods in the history of the school: pre-1919, 1919-1940, and post-1950. Since the curricular archives are open for public access only for the first two periods, this suggested guide must be concerned solely with material prior to 1940. Yet, how truly dramatic those first two periods were for the Army's senior corps of professionals! Such exciting and exacting times witnessed professional growing pains (the first years of implementing the reforms of Elihu Root); the strenuous activities of preparedness, mobilization, and cooperation with industry which accompanied America's entry into the First World War; the veritable testing of War College concepts and verities in the cauldron of that conflict; and finally, the postwar agonies of preparing for future hostilities in time of peace--those meteoric decades of the Roaring Twenties and Depression-ridden Thirties, leading to a second world war.

The curricular archives themselves portray those topics and learning devices which enabled senior Army professionals to meet the challenge of modern war. In the earliest years the primary objective was production of qualified officers for the nascent general staff--senior executives to conduct one phase of the military establishment. The army was small and its task relatively simple, for the navy stood as the nation's first line of defense. Then, World War I spotlighted the difficulties of managing a larger military machine under the technological umbrella of the twentieth century. Planning became the great talisman when the shooting stopped. Curricular revisions focused upon preparation of officers for "G" type general staff assignments, mobilization, war gaming, and the distinct possibility of war in the Pacific. The small cloud of eventual conflict in Europe appeared much later on the horizon.

This guide offers merely one device for exploring the type of educational data and experience which confronted War College students

and faculty before World War II. Lectures, committee analyses, map and war game studies, as well as individual student research papers supplied the medium; historical battles, hypothetical enemies, manpower and transportation issues provided the subject matter. Taken together, their record will yield countless hours of challenge and enchantment for the researcher seeking to understand the Army as an institution in war and peace. This researcher will be aided, as have I, by the cooperative staff of the U.S. Army Military History Research Collection. Yet, in the final analysis, the staff can only suggest a pathway through the maze of documentation. To investigate, to appreciate, to inwardly digest the meanings and nuances--that must remain the challenge of the individual scholar. Good luck--and good hunting!

ARMY WAR COLLEGE RECORDS IN NATIONAL ARCHIVES

The largest existent body of records relating to the U.S. Army War College, 1900-1945, are in the care of the Modern Military Branch, Military Archives Division, U.S. National Archives and Records Service. All Army War College records are allocated to Record Group 165, Textual Records of War Department General and Special Staffs. These records contain material related to the administration of the college, documentation of changes in the course of study, and a few studies produced by students at the college.

The General Correspondence file is the largest and most active series of War College records in Archives custody. This series, also known as the War College Document Collection, includes the records of the War Plans Division and its predecessors; the Army War College; the Second and Third Divisions of the War Department General Staff; the Second Section of the War Department General Staff; and the War College Division. The records reflect the varied functions of these several offices which included study of military problems; preparation of plans for the national defense and utilization of military forces in time of war; investigation of the efficiency and state of preparedness of military forces in time of peace or war; supervision of military education (including the Army War College); preparation of military monographs and historical studies; preparation of non-technical manuals and revision and coordination of all official regulations and manuals; and maintenance of the War Department Library.

The National Archives has microfilmed the basic index to the War College records in its custody as Introduction Microfilm Publication M-912. National Archives is currently working on a microfilm copy of the records themselves. Reference is made to Harry W. John and Olive K. Liebman (compilers), Preliminary Inventory of the Textual Records of the War Department General and Special Staffs (Record Group 165), NM-84, (Washington: National Archives and Records Service, 1967).(*)

SECTION I

NOTES ON THE EVOLUTION OF THE CURRICULUM 1904-1940

1904-1917 Period

General Order 115 issued 27 June 1904 set the pattern for the curriculum during the years preceding World War I. The seven-month academic year was to be devoted to:

1. The critical study of an approved plan of operations with a view to its confirmation or modification.
2. The assumption of the original conditions on which an approved plan was based and the preparation of an independent plan, the two to be subsequently prepared and discussed.
3. In each case a minute and detailed study of a certain number of days' operations at an important period of the plan, involving the preparation of every daily order of importance to be issued during the period, directing the position and movements of wagon trains of every kind, the tactical arrangement of marches (assignment of roads to columns, arrangement of columns on the roads, etc.), length of marches, tactical arrangement of camps and bivouacs, etc.
4. In connection with the above, the discussion of special problems encountered by the technical troops, of the tactical use of the three arms under the given conditions, the supply of ammunition, the disposition of the wounded, etc.
5. A war game, in which an actual campaign (of the Civil War, for instance) will be taken, all the initial conditions of the campaign being assumed to exist now as they actually did, except that the organization, armament, equipment, and tactical methods are those of the present day, the probable result being worked out on the map.
6. Informal lectures and general discussions of current military events and developments.

The major subjects studied included: organization, strategy, tactics, maneuvers, both on maps and on actual terrain, duties of the General Staff, military history, the cooperation of the Army and the Navy, and the preparation of plans for National Defense and Offense, including the preparation of military monographs based upon military geography.

N.B. MATERIAL FOR THIS PERIOD IS ORGANIZED AND BOUND SEPARATELY IN FOLDERS ARRANGED CHRONOLOGICALLY BY YEAR.

Specific examples of material dating from this period include:

Lecture, Brigadier General Tasker H. Bliss, "Duties of the General Staff," Academic Year 1909-1910.

War Game Problem, Blue versus Orange, Academic Year 1914-1915.

Staff Ride, Antietam Campaign, Academic Year 1911-1912.

1919-1920 Period

Reconstitution of the War College under the name "General Staff College" in 1919 led to a curriculum of only brief duration. It was broken down into the following elements: Intelligence Course, Operations Course, Personnel Course, Supply Course, Training Course, War Games Course, Special Course, and Field Exercise. Types of material dating from this period include:

Committee Material--country studies including military, economic, political, and psychological evaluations.

Lecture, Professor Albert Bushnell Hart, "Dangers Resulting from Balkanization of Central Europe."

Special Course Student monographs such as Major E. P. Lahmn, "Air Service."

N.B. MATERIAL AVAILABLE FOR RESEARCH IS ORGANIZED IN BLOC CATEGORY, "GENERAL STAFF COLLEGE, 1919-1920."

1920-1940 Period

A model for the curricular instruction during this period may be found in a sample year, i.e. 1925-1926.

War Plans Division Course

(studies covering type war plans, defense projects, naval plans, joint plans, etc.)

Mobilization Course

(studies of mobilization plans including War Department and Corps Area)

G-1 Course

(studies of policies, regulations and laws concerning organization and functions of War Department, Corps Area, and higher headquarters as well as personnel)

G-2 Course

(survey of leading nations of the world, their national policies and war-making possibilities, important details of G-2 activities, military intelligence functions, and the organizations and methods in certain foreign armies)

G-3 Course

(studies of the development of the general staff, G-3 functions, organization, responsibilities, and methods, comparative studies of the armies of the United States and certain foreign countries, study of military situation of the United States, principles of peacetime training, etc.)

G-4 Course

(studies of G-4 features of war and mobilization plans, supply in selected campaigns, control of transportation, relationship of supply and strategy)

Assistant Secretary of War Course

(studies of past industrial mobilization in principal nations of the world, functions of the Assistant Secretary of War and procurement functions of several supply branches, Navy, etc., and economic survey of the United States and raw materials situation)

Command Course

(study of principles of higher command, analytical studies of organization, command, operation, logistics, and strategy of selected operations and campaigns vis-a-vis command principles, special studies of joint operations and expeditionary forces, preparation and evaluation of a Joint Army and Navy Map and Chart maneuvers, field exercises and command reconnaissance for use in the War Plans period)

War Plans Division Course

(actual preparation of Joint Army-Navy plans, etc.)

Command Course - War Plans Period

(execution of map maneuvers, field exercises, and command reconnaissance)

Coordination Period

(studies of the operation of a staff as a whole, including the correlation of the duties of the several groups of General Staff and of the various branches of the staff)

Examples of variations and changes instituted in the curriculum in this period include: (1930-1931), Assistant Secretary of War Course ended and henceforth given concurrently with the G-4 Course; (1936-1937), Preliminary Command Course added; (1935-1936), informal "Foreign News"

Course added; (1934-), historical rides made to selected Civil War battlefields--similar to rides taken before World War I for the purpose of studying relationship of command, leadership, and operations to local and terrain situations.

N.B. MATERIAL IN CURRICULAR ARCHIVES FOR 1920-1940 IS ARRANGED CHRONOLOGICALLY BY YEARS AND BY COURSE NOMENCLATURE.

Specific examples of material in this period include:

G-2 Course document, Report of Committee Number 13, "Estimate of the Strategic Situation of the Japanese Empire," September 30 and October 1, 1924.

Lectures, Major Oswald H. Saunders, (Infantry), "The Russian-Polish Campaign of 1920," February 5 and 13, 1933, Analytical Studies Course, Volume V, Part I, 1932-1933.

Studies of Overseas Departments and Alaska [including Hawaii, Panama Canal, Alaska, Puerto Rico, and Philippines], War Plans Course, Volume VII, 1939-1940.

Army War College Course Cross Reference Cards 1920-1940

These cards are a useful device for determining the topics and material included in the curricular files. Arranged by (1) Subject, (2) AWC Building and Personnel, (3) MID Publications, (4) Course Instruction, and (5) Name Cards, these files in themselves compose a basic research tool for understanding the philosophy, functions, and evolution of war college education in this period.

SECTION II

SELECTED TOPIC HEADINGS

Recounted below are samplings from the Army War College Course Cross Reference Cards 1920-1940 which suggest certain fruitful areas for further investigation. Not all-inclusive, this sampling is intended to be suggestive of the nature of topics covered in the curricular archives for this period. Spelling and sequence of entries reflect that which may be found on the collection file cards.

A

AVIATION AND AERONAUTICS

File card entries indicate major areas of concern in the War College curriculum including aerial navigation, aerodromes and air bases, the Aeronautical Board, Navy Bureau of Aeronautics, A.E.F. Air Service, Air Corps Materiel Division, air program, air raids, Douhet and air warfare, aircraft and aviation industry, and airways. Significant committee studies include: G-2 Course 1939, "Aviation Survey of Great Britain; France, Italy, Germany, Russia and Japan and Estimate for Determining U.S. Aviation Forces, January 27, 1937"; G-3 Course 1937, "Air Force Support for a Field Army," October 24, 1936; and Analytical Course 1939, "Means for Combat, German-American Operations During World War I, Russo-Polish Campaign of 1920, Recent Operations in China, Ethiopia, Contemporary U.S. Posture," February 23, 1939.

Various illustrative lectures include: Major General M. M. Patrick, "The Air Service," April 25, 1922; Major General B. D. Foullois, "Developments in Organization Armament and Equipment of the Air Corps," September 16, 1935; Brigadier General H. H. Arnold, "Development of the Employment of Air Corps Units as a result of the Experience of the First Wing," March 23, 1936; Major R. E. Rowell, U.S.M.C., "Experiences with the Air Service in Minor Warfare" [Nicaragua], January 12, 1929; and Lieutenant Colonel I. P. Swift, "Commercial Aeronautics as a Military Asset," April 7, 1930.

A third group of important material includes student research papers such as: Lieutenant Colonel V. E. Prichard, "War Reserves of Air Corps Bombs and Storage of Same at Air Base," December 9, 1939; Major G. H. Weems, "General Douhet's 'Air Warfare'; Its Application to the Employment of the U.S. Air Corps," May 25, 1934; and Lieutenant Colonel W. A. Capthorne, "Ability of the Airplane Industry to Meet the Losses of Airplanes in War," December 10, 1938.

Included in this bloc of material are materials relating to the British Commonwealth of Nations, British Expeditionary Force, Guiana, Honduras, British Isles, Malaysia, New Guinea, South Africa, and the British West Indies. These topics generally relate to strategic estimates, and various lectures and committee studies include: G-2 Course II, 1929, Committee 4, "Possible Alliances in War Against the United States, December 19, 1929"; Conduct of War Course 15, 1937, Committee 1, "Development Since 1914 of National Defense Organization of the British Commonwealth, France, Italy, Germany, Russia, Japan, and the United States," February 15, 1937; G-4 Course, 1923, Committee 1, "Plans, Lessons, and Principles Deducible from British Campaigns in Iberian and Crimean Peninsula, Sudan, South Africa, France, and Palestine," January 29, 1923; and Conduct of War Course 28, 2d Period, 1930, "The Operations of the British Expeditionary Force Prior to and including the Battle of the Marne in 1914," April 30, 1930.

COMMUNISM

Army War College students received exposure to this subject through lectures, committee studies and occasional student research projects examining various experiences in China, France, Germany, Latin America, Russia, and the United States. Examples include: G-2 Course 5, 1930, Lecture, S. K. Hornbeck, "Political and Economic Aspects of the Present

Situation in China," December 11, 1930; General Staff Memorandum, Major T. C. Spencer, "The Influence of Soviet Russia in Latin America and its Importance to the United States," April 7, 1930; G-2 Committee 4, 1930, Dr. D. O. Kinsman, "The Union of Soviet Republics in 1931," November 24, 1931; Conduct of War Course 18, 1936, Committee 8, "Internal Stability of Nations: Comparative Analysis of Revolutions - Russian 1917 and 1918, German 1918, Fascist Italy and Lessons Applicable to the United States," February 1, 1936, [n.b. a similar committee study in 1937 included the Paris Commune of 1871, the Spartacist movement of 1919 and the Kapp Putsch of 1920]; and G-2 Course 18, 1938, Committee 6, "Survey of the Union of Soviet Socialist Republics," January 27, 1938, [which included a treatment of action if Germany should invade Czechoslovakia and the outbreak of a Japanese-American conflict].

Of special interest are materials devoted strictly to the American situation. These include internal security problems, (Lecture, M. Woll, "Development of Russian Communistic Propaganda in the United States and its Effect upon Labor in this Country," October 18, 1932); infiltration of the American military establishment, (General Staff Memorandum, Major J. E. Sloan, "Action to Combat Spread of Subversive Doctrines in the Military Establishment," January 18, 1932); and general implications for the nation, (General Staff Memorandum, Major M. C. Handwerk, "Efforts of the Russian Government to Communize the United States," January 30, 1940).

PRINCIPLES OF WAR

The Command Course in 1921-1922 provided the base for seven student research projects related to the topic. Colonels G. T. Bowman and W. B. Wallace wrote on "The Causes of Napoleon's Downfall: The Principle of Objective: Did Wellington beat Napoleon by seizing and defending a morsel of Portugal." Colonel W. H. Harts and Colonel E. A. Sirmyer both addressed his work to "The Principle of the Objective as Illustrated by the Crimean War, 1853-56." Colonel L. B. Simonds examined "The Principles of War Illustrated by the Russo-Japanese War." Colonel G. F. Baltzell attacked the issue of "What Forced Germany to Make Peace? Illustrated by the Principles of War." Finally, Colonel H. S. Miller treated the issue of "Was it the Defeat of the German Main Army or the West Front or the Overthrow of the Turkish and Bulgarian Armies which brought about the Armistices."

WAR PLANS, ORANGE

A sizable body of material exists in course material files of the Army War College pertaining to a fundamental part of the curriculum--teaching of war planning. The types of material are well illustrated by a specific color plan, in the instance "Orange" for war against Japan, and include lectures, committee studies, and student memoranda. Representative illustrations of lectures include: Captain C. G. Day, USN, "Submarines, Their Use in a Campaign against Orange," November 4, 1921; and Miscellaneous Course 12, 1924, Lieutenant Colonel W. L. Goldsborough, "A Strategic Comparison of the Northern and Southern Routes (Basic War Plan, Orange)," June 12, 1924. Committee analyses are shown by G-3 Course 22 and 22A, 1928, Committee 7B, "Changes in the Organization and Equipment of the Army to Meet Requirements of War with Orange, in Philippine Territory or on Asiatic Mainland," October 6, 1928; and Courses 1, 2, 3, 1937, Committee 13, "Determination of Diplomatic and Economic Measures and Methods of Application Against Enemy Nations in a Blue-Green, Blue-Orange, or a Blue-Red War," January 26, 1937. YORKTOWN

The operations at Yorktown, Virginia, during the American Revolution and Civil War received some attention by War College classes in the Thirties. Major C. W.
