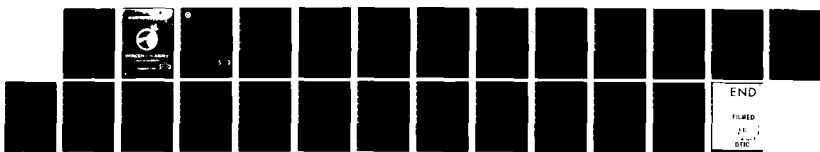

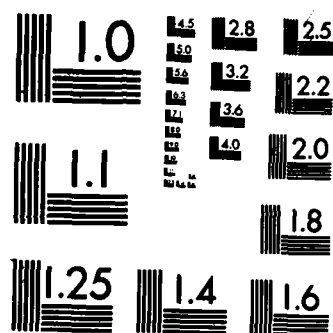

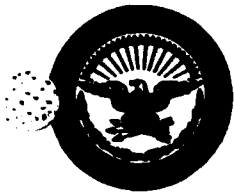

Since May 1981, the Women in the Army Policy Review Groups, ODCSPER-DA, has been involved in a far-reaching analysis of all statutes, policies, and regulations which govern the acquisition, training, assignment, utilization, and professional development of Army women (less female Medical Department Officers). From this review should come far better standards concerning the distribution and MOS training for both Army men and women, with gender-free MOS standards being a major goal of the group. While this is underway, the Army is holding the enlisted women strength at 65,000.
 2. Over the past 10 years, a vast body of literature has developed concerning women in the Army. To assist student researchers, the USAWC Library has developed a bibliography of readings concerning Army women. The list ~~does not pretend to~~ ^{is not} be comprehensive; it reflects only those resources readily available in the USAWC Library collection. For additional information, please contact the compiler, Mr Robert Wood, Reference Librarian, Services Branch, US Army War College Library.

(A history of female participation in the United States armed forces and a study of female occupational choice, both of which indicate factors for consideration in the procurement of women for the military.)

2. Batts, John H., et al. The Roles of Women in the Army and Their Impact on Military Operations and Organizations. Group Research Project. Carlisle Barracks: U.S. Army War College, 23 May 1975. (AD-A 016 998)

(The expanded use of women in the Army has focused attention on some difficult problems, but effective policies, expressed clearly down through the chain of command can help commanders deal with these problems.)

3. Berrong, Larry B. A Case for Women in Combat. Thesis. Fort Leavenworth: U.S. Army Command and General Staff College, 1977. (Microfiche DDC AD-A 043 084)

(The author argues that qualifications other than sex be used to determine assignments to combat and that women should have the prerogative to decide whether they want to serve in combat.)

4. Binkin, Martin. Women and the Military. Washington: Brookings Institution, 1977. (UB323 B57)

(While admitting that women are filling some military jobs, the author urges faster progress toward optimum utilization of women in the military.)

5. Castle, Michael J. The Role of Women in the Armed Services. Canberra, Australia: The Author, 1978. (UA565 W6C3)

(Castle stresses the armed forces should take a non-sexist approach in its continual search for skilled recruits and make full use of all available resources.)

6. Castle, Michael J. Women (and Men) in the U.S. Army: A Study in Optimal Utilization. Thesis. Monterey: U.S. Naval Postgraduate School, 1976. (V325 U5 Th C38)

(Examines the impact that the all-volunteer force, declining number of youths, and political pressures have on the need for women in the Army.)

7. Defense Advisory Committee on Women in the Services. Changing Roles of Women in the Armed Forces. Washington: 1977. (UA565 W6D41)

(Comprised of eight speeches given at the Spring 1977 meeting of DACOWITS.)
8. Defense Advisory Committee on Women in the Services. DACOWITS 1951 - 1976: Future Role for Women in the Armed Forces. Washington: 1976. (UA565 W6D4)

(Minutes of the meeting and 15 presentations from the 25th Anniversary Meeting of DACOWITS.)
9. Follett, George L. Lady Soldiers in the 1970's. Thesis. Carlisle Barracks: U.S. Army War College, 28 December 1974. (AD-A 009 916)

(Examines the status of the WAC enlisted personnel in the Army Reserve system with special emphasis on recruitment, training, and career management.)
10. General Research Corporation. Operations Analysis Division. An Analysis of Army Female Accessions. McLean, VA: 1974. (UA565 W6G45)

(This report analyzes prior service and non-prior service female enlistees with respect to education, race, term of enlistment, AFQT and age for FY 73 and FY 74.)
11. Goldich, Robert L. Women in the Armed Forces. Washington: Congressional Research Service, Library of Congress, 1980. (UB147 G65)
12. Hale, Pam. Women in the Military. Carlisle, PA: The Author, 1978. (UB147 H35)

(The military has changed, but then, so have women, and believing this, the author feels that the only way to learn the true value of women to the military is to provide opportunities and then evaluate performance, and on a far larger scale than is being done.)
13. Heslin, John G. Changing Patterns of the Military Institution. Newport: U.S. Naval War College, 1978. (UA23 H47)

(Provoking comments on the "civilization" of the Army, military unions, and the use of women in the military force.)
14. Hinton, Edith M. Utilization of WAC Personnel in TDA and TOE Units. Thesis. Carlisle Barracks: U.S. Army War College, February 1972. (AD 764 592)

(Considers the feasibility and desirability of changes to current policies pertaining to the utilization of WAC personnel.)

15. Involuntary Separation of Women for Pregnancy and Parenthood. Washington: n.p., 1978. (UB339 I 6)

(A collection of memoranda from the Army, Navy, Air Force, and Marine Corps on the subject of nonproductive time and lost duty time for men and women.)
16. Leepson, Marc. Women and the Military. Washington: Congressional Quarterly, Inc., 1981. (H35 E3 1981 vol. 2 no.1)

(Surveys trends in recruitment of women by the military and looks at the "pause" in female recruitment being pushed by the Reagan Administration.)
17. Maxwell, Jock C. Who...Me. The Role of the Female in Today's Army Reserve under the Civilian Acquired Skills Program. Thesis. Carlisle Barracks: U.S. Army War College, 18 October 1974. (AD-A 003 131)

(Focuses on a program designed to "utilize effectively in the Army Reserve, the vast reservoir of talent represented by women in our society.")
18. McClanahan, Donald D. Women in the Reserve Components: What Are the Real Limits? Thesis. Carlisle Barracks: U.S. Army War College, June 1975. (AD-A 030 434)

(Are women in the reserve components a mobilization asset or liability in view of the vital role assigned to the Reserves? Answers are provided from historical, legal, physiological, and sociological viewpoints.)
19. Mohr, E. Sue, et al. Women and ROTC Summer Camp. Alexandria, VA: U.S. Army Research Institute for the Behavioral and Social Sciences, 1978. (U428.5 W59)
20. Nelson, Robert L. Employment and Utilization of Women in the Army. Washington: U.S. Government Printing Office, 1977. (UA23 A51 1977 N45)
21. Riolo, Augustine G. Women in the Army. Thesis. Fort Leavenworth: U.S. Army Command and General Staff College, 1980. (U415 A4 TH R56)

(This study examines the historical background, present situation, and future indicators of the role women play in the Army.)
22. Rogan, Helen. Mixed Company: Women in the Modern Army. New York: Putnam, 1981. (UB418 W65R63)

(Answers the question of whether women can be good soldiers from the viewpoint of the women soldiers themselves.)

23. Ruff, Edwin. Assignment of Women to Military Police Units in the Corps Battle Area. Thesis. Fort Leavenworth: U.S. Army Command and General Staff College, 1980. (Microfiche DDC AD-A 043 751)

(A study which includes recommendations on which M.P. units and which M.P. functions in the corps battle area are appropriate for women soldiers.)

24. Savell, Joel M., et al. Male and Female Soldiers' Belief About the Appropriateness of Certain Jobs for Women in the Army. Alexandria, VA: U.S. Army Research Institute for the Behavioral and Social Sciences, 1979. (UB147 S3411)

(Reflects the extent to which soldiers in 1974 believed certain jobs were appropriate for women and the extent to which these beliefs were related to selected personnel characteristics of the respondents.)

25. Spencer, Dorothy E. Toward the Army of the 1980s: A Study of Male Attitudes Toward Women as Combatants. Thesis. Fort Leavenworth: U.S. Army Command and General Staff College, 1978. (U415 A4 TH S653)

(This study examines the relationships between traditional and contemporary ways of thinking as reflected in the answers to questions submitted to students at the USACGSC on the subject of using women in combat.)

26. Thomas, Patricia J. Role of Women in the Military: Australia, Canada, the United Kingdom, and the United States. Special Report 78-10. San Diego: U.S. Navy Personnel Research and Development Center, 1978. (Microfiche DDC AD-A 055 044)

(A review of research conducted in four English-speaking countries concerning women in their own armed forces. Topics emphasized were enlistment and retention, assignments, inter-personal factors, and utilization.)

27. Thomas, Patricia J. Utilization of Enlisted Women in the Military. San Diego: U.S. Navy Personnel Research and Development Center, 1976. (UA565 W6T45)

(Author presents the view that until the laws and regulations preventing full utilization of female personnel are repealed or reinterpreted, military women will experience a dissonance between their expectations and experiences.)

28. United States Army Administration Center. Evaluation of Women in the Army: Final Report. Fort Benjamin Harrison: 1978. (UA565 W6U51)

(Analyze all officer specialties closed to women and attempts to determine which ones could be opened and the impact of such utilization.)

29. United States Army Command and General Staff College. Women in the Army. Fort Leavenworth: 1978. (U415 A41 RB 20.2)

(A reference book assembled to provide commanders with a concise guide to pertinent regulations affecting their woman soldiers.)

30. United States Army Research Institute for the Behavioral and Social Sciences. Women Content in Units Force Development Test: (MAX WAC). Arlington, VA: 1977. (UA565 W6A42)

(Provides insight in evaluating the impact of assigning women to selected Army units.)

31. United States Assistant Secretary of Defense (Manpower and Reserve Affairs), Central All-Volunteer Force Task Force. Utilization of Military Women. Washington: 1972. (UA565 W6U53)

32. United States Assistant Secretary of Defense (Manpower, Reserve Affairs, and Logistics). Use of Women in the Military. Washington: 1978. (UA565 W6A45)

(Evaluates the current use of enlisted women serving on active duty in the military and estimates the number of women needed in the future.)

33. United States Assistant Secretary of Defense (Manpower, Reserve Affairs, and Logistics). Women in the Military Background Review. Washington: 1981.

(A review of the armed services female officer and enlisted accession and retention policies in use for the last ten years. Also contains study of the utilization of women by the services.)

34. United States Navy Personnel Research and Development Center. Intentions of Women 18-25 Years Old to Join the Military: Results of a National Survey. San Diego: 1978. (UB323 U54)

35. Women Content in the Army - Reforger 77. Alexandria, VA: U.S. Army Research Institute for the Behavioral Sciences, 1978. (Microfiche DDC AD-A 055 960)

(Support units on both sides of Reforger 77 contained 10% women soldiers, whose performance was analyzed in comparison with their male counterparts. The study concluded that a 10% mix produced negligible deficiencies; mixed units performed as well as all-male units.)

36. Women in the Army - Reserve Components (WITA-RC) Review Group. The Final Report of the Women in the Army, Reserve Components Review Group. Washington: U.S. Department of the Army, Office of the Deputy Chief of Staff for Personnel, 1978. (UA565 W6W61)

(Reviews Army programs and policies as they apply to women in the Reserve Components; 27 separate areas are discussed.)

37. Women in the Army Study Group. The Final Report of the Women in the Army Study Group. Washington: U.S. Department of the Army, Office of the Deputy Chief of Staff for Personnel, 1976. (UA565 W6W6)

(Discusses current and planned policy on the utilization of women in the Army. Recommendations touch on 11 different areas.)

(Research study of selected West Point plebes, which attempts to answer how women can contribute best as military leaders.)

(The author feels that an army of a truly democratic society has no recourse but to put its women in combat.)

3. Adams, Virginia. "Jane Crow in the Army: Obstacles to Sexual Integration." Psychology Today, Vol. 14, October 1980, pp. 50-64.

(Sexual tension still exists in the Army, caused by frequent pregnancies, discrepancies in strength, and male prejudice.)

4. Bailey, Mildred. "Army Women and a Decade of Progress." Army, Vol. 24, October 1974, pp. 85-91.

(Details the significant progress made by the WAC over the last 10 years and suggests what lies ahead for the corps.)

5. "Battle in the Pentagon." Time, Vol. 116, 29 September 1980, pp. 28.

(Many top Army generals privately oppose the all-volunteer army and also Secretary of the Army Alexander's use of women in that force.)

6. Beck, B.G. "Women as Warriors." Army, Vol. 31, February 1981, pp. 26-31.

(The author found that the male-female ratio of soldiers within Army units does not make a difference in the military effectiveness of those units.)

7. Blumenson, Martin. "Women in the Army: An Update." Army, Vol. 29, May 1979, pp. 38-42.

(Committed to doubling the number of women in its ranks, the U.S. Army must now wrestle with several resultant problems, not the least of which, is how to entice women to volunteer for the jobs most beneficial to the services.)

8. Burke, Yvonne. "Let's Play Taps for an All-Male Army." Saturday Evening Post, Vol. 249, October 1977, pp. 12-13, 84.

(The author proposes a universal national service for both men and women, which would include, but not be limited to, military service.)

9. Cavanaugh, Charles. "The Lady and the Lanyard (WAC Artilleryman)." Soldiers, Vol. 28, January 1973, pp. 38-39.

(Profiles Captain Roberta Jordan, first woman to attend the field artillery school for officers at Fort Sill, Oklahoma.)
10. Chaze, William. "Academy Women: Ready to Take Command." U.S. News & World Report, Vol. 88, 26 May 1980, pp. 32-36.

(Discussion of women attending the service academies.)
11. Cheney, Susan. "Women where?" Air Defense, January-March 1979, pp. 15-17.

(New assignments for women will have an impact on Air Defense Artillery Units. With cooperation, this experiment in integration can benefit everyone.)
12. Coe, Gary. "A Cost-Effective Enlistment Supply of Women for the Army." Defense Management Journal, Vol. 15, January 1979, pp. 30-36.

(A look at how the Army is managing the problem of a declining manpower pool.)

(Examples of fraternization and the consequences involved for the Army and the individuals.)

(Special report on women in combat and on the expanded role they play in other areas.)

(Results of an Aviation Center study which analyzed school performance of 29 women aviators. Comparison was also made to the performance levels of male aviators in the same environment.)

(Women juggling two careers- as soldiers and as mothers.)

(Women students at the 3rd Army's drill sergeant's school.)

(WACs performed so well in M-16 marksmanship training at Fort Jackson, South Carolina that the program is now the same for both male soldiers and WACs.)
