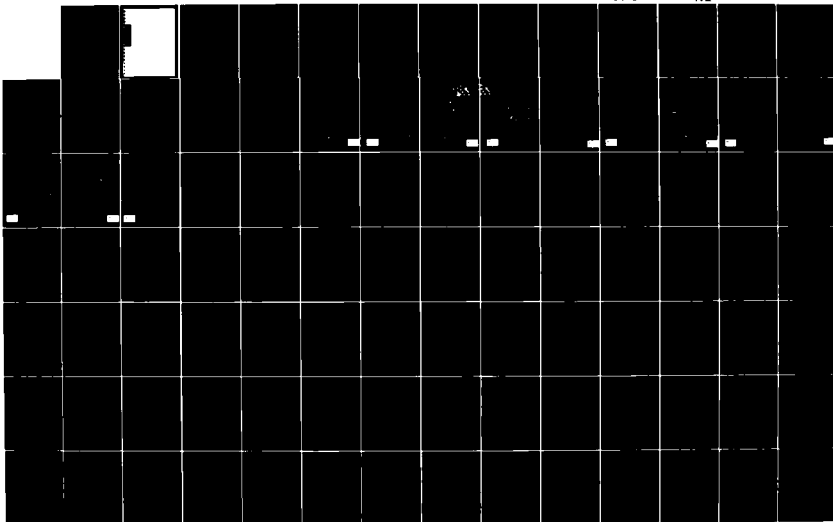

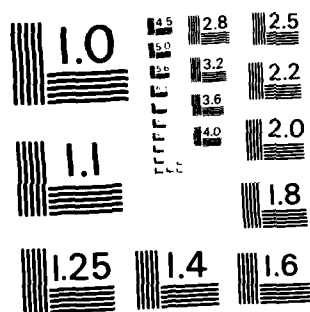

ABSTRACT (Continue on reverse side if necessary and identify by block number) This literature search and records review of the Upper Mississippi River Basin (River Mile 857.6, above St. Anthony Falls, Minneapolis, St. Paul, Minnesota to Lock & Dam #10, (Guttenberg, Iowa) was authorized by the St. Paul District Corps of Engineers as part of its master plan for the 9-foot navigation project. The objectives of the investigation were to: 1. conduct a comprehensive review of existing records and review published and unpublished literature; 2. provide an evaluation of recorded cultural resources; and 3. prepare a detailed

technical and popular report.

Site specific information was compiled for both historic and prehistoric sites from state agencies in Iowa, Minnesota and Wisconsin, and from various local and regional institutions. More than 1,000 historically or architecturally significant sites and districts and, more than 1,400 prehistoric archaeological components were recorded and plotted on base maps. From the site configurations and from other data collected during the course of the records and literature review, a narrative framework for the interpretation of historic and prehistoric sites was developed. Recommendations to enhance the management of the archaeological and historical data base were provided.

Within the study area of Pool 3, 35 properties are considered to possess historic or architectural merit. Of these, two are identified as districts, the East Second Street Commercial District and the West Second Street Residential District, both in Hastings, Minnesota. Sixty-seven archaeological sites were encountered in the study area during the course of archive and literature investigations.

INTRODUCTION:

Archives and literature search has resulted in the identification of 35 properties that are considered to possess historic or architectural merit. Of these 35, 13 properties have been nominated, determined eligible, and placed upon The National Register of Historic Places. Two of the 12 properties are identified as districts, the East Second Street Commercial District and the West Second Street Residential District, both in Hastings, Minnesota. In addition to identification of the districts, individual structures are listed in the tabulations. Figures 1 through 6 present locations of National Register properties, Historic Districts, and sites noted for their architectural and/or historical significance.

Sixty-seven archaeological sites were encountered in the study area during the course of archive and literature investigations. Figures 7 through 12 provide locations for these sites. Identified components are listed in Table 1, and the additional detailed information is provided on the site tabulation forms. It should be noted that site distributions are not based on comprehensive systematic survey and thus should not be used for predictive statements. Finally, sites categorized as ineligible unless specifically noted, means simply that they have not been evaluated in terms of National Register criteria.

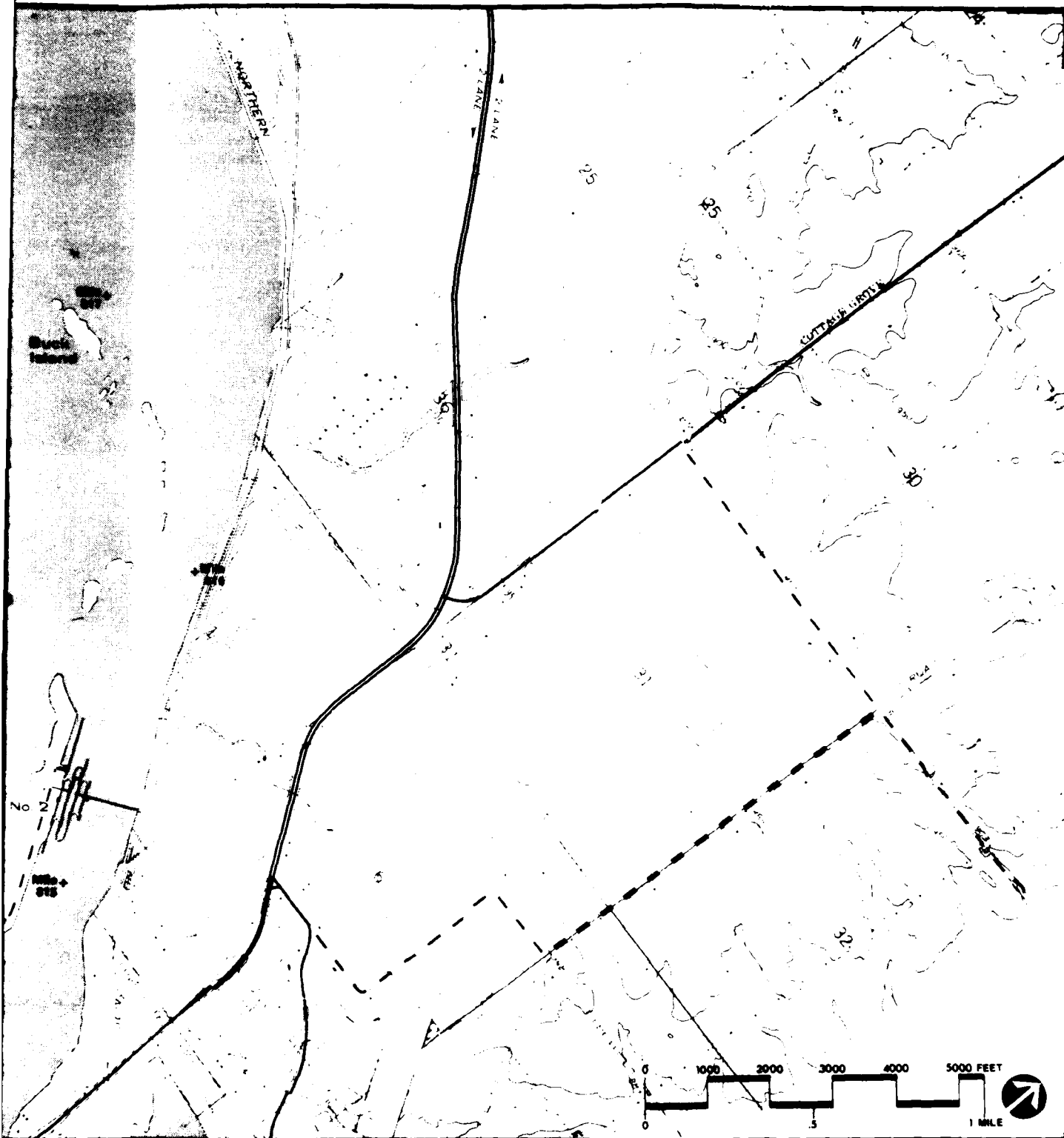

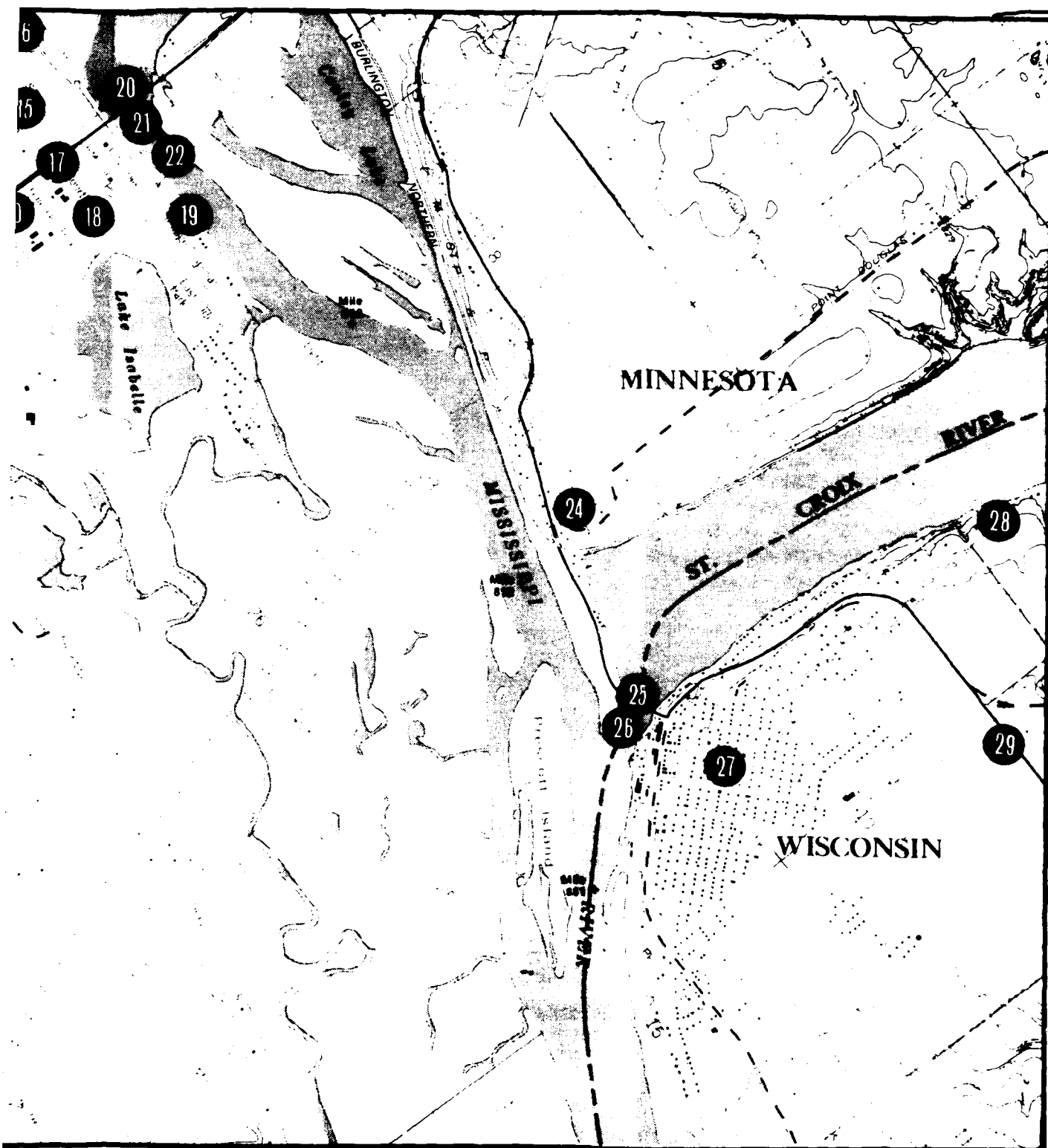

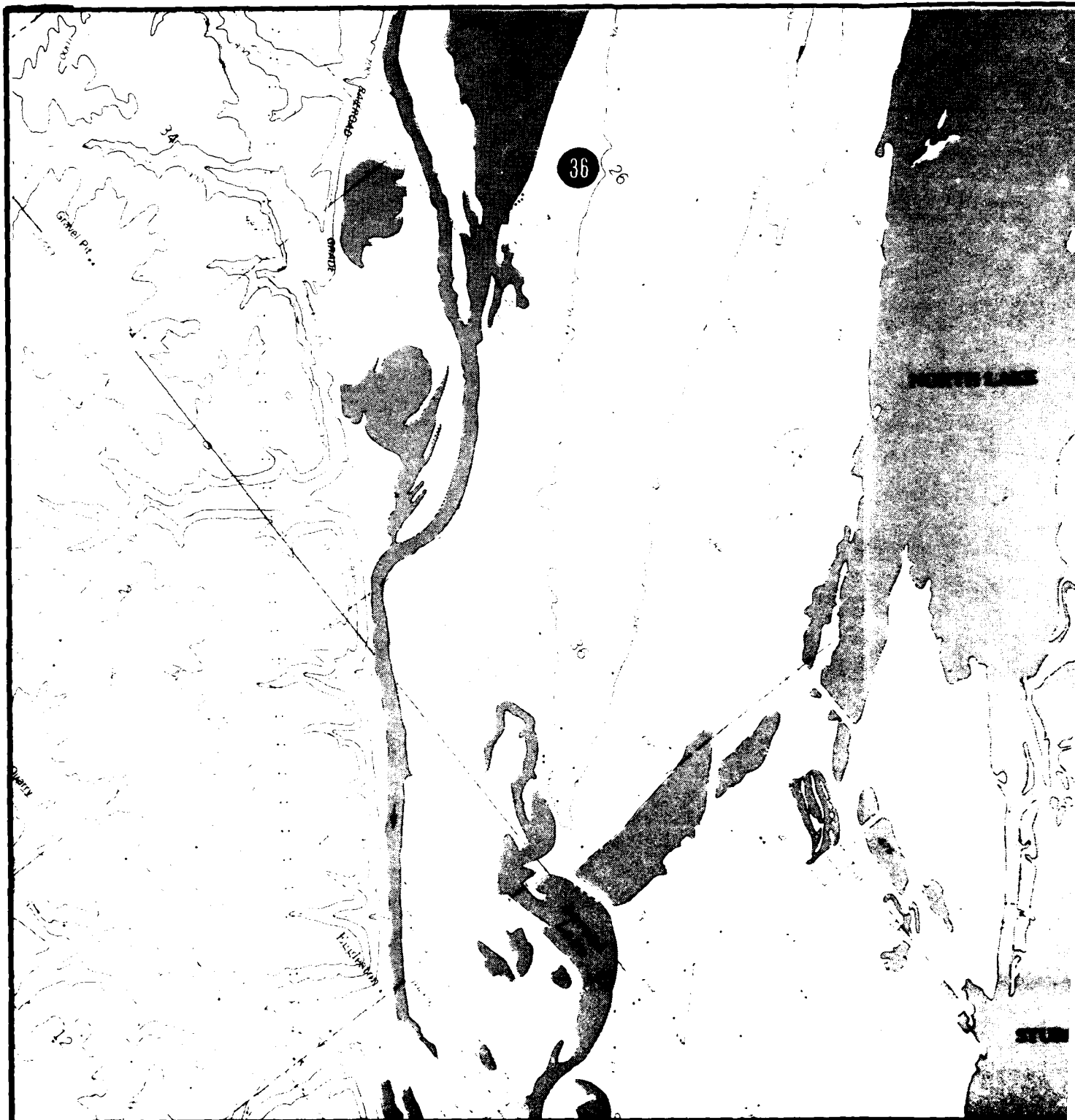
