OTEA Confirmed with ACSI that the armored threat from 1986-1992 is a T-80 and the surrogate should possess a IR night sight capability. Also the thermal tank sight is necessary to determine vulnerability of AHIP due to possible thermal emissions from the mast-mounted sight or other equipment. If M60A3 or M1 tanks are not used, there would exist a serious test limitation.

DCSOPS Recognizes the need for the M60A3s. Other units are to receive M60A3s during this period.

OTEA Resolved that TRADOC in coordination with FORSCOM would evaluate the impact of M60A3 use on the 197th and 194th training Bdes. FORSCOM to impact use of M-1 tanks from Ft Hood; M60A3s from NTC/Cohort units. DCSOPS to evaluate the possible diversion of M60A3s in the fielding plan. Suspense for 15 Jul 83. OTEA to coordinate all responses and prepare a issue paper to the VCSA through DCSOPS if TSARC is unable to resolve issue.

GO ISSUE: FORSCOM unable to provide the 95 man security force for Ft Hunter-Liggett security. Consideration to be given to contracting for this security.

OTEA: TRADOC was tasked to research the legalities of posting notices and employing media awareness as a means to reduce the security requirement. TRADOC/CDEC to continue to define civilian security contract data and incorporate the posting alternative into the security personnel plans. TRADOC solutions to this issue will be presented NLT the Sep 83 TRADOC TSARC. FORSCOM is relieved from providing the 95 man physical and range security force.
