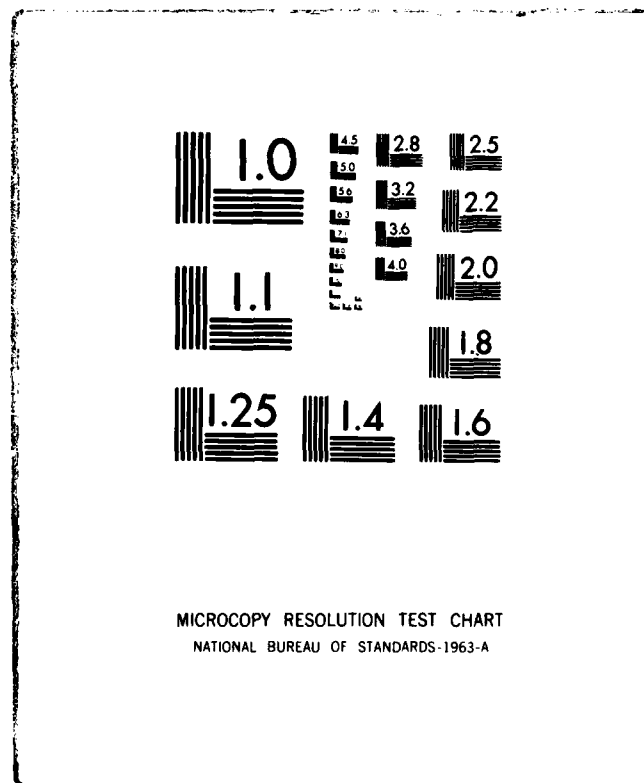

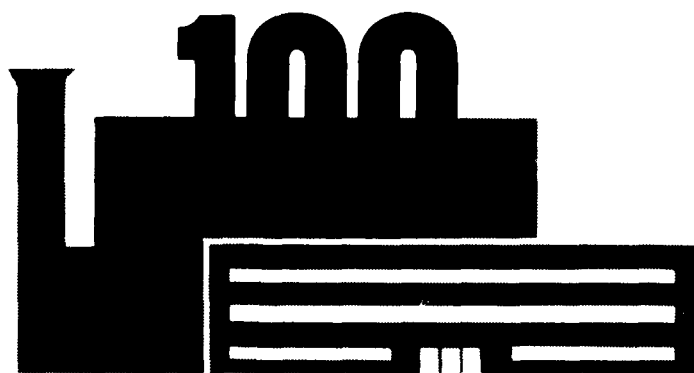

*100 Companies Receiving the Largest Dollar Volume of Prime Contract Awards* is published annually. This report contains summary data on the 100 companies including their subsidiaries, which were awarded the largest total dollar volume of Department of Defense prime contract awards during Fiscal Year 1984.

## INTRODUCTION

This report presents summary data on the 100 companies that received the largest dollar volume of Department of Defense (DoD) prime contract awards during fiscal year (FY) 1984. Table 1, page 7 lists the companies in alphabetical order and gives their associated rank. Table 2 identifies the parent company only, but the total dollars reflect awards made to the parent company and all its subsidiaries. In some cases the parent company receives no awards itself but appears on the list because of its subsidiaries. Table 2 also shows what percent of the total awards each company's awards represent as well as the cumulative percent represented by all companies.

## NOTES ON COVERAGE

Data in this report reflect the net value of both debit and credit procurement actions over \$25,000; e.g. the value of a terminated contract or other downward adjustment to a contract is deducted from a firm's total award amount, while modifications and other positive adjustments are treated as increases. Procurement actions include definitive contracts, the obligated portions of letter contracts, job orders, task orders, delivery orders, and any other orders against existing contracts. Research and development, services, construction, and supply and equipment contracts, worldwide, are included.

The report does not include those parts of indefinite quantity contracts that have not been translated into specific orders to business firms, or those contracts that have not yet become mutually binding agreements between the government and the company. The company totals do not include contracts made by other U.S. Government agencies and financed with Department of Defense funds or contracts awarded in foreign nations through their respective governments.

## HIGHLIGHTS OF FY 1984 DATA

Department of Defense prime contract awards over \$25,000 totaled \$133.6 billion during FY 1984, \$5.4 billion more than in FY 1983. The 100 firms and their subsidiaries receiving the largest amount of DoD contracts in FY 1984 received \$92.3 billion or 69.1 percent of this amount, primarily for aircraft, missile/space systems, ships, and electronics & communications equipment. In FY 1983 the top 100 companies received \$89.6 billion or 69.9 percent of all awards.

Table A below shows that the first five companies received 22.0 percent of the total received by all companies in FY 1984, compared with 20.6 percent during FY 1983. The company ranked as number one during FY 1984, McDonnell Douglas Corporation, ranked as number two last year, with awards of \$7.7 billion during FY 1984 as compared to \$6.1 billion last year. The smallest total amount received by a company in the FY 1984 list was \$142 million, compared with \$126 million in FY 1983.

## Changes in the Top 100 Companies, FY 1983 To FY 1984

Fourteen companies who did not appear on the list last year are among the top 100 companies this year. (See Table B below.) Of these, one appears in position 37, and the balance between positions 52 and 100. The fourteen companies who appeared on the FY 1983 list who do not appear on this year's list are also shown in Table B. Of the 84 companies appearing on the list in both Fiscal Years 1983 and 1984, 45 advanced their position, 33 are in a lower position, and 6 showed no change. Companies are considered as appearing on the list in both years despite mergers, acquisitions, divestitures, and name changes if a major component of a newly constituted company or the newly constituted company itself made the list as a component of a company in the top 100 in the prior year.

## Primary Procurement Categories of the Top 100 Companies

Although the contract work of many companies on the list includes more than one procurement category, each company has been assigned in Table C (below) to the procurement category that accounts for its largest dollar volume of DOD awards; for example, General Electric Co. is a multi-industry company producing electronic and communications equipment and industrial and consumer products. For this table, it has been assigned to "Aircraft", the procurement category accounting for its largest dollar volume of DOD contract awards.
