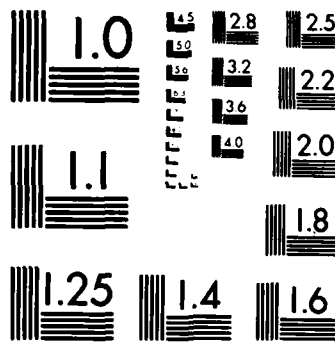

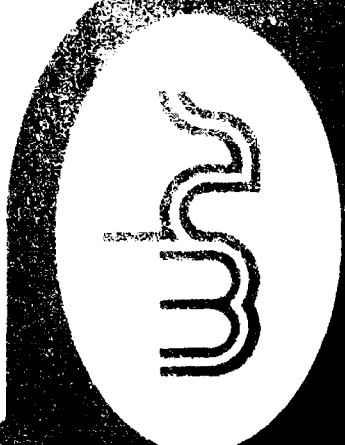
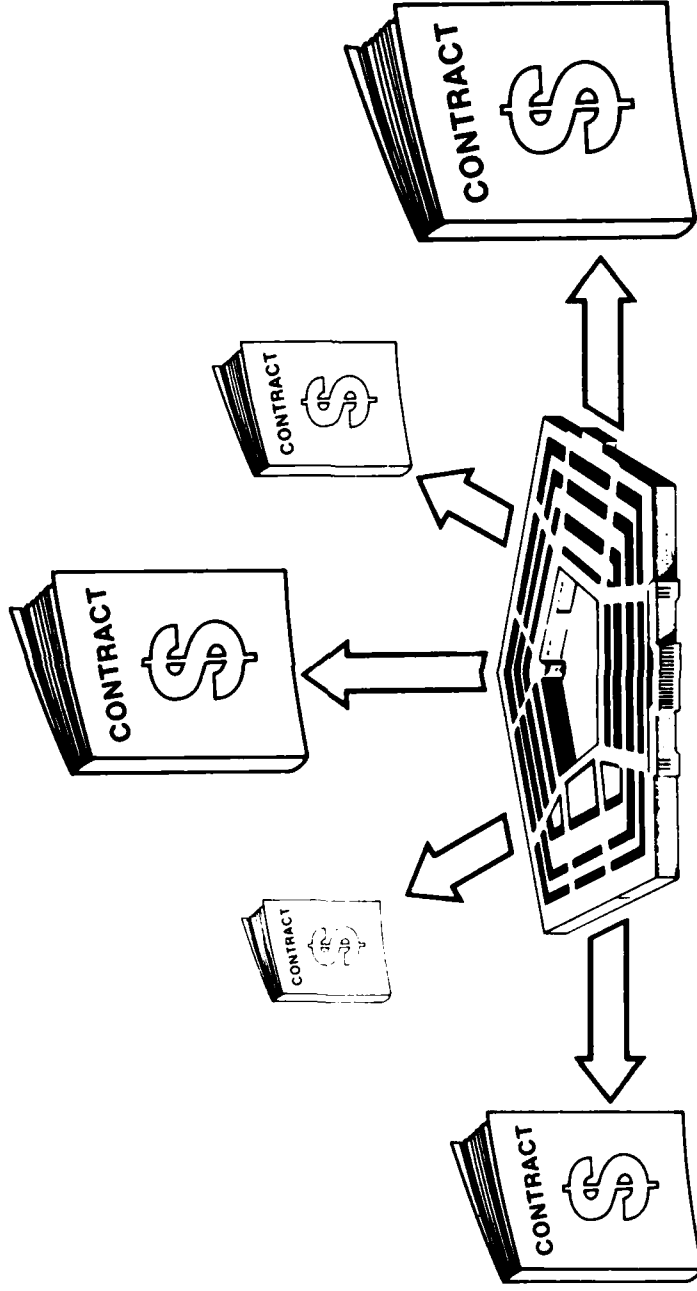

INTRODUCTION

This report provides data on prime contract actions (PCA's) over \$10,000 awarded by the Department of Defense (DOD) in Fiscal Year (FY) 1982. For reporting purposes, contracts have been distributed by dollar value into 11 different size categories. The tables provide information on the number of total actions, their net value, and their percent distribution, by size and according to a variety of categories, including awarding agency, type of contract involved, type of contract action taken, and competitive status. Table 1 presents data by individual size category (e.g., \$10,000 to \$24,000; \$25,000 to \$49,000), while Tables 2 through 5 present data in cumulative categories (e.g., \$10,000 or more; \$25,000 or more).

The information in *Prime Contract Awards, Size Distribution*, assists DOD management in projecting the workload that will be required by various proposed projects. For example, using data in this publication, DOD officials could determine that a proposal to review all contract actions of \$500,000 or more in FY 1982 would require examining approximately 20,800 transactions. These data can also be used to identify trends in DOD procurement, e.g., to identify which one of the various types of contracts was most frequently awarded (in terms of number of contract actions) during FY 1982.

NOTES ON COVERAGE

Contract actions of \$10,000 or less are not included in this report. Information on the types of contracts or kind of action is not compiled on these purchases. Intragovernmental actions of \$10,000 or more (those actions placed by DOD with other Federal agencies) are also excluded from this report, as

are foreign military sales (FMS) actions (actions placed by DOD in support of foreign governments).

The data here represent new definitive awards as well as other types of transactions, including initial letter contracts, definitization of letter contracts, orders under contracts, funding actions, engineering changes, and terminations. Terminations and the downward adjustments of contracts are included in the award category to which their dollar amount corresponds. Both types are considered positive entries when calculating the total number of contract actions but negative entries when calculating total net value.

Each transaction is rounded to the nearest thousand before being assigned to an award category, e.g., a transaction of \$24,499 is rounded down to \$24,000, while a transaction of \$24,500 is rounded up to \$25,000. Due to this rounding process, totals may not add up.

HIGHLIGHTS OF FY 1982 DATA

As indicated above, data in this report exclude all actions of \$10,000 or less as well as those intragovernmental and FMS actions of more than \$10,000. All DOD prime contract awards (over and under \$10,000) in FY 1982 totaled \$124,725 million. This is an increase of \$19,502 million or 18.5 percent over FY 1981. These FY 1982 awards comprised a total of 12,962,728 actions, which is an increase of 216,775 actions or 2 percent over the FY 1981 figure.

As shown in the following table, this report covers 84 percent of the procurement dollars and 3 percent of the actions awarded in FY 1982.

Prime Contract Awards by Awarding Department

Tables 1 and 2 provide data on PCA's by size range (individual ranges in Table 1, cumulative ranges in Table 2) according to awarding department. Contract actions of from \$10,000 to \$49,000 accounted for 64.7 percent of the total number of actions but only 4.7 percent of the total dollars. Conversely, actions of \$1 million or more represented 76.3 percent of the total dollars but only 3.2 percent of the actions. Actions of \$10 million or more accounted for 51.8 percent of the total dollars but only 0.4 percent of the actions. As shown in the following table, these data do not differ greatly from those for FY 1981.

As shown in Table 2, actions of \$1 million or more accounted for 75.2 percent of the total Army procurement dollars, as compared with 79.1 percent for the Navy, 75.9 percent for the Air Force, 76.0 percent for the Defense Logistics Agency (DLA), and 58.4 percent for Civil Functions.

Prime Contract Awards by Type of Contract

As discussed above, data presented in this report have a variety of management uses. Data on the distribution of contracts by type of contract (e.g., firm-fixed price, fixed price incentive, or cost-plus-fixed-fee) are also used for analyzing DOD procurement patterns. Table 3 provides data on the net value and percent distribution of seven different types of con-

tract actions. As shown in this table, actions of \$1 million or more accounted for 95.8 percent of the cost-plus incentive fee dollars, 96.3 percent of the dollars awarded on fixed-price incentive contracts, 91.5 percent of the cost-plus award fee dollars, and from 59.6 to 77.8 percent of the dollars for the remaining types of contracts.

As shown below, firm fixed-price/fixed-price escalation contracts accounted for the highest percentage of actions, both in terms of the number of actions and total net value. Cost-plus-fixed-fee contracts represented the second largest category in terms of number of actions, while fixed-price incentive contracts accounted for the second largest grouping of contracts according to total net value.

Prime Contract Awards by Competitive Status

Table 4 displays information on the net value and percent distribution of PCA's according to competitive status.

Negotiated non-competitive contract actions accounted for 54 percent of all actions and 68 percent of the dollars in the competitive base. Negotiated price-competitive actions made up 36 percent of all actions and 24 percent of the dollars in the competitive base. Formally advertised contract actions accounted for the remaining 10 percent of the actions and 8 percent of the dollars. (These percentages were all computed based on the Total Competitive Base.)

As shown in Table 4, actions of \$1 million or more made up 81.5 percent of the dollars awarded for negotiated non-competitive contract actions, 70.8 percent of the negotiated price-competitive dollars, and 67.1 percent of the formally advertised contract dollars.

Prime Contract Awards by Kind of Action

PCA's are arrayed according to kind of procurement action (initial letter contract, definitive contract, change order, etc.) in Table 5. As shown in this table, actions of \$1 million or more accounted for 99.2 percent of the dollars awarded for definitive contracts which superseded letter contracts, 96.8 percent of the initial letter contract dollars, and from 52.7 to 87.1 percent of the dollars for the remaining kinds of procurement actions.

Contract actions other than modifications accounted for 78 percent of all actions and 62 percent of the dollars. Modifications to contracts accounted for 22 percent of the actions and 38 percent of the dollars. The distribution within these two categories is shown in the table below.
