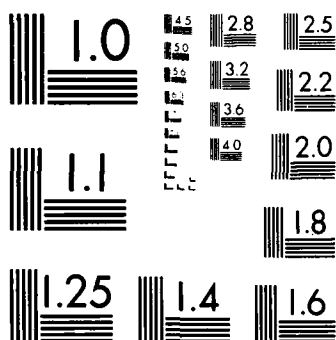

FOREWORD

The Directorate for Information Operations and Reports maintains the Defense Acquisition Management Data System which is developed from data submitted by components of the Department of Defense (DoD) on all contract transactions over \$10,000. These data are available on computer listings which have been sorted either by contractor name (alphabetical) or place of performance (geographic). The column headings are identified in this manual by letters of the alphabet. The corresponding heading on the printout is repeated for the number of positions in the field. (Column heading D is a four-position field and appears on printout as DDDD.)

This manual is intended to assist the user of these computer listings to understand the range of data presented. It is not the final source for all possible codes used in these listings. Where possible, the codes and their meanings have been displayed. For the remaining codes, it may be helpful to refer to the DoD Procurement Coding Manual (4105.61M), Volumes I and III, as well as Appendix N of the Defense Acquisition Regulation (DAR).

Page ii of this manual contains a summarization of the data elements shown in the detailed listing. Note that the first line of each segment of data identifies the contractor and the place of performance, as well as their respective codes. The identification on Line 2 applies to each award made to the contractor shown in Line 1.
