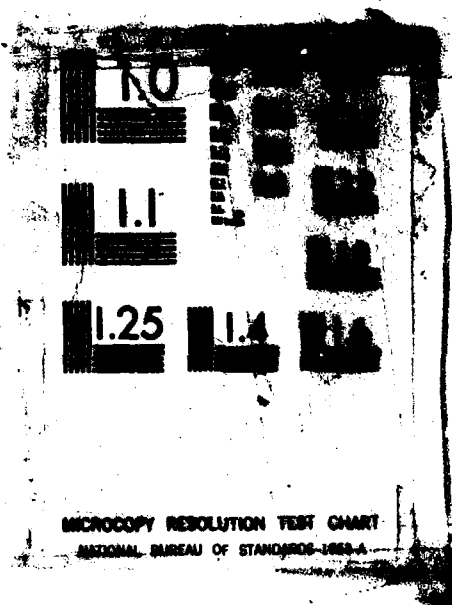

This monthly publication of the General Services Administration (GSA) is issued pursuant to Policy Letter 82-1, dated June 24, 1982, of the Office of Federal Procurement Policy (OFPP). This publication provides a single comprehensive listing of business firms and individuals debarred, suspended, or otherwise excluded by Government agencies from receiving Federal contracts.

An important feature of the OFPP Policy Letter is that "administrative" debarments or suspension actions effected after August 30, 1982, in accordance with the new policy, will have Government-wide application. This publication will keep agencies abreast of these significant actions and the many "statutory" debarment and suspension actions taken throughout the Government.

Contracting is an important, highly visible function of the Federal Government. The information that Federal agencies share through this publication should help to ensure that the Government contracts only with responsible firms and individuals. Therefore, contracting officials of all agencies are urged to carefully examine this publication and rigorously adhere to its instructions. As guardians of the taxpayer and the public trust, all Federal agencies have an obligation to ensure the integrity of the contracting process.

Consolidated List of Debarred, Suspended, and Ineligible Contractors

The Consolidated List of Debarred, Suspended, and Ineligible Contractors is a comprehensive listing of business concerns and individuals excluded from receiving Federal contracts. It is maintained by the General Services Administration (GSA) and published monthly for the use of Federal agencies. The List is issued pursuant to the Office of Federal Procurement Policy's Policy Letter 82-1. Additional information concerning the List is available in Federal Acquisition Regulation 9.4.

The List supersedes the consolidated lists of administrative debarments previously published by GSA and the Department of Defense (DOD). Individual agency lists of debarred, suspended, and ineligible contractors, formerly required by the Federal Procurement Regulations, are no longer necessary.

Purpose of the List

The first function of the List is to notify Federal agency contracting officials of those contractors which are barred governmentwide from participating in Federal contracting programs. Such exclusions may be based on the administrative debarment or suspension of a contractor by any agency on or after August 30, 1982, in accordance with OFPP Policy Letter 82-1, or on a similar action by an agency on the authority provided by statute or executive order.

Second, the List circulates information concerning those contractors administratively debarred or suspended by agencies before August 30, 1982. Generally, these exclusions apply only to the contracting programs of the agency which took the action. However, DOD contracting officials are subject to the special rules of Public Law 97-86, section 914 (See For DOD Users at Code A under the heading "Cause and Treatment Codes.")

The specific treatment to be accorded listed contractors may differ depending on the type of exclusionary action and the authority under which it is taken. The basis for the listings and the effect of the exclusionary actions are described under the heading "Cause and Treatment Codes."

How To Obtain Copies

Federal agencies may purchase their annual List requirements in bulk from the U.S. Government Printing Office at cost and provide for their internal

distribution. Specific instructions concerning List subscriptions have been given to each agency's designated procurement executive.

Other parties interested in obtaining subscriptions to the List should contact the Superintendent of Documents, U.S. Government Printing Office, Washington, DC 20402. The commercial telephone number is (202) 783-3238; the Federal Telecommunications System (FTS) number is 783-3238.

How To Use the List

In the interest of reducing paperwork and printing costs, the List is presented in a concise format with the names of debarred, suspended, and ineligible contractors listed alphabetically in main and cross-reference entries. An initial asterisk indicates an action without governmentwide effect. New additions for the month will be highlighted by the symbol ■.

In a cross-reference, the name under which the entry is listed is in lighter type followed by the name, in **boldface**, under which the main entry is indexed. Generally all information on the contractor, the action, and the term of action is shown in the main entry; except when the address, termination date, or Dun and Bradstreet's D-U-N-S number is different from the main entry.

In a main entry, the initial name is in **boldface** and is followed by:

- An address.
- An alphabetical listing, in italics, of other contractors involved in the action.
- A code letter indicating the cause of the action and the treatment to be accorded the listed contractors.
- The abbreviated name of the agency or other authority imposing the action.
- The termination date of the action, in **boldface**.
- Dun and Bradstreet's D-U-N-S number.

Information is in the same order in each entry. However, some entries may be incomplete, particularly where the exclusionary action was taken prior to the OFPP Policy Letter and only limited information was provided to GSA. For additional facts, contact the agency taking the action.

Cause and treatment codes are explained under the heading "Cause and Treatment Codes" on page 4.

Agency contacts are listed under the heading "For Additional Information."

For Additional Information

Details concerning the debarment, suspension, or determination of ineligibility of contractors can be obtained by telephone from the persons noted below for each agency. All telephone numbers are in area code 202, but Federal officials calling long distance should use the FTS (Federal Telecommunications System) or AUTOVON (Automatic Voice Network). Cause and Treatment Codes:

A. Cause: Debarment by an agency pursuant to FAR 9.406-2 for one or more of the following causes: (a) conviction of or civil judgment for fraud, violation of antitrust laws, embezzlement, theft, forgery, bribery, false statements, or other offense indicating lack of business integrity; (b) violation of the terms of a Government contract, such as a willful failure to perform in accordance with its terms or a history of failure to perform; or (c) any other cause of a serious and compelling nature affecting responsibility.

Treatment: Contractors are excluded from receiving contracts, and agencies shall not solicit offers from, award contracts to, renew or otherwise extend the duration of current contracts, or consent to subcontracts with these contractors, unless the acquiring agency's head or a designee determines that there is a compelling reason for such action. Debarments are for a specified term as determined by the debarring agency and as indicated in the listing.

Note: Debarments and suspensions effected after August 30, 1982, in accordance with the policies and procedures set forth in OFPP Policy Letter 82-1, are effective throughout the Executive Branch. Debarments and suspensions effected prior to that date are listed with an asterisk appearing before the listed party's name and are generally effective only in the agency which took the action. Such listings are for information purposes only, but should be considered by contracting officials as reflecting acts or circumstances which may have a bearing on the contractor's responsibility, and which may serve as a basis for debarment or suspension of the contractor by another agency.

For DOD Users: Debarment and suspension actions by any DOD component (e.g., DLA, Army, Navy, Air Force) are effective throughout DOD whether or not preceded by an asterisk. Special rules govern whether non-DOD debarments or suspensions (Codes A or B) are effective within DOD: debarments and suspensions imposed after November 30, 1981, by non-DOD agencies are effective within DOD, while those imposed on or before that date are not.

Each Code A debarment or Code B suspension action on the list that was taken before August 30, 1982, is preceded by an asterisk. Because none of these entries carries an effective date, in instances where an action is imposed by a non-DOD agency, it will be necessary for DOD users to contact the action agency to determine when the action was imposed. If the action was imposed after November 30, 1981, the action is effective within DOD; if it was imposed

on or before November 30, 1981, it is not effective within DOD, but is for information purposes only.

DOD users should consult counsel for advice prior to taking a procurement action with respect to a contractor that has been debarred or suspended by a non-DOD agency if doubt exists whether such action is effective within DOD.

B. Cause: Suspension by an agency pending completion of investigation or legal proceedings pursuant to FAR 9.407-2 and based on (a) an indictment for or adequate evidence of the commission of fraud, antitrust violations, embezzlement, theft, forgery, bribery, false statements, or other offense indicating a lack of business integrity; or (b) adequate evidence of any other cause of a serious and compelling nature.

Treatment: Same as for Code A. Suspensions are temporary actions and the period of the suspension is indefinite. Therefore, no termination date will be listed.

C. Cause: Debarred by the Comptroller General for violation of the Davis-Bacon Act (40 U.S.C. 276a-2(a)).

Treatment: Offers shall not be solicited from, nor contracts be awarded to, the listed contractor or any firm, corporation, partnership, or association in which the contractor has an interest. Debarment is for a three-year period to terminate on the date shown.

D. Cause: Debarred by the Secretary of Labor for violation of the Walsh-Healey Public Contracts Act (41 U.S.C. 37) or the Service Contract Act (41 U.S.C. 354).

Treatment: Offers shall not be solicited from, nor contracts be awarded to, the listed contractor or any firm, corporation, partnership, or association in which the contractor has a controlling (WHA) or substantial (SCA) interest. Debarment is for a three-year period to terminate on the date shown.

E. Cause: Debarred by any agency for violation of the Buy American Act (41 U.S.C. 10b(b)).

Treatment: Offers shall not be solicited from, nor contracts or subcontracts for the construction, alteration, or repair of public buildings or works be awarded to the listed contractor. The contractor may be solicited for offers and awarded contracts for other than construction, alteration, or repair of public buildings or works. Debarment will terminate on the date shown.

F. Cause: Declared ineligible by the Director, Office of Federal Contract Compliance, Department of Labor, in accordance with Executive Order No. 11246 and based on the contractor's failure to satisfy its obligations under the Equal Opportunity Clause of a Federal contract.

Treatment: Contractor is ineligible for the award of any contract or subcontract funded in whole, or in part, with Federal funds from any agency, or for the extension or other modification of existing contracts or subcontracts. Ineligibility is for an indefinite period of time pending contractor's compliance with the executive order and implementing regulations. Therefore, no termination date will be listed.

G. Cause: Declared ineligible by the Secretary of Labor under the authority granted in Reorganization Plan No. 14 of 1950 and based on a violation of one or more of the labor standards provisions of one or more of the following Federal statutes: Contract Work Hours and Safety Standards Act, 40 U.S.C. 327, et seq.; Copeland Act, 40 U.S.C. 278c; Hospital Survey and Construction Act, as amended by the Hospital and Medical Facilities Amendments of 1964, 41 U.S.C. 291e(a)(5); United States Housing Act of 1937, as amended, 42 U.S.C. 1418; National Housing Act, 12 U.S.C. 1715c, as amended; Housing Act of 1949, 42 U.S.C. 1459; Housing Act of 1961, 42 U.S.C. 1500c-3; Housing and Urban Development Act of 1965, 42 U.S.C. 3107; Federal-Aid Highway Act of 1956, as amended by the Federal-Aid Highway Act of 1968, 23 U.S.C. 113(a); Federal Water Pollution Control Act, as amended (Sec. 4(g) of the Water Quality Act of 1965, 33 U.S.C. 466e(g)); Postal Reorganization Act, 39 U.S.C. 410 (b)(4)(c); Vocational Education Act of 1963, 20 U.S.C. 35(f); Public Works and Economic Development Act of 1965, 42

U.S.C. 3222; State and Local Fiscal Assistance Act of 1972, 31 U.S.C. 1243(a)(6); Public Health Service Act, 42 U.S.C. 291e; Housing and Community Development Act of 1974, 42 U.S.C. 1437; Local Public Works Capital Development and Investment Act of 1975, 42 U.S.C. 6701, et seq. as amended; Health Professions Educational Assistance Act of 1963 (Sec. 2(a), 77 Stat. 184; 42 U.S.C. 292d(c)(4) and 293a(c)(5), P.L. 88-129); Higher Educational Facilities Act of 1963 (Sec. 403, 77 Stat. 379; 20 U.S.C. 753, P.L. 88-204); Appalachian Regional Development Act of 1965, (Sec. 402, 79 Stat. 21; 40 U.S.C. App. 402); Urban Mass Transportation Act of 1964, 40 U.S.C. 6109.

Treatment: The contractor, or any firm, corporation partnership, or association in which the contractor has a substantial interest is ineligible to receive any contract for work subject to the labor standards provisions of any of the listed statutes. The period of ineligibility determined by the Secretary, may not exceed three (3) years and will terminate on the date shown.

H. Cause: Facility declared ineligible for use in Federal contract by the Administrator of the Environmental Protection Agency pursuant to the Clean Air Act (42 U.S.C. 1857h-4), the Federal Water Pollution Control Act, (33 U.S.C. 1368), and Executive Order 11738. Ineligibility is based on noncompliance with clean air or water standards resulting in a conviction under 113(c)(1) of the Air Act of 309(c) of the Water Act (listed as "H1") or other action (listed as "H2").

Treatment: No agency shall enter into, renew, or extend any non-exempt contract or subcontract, where a listed facility would be used for the contract or subcontract. Ineligibility is for an indefinite period until terminated by the Administrator. Therefore, no termination date will be listed.

A contract or subcontract is exempt from the ineligibility determination if it does not exceed \$100,000, or its purpose is to assist a facility to comply with any law or regulation relating to environmental pollution. However, this exemption does not apply where the facility is listed as "H1". See 40 CFR 15.5 for additional information concerning exemptions.
