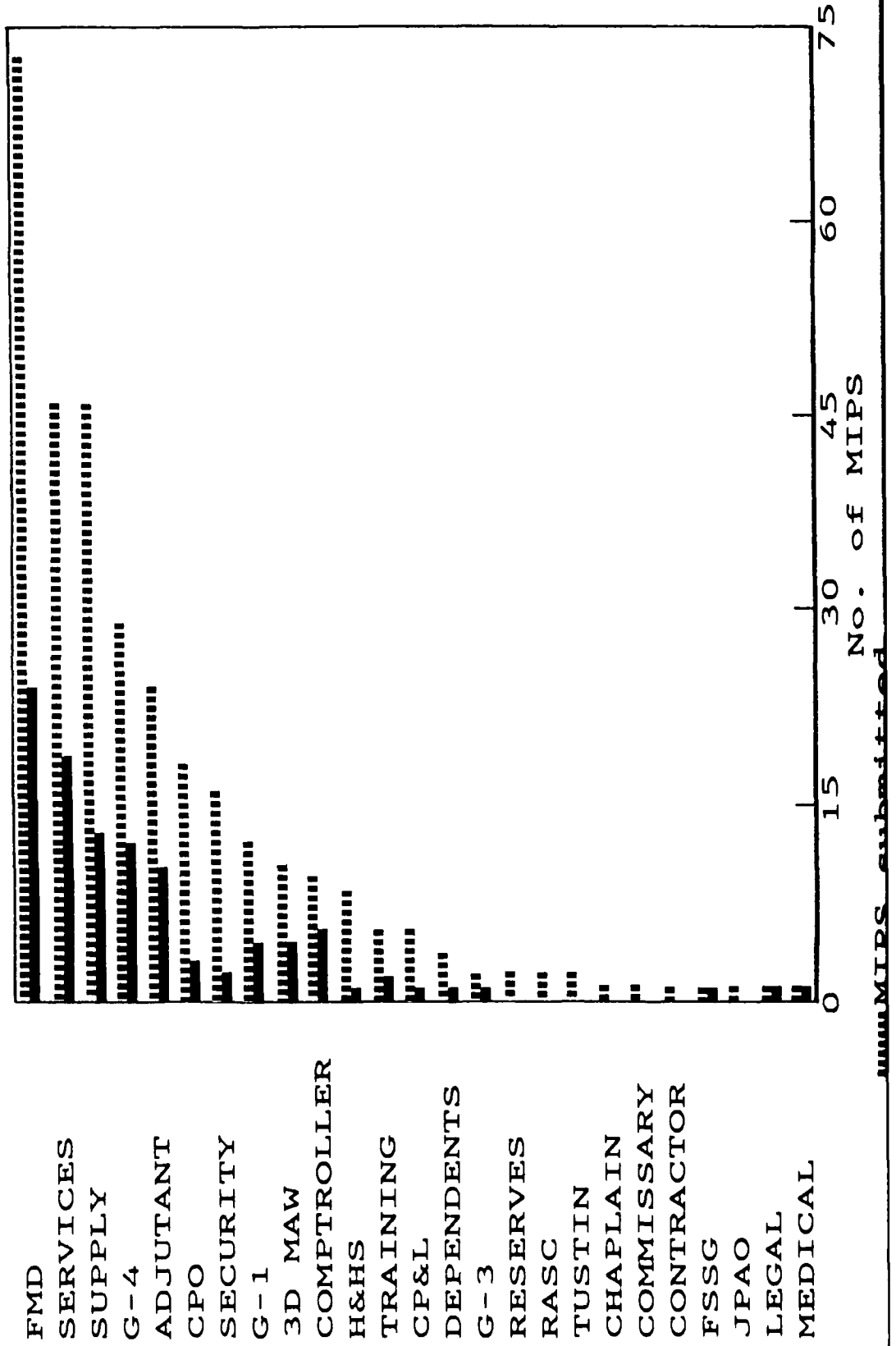

(APRIL 1984 - JUNE 1987)

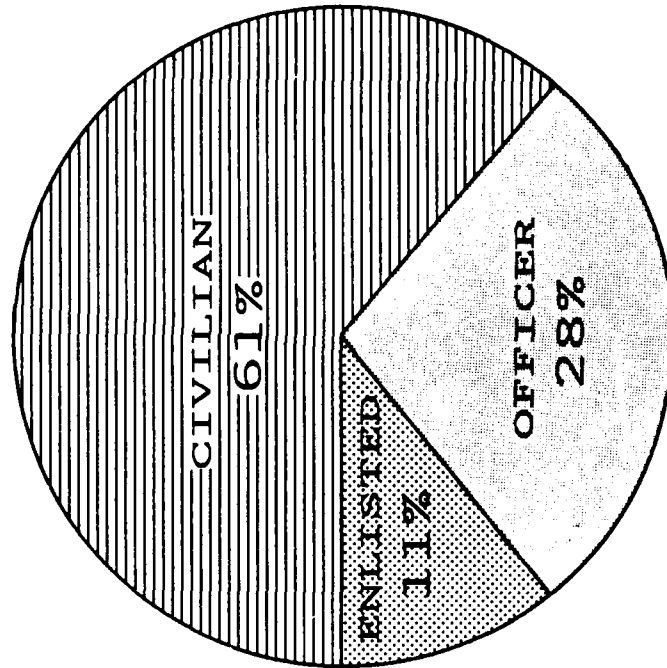


NUMBER OF MIPS SUBMITTED/APPROVED
