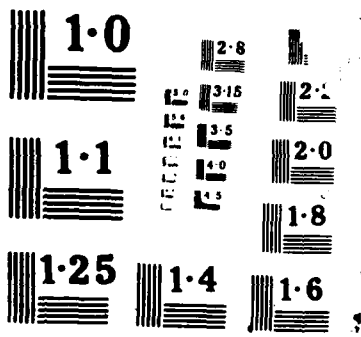

ABSTRACT (Continue on reverse if necessary and identify by block number) This three-month effort consisted in providing Secretariat services to the DoD Advisory Group on Electron Devices (AGED) for OUSDA. The function of AGED is to provide technical advice to assist DoD and the military departments in planning and directing adequate and economical electron device research and development programs. During the contract period, the contractor provided support for eight AGED meetings, three Special Technology Area Reviews, and six technology briefings. Meeting support included: developing agendas; providing meeting sites and security; and reporting and disseminating meeting results. During this period the contractor also maintained a comprehensive database of information on current and planned government-sponsored electron device R&D programs. This effort was a follow-on to contract N00039-84-C-0213.

FOREWORD

This is the Annual Report (Final) on Contract No. N00014-88-C-0051, and it covers the period 1 October 1987 through 31 December 1987. Palisades Institute for Research Services, Inc. has carried out all the functions required of it in the formal agreement, as well as special tasks as assigned by the Office of the Director, Computer and Electronics Technology, OUSDA, from time to time.

Internal work on advanced information retrieval and dissemination techniques continued during the period for purposes of enhancing these services to the Advisory Group on Electron Devices, its Working Groups, government agencies, government contractors, and other groups under various agreements, some of which were international in scope.

The documentary output from these various efforts (excluding wholly internal working documents) are listed in the appended "Production Report No. 1" which has been prepared for contractual purposes.

Additional tasks involving the organization of Special Technology Area Reviews were successfully accomplished.

2. Special Technology Area Reviews

During the contract period, three Special Technology Area Reviews (STARs) were held. These reviews represent an intensive examination of a particular technology thrust which merits such scrutiny due to technology breakthroughs or other considerations. Both industrial and military experts were invited and asked to provide presentations on the critical areas being considered. An invitation to the entire membership of the Advisory Group on Electron Devices is issued, but restrictions may be imposed based on space limitations at the meeting locations.

(a) Lithography

This review was held on 23 October 1987 at Palisades Institute for Research Services, Inc., Arlington, VA. Mr. Jack S. Kilby, Chairman of the Advisory Group, served as the chairman for this event.

(b) Draft RFP for an IRFPA Producibility Initiative

This review was held on 3 December 1987 at Palisades Institute for Research Services, Inc., Arlington, VA. Dr. James Hall, Chairman of Working Group C (Electro-Optics), served as the chairman for this event.

(c) Refractory Semiconductors

This review was held on 15 December 1987 at Research Triangle Institute, Research Triangle Park, NC. Dr. John T. Mendel, Consultant Member of the Advisory Group, served as the chairman for this event.

3. Briefings

In addition to the STAR presentations, there were smaller-scale briefings held for the purpose of providing information on important technology aspects to the Department of Defense and OUSDA.

(a) GaAs Processor Technology

This briefing was provided by Dr. Miller of NASA-Goddard on 6 October 1987 at Palisades Institute for Research Services, Inc., Arlington, VA. Working Group B (Microelectronics) was in attendance.

(b) Free Electron Laser and Solid-State Laser Program

This was a general briefing on 14 October 1987 at Lawrence Livermore National Laboratory, Livermore, CA. Working Group C was in attendance.

(c) HBT Technology

This briefing was provided by Mr. Yoder of ONR on 21 October 1987 at Palisades Institute for Research Services, Inc., Arlington, VA. Working Group A was in attendance.

(d) Qualification Procedures for VHSIC/VLSI

This briefing was provided by Dr. Messenger of AFRODC on 1 December 1987 at Palisades Institute for Research Services, Inc., Arlington, VA. Working Group B was in attendance.

(e) IR Search and Track Program

This briefing was provided by Dr. Scribner of NRL on 2 December 1987 at Palisades Institute for Research Services, Inc., Arlington, VA. Working Group C was in attendance.

(f) Power Source Initiative

This briefing was provided by Mr. Butler of BETEC, Inc (Consultant Member of AGED) on 16 Dec 1987 at Research Triangle Institute, Research Triangle Park, NC. AGED was in attendance.
