The intended use of these paragraphs is not clear. The information could be addressed simply as interface hardware and software. There is no coherent pattern to the information supplied in the corresponding paragraphs of other interfaces, so it is difficult to determine what information is actually required. For example, subparagraph l, which is entitled Transmission Mode, identifies UNISCOPE and Direct Interface Unit on this page, while paragraph 3.2.1.2.1.4.1 reads "Electronics - Hard copy via aircraft". The two descriptions are at least inconsistent, if not incorrect. As another example, subparagraph m. on this page uses the term "Hardwire" to describe the Electronic Protocol used, as compared to "X.25 STD (FULL)" in subparagraph 3.2.1.2.1.4.m.
