APPROPRIATION LANGUAGE

For construction, procurement, production, and modification of ammunition, and accessories therefore; specialized equipment and training devices; expansion of public and private plants, including ammunition facilities authorized in military construction Authorization Acts or authorized by section 2854, title 10, United States Code, and the land necessary therefor, for the foregoing purposes, and such lands and interests therein, may be acquired, and construction prosecuted thereon prior to approval of title; and procurement and installation of equipment, appliances, and machine tools in public and private plants; reserve plant and Government, and contractor-owned equipment layaway; and other expenses necessary for the foregoing purposes; \$1,424,400,000, to remain available for obligation until September 30, 1993.

The FY 1991 Amended program provides for worldwide training consumption and replaces losses to inventory through FY 1991 funded delivery periods, maintains U. S. Army readiness, buys war reserves through the FY 1994 authorized acquisition objective, and maintains the active ammunition production base at a reduced level. The following table depicts the ammunition program by major categories:

Part 1 - PURPOSE AND SCOPE

The FY 1991 Amended President's Budget contains an ammunition program that provides for worldwide training consumption, near-term readiness and combat sustainability, and the acquisition of war reserve stocks. Families of ammunition included in the request are special munitions, small arms, mortars, tanks, artillery, artillery fuzes, rockets, mines, and other ammunition items. War reserve ammunition requirements equate to 59 percent of the Activity I request.

The FY 1991 Amended President's Budget contains an ammunition production base support program that provides for the support of plants in active production and required for mobilization; the establishment of initial-production facilities; modernization, and expansion of production capability for ammunition; modernization of Proving Grounds; layaway of industrial plants and equipment, which is the procedure associated with placing a previously active production facility or line into inactive status; and components for prove-out, which refers to the procedures associated with demonstrating that a production facility or line is capable of manufacturing the ammunition item. Also included in the program beginning in FY 1990 is funding for the maintenance of the inactive industrial facilities after they are laid away.

The FY 1991 Amended request of \$134.6 million contains the following projects:

To correct safety deficiencies at various Army Ammunition Plants (AAP), \$8.6 million is requested. This amount will provide for upgrading of fire detection and suppression equipment in the tracer charging area, modernization of the primer assembly process and plant-wide upgrading of the lightning protection system at Lake City AAP (Independence, Missouri). In addition, at Radford AAP (Radford, Virginia), the existing two-wire electrical system will be upgraded; at Indiana AAP (Charlestown, Indiana), a deluge system will be provided on two load lines; and a portable high-speed deluge system for use at several plants will be provided.

At Holston AAP (Kingsport, Tennessee), \$3.1 million is requested to construct a two-lane bridge across the Holston River from the production area to the explosive storage area where all on-plant storage is located. The existing bridge, constructed in 1943, has deteriorated to a point of being unsafe and structurally incapable of carrying a fully loaded trailer.

The main steam lines at Holston AAP are over 40 years old and deteriorated. \$1.5 million is requested to relocate approximately 400 feet of line and replace supports, traps, valves, insulate the headers, and demolish/rehabilitate the collateral air lines.

To enhance personnel safety in the pyrotechnic manufacturing area at Lone Star AAP (Texarkana, Texas) and Longhorn AAP (Marshall, Texas), \$16.6 million is requested. This project will provide for the installation of remotely operated mixers, granulators and dryers for pyrotechnic compositions; remote handling equipment; and an improved fire suppression system.

To provide adequate storage of Nitroguanidine, \$2.2 million is requested to construct seven concrete arched igloos to replace defective steel arched igloos at Sunflower AAP (Lawrence, Kansas).

At Louisiana AAP (Shreveport, Louisiana), the projectile metal parts line is experiencing significant downtime due to a worn machining chip conveyor system. Replacement of this system at a cost of \$2.4 million will also correct some environmental deficiencies.

In an effort to meet environmental laws and regulations, \$12.0 million is requested to restore land and equipment that have been damaged, contaminated, or disturbed by activities at the ammunition plants and modify production operations and processes to meet the requirements of various environmental laws and regulations.

For hazardous waste disposal at Army ammunition installations, \$3.6 million is requested.

To acquire equipment and update existing systems used for small caliber ammunition inspection and quality control at Lake City AAP, \$6.5 million is requested.

To reduce waste and permit continued, uninterrupted depleted uranium penetrator manufacture at Aerojet Ordnance Company, Jonesborough, Tennessee, \$2.5 million is requested.

In support of the Air Force Sensor Fuzed Weapon program, \$10.0 million is requested for Textron Defense Systems, Wilmington, MA. Funding is for production transition program in which high risk tooling/test equipment and/or critical production processes will be demonstrated, run-off qualification piece parts/components produced, and sub-system qualification tests conducted.

Engineering design funds in the amount of \$25.9 million are required for initiation and/or continuation of construction design criteria, equipment and construction concept final design, process design specifications, design related studies; and other design related work necessary to assure efficient and timely execution of facility projects.

Also included in the FY 1991 request is \$39.8 million for the necessary production support and equipment replacement for plants in active production.

LAYAWAY OF INDUSTRIAL FACILITIES

The FY 1991 Amended request is for the protection and preservation of equipment and facilities no longer required for active production, but which must be retained for future peacetime or mobilization production needs. Included are funds for the partial layaway of Mississippi AAP (Picayune, Mississippi) and the layaway of lines where production will end at various ammunition plants.

COMPONENTS FOR PROVE-OUT

12.100

This line provides for the prove-out and acceptance of prior year modernization, expansion and initial production facilities. Funds are used to assure that the facility is capable of producing an acceptable end product, manufacturer warranties are met, and the facility is capable of producing at the designed rate.

The FY 1991 prove-out program includes nitric acid concentration (NAC)/sulfuric acid concentration (SAC) lines deficiency corrections at Badger AAP (Barboe, Wisconsin), Composition A line modernization at Holston AAP and CASBL deficiency correction at Radford AAP.

PROVING GROUND MODERNIZATION

4.000

This program will modernize and upgrade existing test instrumentation to conduct production acceptance testing of Army ammunition components. This effort will replace obsolete, unreliable, or economically unrepairable test equipment and instrumentation currently in use. This will result in more accurate reliable data and faster turn around of the production items being tested. This will also allow for earlier release of product, avoiding the requirement for additional storage facilities, and reduce waste and scrap resulting from stopping faulty production. Jefferson Proving Ground is on the proposed base closure list for Department of Defense installations. The mission performed at Jefferson Proving Ground will be transferred to Yuma Proving Ground and the modernization funding will be required there.

MAINTENANCE OF INACTIVE FACILITIES

67.800

In FY 1990, the Congress appropriated funding for the Maintenance of Inactive Ammunition Industrial Facilities as a new line item in the Procurement of Ammunition, Army Appropriation. In FY 1989 and prior years this program had been financed in the Operation and Maintenance, Army Appropriation. The funds provide for the maintenance of laidaway portions of active plants including utilities, buildings, nonseverable plant equipment, administration, surveillance, inspection, protection, and maintenance and repair of buildings, grounds, railroads, and integral equipment. The program also supports retention, maintenance and protection of the government-owned, inactive plants and inactive lines of active plants which are needed to assure emergency production capacity for mission essential material.

The program supports maintenance, protection, repair, and rebuild of government-owned plant equipment packages including: industrial plant equipment, other plant equipment, special tooling and special test equipment. These plant equipment packages are maintained in anticipation of future production and mobilization requirements of ammunition. Facilities maintained include nine inactive GOCO plants, inactive lines at 17 active plants (three GOCO and 14 GOCO), and inactive lines at 26 contractor plants.

Activity 1 - Ammunition - The net increase resulted from Congressional adjustments to 5.56mm (3,500), 7.62mm (\$10,000), 20mm (\$10,000), 25mm (\$10,000), 40mm (\$15,000), 4.2 in Mortar (\$-11,253), 35mm Tank (\$-11,800), 105mm (\$-36,700), 120mm (\$42,300), 155mm (\$146,155), Fuzes (\$-14,840), Mines (\$-40,621), AT-4 (\$10,079), and Demolition Munitions (\$5,000). Adjustments were also required for an Military Pay reprogramming (\$-200) and a transfer of deferred programs (\$-90,000).

Activity 2 - Ammunition Production Base Support - Net increase resulted from Congressional adjustments to Provision of Industrial Facilities (\$120,000), Components for Prove-Out (\$-3,000) Lawaway of Industrial Facilities (\$-11,977) and Industrial Preparedness (\$64,600). Adjustments were also required for a Drug Interdiction Reprograming (\$-12,000).
