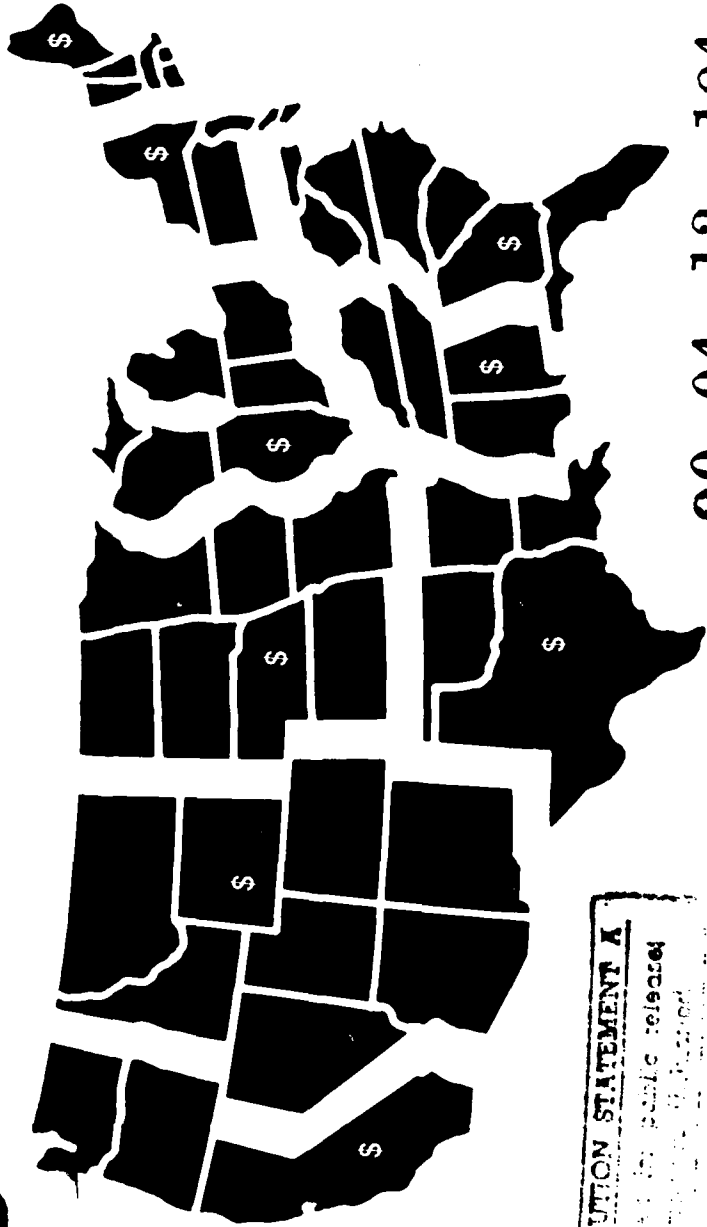

FOREWORD

Prime Contract Awards by Region and State is published annually. This issue provides information on the geographical distribution of Department of Defense prime contract awards over \$25,000 for Fiscal Years (FY) 1989, 1988, and 1987 by the United States region and state.

This information is detailed in ten tables and three figures showing:

1. The net value and percent distribution of awards, by region and state, for FY 1989, 1988, and 1987;
2. The net value and percent distribution of awards within the seven major hard goods programs, by region, for FY 1989, 1988, and 1987;
3. The net value and percent distribution of awards in the 25 major procurement programs for each state for FY 1989, 1988, and 1987; and
4. Data on research, development, test, and evaluation (RDT&E) awards by region and state according to the type of contractor for FY 1989, 1988, and 1987.

INTRODUCTION

This report contains a variety of data on the distribution of prime contract awards over \$25,000 within the United States, by region and state, for Fiscal Years (FY) 1989, 1988, and 1987.

This publication is divided into four parts: Part I, Distribution of Prime Contract Awards Over \$25,000 by Region and State; Part II, Distribution of Prime Contract Awards Over \$25,000 for Major Hard Goods; Part III, Distribution of Prime Contract Awards Over \$25,000 by State; Part IV, Distribution of Prime Contract Awards Over \$25,000 for Research, Development, Test, and Evaluation.

Prime contract data are not a means of measuring the total volume of defense work performed within a state, as a substantial amount of the work may be subcontracted.

Notes on Coverage

Contract work is not necessarily performed in the state where the contract is awarded. Most manufacturing contracts have been attributed to the contractor's location where the product will be processed and assembled. When contract work has been performed at more than one plant, the contract has been attributed to the location where the largest dollar amount of work was produced. Both construction and service contracts have been attributed to the state where the work is to be performed. Contracts for transportation and communication services in most cases have been attributed to the state where the contractor's home office is located. For purchases from wholesale or other distribution firms, the location is the contractor's business address.

Amounts not distributed by state include contract actions performed in classified locations and other contract actions for work performed in the U.S. outlying areas.

Some special characteristics of the data on prime contract awards by procurement program category should be noted:

1. The Electronics and Communication Equipment category includes all electronics procured separately under prime contract. However, in the case of Missiles and Space Systems or Aircraft Engines and Related Spares, electronics work is often a basic part of the assembly prime contract; therefore, awards for electronics are included in the statistics for these categories.
2. Contracts for all other types of equipment and parts for repair, maintenance, overhaul, modification, or other services, which can be identified with a specific category, are assigned to that category. As an example, the installation or inspection of equipment at ballistic missile sites is recorded as missile work in the state where the site is located. However, the contract for manufacturing such equipment is reported according to the location of the manufacturer's plant. Therefore, aircraft, missile, or other program contracts may be reported in states where there are no weapon assembly plants but where bases, laboratories, or suppliers of instruments, parts, or support equipment may be located.
3. The dollar value shown for each category includes the Research, Development, Test, and Evaluation (RDT&E) work associated with it. RDT&E coverage includes research, exploratory development, advanced development, engineering development, operational systems development, and management and support. Full definitions for each of these categories are provided in Federal Acquisition Regulation 235.001.
4. Figures in these tables may not add up due to rounding.

Highlights

Total prime contract awards in FY 1989 totaled \$139,343 million, a decrease of \$12,010 million or 7.9 percent less than FY 1988. Awards over \$25,000 for work performed within the United States, by region and state, are shown in this report. These awards totaled \$119,917 million in FY 1989. The kinds of awards not included in this report (see Notes on Coverage) are distributed as follows:

PART I
DISTRIBUTION OF PRIME CONTRACT AWARDS
OVER \$25,000, BY REGION AND STATE

The U.S. regions are shown in Figure I-1 (page 4). The three regions that received the largest share of the awards in FY 1989 were the Pacific (22.8 percent), the South Atlantic (16.1 percent), and New England (13.6 percent). (See Figure I-2, page 5.) Those regions that make up the eastern part of the United States received awards totaling \$ 62,875 million or 52.5 percent. The western regions received the remaining 47.5 percent of the awards totaling \$ 57,041 million.

Table I-1 (page 6) shows the net value and percent distribution of awards, by region and state, for FY 1989, 1988, and 1987. The region showing the largest percentage increase in the net value of total awards over FY 1988 was New England, up \$2,596 million or 19.0 percent. The regions showing the largest percentage decreases in the net value of total awards compared to FY 1988 were East South Central, down \$1,774 million or 30.2 percent and South Atlantic, down \$6,051 million or 23.7 percent. The remaining regions had award changes in FY 1989 ranging from 4.8 to -11.1 percent.

In individual states, Vermont had a 34.2 percent increase in the net value of total awards from FY 1988 to FY 1989. Six other states showed award increases of 20 percent or greater. Eighteen states had award increases of less than 20 percent. The remaining twenty-five states all had award decreases from FY 1988 to FY 1989.

The following table shows the ten states with the largest percentage change in awards from FY 1988 to FY 1989.

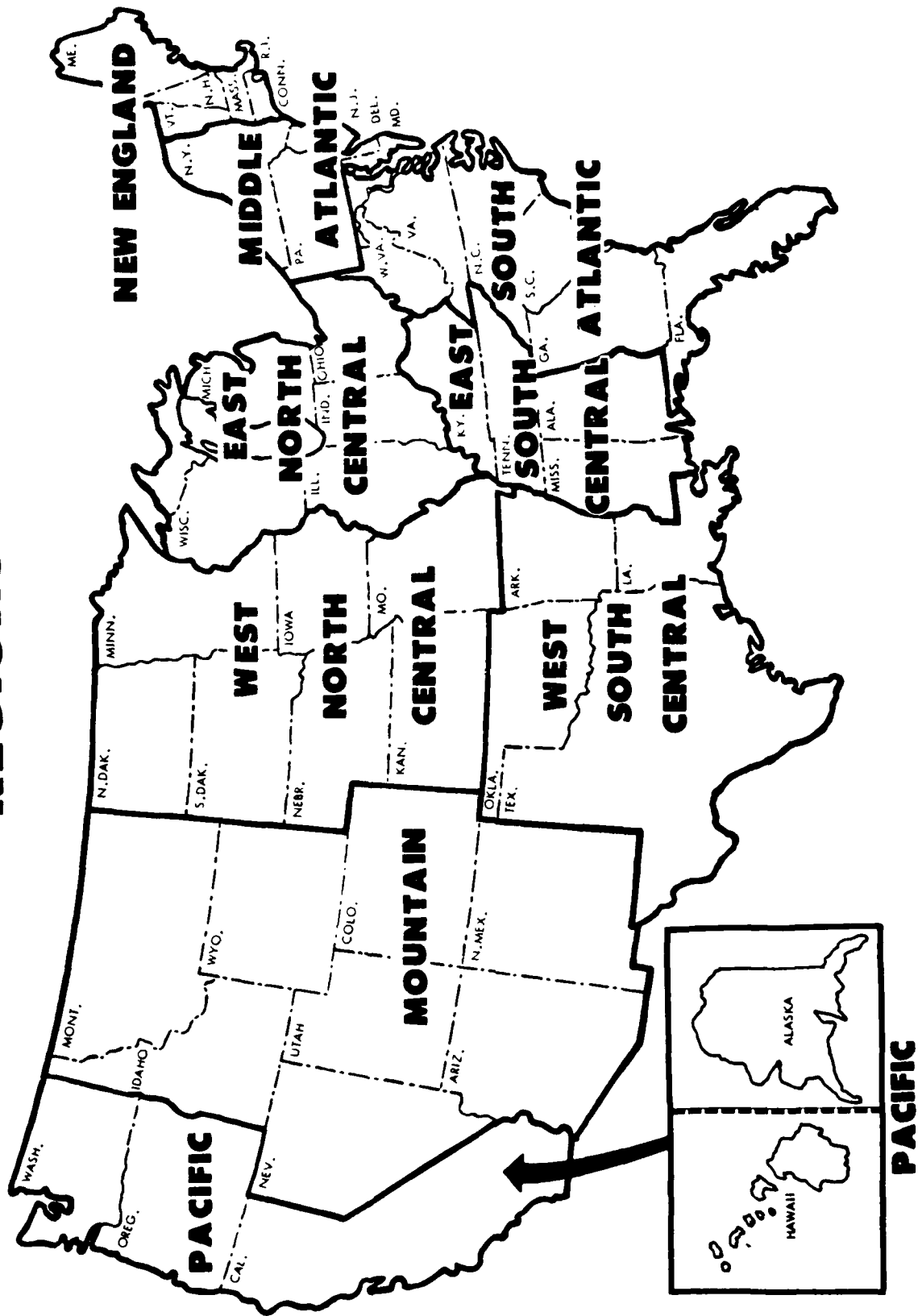
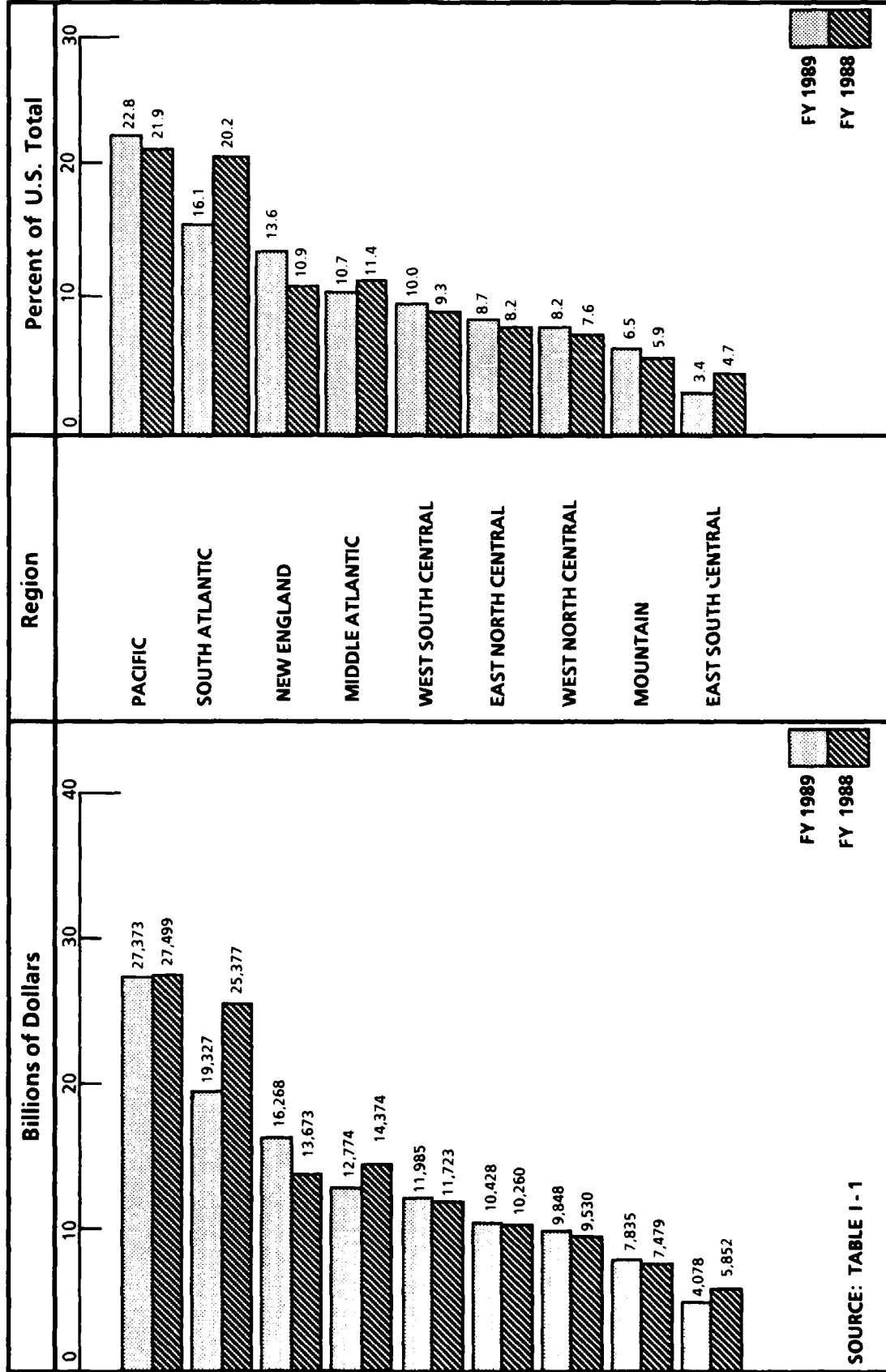

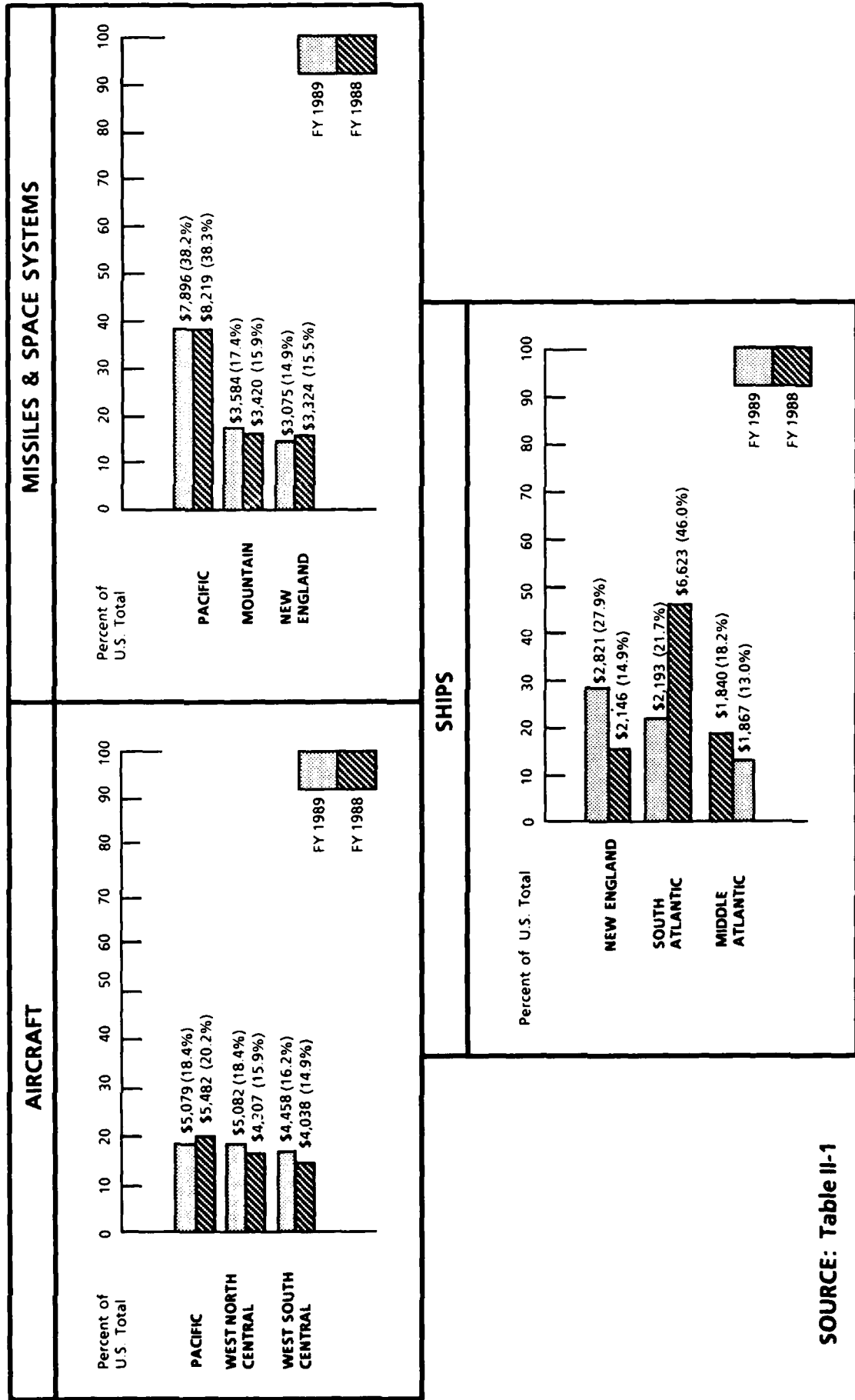
PART II

DISTRIBUTION OF PRIME CONTRACT AWARDS OVER \$25,000 FOR MAJOR HARD GOODS

Figure II-1 (page 10) shows the top three regions for FY 1989 in each of the seven major hard goods programs as well as the net value and percent distribution of awards in each region for FY 1989 and 1988. The Pacific region ranked as one of the top three regions most frequently, placing in the top three for three out of the seven programs.

Table II-1 (page 12) shows the net value and percent distribution of awards within the seven major hard goods programs, by region, for FY 1989, 1988, and 1987. Table II-2 (page 14) shows that awards within these hard goods programs accounted for 71 percent of all prime contract awards in FY 1989, a two percent decrease from the FY 1988 figure. Overall, hard goods programs decreased 4.8 percent from FY 1988 to FY 1989. The percentage distribution of awards within the seven major hard goods programs, both as a percentage of all awards and as a percentage of all hard goods awards, shows missiles and space systems, ships, tank-automotive, weapons, and ammunition awards decreased in FY 1989 from FY 1988, while aircraft and electronics and communication equipment increased during the same time period.

 FOR MAJOR HARD GOODS: FY 1989 AND 1988**

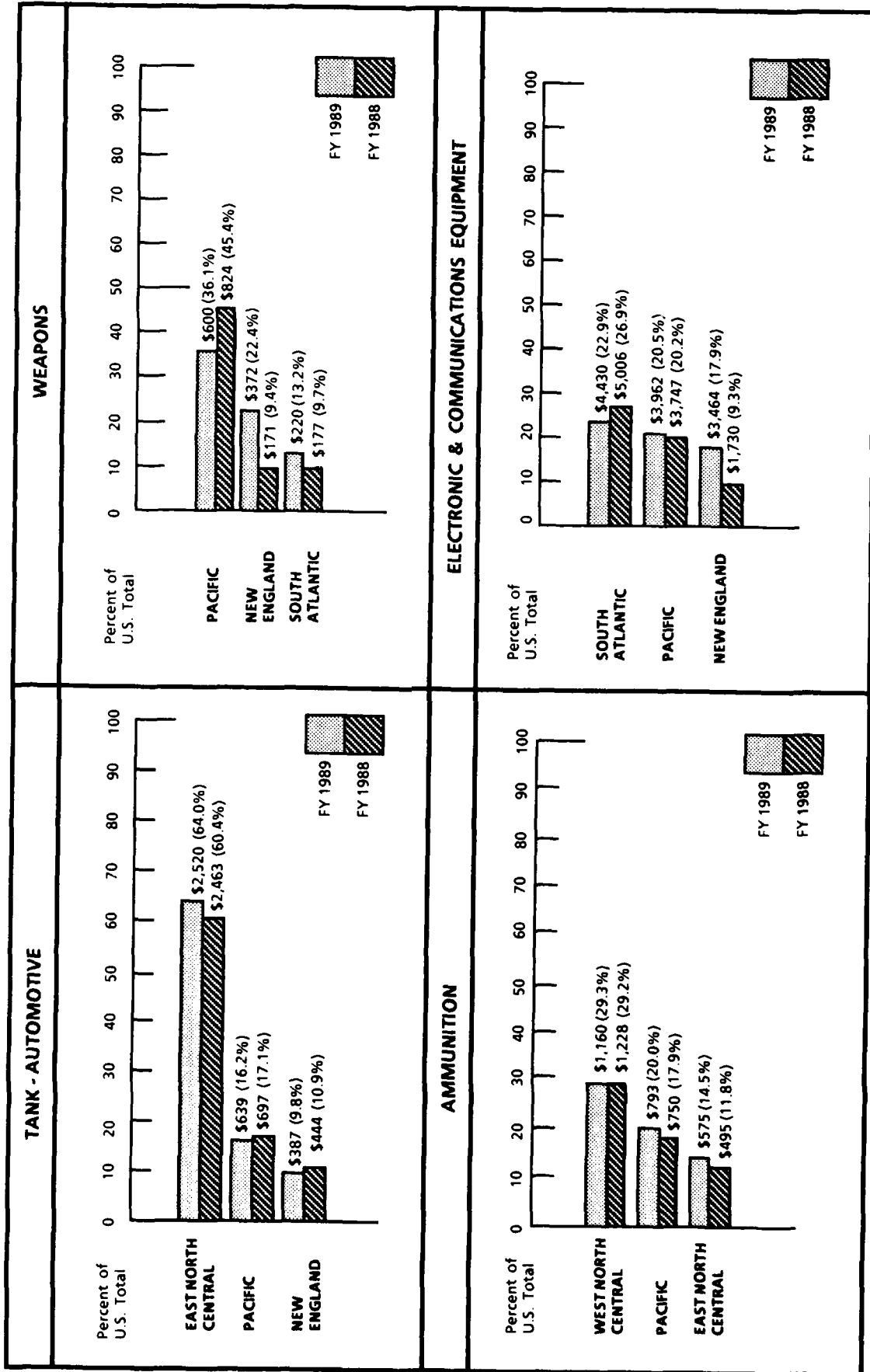

PART III
DISTRIBUTION OF PRIME CONTRACT AWARDS OVER \$25,000 BY STATE

The net value and percent distribution of awards in each of the 25 major procurement programs for the fiscal years 1987 through 1989 for individual states are provided in Tables III-1, beginning on page 17. Table III-2 (page 69) shows the five leading states in each of these 25 procurement programs for FY 1989. While California ranked first in ten of the programs, there was a broad representation of other states in the top five ranking. A total of 32 states appear in the table, which was the same as the number in FY 1988. In FY 1989, 12 states ranked first in one or more of the programs compared to 11 states in FY 1988.

PART IV DISTRIBUTION OF PRIME CONTRACT AWARDS OVER \$25,000 FOR RESEARCH, DEVELOPMENT, TEST, AND EVALUATION

As shown in Table IV-1 (page 72), RDT&E awards totaled \$21,966 million in FY 1989, a decrease of \$243 million or 1.1 percent from the FY 1988 figure. Nevertheless, the ratio of RDT&E awards to total awards remained at 18 percent for FY 1989. Table IV-1 also shows that the distribution of RDT&E awards among the three types of contractors did not change significantly from FY 1988 to FY 1989.

Table IV-2 (page 73) shows the net value and percent distribution for both total awards and RDT&E awards, by region, and the percent distribution of RDT&E awards within each region for FY 1989. Five of the nine regions received more RDT&E awards in FY 1989 than in FY 1988. The three regions that had the largest dollar increases were the East North Central (\$857 million), the West South Central (\$371 million), and the West North Central (\$309 million). In terms of the distribution of RDT&E awards, the Pacific region showed the most significant change. In FY 1988, 37.5 percent of RDT&E awards were in this region; however, in FY 1989, this percentage decreased to 31.6 percent.

The ratio of RDT&E awards to total awards showed an increase from FY 1988 to FY 1989 (17.7 percent to 18.3 percent). Regional RDT&E awards as a percent of regional total awards did not change significantly. The six regions showing increases were the South Atlantic (3.4 percent), Middle Atlantic (.1 percent), East North Central (8.1 percent), West South Central (2.9 percent), the West North Central (2.9 percent), and the East South Central (6.2 percent).

Tables IV-3, IV-4, and IV-5 (pages 74, 77, and 80, respectively) show the net value and percent distribution of prime contract awards for RDT&E work, by region and state, according to type of contractor (educational institutions, other nonprofit institutions, and business firms), for FY 1989, 1988, and 1987, respectively. As shown in Table IV-3, the four states receiving the largest share of RDT&E awards in FY 1989 were California, Colorado, Massachusetts, and Texas.
