Building data base backup files will require inputs of static and dynamic data; this results in arrow change 1. The backup files produced will be stored in the Backup_Files data store; this results in arrow change 2 and name change 2. At the time of recovery action, inputs of static data and backup files will reconstruct CMOS_Dynamic_Data; this results in arrow change 3 and name changes 1 and 3.

COMMENT OR RECOMMENDED CHANGE:

Delete the inputs and outputs to the Support Mobility Operations capability. This capability should not be depicted in a separate process as is the case in Figure 3.2.1.1. Rather, the mobility related inputs and outputs should flow to and from the Initialize CMOS process. This also applies to the subordinate capabilities (SC1151 and 1152).

RATIONALE:

The capability to support mobility operations is an expansion of the SAs' overhead responsibilities and should be integrated with the existing SA process as stated in the "Purpose and requirements satisfied" paragraph, page 52, line 7. Furthermore, SS2204, which is allocated to SC1151 and SC1152, states that mobility related applications "shall be integrated into the System Administrator's standard processing environment."

Neither of the shall statements allocated to SC1151 propose dual data bases (on the contrary, SS2383 refers to the centralized data base) or distinguish between on-line and off-line processing relative to the SA.

The System Environment SRS describes the EDI Software as part of the System Environment CSCI. The description of this capability (paragraph 3.2.9) and other EDI descriptive material conflict in five ways:

1. Figure 3.2.9 depicts translation software that produces MILSTAMP formatted data before reaching CMOS. This conflicts with the external and internal interface paragraphs listed above that describe MILSTAMP translation processes as part of SC267 and SC26H.
2. SC267 and SC26H appear to be duplicates. One or both may be unnecessary.
3. An incoming EDI message is handled by the Incoming Message Manager twice in the SC267 and SC26H descriptions, but only once in Figures 3.2.6 and 3.3b.
4. Figures 3.2.6 and 3.3b illustrate a relationship between the EDI distributor level SCs and the RDBMS that conflicts with the descriptions in paragraphs 3.3.35 and 3.3.45. Neither of these SCs appear to directly update the database.
5. The identity of the "appropriate data store" that appears to be a central processing queue (a new entity) for the EDI software is obscure.
