Resolve the issue of which HWCi category the LAN transceivers and cables belong. Correct the paragraphs and corresponding tables.

RATIONALE:

Each HWCi descriptive paragraph references tables that list components in terms of contracts rather than HWCIs. This causes LAN components to be over counted by a factor of three. While it is true that each contract, (ULANA, SMSRCR, Desktop III) supplies LAN components, it is not true that all LAN components belong in each HWCi. This comment was previously provided (SSDDII-0004).
