INTRODUCTION

The federal government offers a wide variety of technical assistance, information, and financial help to state and local governments and other eligible institutions for the purposes of stabilizing and developing communities. The Catalog of Federal Domestic Assistance (CFDA) provides the best listing of these programs. The CFDA is updated and printed annually and can be purchased from the U.S. Government Printing Office. It is also available in most public and university libraries.

This presentation of commonly used development programs has been prepared for community leaders to illustrate the range of federal government services. Only a few of each program's characteristics are presented, but each program title is preceded by the CFDA program code number so that the complete explanation can be readily located in the CFDA. Note that each Description section here begins with the word "Assists" when technical assistance is offered and the word "Supports" when financial aid is offered.

The cited program information comes from the FY1990 edition of the CFDA. It is divided here into two categories: PLANNING AND TECHNICAL ASSISTANCE and IMPLEMENTATION. Programs offering both categories of aid are listed under the first, and both are noted in the Description section. Other programs devoted to communities' general capacity to thrive are also listed in this first category. Of course, programs that aid only construction programs and related physical developments in communities are listed in the second category. *Requirements for each program are listed in the CFDA.*

When researching programs in the CFDA, be sure also to read the sections listed immediately below that further define them:

- o Financial Information
- o Beneficiary Eligibility
- o Information Contacts
- o Formula and Matching Requirements
- o Related Programs

Federal programs are dynamic and subject to formal and to informal changes both in scope and funding level. After using the most current edition of the CFDA for reference, contact the cognizant program agency to confirm the information provided.
