COMMENT OR RECOMMENDED CHANGE:

Add instructions for each of the options currently being considered to accomplish conversion from a dual server site to a single server site.

RATIONALE:

The issue of conversion from dual to single server site remains open as we comment to the final iteration of the CSOM. In the interest of the future operator, it is important to document each possibility, with the caveat that final resolution will result in an update. There appear to be three possibilities at hand: 1) the differential SCSI hardware, 2) an external or removable drive, or 3) conversion without 1 or 2 being present. At a minimum, the operator should have instructions for determining which situation he/she is in and what action should follow. In the case of 1 or 2, instructions beyond determination of situation cannot be completed. The instructions for 3, however, should be included. Previous CSOM iterations included portions of what is necessary to convey the entire picture to the operator. These could be combined and edited for Appendix E. This will not impact the necessity of forthcoming changes to the document, but will reduce the risk of an inadequate document being in circulation if the time needed to resolve the issue exceeds expectations. The operator is best served by having all of the information available at press time.
