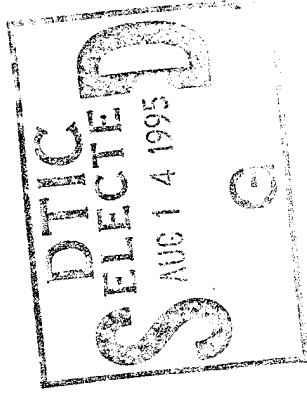

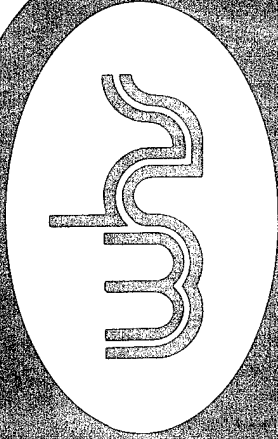

## FOREWORD

This manual explains all codes that appear on the detailed computer listing of awards produced using the Defense Contract Action Data System (DCADS). Data are listed alphabetically by Department of Defense (DoD) prime contractors who received awards over \$25,000 by principle place of performance (city, state or country).

The first line of each entry identifies the unique Contractor Establishment Code assigned to the DoD prime contractor by the Dun and Bradstreet Corporation under contract to General Services Administration, the Commercial and Government Entity (CAGE) code, and the contractor's name and principal place of performance (city and state or country). Data on each individual award to the contractor are then displayed on the following lines. This manual provides information on the meaning of the column headings that apply to those individual awards.

Additional references may be helpful in further describing the data. These may include: *The DoD Procurement Coding Manual: Commodities and Services* (MN02); the DoD Federal Acquisition Regulation (FAR) Supplement (DFARS), sections 204.6 through 204.7, and 253.204; and the DFARS Appendix G.

## CODE TRANSLATION MANUAL - FY 1994

There is a 15 position field available for the Procurement Instrument Identification (PII) number which for DoD contracts is 13 digits in length. The last 2 positions of the field are blank. The four sections of this alphanumeric code are department or activity (6 digits); fiscal year (2 digits); instrument code (1 digit); and serial number (4 digits). In those instances, where DoD purchases under another federal department or agency's contract (GSA, OPM, VA, etc.), the number assigned by the originating department or agency is shown and may not necessarily conform to this convention.
