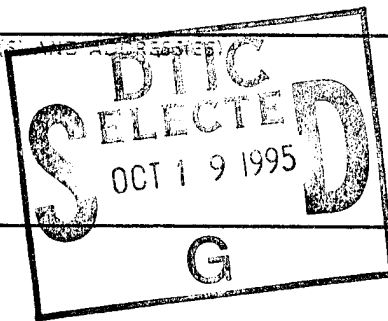

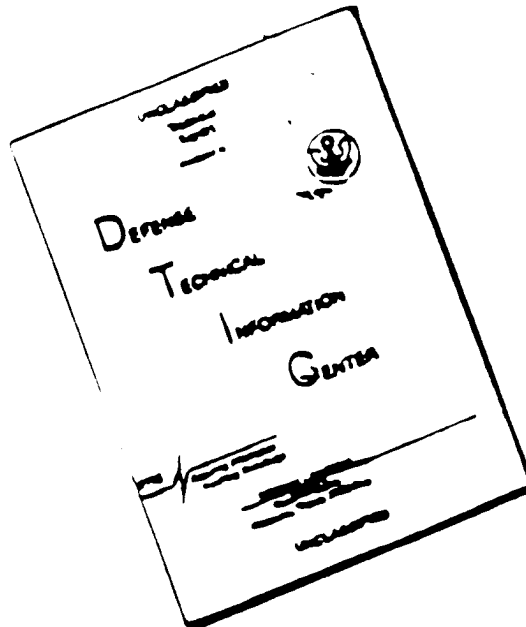

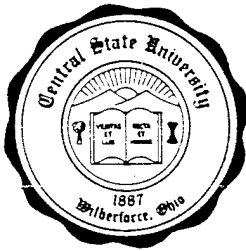

U. S. AIR FORCE INFRASTRUCTURE EQUIPMENT REQUEST**

In FY '94, Central State University established a Center for Scientific Visualization (CSV) using state-of-the-art technology in an interdisciplinary approach to solving problems in research.

The primary objectives of the CSV are as follows: 1) provide an environment for multiple disciplines to work together as science teams; 2) support undergraduate and faculty research projects requiring advanced visualization techniques; 3) serve as a testbed to develop new visualization mechanisms to aid in teaching difficult mathematics, scientific and engineering concepts; 4) support undergraduate courses which prepare students to utilize advanced computer graphics, image processing and visualization techniques in a research environment.

The Center was built upon the existing expertise and resources of the manufacturing engineering, science, mathematics, computer science and art departments.

Central State University requested and received funding from the Department of the Air Force, Office of Scientific Research to assist in developing the infrastructure for the Center.

Attachment A lists the instrumentation that was purchased and is being used to achieve the objectives of the programs in the Center.

As a part of its commitment to establish and maintain the Center for Scientific Visualization, the University provided, through its capital improvements budget, funds to renovate space to house the Center. In addition, University funds were used to purchase additional equipment. The University will continue to provide the resources for the maintenance and upkeep of the facility.

During the developmental stages of the CSV and the proposal to the Department of the Air Force for infrastructural development, Ms. Gloria Brown-Simmons was the Director for the Center and Principal Investigator for the project. Pursuant to the award and the completion of the project, i.e., purchasing equipment and supervising its installation, Ms. Brown-Simmons left Central State to assume another position. Pursuant to her departure, in June 1994, Ms. Dianne Love, Assistant Professor in the International Center for Water Resources Management was appointed as Director of the Center for CSV and Project Director for the infrastructure development projects.

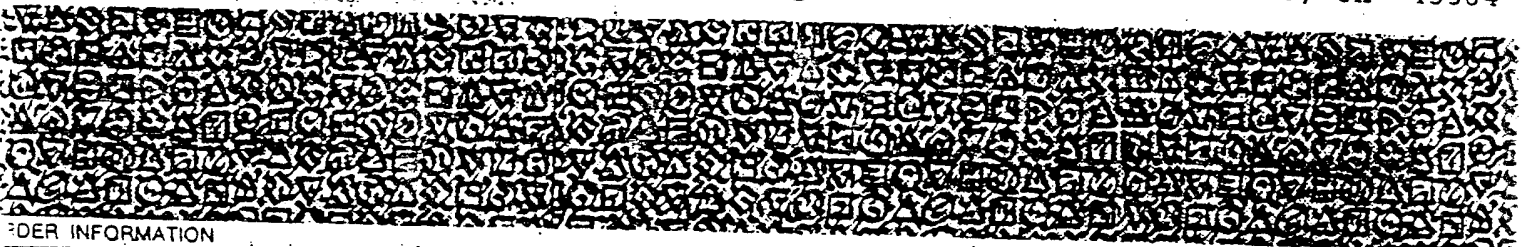

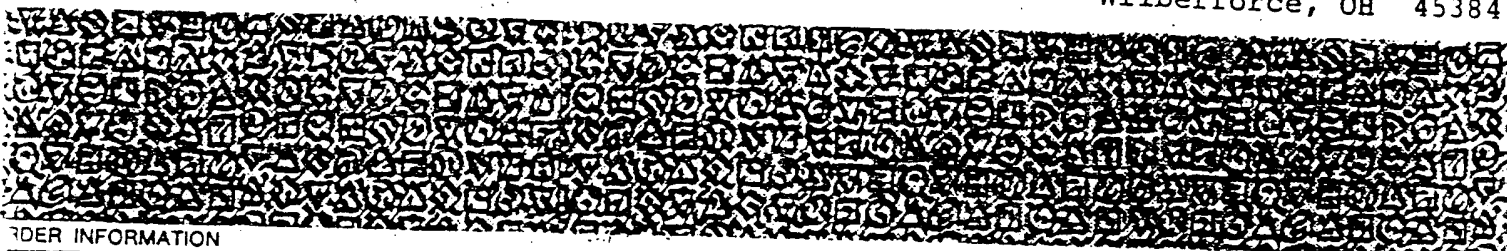
