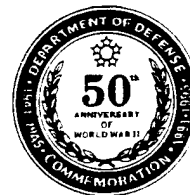



HC HD MI	2128	DATE, EFFECTIVE, LOGISTICS ACTION	0005 N	FIRST TWO POSITIONS INDICATE YEAR. LAST THREE POSITIONS INDICATE DAY OF YEAR AND MUST BE WITHIN THE RANGE OF 001 THROUGH 366. INPUT MUST REFLECT THE FIRST DAY OF A CALENDAR MONTH. FOR LDU INPUT THE DATE REFLECTED MUST BE A MINIMUM OF 30 DAYS AND CANNOT EXCEED THE MAXIMUM OF 120 DAYS FROM THE TRANSACTION DATE. LDU FOR DELETION OF DEFENSE NUCLEAR AGENCY (DNA), NATIONAL SECURITY AGENCY (NSA), DEFENSE INDUSTRIAL PLANT EQUIPMENT CENTER (DIPEC) INTEREST ONLY (LEVELS OF AUTHORITY (LOA) 07 AND 08), AND CIVIL AGENCY (LOAS 11 AND 48) RECORDINGS MAY BE ZERO EFFECTIVE DATED. LDU FOR DELETION OF NORTH ATLANTIC TREATY ORGANIZATION/FOREIGN GOVERNMENT(NATO/FG) RECORDINGS (LOA 81) MUST BE ZERO EFFECTIVE DATED OR BLANK. FOR SERVICE/AGENCY INPUT OF DOCUMENT IDENTIFIER CODES (DICS) LKD, LKU AND LKV, THE DATE MUST BE A MINIMUM OF 45 AND A MAXIMUM OF 120 DAYS FROM TRANSACTION DATE. FOR DLSC INPUT OF DICS LKD, LKU, AND LKV, THE DATE MUST BE A MINIMUM OF 90 AND A MAXIMUM OF 120 DAYS FROM TRANSACTION DATE UNLESS THE AFFECTED ITEM IS IN INACTIVE NO-USER STATUS AND SEGMENT H DATA IS NOT REQUIRED, THEN ZERO-EFFECTIVE DATE MAY BE USED.
