Purpose and Scope of Work

Through FY 1996, these funds provide for the equipment procured by Joint Staff Activities to include Command and Control Initiatives Programs (C2IP); Global Command and Control System (GCCS) through 1995; C4I for the Warrior (C4IFTW) starting in FY 1996; the Joint Warfighting Center (JWFC); ISLAND SUN (a Special Access Required program); CINC/Joint Models & Simulation; Joint Exercise evaluations; Pentagon Renovation Program; Joint Staff operations, such as the Automation Network; and Joint Analytical Model Improvement Program (JAMIP). In consonance with the National Performance Review and the Defense Performance Review, funding for noncentrally procured items has migrated to O&M. Therefore, FY 1997 procurement requests support only the following programs: C2IP, JAMIP and C4IFTW.

FY 1997 Justification of Funds

The C2IP, which was established in the 1987 Appropriations Act, provides funding for urgent command, control, and communications requirements. The C4IFTW program supports the Joint Warrior Interoperability Demonstrations (JWIDs) and Standardized Tactical Entry Point (STEP). The procurement for this effort started in FY 1996 and will support the Commanders of the Joint Task Forces (CJTFs) to communicate with his forces anywhere in the world. This procurement funding will also support the Joint Staff's management and directorate support efforts for various equipment initiatives. Finally, the JAMIP procurement will support the four-prong approach to upgrade the capability of joint modeling to accurately assess the capabilities of our forces and programs to execute US strategy within the constraints of limited resources.

The following programs will be funded in FY 1997: (1) Command and Control Initiatives Program (C2IP) which provide funding for urgent command, control, and communications requirements. The 1987 Appropriations Act established the Commander-in-Chief (CINC) C2IP funding for this purpose. The procurement instituted under this program results in discernible improvements in the readiness/combat capability of the command by virtue of the CINC's enhanced ability to command and control the forces assigned to him. The funds provide for such items as satellite communications for special operation forces communications, conversation kits for flagships to overcome CINCs' interoperability problems, command center improvements, and secure/voice/record travel communications.

(2) The C4IFTW promotes joint and coalition forces C4I interoperability. C4IFTW's three overlapping phases lead to global interoperability for US forces deployed anywhere, on any mission, at any time, with maximum flexibility in force composition. These procurement funds support this program in providing necessary hardware and connectivity. (3) JAMIP will improve the state of analytical models throughout the Department of Defense. The initiative proceeds with a four prong approach to upgrade the capability of joint modeling to accurately assess the capabilities of our forces. The procurement funds will support the Joint Staff contribution to the JAMIP initiative envisioned by DoD. (4) Directorate Support provides procurement funds for miscellaneous equipment purchases for the Joint Staff.

Decreased amounts from prior FYs include requirements for Global Command and Control System (GCCS) moving to Defense Information Service Agency (DISA); and the FY 1997 migration of procurement funding to O&M, Defense-Wide.

### D. REMARKS

Funds will be used for continuation of current projects to enhance the Intrusion Detection System (IDS) and the In-Place Monitoring System (IPMS) for the Joint Staff. These funds will be used to upgrade/replace the current alarm panel for an IDS that will cover more zones, which will be to support future vaulting requirements of the Joint Staff. Additionally, monitors and processors currently utilized by the Military Security Force Office to support alarm requirements for the National Military Command Center (NMCC) will require expansion/replacement since these systems have been in place for over ten years. These funds will also be used to upgrade/expand IPMS coverage within the restricted area and the Chairman's area using additional sensor system antennas and micro-processors. Finally, new areas currently under construction will require complete alarm systems and monitoring coverage.

**D. REMARKS**

To accomplish its mission, J-8 must develop increasingly complex and automated analytic capabilities in the areas of Joint Warfighting Capabilities Assessment, Conventional Forces Analysis, Nuclear Forces Analysis, Force Planning Analysis, and CINC Wargaming, as designated by Joint Chiefs of Staff and Congressional charter. Current systems supporting those analyses are approaching saturation in terms of data storage and processing power. Graphics output devices are continually upgraded and improved. This growth will be met by a phased procurement program that concentrates on obtaining graphics and high resolution workstations, higher density storage capacities and upgraded processors, along with faster, more capable work stations.
