Project repairs HVAC, life safety and handicap deficiencies, and interior of the avionics facility. This facility is over 30 years old and has an inadequate HVAC system, no fire suppression system, compromised fire walls, substandard protection of egress routes, inadequate access for the disabled, and deteriorated interior finishes. Inefficient functional layout also hinders the accomplishment of avionics maintenance. Without this project, avionics maintenance will continue to be marginally supported by an inefficient and substandard facility.

Project repairs 99th Squadron Operations Facility. Repairs include HVAC and electrical systems, interior revitalization by reconfiguring partition layout and replacing interior finishes, and asbestos abatement. This facility is 28 years old with obsolete/inefficient HVAC and electrical systems, and deteriorated interior finishes. The 99th Squadron Operations offices also are located in other base facilities. This project will enable consolidation of all squadron administrative functions. Without this project, this facility will continue to deteriorate, and physical separation of squadron offices will negatively impact their ability to function efficiently.

**Air Force Real Property (RPM) Requirements
(\$ in Thousands)**

In FY96, the Air Force began using the Commanders' Facility Assessment (CFA) to determine the Backlog of Maintenance and Repair (BMAR) of Real Property Maintenance (RPM). CFA links facility condition to mission accomplishment and ensures resources for maintenance, repair, and minor construction are allocated to the most critical mission needs of field commanders. CFA requires field commanders to identify RPM requirements in two categories.

First is Preservation Maintenance Level (PML), or "must pay" which identifies resources necessary to accomplish day-to-day maintenance required to preclude further deterioration of the real property facilities and infrastructure.

Secondly, commanders identify and prioritize (three levels) their remaining facility requirements to accomplish their mission. Level I of "Unsatisfactory" reflects deficiencies which, if not corrected, cause frequent mission interruptions, accelerate facility deterioration (resulting in high life cycle maintenance costs), curtail some operations or eliminate them altogether, and degrade livability and workplace conditions. Level II or "Degraded" deficiencies, if not corrected, impair mission support and require workarounds, thereby, reducing effectiveness of the workforce and speed deterioration of the facility. Level III or "Adequate" rated facilities do not impair mission accomplishment. However, these requirements improve operational productivity and reduce operating costs (facility consolidations, demolitions, and energy conservation measures).
