



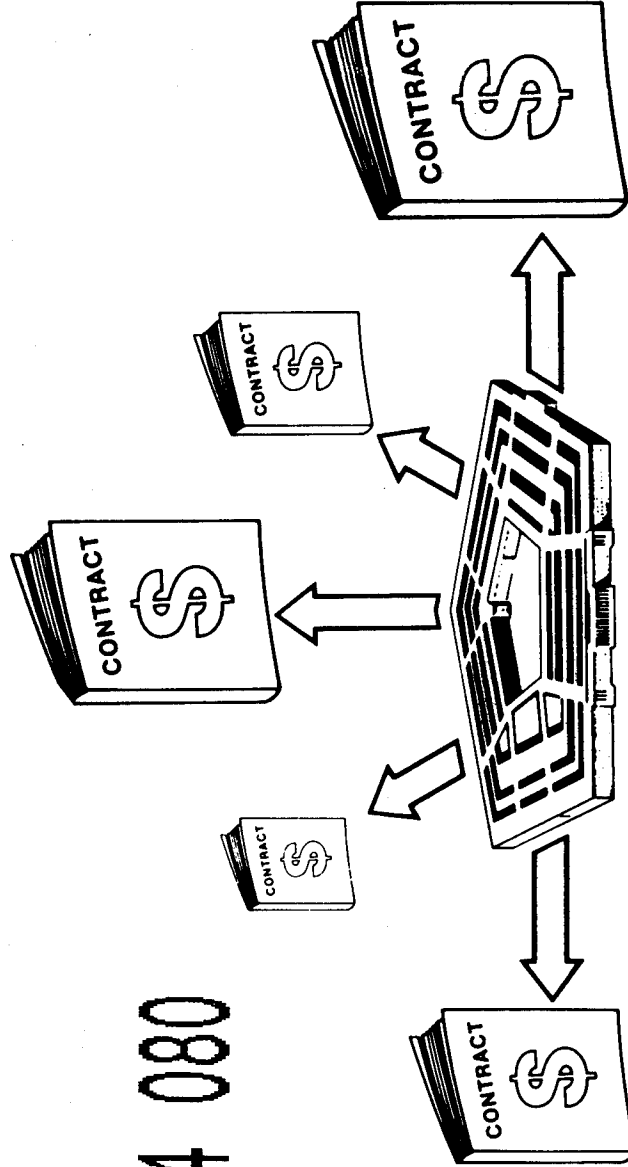

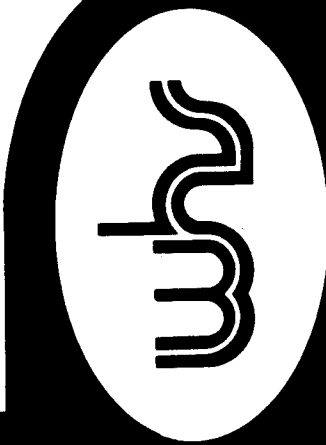

INTRODUCTION

This report provides data on prime contract actions (PCAs) over \$25,000 awarded by the Department of Defense (DoD) in fiscal year (FY) 1995. For reporting purposes, contracts have been distributed by dollar value into 11 different size categories. The tables provide information on the number of total actions, their net value, and their percentage of distribution, by size and according to a variety of categories. The categories include Defense Component, type of contract involved, extent of competed procurements, kind of contract action taken, selected procurement programs, and labor standard statutes. Table 1 presents data by individual size category (e.g., \$25,000 to \$49,999, \$50,000 to \$99,999) while Tables 2 through 7 present data in cumulative categories (e.g., \$25,000 or more; \$50,000 or more).

The information in *Prime Contract Awards, Size Distribution*, assists DoD management in projecting the workload that will be required by various proposed projects. For example, using data in this publication, DoD officials could determine that a proposal to review all contract actions of \$500,000 or more in FY 1995 would require examining approximately 43,000 transactions, or

18.4 percent of the total transactions as shown in Table 2. These data can also be used to identify trends in DoD procurement, (e.g., to identify which of the various types of contracts were most frequently awarded, in terms of number of contract actions, during FY 1995).

NOTES ON COVERAGE

Contract actions of \$25,000 or less are not included in this report. Additionally, interagency actions of \$25,000 or more (those actions placed by DoD with other Federal Agencies, except as footnoted in Table 4) are also excluded from this report, as are foreign military sales (FMS) actions (actions placed by DoD in support of foreign governments). However, orders under another Agency's contract are included in all tables of the publication.

The data represent new definitive awards as well as other types of transactions, including initial letter contracts, definitization of letter contracts, orders under contracts, funding actions, engineering changes, and terminations. Terminations and other downward adjustments of contracts are included in the award category to which their dollar amount corresponds. Both types are considered positive entries when calculating the total number of contract actions, but negative entries when calculating total net value.

Each transaction is assigned to a dollar size category based on its' absolute value (e.g., a transaction of a negative \$50,000 is equivalent to a positive \$50,000 as far as the size category and the number of transactions are concerned, but is added or subtracted in the dollar amount column based on its' true dollar value). Totals and percentages may not add up due to rounding.

HIGHLIGHTS

As indicated on the previous page, this report excludes all actions of \$25,000 or less, FMS actions, and, with the exception of Table 4, page 11, interagency actions of more than \$25,000. All DoD PCAs (over and under \$25,000) in FY 1995 totaled \$131,365 million. This is a decrease of \$854 million, or .6 percent less than the total amount in FY 1994. Also, in FY 1995 awards totaled 10,613,238 actions, which is a decrease of 603,325 actions, or 5.4 percent less than the FY 1994 figure. As shown in the following table, this report covers 81.1 percent of the procurement dollars and 2.2 percent of the actions awarded in FY 1995.

Prime Contract Awards by Defense Component

Tables 1 and 2, pages 7 and 8, provide data on PCAs by size range (individual ranges in Table 1, cumulative ranges in Table 2) according to Defense Component. As shown in the chart below, contract actions of \$25,000 to \$49,999 accounted for 27.5 percent of the total number of actions, but only 1.9 percent of the total dollars. Actions of \$1 million or more represented 74.4 percent of the total dollars, but only 12.2 percent of the actions. Actions of \$10 million or more accounted for 45.3 percent of the total dollars, but only 2.9 percent of the actions.

As shown in Table 2, actions of \$1 million or more accounted for 71.1 percent of the total Army procurement dollars, as compared with 76.1 percent for the Navy, 78.1 percent for the Air Force, 67.2 percent for the Defense Logistics Agency (DLA), and 55.8 percent for Army Corp of Engineers Civil Functions.

Prime Contract Awards by Type of Contract

As discussed above, data presented in this report have a variety of management uses. Data on the distribution of contracts by type of contract (e.g., firm fixed/fixed price economic price adjustment, fixed price incentive, or cost-plus fixed fee) are also used for analyzing DoD procurement patterns. Table 3, page 9, provides data on the net value and percent distribution of seven types of contract actions.

As shown in Table 3, actions of \$1 million or more accounted for 97.1 percent of the cost-plus incentive fee dollars, 97.1 percent of the dollars awarded on fixed price incentive dollars, 88.2 percent of the cost-plus award fee dollars, 73.3 percent of the fixed price redetermination dollars, and from 59.4 to 70.0 percent of the dollars for the remaining types of contracts.

As shown in the chart below, firm fixed/fixed price economic price adjustment contracts accounted for the highest percentage of actions, both in terms of the number of actions and total net value. Cost-plus fixed fee contracts represented the second largest category in terms of both number of actions, and total net value.

Prime Contract Awards by Extent of Competed Procurement

Table 4 displays information on the net value and percent distribution of PCAs according to extent of competed procurement. Competed contract actions accounted for 82.4 percent of the actions and 63.0 percent of the dollars. Actions not competed made up 14.8 percent of the actions and 27.9 percent of the dollars. Follow-on only accounted for 2.8 percent of the actions, but 9.1 percent of the dollars. (These percentages were all computed based on the Total Except Exclusions column of Table 4.)

Prime Contract Awards by Kind of Action

PCAs are arrayed according to kind of procurement action (e.g., initial letter contract or definitive contract superseding letter contract) in Table 5, page 12. As shown in Table 5, actions of \$1 million or more accounted for 96.0 percent for definitive contract superseding letter contracts, 93.8 percent of the dollars awarded for initial letter contracts, and from 47.1 to 82.8 percent of the dollars for the remaining kinds of procurement actions.

As shown in the chart below, contract actions other than modifications accounted for 65.8 percent of the actions and 51.8 percent of the dollars. Modifications to contracts accounted for 34.2 percent of the actions and 48.2 percent of the dollars.

Prime Contract Awards by Selected Procurement Programs

A procurement program designates a grouping of supplies, construction, or other services. When planned use is known at the time of purchase, a procurement program is assigned on the basis of the use of the supplies or work purchased (e.g., expenditure for maintenance tools peculiar to an aircraft would be included in the procurement program for aircraft, while general purpose production equipment would be grouped in the miscellaneous supplies procurement program). In Table 6, page 14, nine selected procurement programs have been developed for displaying information for management use.

Prime Contract Awards by Labor Standard Statutes

Table 7, page 16, deals with certain labor standard statutes applicable to DoD contract awards. Actions of \$1 million or more accounted for 86.1 percent of the dollars subject to the Walsh-Healey Act, Manufacturer; 64.5 percent of the Davis-Bacon Act dollars; 63.4 percent of the Service Contract Act dollars; and 53.7 percent of the Walsh-Healey Act, Regular Dealer dollars.

As shown in the chart below, 72.6 percent of the total dollars are subject to some form of labor standard statute.
