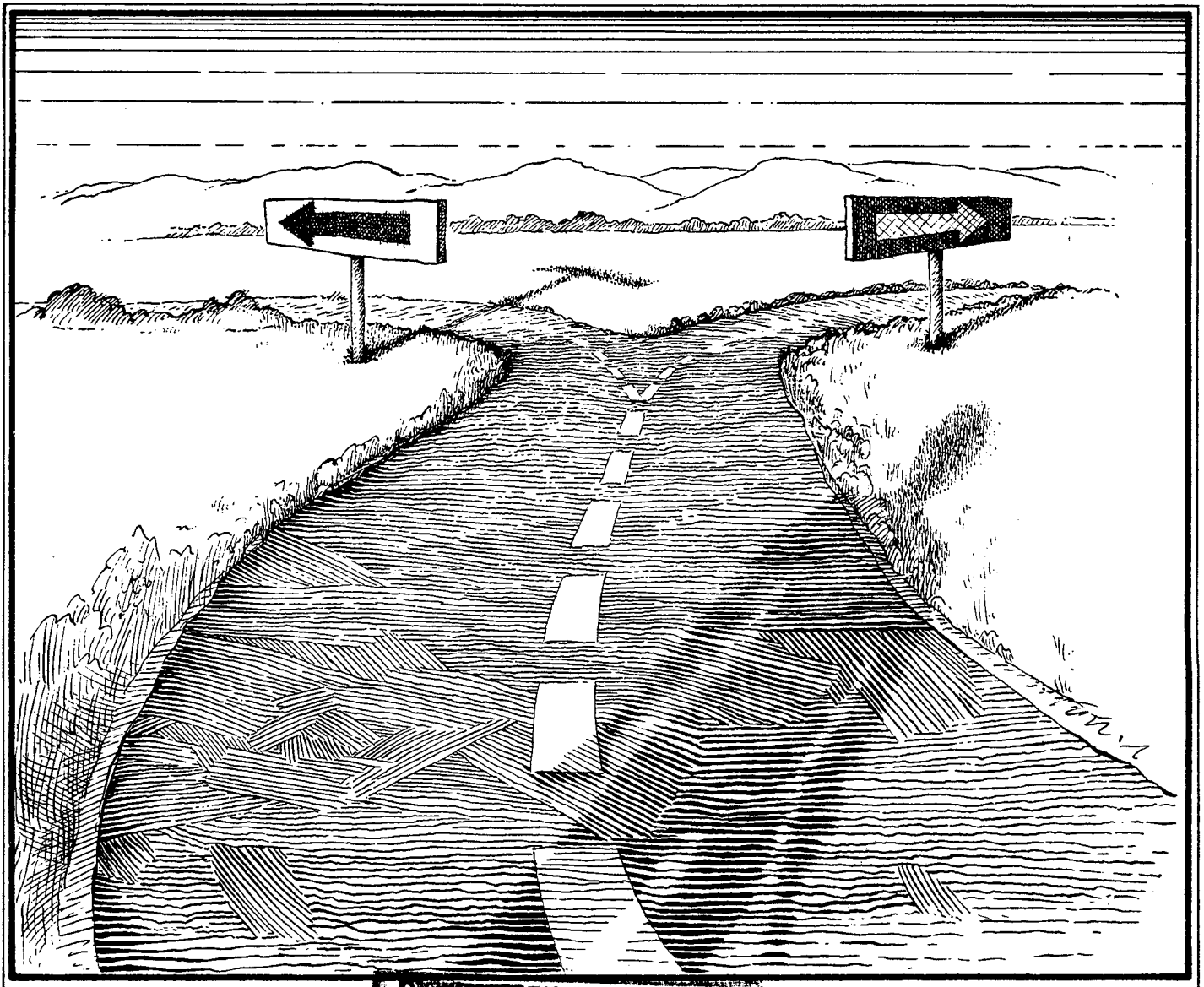

PREFACE

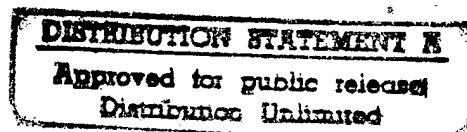
Ethics: A Selected Bibliography, now in its fourth revised edition, was compiled to support the study of ethics, one of the enduring curricular themes at the U.S. Army War College.
