

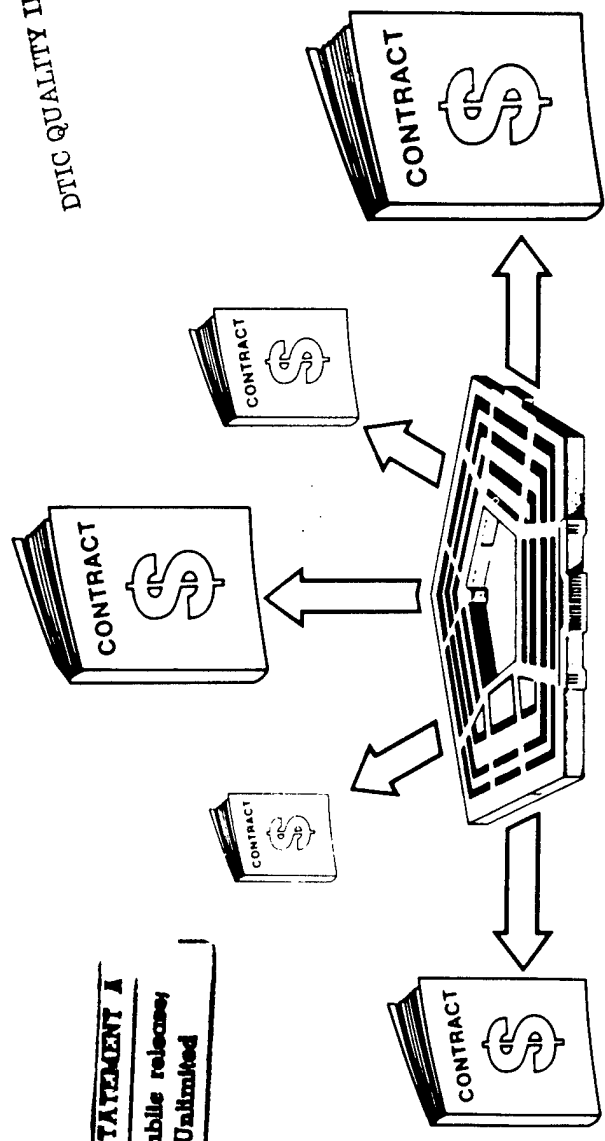

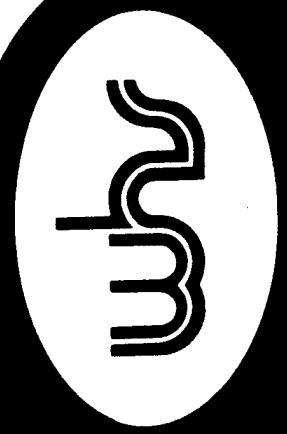

## INTRODUCTION

This report provides data on prime contract actions (PCAs) over \$25,000 awarded by the Department of Defense (DoD) in fiscal year (FY) 1997. For reporting purposes, contracts have been distributed by dollar value into 11 different size categories. The tables provide information on the number of total actions, their net value, and their percentage of distribution, by size, and according to a variety of categories. The categories include Defense Component, type of contract involved, extent of competed procurements, kind of contract action taken, selected procurement programs, and labor standard statutes. Table 1 presents data by individual size category (e.g., \$25,000 to \$49,999, \$50,000 to \$99,999) while Tables 2 through 7 present data in cumulative categories (e.g., \$25,000 or more; \$50,000 or more).

The information in *Prime Contract Awards, Size Distribution*, assists DoD management in projecting the workload that will be required by various proposed projects. For example, using data in this publication, DoD officials could determine that a proposal to review all contract actions of \$500,000 or more in FY 1997 would require examining approximately 26,000 transactions, or 11.3 percent of the total transactions as shown in Table 2. These data can also be used to identify trends in DoD procurement, (e.g., to identify which of the various types of contracts were most frequently awarded, in terms of number of contract actions, during FY 1997).

## NOTES ON COVERAGE

Contract actions of \$25,000 or less and consolidated awards greater than \$25,000 with more than one action (see Defense Federal Acquisition Regulation Supplement (DFARS) 204.670-6) are not included in this report. Additionally, interagency actions of \$25,000 or more (those actions placed by DoD with other Federal Agencies, except as footnoted in Table 4) are also excluded from this report, as are foreign military sales (FMS) actions (actions placed by DoD in support of foreign governments). However, orders under another Agency's contract are included in all tables of the publication.

The data represent new definitive awards as well as other types of transactions, including simplified acquisition procedures, letter contracts, orders under contracts/agreements, additional work, funding actions, change orders, and terminations. Terminations and other downward adjustments of contracts are included in the award category to which their dollar amount corresponds. Both types are considered positive entries when calculating the total number of contract actions, but negative entries when calculating total net value.

Each transaction is assigned to a dollar size category based on absolute value (e.g., a transaction of a negative \$50,000 is equivalent to a positive \$50,000 as far as the size category and the number of transactions are concerned, but is added or subtracted in the dollar amount column based on true dollar value). Totals and percentages may not add up due to rounding.

## HIGHLIGHTS

All DoD PCAs (over and under \$25,000) in FY 1997 totaled \$128,415 million. This is a decrease of \$3,763 million, or 2.8 percent less than the total amount in FY 1996. Also, in FY 1997 awards totaled 7,786,740 actions, which is a decrease of 919,986 actions, or 10.6 percent less than the FY 1996 figure. Increased use of the Government Purchase Card, not reported in the Defense Contract Action Data System, is the primary reason for the decline in the number of actions of \$25,000 or less. As shown in the following chart, this report covers 79.9 percent of the procurement dollars and 3.0 percent of the actions awarded in FY 1997.

## Prime Contract Awards by Defense Component

Tables 1 and 2, pages 7 and 8, provide data on PCAs by size range (individual ranges in Table 1, cumulative ranges in Table 2) according to Defense Component. As shown in the chart below, contract actions of \$25,000 to \$49,999 accounted for 33.5 percent of the total number of actions, but only 2.4 percent of the total dollars. Actions of \$1 million or more represented 73.4 percent of the total dollars, but only 6.0 percent of the total actions. Actions of \$10 million or more accounted for 44.6 percent of the total dollars, but only 0.6 percent of the total actions.

As shown in Table 2, actions of \$1 million or more accounted for 70.3 percent of the total Army procurement dollars, as compared with 75.1 percent for the Navy; 78.4 percent for the Air Force; 64.6 percent for the Defense Logistics Agency (DLA); and 54.7 percent for Army Corps of Engineers Civil Functions.

### Prime Contract Awards by Type of Contract

As discussed above, data presented in this report have a variety of management uses. Data on the distribution of contracts by type of contract (e.g., firm fixed/price economic price adjustment, fixed price incentive, or cost-plus fixed fee) are also used for analyzing DoD procurement patterns. Table 3, page 9, provides data on the net value and percentage distribution of seven types of contract actions.

As shown in Table 3, actions of \$1 million or more accounted for 97.2 percent of the cost-plus incentive fee dollars, 91.9 percent of the dollars awarded on fixed price incentive dollars, 88.4 percent of the cost-plus award fee dollars, 76.3 percent of the fixed price redetermination dollars, and from 54.2 to 70.3 percent of the dollars for the remaining types of contracts.

As shown in the chart below, firm fixed/price economic price adjustment contracts accounted for the highest percentage of actions, both in terms of the number of actions and total net value. Cost-plus fixed fee contracts represented the second largest category in terms of both number of actions, and total net value.

## Prime Contract Awards by Extent of Competed Procurement

Table 4, page 11, displays information on the net value and percentage distribution of PCAs according to extent of competed procurement. Competed contract actions accounted for 83.0 percent of the actions and 66.1 percent of the dollars. Actions not competed made up 15.6 percent of the actions and 28.3 percent of the dollars. Follow-on only accounted for 1.3 percent of the actions, and 5.6 percent of the dollars. (These percentages were all computed based on the Total Except Exclusions column of Table 4.)

## Prime Contract Awards by Kind of Action

PCAs are arrayed according to kind of procurement action (e.g., letter contract or simplified acquisition procedures) in Table 5, page 12. As shown in Table 5, actions of \$1 million or more accounted for 9.4 percent of the number of actions and 81.6 percent of the dollars awarded for modifications to contracts, and accounted for 4.0 percent of the number of actions and 64.1 percent of the dollars awarded for other than modifications to contracts.

As shown in the chart below, contract actions other than modifications accounted for 63.4 percent of the actions and 46.6 percent of the dollars. Modifications to contracts accounted for 36.6 percent of the actions and 53.4 percent of the dollars.

## Prime Contract Awards by Selected Procurement Programs

A procurement program designates a grouping of supplies, construction, or other services. When planned use is known at the time of purchase, a procurement program is assigned on the basis of the use of the supplies or work purchased (e.g., expenditure for maintenance tools peculiar to an aircraft would be included in the procurement program for aircraft, while general purpose production equipment would be grouped in the miscellaneous supplies procurement program). In Table 6, page 14, nine selected procurement programs have been developed for displaying information for management use.

## Prime Contract Awards by Labor Standard Statutes

Table 7, page 16, deals with certain labor standard statutes applicable to DoD contract awards. Actions of \$1 million or more accounted for 82.1 percent of the dollars subject to the Walsh-Healey Act; 68.4 percent of the Davis-Bacon Act dollars; and 65.2 percent of the Service Contract Act dollars.

As shown in the chart below, 66.6 percent of the total dollars are subject to some form of labor standard statute.
