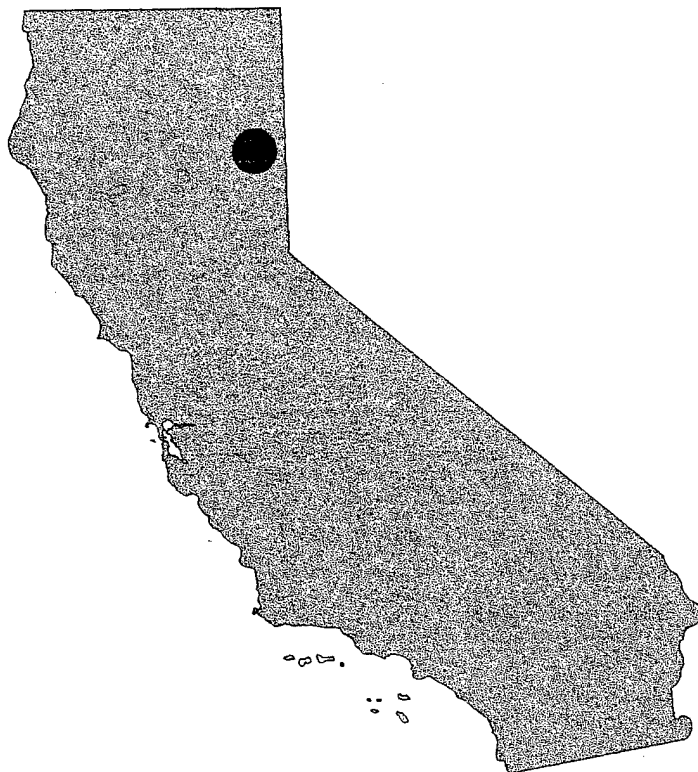

ABSTRACT (Maximum 200 words) The U.S. Army Environmental Center tasked the Mandatory Center of Expertise for the Curation and Management of Archaeological Collections (MCX) with the job of assisting the Army in complying with the Native American Graves Protection and Repatriation Act (NAGPRA), P.L. 101-601. The MCX was asked to locate and assess archaeological collections derived from Army lands, to identify the Native American or Native Hawaiian organizations culturally affiliated with the collections, and to draft Section 6 summary letters for each installation. A two-stage process was used to identify, locate and assess the contents of the collections, consisting of archival research and telephone interviews with the repository personnel. This report conveys the results of the collection research completed for the compliance with Section 6 of NAGPRA

OBJECTIVES AND METHODS

The U.S. Army Environmental Center (AEC) tasked the Mandatory Center of Expertise for the Curation and Management of Archaeological Collections (MCX) with the job of assisting Army installation personnel in complying with the requirements of the Native American Graves Protection and Repatriation Act (P.L. 101-601, NAGPRA). The MCX was asked to locate and assess archaeological collections derived from Army-owned lands, to identify the federally recognized Native American tribes most likely culturally affiliated with the collections, to draft Section 6 Summary letters for each installation, and to conduct physical inventories of any collections that contain human skeletal remains. This report conveys the results of the collections research completed to assist the Sierra Army Depot in complying with the Section 6 Summary requirements of NAGPRA.

The MCX used a two-stage process to identify, locate, and assess the contents of archaeological collections from the installation. First, archival research was performed to review all archaeological site records and reports for the installation. Second, telephone interviews were conducted with personnel at installations, universities, museums, and archaeological contractors that were identified during the archival research as possible repositories of Army collections. The MCX did not physically verify the existence of collections and, as such, the information contained in this report is based on background record reviews and information obtained via telephone interviews with the aforementioned installation personnel and institution professionals.

Archival research for Sierra Army Depot began with a search of the National Archeological Data Base (NADB) for references pertaining to the installation. This was followed by a thorough examination of all archaeological site forms and a literature review of all pertinent archaeological reports and manuscripts provided by the Northeast Center of the California Historical Resources Information System, Chico, California. The records search was performed and provided to the MCX in March 1995, and sought to identify any work on the installation that may have produced archaeological collections.

Subsequent telephone interviews to potential collections repositories ascertained whether the materials were present and the range of objects in each collection. Once the collections were located and assessed, MCX personnel identified federally recognized Native American tribes that are likely to be culturally affiliated with the materials in the collections. Draft Section 6 Summary letters are enclosed for each of these tribes (Appendix I), as well as a listing of each current tribal chairperson (Appendix II).

RESEARCH RESULTS

ARCHAEOLOGICAL INVESTIGATIONS AT SIERRA ARMY DEPOT

Archaeological work on Sierra Army Depot reportedly began in 1992 with a survey conducted by Phillip C. Green and Scott K. Olsen, Environmental Protection Specialists from the Environmental Management Division, Sierra Army Depot. The work consisted of a reconnaissance for a proposed LAN Fiber Optic Cable Route, and resulted in the recording of a single, large prehistoric archaeological site. Subsequent archaeological work on Sierra Army Depot between 1992 and the present has been performed by the following two groups:

Environmental Management Division, Sierra Army Depot, Herlong, California and INFOTEC Research, Inc., Fresno, California.

The Environmental Management Division of the Sierra Army Depot conducted two surveys on the Depot in 1993: a reconnaissance of a portion of the Honey Lake shoreline and a reconnaissance of a proposed natural gas pipeline. These projects, along with the cable route survey, resulted in the recording of 10 prehistoric sites and three isolated finds within the property boundaries of the Sierra Army Depot. Prehistoric stone tools and stone tool fragments were collected during all three projects, and a shell bead was recovered from the Honey Lake shoreline project.

INFOTEC Research conducted a survey in 1993 for the Tuscarora Gas Transmission Project. This project recorded nine historic sites, five of which are believed to be within the boundaries of the Sierra Army Depot (CA-Las-1701 and 1702, and temporary site numbers 18-1678, 1688, and 1697, as assigned by the Northeast Center of the California Historical Resources Information System, letter dated 28 March 1995). Historic materials such as metal, glass, and ceramics were encountered, but no material was collected during INFOTEC's survey. Far Western Anthropological Group, Reno, Nevada undertook subsequent testing and excavations for the Gas Transmission Project; however, no excavations were conducted on Depot property.

In addition to the 15 sites and three isolated finds discussed above, the Northeast Information Center, Chico, California, reported five other archaeological sites within the boundaries of Sierra Army Depot (CA-Las-46, 1686, 1687, 1689, and temporary site 18-1679). CA-Las-46 was recorded by F.A. Riddell in 1949 and the other four were recorded by INFOTEC during their 1993 Gas Transmission Project. Subsequent to receiving the information from the

Northeast Information Center, the MCX determined that these five sites are not located on the depot (archaeological site records: CA-Las-46, -1686, -1687, -1689, and temporary site #18-1679; Green *et al.* 1984:13; telephone conversations, John Colberg, Sierra Army Depot, December 14, 1995; Michael Moratto, INFOTEC, December 14, 1995; Kevin Darvell, U.S. Army Corps of Engineers, Sacramento, 18 December 1995).

In addition to the archaeological survey work on Sierra Army Depot, Wirth Environmental Services prepared an archaeological overview and management plan for the depot in 1984. A historic properties survey and report was undertaken in 1983 by Building Technology Incorporated, Silver Spring, Maryland. No archaeological collections were generated from these works.

SUMMARY OF ARCHAEOLOGICAL COLLECTIONS

A total of less than one cubic foot of artifacts and associated documentation has been reportedly collected from nine prehistoric sites on Sierra Army Depot. Artifacts recovered include stone tools, stone tool fragments, and a shell bead. As of the date of this report, the collections are located in the offices of the Environmental Management Division of the Sierra Army Depot.

The attached *Summary of Current Locations of Archaeological Collections from Sierra Army Depot* (Appendix III) provides detailed information about each collection derived as a result of archaeological investigations at the installation. A collection consists of all of the materials, artifacts, and associated documentation (e.g., field notes, maps, photos, data analyses, correspondence), produced as a result of an archaeological investigation or project at a single site or multiple sites. In some cases, the same archaeological site may have been investigated by various individuals or organizations. Depending on where the resulting collections are curated, they may be stored and identified as separate collections or separate components of a single collection. In cases where the artifacts and records have become separated, we list the records collections repository as well. Every attempt has been made to locate all collections cited on available archaeological site records or in published and unpublished references to archaeological investigations on the installation.

NAGPRA-Related Items

No known human skeletal remains or funerary objects were encountered during the documentation review and telephone interviews. Sacred objects or objects of cultural patrimony among the Sierra Army Depot collections may be established upon further consultation with culturally affiliated Native American tribes according to the definitions and restrictions specified in NAGPRA.

REFERENCES TO ARCHAEOLOGICAL INVESTIGATIONS

Two sets of references regarding archaeological work conducted on Sierra Army Depot are attached: Appendix IV contains the list of references reviewed by the MCX during its archival research; and Appendix V is the list of references contained in the National Archeological Data Base (NADB).

NATIVE AMERICAN TRIBES ASSOCIATED WITH SIERRA ARMY DEPOT

Sierra Army Depot, midway between Reno, Nevada and Susanville, California, is located east of the Sierra Nevada Mountains and adjacent to the eastern Honey Lake shoreline in Lassen County, California. Sierra Army Depot falls at the western edge of the Great Basin culture area, which was one of the last areas to be impacted by westward Euroamerican expansion (d'Azevedo 1978a). Three reports prepared for archaeological work on the depot recorded two Great Basin tribes, the Northern Paiute and Washoe, as being historically located in the region (Green 1992, 1993a, 1993b). In addition, further literature review identified the Maidu tribe of California, as well as the Northern Paiute and Washoe, as having possible aboriginal territories or subsistence/trade routes encompassing the area now occupied by the depot (Bibby 1994; d'Azevedo 1994; Fowler 1994:422; Johnson 1993:127; Clemmer and Stewart 1978; d'Azevedo 1978a, 1978b; Fowler and Liljeblad 1978:435; Riddell 1978).

Early in the nineteenth century, the Northern Paiute occupied a vast area from Mono Lake, California in the south, to the John Day River, Oregon in the north. The northern end of this territory was approximately 400 miles wide, tapering to a width of about 75 miles just below Mono Lake. The western border of their territory roughly paralleled the eastern slopes of the Sierra Nevada and Cascade mountains, and the eastern limit continued from the east side of Mono Lake diagonally north through central Nevada, to the outlets of the Wieser and Powder Rivers along the present-day Oregon-Idaho border (Fowler 1994:422; Johnson 1993:127; Fowler and Liljeblad 1978:435). Archaeological evidence for this occupation does not extend significantly earlier than A.D. 1000, but has been shown to be consistent from that date through historic times. Bands of Northern Paiute occupied more variable territories in the northern end of the Paiute range compared to those in the southern end nearer to California. Aboriginally, this variability is thought to be related to differences in ecological zones, while historically, the difference appears to be related to the earlier acquisition of the horse by bands in Oregon (Fowler and Liljeblad 1978:454-455).

In 1859, the federal government began setting aside reserved lands for the Northern Paiute people. Many people, however, refused to leave their homelands, so that well into the twentieth century, additional colonies were established by different bands throughout the region, primarily on the outskirts of Euroamerican settlements (Fowler 1994:422; Fowler and Liljeblad 1978:457).

Original Washoe territory comprised an area of more than 4,000 square miles in present-day California and Nevada, from Honey Lake in the north to Antelope Valley in the south, and from the Sierra Nevadas in the west, to the Virginia and Pinenut ranges to the east. Their core homeland encompassed the areas surrounding Lake Tahoe, extending northward to the southern edge of Honey Lake. Additional hunting and gathering ground has been identified surrounding this core, including areas to the east of Honey Lake (d'Azevedo 1994:685-689; Johnson 1993:134; D'Azevedo 1978b:467; Clemmer and Stewart 1978:538).

Based on linguistic and ethnographic evidence, the Washoe are believed to have had long tenure in their known area of historic occupation, and their presence is believed to have predated the arrival of their Numic-speaking neighbors, including the Northern Paiute. However, the Washoe and their neighbors are believed to have occupied a somewhat open range, and there is no evidence that they regularly defended or excluded others from this region. Much of the Washoe subsistence range, including the Honey Lake area, was jointly used by adjacent non-Washoe people or provided a corridor for trade and travel. The Washoe and Northern Paiute jointly used fishing and gathering sites around Honey Lake eastward to Pyramid Lake, and although northern Washoe tradition reveals a distrust of the Maidu, the two groups shared use of sections of Sierra Valley and Honey Lake Valley. Land allotments to the Washoe peoples began late in the nineteenth century, and in 1917 (d'Azevedo 1994:687; d'Azevedo 1978: 467-470).

Maidu, a linguistic family of north central California, can be subdivided into three tribes: the Maidu (or Northern Maidu), who occupied the upper reaches of the Feather River south of Eagle Lake around Susanville, Butte Valley, and Quincy; the Konkow who lived on the east side of the Sacramento River around Chico; and the Nisenan (or southern Maidu) who occupied the valleys of the Yuba, Bear, and American Rivers surrounding Marysville, Nevada City, Placerville, and Auburn (Bibby 1994:325; Johnson 1993:136; Riddell 1978:370-371).

The Maidu penetration into the Great Basin region was believed to have been greater in earlier times than at first American contact around 1850. Traditionally, the Maidu claim the entire Honey Lake Valley, although they withdrew to the west side of Honey Lake possibly circa 1700 AD. The vacated area was taken over by the Northern Paiute. Although differences of opinion as to tribal territory between Maidu and their Great Basin neighbors may exist, the border areas of value for hunting and gathering may have been used by both the Maidu and their neighbors (Riddell 1978:372).

During the early portion of the twentieth century, most of the Maidu population lived on the outskirts of American towns in present-day Plumas and Lassen Counties, California. Beginning at this time, a series of acts were passed by Congress to purchase tracts of land for "homeless Indians" in California. Small reservations, often called rancherias, were purchased. All of the current, as well as terminated, rancherias within the Maidu area were established through this process (Bibby 1994:325; Johnson 1993:136; Riddell 1978:386).

Many Native American tribes have made claims for compensation for lands lost by treaty or other means. This process has resulted in judicial decisions defining the extent of land that a tribe had exclusively occupied and used for an extended period of time. These are known as "Indian Land Areas Judicially Established," and hereafter will be referred to as adjudicated lands. Sierra Army Depot is located on lands adjudicated to the Northern Paiute, whose adjudicated lands occupy portions of eastern California, western Nevada and southeastern Oregon (U.S.G.S. n.d.). The Washoe were adjudicated lands immediately south of the Depot, in the area surrounding Lake Tahoe in both California and Nevada (U.S.G.S. n.d.).

SECTION 6 COMPLIANCE

P.L. 101-601 (NAGPRA) requires that federal agencies engage in active consultation with Native Americans of federally recognized tribes and/or lineal descendants who may be culturally affiliated with the archaeological collections from the installation. Enclosed are draft NAGPRA Section 6 Summary letters (Appendix I) and a list of the tribal chairpersons from the federally recognized tribes that may be culturally affiliated with the collections (Appendix II).

For the Native American groups discussed in the previous section, there are 22 tribes and four component bands that are federally recognized (Department of the Interior 1995):

A number of potentially relevant Native American groups are currently in various stages of petitioning for federal recognition, but as yet, are not federally recognized. Letters of intent to petition have been filed by the following Northern Paiute groups: Antelope Valley Paiute Tribe, Mono Lake Indian Community, Wadatuht Band of Northern Paiutes of the Honey Lake Valley, and Washoe/Paiute of Antelope Valley. The Maidu Nation currently has an incomplete petition filed with the Bureau of Indian Affairs (Bureau of Indian Affairs 1995).

Initial consultation should be conducted on a government-to-government basis. Refer to P.L. 101-601 (NAGPRA) for specifics on required Native American consultation and the legal definitions of items subject to NAGPRA.

I am writing to inform you of archaeological collections held by Sierra Army Depot that may contain Native American cultural items, as defined by the Native American Graves Protection and Repatriation Act (NAGPRA), that are, or are likely to be, culturally affiliated with the Northern Maidu. Sierra Army Depot has documented these archaeological collections in a Summary in accordance with the requirements of Section 6 of NAGPRA.

Sierra Army Depot is responsible for collections that include less than one cubic foot of material housed at the Sierra Army Depot. These archaeological collections were generated from three surveys conducted by the Environmental Management Division of Sierra Army Depot in 1992 and 1993. The collections consist of prehistoric stone tools, stone tool fragments, and a shell bead, as well as collections documentation such as field notes and reports. No known human skeletal remains or funerary objects were encountered during a review of the collections documentation.

We are notifying the Berry Creek Rancheria because some of these materials were found near the area thought to be part of the territory occupied or used aboriginally by the Northern Maidu members of your community. In accordance with Section 6 of NAGPRA, we are inviting you to consult with us regarding these archaeological collections. Upon your written request, we will provide you access to review our records, catalogues, relevant studies, or other pertinent data for the purpose of determining the geographic origin, cultural affiliation, and basic facts surrounding acquisition and accession of these collections.
