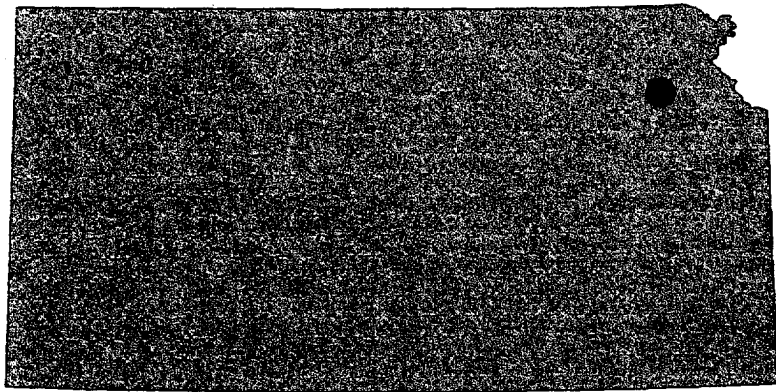

The MCX was asked to locate and assess archaeological collections derived from Army lands, to identify the Native American or Native Hawaiian organizations culturally affiliated with the collections, and to draft Section 6 summary letters for each installation. A two-stage process was used to identify, locate and assess the contents of the collections, consisting of archival research and telephone interviews with the repository personnel. ## OBJECTIVES AND METHODS

The U.S. Army Environmental Center (AEC) tasked the Mandatory Center of Expertise for the Curation and Management of Archaeological Collections (MCX) with the job of assisting Army installation personnel in complying with the requirements of the Native American Graves Protection and Repatriation Act (P.L. 101-601, NAGPRA). The MCX was asked to locate and assess archaeological collections derived from Army-owned lands, to identify the federally recognized Native American tribes most likely culturally affiliated with the collections, to draft Section 6 Summary letters for each installation, and to conduct physical inventories of any collections that contain human skeletal remains. This report conveys the results of the collections research completed to assist Fort Leavenworth in complying with the Section 6 Summary requirements of NAGPRA.

The MCX used a two-stage process to identify, locate, and assess the contents of archaeological collections from the installation. First, archival research was performed to review all archaeological site records and reports for the installation. Second, telephone interviews were conducted with personnel at installations, universities, museums, and archaeological contractors that were identified during the archival research as possible repositories of Army collections.

Archival research for Fort Leavenworth began with a search of the National Archeological Data Base (NADB) for references pertaining to the installation. This was followed by a thorough examination of all archaeological site forms and a literature review of all pertinent archaeological reports and manuscripts on file at the Kansas State Historical Society in Topeka, Kansas. The records search was performed in April 1995 and sought to identify any work on the installation that may have produced archaeological collections.

Subsequent telephone interviews to potential collections repositories ascertained whether the materials were present and the range of objects in each collection. Once the collections were located and assessed, MCX personnel identified federally recognized Native American tribes that are likely to be culturally affiliated with the materials in the collections. Draft Section 6 Summary letters are enclosed for each of these tribes (Appendix I), as well as a listing of the current tribal chairperson (Appendix II).

The attached *Summary of Current Locations of Archaeological Collections from Fort Leavenworth* (Appendix III) provides detailed information about each collection derived as a result of archaeological investigations at the installation. A collection consists of all of the materials, artifacts and associated documentation (e.g., field notes, maps, photos, data analyses, correspondence), produced as a result of an archaeological investigation or project at a single site or multiple sites. In some cases, the same archaeological site may have been investigated by various individuals or organizations. Depending on where the resulting collections are curated, they may be stored and identified as separate collections or separate components of a single collection. In cases where the artifacts and records have become separated, we list the records collections repository as well.

Every attempt has been made to locate all collections cited on available archaeological site records or in published and unpublished references to archaeological investigations on the installation.

### **NAGPRA Related Materials**

No funerary objects were identified in a thorough review of the archaeological records, associated literature, and telephone interviews. The final examination of sacred objects or objects of cultural patrimony may be established by the associated Native American tribes (if determined to be culturally affiliated and the objects meet the definitions and restrictions specified in NAGPRA) upon further deliberation.

In 1966, three human pelvis fragments and associated artifacts (a burned antler fragment, a stone projectile point, a stone drill fragment, and chipped stone flakes), were excavated on Fort Leavenworth. They are presently curated at the Kansas State Historical Society.

### **REFERENCES TO ARCHAEOLOGICAL INVESTIGATIONS**

Two sets of references regarding archaeological work conducted on Fort Leavenworth are attached: Appendix IV contains the list of references reviewed by the MCX during its archival research; and Appendix V is the list of references contained in the National Archeological Data Base (NADB).

## NATIVE AMERICAN TRIBES ASSOCIATED WITH FORT LEAVENWORTH

The cultural affiliation for the artifacts collected from Fort Leavenworth was not stated in the reports or site files, however there is ethnographic evidence of Native American groups in the area. The federally recognized Native American tribes which claim aboriginal land on or bordering Fort Leavenworth are the Otoe and Missouri, the Iowa, the Omaha, and the Sac and Fox (U.S.G.S. n.d.; Peterson and Otter n.d.:6-17).

Other federally recognized Native American groups that resided aboriginally near the Fort Leavenworth area are the Kansa (or Kaw) (Unrau 1994:285) and the Osage (Wilson 1994:411-412; Peterson and Otter n.d.:6-17). Other groups that moved through the area in historic times are the Delaware (or Lenape), the Miami, and the Wyandot (or Wyandotte), the Loyal Shawnee, and Nez Perce (Clark 1994; Miller 1994; Trafzer 1994; Waldman 1985,1988; Peterson and Otter n.d.; Hacker 1994; Neely 1994). The Kickapoo (Stull 1994) and the Potawatomi (Neely 1994) received federally recognized reservations in Kansas in the late 19th Century.

The Otoe originally resided in eastern Nebraska, and the Missouri were located in the Lower Missouri River Valley as far south as present day Kansas City. In 1825, both tribes were resettled on a reservation in southern Nebraska and northern Kansas (Edmunds 1994:412-413; Peterson and Otter n.d.:6-17). Then in 1876 and 1881, they were moved to north central Oklahoma where they reside today (Edmunds 1994:412-413). The Otoe-Missouria have been adjudicated lands in northeast Nebraska, southwest Iowa and the northeast corner of Missouri (U.S.G.S. n.d.).

The Iowa are believed to originate from the Great Lakes region. They moved to what is now Iowa before recorded history (Waldman 1988:102-103; Peterson and Otter n.d.:6-17). The Iowa now reside on two reservations: the Iowa Tribe of Kansas and Nebraska reside in the extreme northeast corner of Kansas, near White Cloud, and the Iowa Tribe of Oklahoma in Perkins, Oklahoma (Foster 1994:276-277). The Iowa have been adjudicated lands in northwest Missouri and southern Iowa (U.S.G.S. n.d.).

The ancestors of the Omaha Tribe lived east of the Lower Ohio River Valley in what is now Indiana and Kentucky. In the 1770's they settled on the Missouri River near Homer, Nebraska (Waldman 1985:39; Ridington 1994:406-407). Then in 1854, they moved to a reservation in northeast Nebraska where they reside today (Ridington 1994:406-407). The Omaha Tribe has been adjudicated lands in northeast Nebraska, the northwest Missouri and Southwest Iowa (U.S.G.S. n.d.).

The Sac and Fox Tribe occupied present-day Michigan and Wisconsin in the Great Lakes region. In 1804, they were removed to Iowa, and then in 1861 forced into Kansas (Grant

Oklahoma (Trafzer 1994:700-701). The Wyandot have adjudicated land in northern Ohio (U.S.G.S. n.d.).

The Shawnee originated in the Ohio River Valley, but after the death of the Shawnee leader Tecumseh in 1813, the various bands split apart and began to migrate south and west. The group known as the Loyal Shawnee resided in northeastern Kansas until they were removed to Oklahoma in 1872. They are not a federally recognized tribe but since moving to Oklahoma, they have become affiliated with the federally recognized Cherokee Nation (Hacker 1994:585-586; Neely 1994:584-585).

Additionally, a number of Nez Perce were held on Fort Leavenworth as prisoners of war in the late 1800's. The Nez Perce are a federally recognized tribe and reside on reservations in Idaho and Washington (Waldman 1985:136; 1988:158-161).

The Kickapoo inhabited southern Wisconsin when Europeans first came in contact with them in 1667. In 1832, they were removed to a newly created reservation in northeastern Kansas, forty miles north of Topeka in Brown County where many reside today (Stull 1994:286-287). The Kickapoo have been adjudicated lands in north central Illinois (U.S.G.S. n.d.).

And lastly, the Prairie Band of the Potawatomi have roots in the southern Great Lakes region (Waldman 1985:193; Stull 1994:464-466). Sometime between the 1830s (Edmunds 1994:469) and 1847 (Stull 1994:464), they were moved to a reservation in northeastern Kansas, in Jackson County, approximately forty miles west of Fort Leavenworth. In 1861, the Citizen Band of Potawatomi split from the Prairie Band and moved to Oklahoma (Edmunds 1994:469). Both groups are federally recognized.

## SECTION 6 COMPLIANCE

P.L. 101-601 (NAGPRA) requires that federal agencies engage in active consultation with Native Americans with federally recognized tribes and/or lineal descendants who may be culturally affiliated with the archaeological collections from the installation. Enclosed are draft NAGPRA Section 6 summary letters (Appendix I) and a list of the tribal chairpersons from the federally recognized tribes which may be culturally affiliated with the collections (Appendix II).

Initial consultation should be conducted on a government-to-government basis. Refer to P.L. 101-601 (NAGPRA) for specifics on required Native American consultation and the legal definitions of items subject to NAGPRA.
