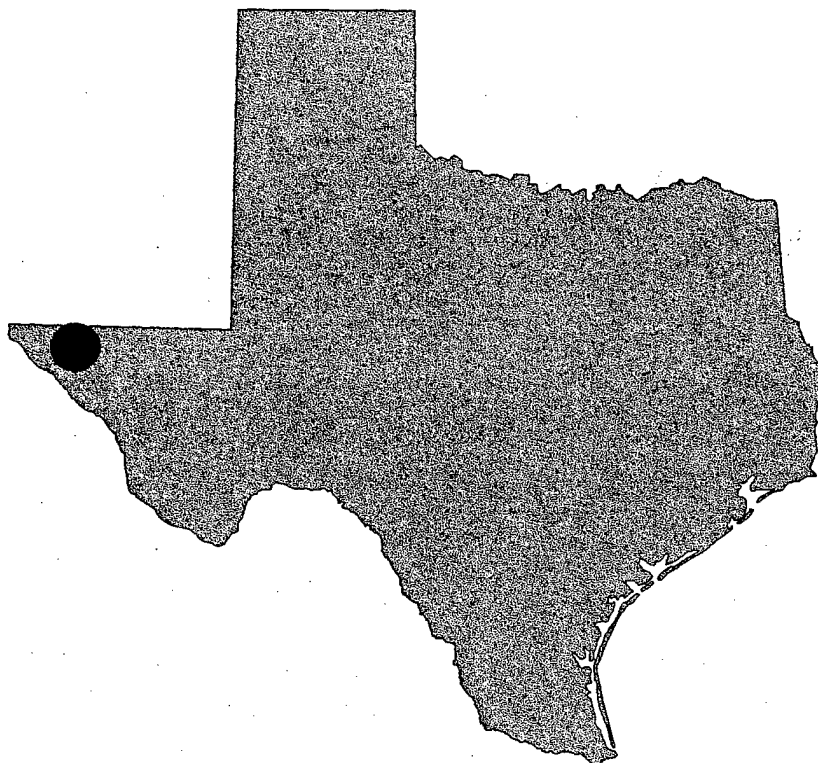

ABSTRACT <i>(Maximum 200 words)</i> The U.S. Army Environmental Center tasked the Mandatory Center of Expertise for the Curation and Management of Archaeological Collections (MCX) with the job of assisting the Army in complying with the Native American Graves Protection and Repatriation Act (NAGPRA), P.L. 101-601. The MCX was asked to locate and assess archaeological collections derived from Army lands, to identify the Native American or Native Hawaiian organizations culturally affiliated with the collections, and to draft Section 6 summary letters for each installation. A two-stage process was used to identify, locate and assess the contents of the collections, consisting of archival research and telephone interviews with the repository personnel. This report conveys the results of the collection research completed for the compliance with Section 6 of NAGPRA

Fort Bliss also supplied the MCX with a 27 October 1994 memo to Mr. Keith Landreth, Fort Bliss Historic Preservation Officer. In the document, Mr. James Bowman, Fort Bliss Cultural Resources Branch, outlines the results of NAGPRA-related research conducted by Mr. Bowman and Mr. Mark T. Bentley. Mr. Bowman and Mr. Bentley identified a total of 39 Native American burials and two funerary objects from sites that have been within the property boundaries of Fort Bliss. The information contained in the memo, as well as telephone conversations to Mr. Bowman, Mr. Bentley, and Mr. Paul Lukowski of Fort Bliss, was utilized extensively in preparing this report. In addition, telephone interviews to potential collections repositories off-post ascertained whether the materials were present and the range of objects in each collection. All information presented in this report under NAGPRA-Related Materials combines the information gathered by the MCX with that provided in the above mentioned memo and telephone conversations.

Once the collections were located and assessed, MCX personnel identified federally recognized Native American tribes that are likely to be culturally affiliated with the materials in the collections. Draft Section 6 Summary letters are enclosed for each of these tribes (Appendix I), as well as a listing of the current tribal chairpersons (Appendix II).

RESEARCH RESULTS

ARCHAEOLOGICAL INVESTIGATIONS AT FORT BLISS

Archaeological work began on current Fort Bliss property in the late 1920s with surveys and research excavations conducted primarily by C.B. Cosgrove, William A. Bryan, Henry Wylde, and Wesley Bliss. During the 1960s, most of the archaeological work on Fort Bliss was conducted by local non-professional archaeologists of the El Paso Archaeological Society (EPAS). Presently, there are at least 14,703 known archaeological sites on the Fort. Extensive survey, testing, excavation, and reporting between 1970 and the present has been performed by:

Fort Bliss occupies approximately 1.2 million acres of land in Texas and New Mexico. Of this land, over 600,000 acres is called the McGregor Range. The McGregor Range is federally withdrawn land, of which the majority is owned by the U.S. Department of the Interior, Bureau of Land Management (BLM). The U.S. Department of the Army, Headquarters, U.S. Army Air Defense Artillery Center, and Fort Bliss possess 71,083 acres of fee-owned land on the McGregor range; that is, they have title to the land (telephone conversations, Bill Tipton, Fort Bliss Real Estate Branch 29 August 1995; Tim Murphy, Area Manager, Caballo Area, Las

Cruces District BLM, 30 August 1995). A Memorandum of Understanding (MOU) between the BLM and Fort Bliss defines the responsibilities of each agency for cultural resources.

The nature and extent of collections from BLM archaeological work on the McGregor Range is not known to the MCX. The MOU contains no provisions regarding NAGPRA. The BLM has completed NAGPRA compliance for all collections generated as a result of BLM archaeological work on the McGregor Range. This material is housed at the Museum of New Mexico, Santa Fe, New Mexico (telephone conversation, Teresa Hanley, Lead Archaeologist, Caballo Area, Las Cruces District BLM, 6 September 1995). To the MCX's knowledge, BLM's NAGPRA compliance work did not include any of the collections mentioned below.

SUMMARY OF ARCHAEOLOGICAL COLLECTIONS

A total of approximately 2,000 ft³ of archaeological material has been collected from the archaeological sites on Fort Bliss. The majority of this material (>1800 ft³) is housed on Fort Bliss in Building 622. The remaining archaeological material is believed to be located in the following six known repositories:

The archaeological sites on Fort Bliss are both historic and prehistoric. The historic sites have yielded five different classes of collected materials: faunal, metal, glass, pottery, and building materials. Materials collected from the prehistoric sites included fauna, flora, flaked stone chipping debris, stone tools, ceramics, fire cracked rock, and charcoal. In addition, Native American skeletal remains and funerary objects have been found and collected at a number of sites (see NAGPRA-Related Materials).

The attached *Summary of Current Locations of Archaeological Collections from Fort Bliss* (Appendix III) provides detailed information about each collection derived as a result of archaeological investigations at the installation. A collection consists of all of the materials, artifacts and associated documentation (e.g., field notes, maps, photos, data analyses, correspondence), produced as a result of an archaeological investigation or project at a single site or multiple sites. In some cases, the same archaeological site may have been investigated by various individuals or organizations. Depending on where the resulting collections are curated, they may be stored and identified as separate collections or separate components of a single collection. In cases where the artifacts and records have become separated, we list the records collections repository as well.

Every attempt has been made to locate all collections cited on available archaeological site records or in published and unpublished references to archaeological investigations on the installation.

NAGPRA-Related Materials

A total of 16 known sites that have been located within the property boundaries of Fort Bliss have produced human skeletal remains and/or funerary objects. Four of these sites contain burials that have not been excavated and are currently *in situ* on Fort Bliss. In addition, due to the changes in land ownership through time, burials were excavated from four sites prior to property ownership by Fort Bliss. A brief synopsis by site number is provided below within these three categories:

1. Sites Excavated On Lands During Occupation by Fort Bliss:

- a) FB6271 (M-170): In May 1982, the skeletal remains of three individuals were observed at site FB6271. At that time, collections were made from Burial 1 (skull fragments, limb bones, and portions of the pelvic girdle) and Burial 3 (one femur). In June 1982, Burial 2 was excavated. During this excavation, a small brownware sherd was found near the knee of the individual. Two of the three burials (Burials 1 and 2) were analyzed by Marilyn London at the University of New Mexico, Albuquerque in 1982.
- b) FB6281 (Meyer Pit House Village): Vernon L. Scarborough (1985) reported that one burial without funerary objects was observed from FB6281. Although the site form does not indicate that human bone was collected, an Archaeological Site Catalog indicates that a burial was collected on 1 November 1984, and Mr. Paul Lukowski at Fort Bliss and Vernon L. Scarborough believes that the burial was removed (telephone conversations 24 August 1995 and 11 October 1995).
- c) FB6873 (Sergeant Doyle Site): EPAS excavated two burials in 1968. The collections from the first burial, an adult male, included human skeletal remains and an "El Paso Polychrome olla fragment." Only the upper jaw and teeth were recovered from the second burial, a child of about two years of age.
- d) FB9204 (Bishop's Cap Cave, a.k.a. Conkling Cave): In 1929, human bone fragments from an undetermined number of individuals were collected by William A. Bryan, Henry Wylde, and others of the Los Angeles County Museum of Natural History, Los Angeles, California. In addition, Henry Wylde collected a partial human skeleton and a number of artifacts (including lithics, fiber, fauna, and charcoal) from "A Ledge Site Near Conkling Cave." There is no site number for this material, but the site is recorded to be two miles north of Bishop's Cap Cave and may be located on Fort Bliss.

- e) FB9287 (M-83): Two burials were collected by the University of Texas, Austin in August 1975.
- f) FB9569 (Escondido Pueblo): Initial recording and collection of the site was conducted by EPAS in 1962. During excavations in December 1975, human skeletal fragments, from a looted pit, were recovered from the site along with lithics, sherds, and charcoal. The burial had apparently been removed by pothunters.
- g) FB9692 (Range 50): One burial and a number of funerary objects were collected during a survey in 1985 by Mr. Paul Lukowski and Mr. Chuck Haight.
- h) FB10533 (McGregor Pueblo): EPAS collected skeletal fragments from one individual and an associated Terra Cotta bowl in 1963. In addition, a child interment apparently had been collected from the site by looters.
- i) FB14500: Two burials were discovered during blading in Maneuver Area 2B. One of these was excavated by Jeff Leach and Dayna Potter, and the other remains in the ground. No associated objects were noted.
- j) 41EP6 (Northgate Site): Three burials have been collected from the Northgate Site. One burial was excavated by Les Davis in 1966 and another by Lawrence Aten in 1972. A child burial was removed by looters. There may be another burial associated with the site (reported by Charles Koerner in 1966 as excavated by Jack Hedrick and others), but this requires further investigation by the MCX. The Northgate site is no longer located on Fort Bliss property, but the human remains were collected during Fort Bliss' ownership of the property.

The above human skeletal material and funerary objects are presently stored at five known locations:

- 1) Fort Bliss: Fort Bliss has both human skeletal remains and funerary objects stored in Building 622. The following human skeletal remains and funerary objects are believed to be housed at Fort Bliss:

FB6873, two burials and an associated El Paso Polychrome olla fragment,
 FB9569, human skeletal fragments,
 FB9692, funerary objects including approximately 30 lithics, 3 antler fragments,
 a possible worked bone tool and a possible ochre fragment; the
 associated burial is located at the University of New Mexico,
 Albuquerque, and
 FB14500, one burial.

- 2) El Paso Centennial Museum, El Paso, Texas: One burial from the Northgate Site is reportedly stored at the El Paso Centennial Museum.

3. Sites Collected Prior to Fort Bliss Occupation of the Land:

- a) FB6363 (Hot Well Pueblo): EPAS excavated 15 burials from Hot Well in the 1960s, when the land was owned by the Hot Well Cattle Company. Eight of the burials are currently housed at the University of Arizona, one burial is located at the El Paso Centennial Museum, and six of the burials are at Fort Bliss.

- b) C.B. Cosgroves collected skeletal remains from three sites in the 1930s: From the Ceremonial Cave (FB6680), skeletal remains and funerary objects were collected from an adult burial and skeletal remains were collected from an infant burial. From Cave 1, two individuals and a number of funerary objects were excavated. These individuals, a very young infant and an adult, were collected from the same burial pit. A femur was removed from Cave 7. The Peabody Museum of Anthropology at Harvard University currently houses this material.

Currently, skeletal remains from five individuals cannot be located: one burial from FB6281, one burial from the Northgate site, and one each looted from FB9569, FB10533, and the Northgate Site.

In summary, there are approximately 42 known individuals from 16 sites that are now or have been within the property boundaries of Fort Bliss. Eight of these sites may have associated funerary objects. Of these 42 individuals, 20 were collected on land prior to Fort Bliss' ownership of the property; Fort Bliss is the current repository for six of these individuals. In addition, any burials from sites on the McGregor Range may be located on federally withdrawn land owned by the BLM. During the Section 5 Inventory investigations to be conducted by the MCX in early 1997, further determination of the exact location of the burials from the McGregor Range is required. Appendix IV provides a summary of the burial materials.

The final determination of any additional funerary objects, sacred objects or objects of cultural patrimony among the Fort Bliss collections may be established upon further consultation with culturally affiliated Native American tribes according to the definitions and restrictions specified in NAGPRA.

REFERENCES TO ARCHAEOLOGICAL INVESTIGATIONS

Two sets of references regarding archaeological work conducted on Fort Bliss are attached: Appendix V contains the list of references reviewed by the MCX during its archival research, and Appendix VI is the list of references contained in the National Archeological Data Base (NADB).

NATIVE AMERICAN TRIBES ASSOCIATED WITH FORT BLISS

Beginning in the 14th century, the Apache occupied the land area that is now Fort Bliss. Small autonomous groups of Apache occupied the plains and mountains from central Texas in the east to central Arizona, and from southern Colorado in the north to the Sierra Madre Mountains in Mexico. Historically, the Apache have been subdivided into a number of groups, including the Chiricahua, Jicarilla, Kiowa-Apache, Lipan, Mescalero, Tonto, and Western Apache (Cole 1994:44; Johnson 1993:147-150). All of these groups have been adjudicated different land areas (including land in Texas, New Mexico, Arizona, Oklahoma, Kansas, and Colorado). In addition, there might be Apache representation within two Yavapai groups, the Mohave-Apache and the Yavapai-Apache Community Councils (Cole 1994:44-45). Fort Bliss is located on the land adjudicated to the Mescalero Apache (U.S.G.S. n.d.).

The Kiowa and Comanche have historically been identified in the regions of New Mexico and Texas now occupied by Fort Bliss (Peterson and Otter n.d.:6-7). The Comanche were first documented in the region in 1705, when they were identified in New Mexico by Spanish records. By 1836, the Comanche had totally displaced the Apache (Jicarilla, Lipan, Mescalero), and controlled the territory south of the Arkansas River down to the Mexican settlements along the Rio Grande (Hofman et. al. 1989).

Although the primary range of the Kiowa was from south of the Arkansas River to the headwaters of the Red River, they had contacts with peoples in every direction, including the Comanche in the region now occupied by Fort Bliss (Hofman et. al. 1989; Johnson 1993:85). The Kiowa, Comanche and Apache claim original tribal occupancy on lands in Texas immediately adjacent to those of the Mescalero Apache. This land extends northward into Oklahoma, Kansas, and Colorado (U.S.G.S. n.d.).

In 1682, the Tigua Tribe settled within the city of El Paso after the Great Pueblo Revolt of 1680. They are closely related to the Tiwa, who are believed to have occupied areas in New Mexico in the vicinity of current Fort Bliss property (Johnson 1993:154; Beckett and Corbett 1994:641; Diamond 1994:714-715). The Tigua reservation, (Ysleta del Sur Pueblo), is located immediately south of Fort Bliss in El Paso, Texas (U.S.G.S. 1993).

Appendix III of this report contains a list of the federally recognized tribes for the above mentioned Native American groups.

SECTION 6 COMPLIANCE

P.L. 101-601 (NAGPRA) requires that federal agencies engage in active consultation with Native Americans of federally recognized tribes and/or lineal descendants who may be culturally affiliated with the archaeological collections from the installation. Enclosed are draft NAGPRA Section 6 Summary letters and a list of the tribal chairpersons from the federally recognized tribes which may be culturally affiliated with the collections (Appendix I). The following are the relevant federally recognized tribes for the groups mentioned above:

There are two groups in New Mexico that have been contacted by Fort Bliss (telephone conversation, Jim Bowman, Fort Bliss, 25 August 1995) and who have been treated as "consulting entities" by the state of Texas (telephone conversation, David Carmichael, University of Texas at El Paso, 6 September 1995). These two tribes, the Piro-Manso-Tiwa Tribe and the Los Indigenas de Nuestra Senora de Guadalupe, are not federally recognized, although the Piro-Mansa-Tiwa Tribe has petitioned the federal government for recognition and is awaiting the decision of the Bureau of Indian Affairs (Bureau of Indian Affairs 1995).

Pursuant to Section 3 of P.L. 101-601, the appropriate Native American group must be notified of any inadvertent discovery of Native American remains and cultural items on federal lands, as well as prior to the intentional excavation of any such remains or items. This applies to the four (possibly five) sites with *in situ* human remains on Fort Bliss and any future Native American human remains and objects discovered on Fort Bliss.

Initial consultation should be conducted on a government-to-government basis. Refer to P.L. 101-601 (NAGPRA) for specifics on required Native American consultation and the legal definitions of items subject to NAGPRA.
