13. ABSTRACT *(Maximum 200 words)*
The U.S. Army Environmental Center tasked the Mandatory Center of Expertise for the Curation and Management of Archaeological Collections (MCX) with the job of assisting the Army in complying with the Native American Graves Protection and Repatriation Act (NAGPRA), P.L. 101-601. The MCX was asked to locate and assess archaeological collections derived from Army lands, to identify the Native American or Native Hawaiian organizations culturally affiliated with the collections, and to draft Section 6 summary letters for each installation. A two-stage process was used to identify, locate and assess the contents of the collections, consisting of archival research and telephone interviews with the repository personnel. This report conveys the results of the collection research completed for the compliance with Section 6 of NAGPRA

OBJECTIVES AND METHODS

The U.S. Army Environmental Center (AEC) tasked the Mandatory Center of Expertise for the Curation and Management of Archaeological Collections (MCX) with the job of assisting Army installation personnel in complying with the requirements of the Native American Graves Protection and Repatriation Act (P.L. 101-601, NAGPRA). The MCX was asked to locate and assess archaeological collections derived from Army-owned lands, to identify the federally recognized Native American tribes most likely culturally affiliated with the collections, to draft Section 6 Summary Letters for each installation, and to conduct physical inventories of any collections that contain human skeletal remains. This report conveys the results of the collections research completed to assist Fort Leonard Wood in complying with the Section 6 Summary requirements of NAGPRA.

The MCX used a two-stage process to identify, locate, and assess the contents of archaeological collections from the installation. First, archival research was performed to review all archaeological site records and reports for the installation. Second, telephone interviews were conducted with personnel at installations, universities, museums, and archaeological contractors that were identified during the archival research as possible repositories of Army collections.

Archival research for Fort Leonard Wood began with a search of the National Archeological Data Base (NADB) for references pertaining to the installation. This was followed by a thorough examination of all archaeological site forms and a literature review of all pertinent archaeological reports and manuscripts on file at the Archaeological Survey of Missouri, in Columbia, Missouri, and the Historic Preservation Program, Department of Natural Resources, in Jefferson City, Missouri. The records search was performed at these two locations in December 1994 and sought to identify any work on the installation that may have produced archaeological collections.

Subsequent telephone interviews to Fort Leonard Wood and potential collections repositories ascertained whether the materials were present and the range of objects in each collection. Once the collections were located and assessed, MCX personnel identified federally recognized Native American tribes that are likely to be culturally affiliated with the materials in the collections. A draft Section 6 Summary letter is enclosed (Appendix I), as well as a listing of the current tribal chairperson (Appendix II).

RESEARCH RESULTS

ARCHAEOLOGICAL INVESTIGATIONS AT FORT LEONARD WOOD

Prior to the establishment of the Fort in 1940-41, archaeological investigations were conducted in the area by Gerald Fowke during the first quarter of the twentieth century. He investigated primarily cave sites, one of which, Miller Cave (23 PU 2), produced human remains and associated artifacts which are now stored at the Smithsonian Institution (Markman 1993). Since these materials were collected before the U.S. Army owned the land, they are not included in Fort Leonard Wood's NAGPRA reporting.

The first professional surveys on Fort-owned lands started in the mid-1970s and continue to this day. Among the contractors and individuals who conducted work are:

Investigations consisted of systematic surveys, test excavations, posthole surveys, and surface collecting. Artifacts collected include prehistoric lithics, ceramics, faunal remains (bone and shell), and historic ceramics, metal, glass and brick. Prehistoric human remains and associated funerary objects have been recovered from Fort Leonard Wood.

SUMMARY OF ARCHAEOLOGICAL COLLECTIONS

An estimated total of 70.9 ft³ of boxed archaeological materials and associated documentation have been identified for Fort Leonard Wood through 1994 (Edging, personal communication).

the objects. The Forest Service and the Fort will need to determine which agency is responsible for NAGPRA compliance for the collections from the fifty-one corridor sites.

Fort Leonard Wood has contracted with the U.S. Army Corps Construction Engineering Research Lab (USACERL) in Champaign, Illinois to rehabilitate the archaeological collections excavated since the early 1980s by Cultural Resource Analysts, Markman and Associates, Environmental Consultants, and American Resources Group, and possibly the artifacts surface-collected over the years by the Fort and Forest archaeologists. These materials were originally provided temporary storage space by the Fort Leonard Wood Museum. They were transferred to the Public Service Archaeology Program (PSAP) at the University of Illinois at Urbana-Champaign at the time PSAP conducted additional investigations on post. USACERL received the collections to be rehabilitated on 13 June 1995. Once the collections have been inventoried, rebagged and reboxed in archival storage containers, they will be transferred to the Natural History Collections and Conservation Center of the Department of Anthropology at the University of Columbia, Missouri (Edging, personal communication). The other collections listed in Appendix III are not included in this project.

The presence of human skeletal remains and associated funerary objects in the collections was identified in a thorough review of the archaeological records, associated literature, and telephone interviews. Five of the Forest Service corridor sites (23 PU 222, -224, -234, -311 and -313) are known to contain prehistoric human remains. Human remains and associated funerary objects from Sadie's Cave (23 PU 235) are housed at PSAP. Additional fragmentary human remains are likely to be found among the collections being rehabilitated by USACERL. The final examination of sacred objects or objects of cultural patrimony may be established by the associated Native American tribes (if determined to be culturally affiliated and the objects meet the definitions and restrictions specified in NAGPRA) upon further deliberation.

REFERENCES TO ARCHAEOLOGICAL INVESTIGATIONS

Three sets of references regarding archaeological work conducted on Fort Leonard Wood are attached: Appendix V contains the list of references reviewed by the MCX during its archival research; Appendix VI is the list of references contained in the National Archeological Data Base (NADB); and Appendix VII provides the references cited in the literature but not available for review by the MCX.

NATIVE AMERICAN TRIBES ASSOCIATED WITH FORT LEONARD WOOD

Early French explorers reported that the Osage tribe occupied south-central Missouri in the 17th Century (Waldman 1988), and in the 18th Century the Osage are known to have inhabited the area around Pulaski County and Fort Leonard Wood (Ahler 1995). The Osage tribe currently claims aboriginal land that includes portions of Arkansas, Oklahoma, Kansas and Missouri. Fort Leonard Wood is located within the Osage land claim area (U.S.G.S. n.d.). The aboriginal lands adjudicated in the land claims cases to the Otoe-Missouria and Sac and Fox tribes are located northwest and northeast of Fort Leonard Wood (U.S.G.S. n.d.).

Members of other tribes, including the Kickapoo, Delaware, Shawnee and Cherokee also moved into the Pulaski County and Fort Leonard Wood areas during the late 18th and early 19th Centuries after having been forced out of their eastern homelands by Euroamerican and African-american expansion. It is reported, however, that these groups had again relocated outside of Missouri by about 1830 (Ahler 1995).

Peterson and Otter (n.d.) compiled a report that assessed the status of TRADOC installations with regard to NAGPRA. Their findings for Fort Leonard Wood are included below:

The Great and Little Osage Indians ceded the southern half of the Missouri to the United States in 1807, 1808, and 1825. Villages of these groups were present in Missouri as late as 1805 (Royce). The Missouri and Oto likely passed through, although their homeland was north of the Fort Leonard Wood area. The remnants of these groups are currently identified as the Otoe-Missouria groups in Oklahoma.

The Delaware Indians were placed on a reservation near, but not at, the location of Fort Leonard Wood.

If late prehistoric or contact period remains are encountered, ethnic affiliation should be fairly easy to determine. These remains will likely be either Osage or Otoe-Missouria (n.d.:6-19).

No specific cultural affiliations for any of the prehistoric human remains recovered from Fort Leonard Wood were noted on the archaeological site records or associated literature.

SECTION 6 COMPLIANCE

P.L. 101-601 (NAGPRA) requires that federal agencies engage in active consultation with Native Americans with federally recognized tribes and/or lineal descendants who may be culturally affiliated with the archaeological collections from the installation. Enclosed are a draft NAGPRA Section 6 Summary letter (Appendix I) and a list of the tribal chairpersons from the federally recognized tribes (Appendix II) which may be culturally affiliated with the collections.

Dr. Edging sent letters to three federally recognized tribes, the Osage, Otoe-Missouria and Sac and Fox, in July 1994. These letters informed the tribes of the ongoing archaeological testing program at the Fort and that some sites were known to contain human skeletal remains. Dr. Edging invited comment and participation in the program, but has received no responses to date. These letters did not convey Section 6 Summary results. The intent was to initiate communication with the tribes concerning the potential for future inadvertant discoveries.

Initial consultation should be conducted on a government-to-government basis. The attached list provides the name and address for the tribal chairperson. The draft letter invites the chairperson to provide the Fort with the tribe's point of contact for NAGPRA-related issues.

Refer to P.L. 101-601 (NAGPRA) for specifics on required Native American consultation and the legal definitions of items subject to NAGPRA.

I am writing to inform you of collections held by Fort Leonard Wood that may contain Native American cultural items, as defined by the Native American Graves Protection and Repatriation Act (NAGPRA), that are, or are likely to be, culturally affiliated with the [Tribe]. Fort Leonard Wood has documented these archaeological collections in a Summary in accordance with the requirements of Section 6 of NAGPRA.

Fort Leonard Wood is responsible for collections that include approximately 71 cubic feet housed at the U.S. Army Research Construction Laboratory (USACERL) in Champaign, Illinois, the University of Illinois at Urbana-Champaign, Southwestern Missouri State University, Springfield, Missouri, and Fort Leonard Wood. These archaeological collections were generated from surveys and/or excavations conducted from the 1970s to the present. The collections consist of prehistoric stone tools, ceramics, animal bone, shell, radiocarbon samples and soil samples, and historic materials such as building materials, ceramics, and metal fragments, as well as associated documentation such as field notes, photographs, and correspondence. In addition, human skeletal remains and associated funerary objects were identified in our review of the collections documentation.

We are notifying [Tribe] because some of these materials were found in, or near, the area thought to be part of the territory occupied or used aboriginally by the [Tribe]. In accordance with Section 6 of NAGPRA, we are inviting you to consult with us regarding these archaeological collections. Upon your written request, we will provide you access to review our records, catalogues, relevant studies, or other pertinent data for the purpose of determining the geographic origin, cultural affiliation, and basic facts surrounding acquisition and accession of these collections.

In the process of completing the Section 6 Summary, the following Native American human remains were identified in Fort Leonard Wood's collections. Fragmentary human skeletal

remains were reported from surveys and test excavations by Niquette (1983 and 1984), Markman (1992) and by the Public Service Archaeologic Program (report in preparation). The majority of the human skeletal remains are reported to be very fragmentary. These remains are presently located at the U.S. Army Construction Engineering Research Lab in Champaign, Illinois and at the Public Service Archaeology Program at the University of Illinois at Urbana-Champaign.

Therefore, by means of this letter we are also initiating consultation regarding the NAGPRA Section 5 Inventory. Fort Leonard Wood is tentatively scheduled to conduct our Section 5 Inventory of human remains and any associated funerary objects in December 1995. If [Tribe] wishes to comment on, or participate in the Section 5 Inventory, please respond within 60 days of receipt of this letter.

To facilitate discussions between Fort Leonard Wood and the [Tribe] on these matters, please forward the name and method of contacting your tribal representative, traditional religious leader, or preferred NAGPRA point of contact. We look forward to working with you.

SUMMARY OF CURRENT LOCATIONS OF ARCHAEOLOGICAL COLLECTIONS FROM FORT LEONARD WOOD, MISSOURI

All collections information has been entered into a Paradox data base file and can be queried by any of the fields listed below, as well as by the name of the installation and by MACOM. The data base will be delivered by the MCX to the U.S. Army Environmental Center upon completion of the U.S. Army NAGPRA Compliance Project. Inquiries for additional information are welcome (MCX: 314-331-8865; U.S. Army Environmental Center NAGPRA Compliance Project: 410-671-1573). The data fields listed in the summary of collections contain the following information:

- REPOSITORY:** The current location in which the collection is stored, as of the date of this report.
- REPOSITORY POC:** The person contacted by the MCX, or the person to whom inquiries regarding the collection should be addressed.
- TELEPHONE:** The telephone number for the repository POC.
- COLLECTION ID:** The identifying unit used by the repository to store and/or locate the collection. This can be a unique accession number assigned by the repository, the archaeological site number or project name, the name of the collector of the collection, or another number or name assigned by the repository.
- SITE NUMBERS:** The official site number or name only for those sites from which materials were collected. An investigator may have performed work at additional sites but did not collect any materials. Those site numbers are not included in this field.
- FIELDWORK DATES:** The date(s) during which the investigation(s) occurred. This information is provided to differentiate between projects that may have investigated the same site repeatedly.
- EXCAVATOR/COLLECTOR:** The individual and/or organization that conducted the investigation.

- COLLECTION SIZE:** The volume or number of objects in a collection, estimated by the repository POC or from project reports.
- DESCRIPTION OF MATERIALS:** General material classes of the objects in the collection derived from data provided on site records, in references, and/or by the Repository POC.
- ANTIQUITY/ARCH. PERIOD:** Chronological or cultural-historical designations recorded on site records or in references specific to the collection.
- CULTURAL AFFILIATION:** This column contains only those ethnic identifications found in the site records or references specific to the collection. This field is left blank if no such information was recorded.
- BASIS OF DETERMINATION:** Documents the source of the cultural affiliation information (e.g., site record, oral testimony, reference).
- SECTION 5 MATERIALS:** Describes the number and kind of human skeletal remains and associated funerary objects in the collection, as indicated by the site records, references, repository management documents, or information from repository POC. If these materials are present or are suspected to be present, NAGPRA Section 5 requires a physical inventory of the materials.
