A PROGRAMMATIC DOCUMENT THAT HAS HISTORIC SIGNIFICANCE IN THE CONSTRUCTION OF

Our party has the brilliant history behind it of having charted a self-dependent road to the construction of a revolutionary party of the working class in the era of the independent stand and attitude.

The first party organization was above all a vanguard organization of the revolution struggling, holding the great leader Comrade Kim Il-song's revolutionary thought as the guiding principle and holding it as its lofty mission to carry through the chuche-oriented revolutionary line and guidelines set forth by our respected and beloved leader.

In order to correctly carry forward the legacies of national culture, it is imperative to discard the reactionary, corrupt culture created by the ruling circles in the past with a view to their class-oriented domination and pleasures and carry forward the culture congruent with national feeling achieved by the resourceful, courageous masses of working people. Only by thoroughly overcoming both of the restorationist tendencies and nihilistic tendencies toward the legacies of national culture, is it possible to construct and develop culture congruent with the feeling of one's people and with chuche established in it.

Again, as for the culture of other countries, too, what is congruent with the feeling of one's people and progressive must be embraced critically. To say to develop national culture means by no means to reject the culture of other countries. Only if out of the culture of other countries, what is congruent with the feeling of one's people and progressive is embraced, is it possible to further develop the national culture of one's country.

It performs an important function in establishing chuche in ideology to positively develop science and technology and improve the cultural and technical standards of the masses. Science and technology perform a great function in enhancing people's creative strength and going forward to remake nature and society. Most important in people's creative strength is the knowledge of science and technology. Success in the creative activity of people remaking nature and society comes to be guaranteed by their high ideological character and at the same time by their intellectual strength, their strength of science. Only by developing science and technology is it possible to develop the creative strength of people remaking the world. Only by developing science is it possible to enhance the independent stand and attitude and the creative stand and attitude of people, the subject of the social movement, and go forward to energetically step up the nature-remaking task and the society-remaking task, strengthening the creative role of people. Only by positively developing science and technology and improving the cultural and technical standards of the masses is it possible to turn working people into the genuine master of nature and society and thoroughly establish chuche, uprooting the idea of looking up to others and depending on them in science and technology.

Only if their developmental standard of the economy or their developmental standards of science and technology are higher than those of other countries, people will no longer look up to other countries. In order to establish chuche in ideology, it is imperative to more rapidly develop the economy and at the same time, science and technology in all areas.

In the thesis it is also pointed out that in order to establish chuche in ideology, it is imperative to oppose all kinds of the old ideas such as flunkeyism.

The dear leader Comrade Kim Chong-il taught as follows:

"To establish chuche in ideology is in itself an ideological liberation of people from the constraint of the old ideas, and an ideological revolution to establish the chuche world view. If chuche is to be established in ideology, it is imperative to repudiate all kinds of old ideas running counter to it and in particular, thoroughly uproot flunkeyism." (Ibid., p 41)

If the masses of people are to properly occupy their position as the master of revolution and construction and fully perform their role as the master, they must of necessity energetically launch the struggle to overcome flunkeyism.

Historical experience shows that if a man practices flunkeyism, he becomes a nitwit; if a nation practices flunkeyism, it ruins the country; if a party practices flunkeyism, it makes a mess of revolution and construction.

Today what is most harmful and dangerous is flunkeyism toward the U.S. imperialists. Flunkeyism toward the U.S. imperialists, which is manifesting itself in the respect-U.S., worship-U.S. idea, is inflicting tremendous harm on the revolutionary struggle of the people. The poison of flunkeyism toward the U.S. imperialists is surfacing intensively in south Korea today. Flunkeyism toward the U.S. imperialists, which the U.S. imperialist aggressors and their lackeys have spread, is paralyzing the national, class-oriented awakening of people in south Korea and is becoming a most harmful element of ideological poison trampling the priceless cultural legacies and laudable manners and customs of our nation. Without strengthening the struggle to oppose the respect-U.S., worship-U.S. idea and heightening the national sovereignty consciousness among the south Korean people, it is impossible to either win the victory of the south Korean revolution or achieve the independent reunification of the fatherland.

[Text] Self-dependence in politics is a guiding principle in insuring the sovereign rights of the country and the people and realizing the independent stand and attitude of the masses of people in the sphere of sociopolitical life.

This principle enunciates the chuche stand which must be invariably maintained in the activities of the party and the state, and illuminates the true road to making each country or nation, the masses of people, become the master of their destiny.

In the thesis "On the Chuche Ideology" by Comrade Kim Chong-il, an esteemed member of the Standing Committee of the Political Bureau of the Central Committee of the Korean Workers Party and an esteemed secretary of the Party Central Committee, is given a comprehensive, profound scientific and theoretical elucidation of the position the principle of self-dependence in politics occupies in the struggle for the independent stand and attitude of the masses of people and even of the intrinsic content, the ground for the need and method of the matter in maintaining the principle of self-dependence in politics.

The thesis "On the Chuche Ideology" first of all enunciates the position the principle of self-dependence in politics occupies in maintaining the independent stand.

Self-dependence in politics is a guiding principle which occupies the most important place in maintaining and embodying the independent stand and attitude. This is related to the fact that politics is the sphere of decisive significance in social life.

The dear leader Comrade Kim Chong-il taught as follows:

"Politics is the sphere of decisive significance in social life. Apart from self-dependence in politics, it is impossible to speak about the independent stand and attitude of any kind. It is above all in the self-dependence in

politics that chuche in ideology is expressed, and it is also by the self-dependence in politics that self-support in the economy and self-reliance in national defense are insured." (Book "On the Chuche Ideology," p 42)

Politics is a social function which organizes and commands in a unified manner the activity of people to suit the common interests of a class or society.

Society is a collective of people, and the collective life of people is achieved amid complex social relations. From this, what becomes necessary is politics, a social function which establishes a certain order and standard of action with a view to maintaining the society, and directly administers and commands people to act in accordance therewith.

Politics is the basic condition for making it possible to form and develop society. Without politics it is impossible to achieve or maintain people's collective life and common activity.

Therefore, politics holds a dominant position over all other aspects of social life and has decisive significance in people's social life and practical struggle.

Inasmuch as politics has decisive significance in social life, in the struggle for the independent stand and attitude of the masses of people, too, it arises as a priority demand to realize the sociopolitically independent stand and attitude. To realize the sociopolitically independent stand and attitude constitutes the key to making people cast off the constraint of nature and achieve their ideocultural development.

Under conditions that the masses of people are sociopolitically enslaved, even if productive forces are developed, they can neither properly enjoy their benefits nor cast off the constraint of reactionary ideas and culture. This bespeaks the fact that apart from self-dependence in politics, the independent stand and attitude of any kind is unthinkable.

As pointed out in the thesis, it is above all in the self-dependence in politics that chuche in ideology is expressed, and it is also by the self-dependence in politics that the self-support in the economy and the self-reliance in national defense are insured.

To establish chuche in ideology has its objective in making people fully perform their role as the master of revolution and construction, as the master of the state and society, holding the chuche viewpoint and attitude. Such objective can be firmly realized only if the independent stand and attitude is insured in the sphere of politics which has decisive significance in all aspects of social life.

It is by politics that the direction and method of economic construction and national defense construction are determined, and their success is influenced by how the political guidance of the party and the state is exercised.

Only if the politically independent stand and attitude is maintained in the activities of the party and the state, is it possible to establish the line

and guidelines for economic construction and national defense construction to suit the interests of their people and the specific conditions of their country, and realize the self-support in the economy and the self-reliance in national defense.

The principle of self-dependence in politics thus constitutes the decisive condition for realizing the independent stand and attitude in all aspects of social life.

The thesis "On the Chuche Ideology," based on having elucidated the position the principle of self-dependence occupies in politics, uniquely enunciates what the maintaining of the independent stand and attitude in politics means.

As elucidated in the thesis, to say to maintain the independent stand and attitude in politics means to implement politics which defends the national independence and sovereign rights of one's people, protects the interests of one's people and relies on the strength of one's people.

It is part of the most intrinsic content of the principle of self-dependence in politics to defend the national independence and sovereign rights of one's people.

It is a priority condition for realizing the independent stand and attitude of the masses of people to defend their national independence and sovereign rights. The country or the nation is a historically formed social life unit and a firm collective of people. The struggle of the masses of people for the independent stand and attitude is conducted on a nation-state unit basis, and the destiny of the masses of people, too, is worked out on a national or state basis. In consequence, if the country or the nation is enslaved, neither can the masses of people escape the plight of a slave; if the country or the nation fails to hold the independent stand and attitude, neither can the independent stand and attitude of the masses of people be realized. The masses of people, only when the independent stand and attitude of the country or the nation is insured, can go forward to successfully work out their destiny to suit their aim and demand.

National independence is an important condition for realizing the independent stand and attitude of the country or the nation. Remaining under the domination and enslavement of outside forces, it is impossible to speak about the independent stand and attitude of the country or the nation. Only if the masses of people, achieving national independence, hold their destiny in their own hands, can they achieve the independent development of the country or the nation.

This is not to say that just because national independence is an indispensable condition for realizing the independent stand and attitude of the country or the nation, the independent stand and attitude will be insured spontaneously once national independence is achieved.

If the independent stand and attitude of the country or the nation is to be thoroughly insured, it is imperative that together with national independence, the sovereign right to work out its destiny should be firmly defended.

The sovereign right is a sacred right of all countries or nations no one may deprive. Deprived of its sovereign right, it is in the scheme of things that the country or the nation will be enslaved to others, and it cannot become an independent country, an independent nation. Deprived of its sovereign right, the country may still maintain its national independence, but such country cannot become a genuine independent sovereign state.

Another part of the intrinsic content of the principle of self-dependence in politics is implementing politics which protects the interests of one's people and relies on the strength of one's people.

Politics is a means of and the decisive factor in serving for the realization of the independent stand and attitude of the masses of working people.

The aim and demand of the masses of working people for the independent stand and attitude are spoken for, protected, and realized above all by politics. In consequence, if the politically independent stand and attitude of the masses of working people is to be realized, it is imperative to implement politics protecting their interests and relying on their strength.

To say to implement politics which protects the interests of the masses of working people means to implement politics which protects the right of the masses of people as the master of revolution and construction; to say to implement politics which relies on the strength of the masses of people means to implement politics which, enhancing their role, enables them to fully discharge their responsibility as the master.

When politics protects their right as the master of revolution and construction, as the master of the state and society, and makes them fully discharge their responsibility as the master, the independent stand and attitude of the masses of working people comes to be firmly realized.

Under conditions as exist today that there are international boundaries and the distinctions of nations and that people live and conduct revolution and construction on a nation-state unit basis, the politically independent stand and attitude is realized only by politics which protects the interests of one's people and relies on the strength of one's people.

Only by implementing politics which protects the interests of the people of one's country and relies on the strength of one's people is it possible to firmly protect and defend the independent stand and attitude of the country or the nation and genuinely realize the independent stand and attitude of the masses of people.

To implement politics which protects the interests of the people of one's country and relies on the strength of one's people is thus a firm guarantee for realizing the independent stand and attitude of the masses of working people.

The thesis "On the Chuche Ideology" profoundly enunciates the ground for the need of maintaining the independent stand and attitude in politics.

The reason the principle of self-dependence in politics must be maintained is first of all related to the fact that the politically independent stand and

attitude is the first and foremost characteristic and the first and foremost life of an independent sovereign state.

The politically independent stand and attitude is the first and foremost characteristic of an independent sovereign state. The independence and sovereignty of the country or the nation presuppose the politically independent stand and attitude. The country devoid of the politically independent stand and attitude cannot be said to be a genuinely independent sovereign state. Only if the sovereign right is exercised in the activity of the state with the independent stand and attitude firmly held, is it possible to defend the dignity and glory of the nation and achieve the enrichment, strengthening, and development of the country to suit the desires of the people.

Therefore, to self-dependently solve the questions arising in the state activity in accordance with one's independent opinion and conviction on the politically independent stand and attitude, constitutes the basic characteristic differentiating whether or not it is a genuinely independent sovereign state.

The politically independent stand and attitude is not only the first and foremost characteristic but also the first and foremost life of an independent sovereign state.

The existence and development of an independent sovereign state are determined by the politically independent stand and attitude.

It is in the scheme of things that, failing to hold the politically independent stand and attitude, the country will be enslaved to others and that eventually it will be unable to maintain its existence as an independent sovereign state and be eaten up by others, in the end.

Deprived of the politically independent stand and attitude, even if the country has a mighty economic power and developed culture, these cannot prove their worth or firmly guarantee the independence and sovereignty of the country.

Inasmuch as the politically independent stand and attitude is the first and foremost characteristic and the first and foremost life of an independent sovereign state, any nation, only if it maintains the politically independent stand and attitude, can insure independence and freedom and achieve happiness and prosperity.

When one knuckles to the pressure of another country and completely embraces its political stand, one cannot establish and execute the line and policy in accordance with one's conviction and determination or achieve the complete independence of the country and the prosperity of the nation.

Therefore, in order to build a completely independent sovereign state and achieve the prosperity of the country and the people, it is imperative of necessity to maintain the principle of self-dependence in politics.

The reason the principle of self-dependence in politics must be maintained is also related to the fact that the fate of the revolutionary cause is influenced by the politically independent stand and attitude.

The revolutionary struggle is a struggle for the politically independent stand and attitude, and the solution to all questions in revolution and construction depends directly on politics. Depending on what kind of a stand is taken in politics, the general direction and method of revolution and construction are determined and the success influenced.

If the party and the state of the working class, devoid of the independent stand and attitude and individuality in politics, should copy the doings of others, they would be unable to hold the character of principle and invariability in their line and policy. In this way they will come to lose the sovereign rights of the country and the people and make a mess of revolution and construction.

In particular, today's realities wherein the imperialists, the dominationists are flagrantly perpetrating aggression and intervention against other countries, present it as an even more clamant demand to the party of each country to go forward to independently solve all questions arising in revolution and construction in accordance with its own conviction and determination.

Whether or not the politically independent stand and attitude is maintained thus constitutes the basic question influencing the fate of the revolutionary cause of the working class of completely realizing the independent stand and attitude of the masses of working people.

The thesis "On the Chuche Ideology" graphically enunciates the method to carry through the principle of self-dependence in politics.

As enunciated in the thesis, in order to maintain the independent stand and attitude in politics, it is imperative first of all to establish a people's government.

The dear leader Comrade Kim Chong-il taught as follows:

"In order to insure the independent stand and attitude in politics, it is imperative to establish a people's government." (Ibid., p 43)

The independent right of people is expressed intensively in the state ruling power.

The state ruling power is a political ruling power, and the basic factor determining the position and role of people.

In the exploiting society, only the exploiting class with a grip on the state ruling power exercises all rights by its ruling power, and the masses of working people without the state ruling power have no freedoms, no rights and merely become an object of exploitation and oppression.

The independent people's government, through its political rule and leadership over society, realizes the demand and aim of the working class and the masses of working people, and firmly insures the position and role of the masses of working people as the master. Therefore, if the working class and the masses

of people are to completely realize the independent stand and attitude, they must above all become the master of the government. The working class and the masses of people, only if they hold the political ruling power in their own hands and become the genuine master of the state and society, can realize the politically independent stand and attitude and genuinely enjoy an independent and creative life.

Under the sagacious leadership of the great leader Comrade Kim Il-song our people, by establishing the people's government, have come to hold the political ruling power in their own hands for the first time in history and become the genuine master of the state and society.

Our people's government is a political organization representing the interests of the masses of working people such as the working class and the peasantry and working intellectuals, and a political weapon serving to protect and realize the independent stand and attitude of the masses of working people. The politically independent stand and attitude of our people is being firmly guaranteed by the people's government.

As enunciated in the thesis, in order to insure the independent stand and attitude in politics, it is imperative to organize a chuche-oriented political force next.

In order to realize the independent stand and attitude of the masses of working people, stepping up revolution and construction, a revolutionary force must be thoroughly created. The revolutionary force is the decisive guarantee for victory of the revolution.

The revolutionary force consists of the political force, economic force, military force, and what constitutes the primary force here is the political force. The political force is a force which pushes the revolutionary struggle forward and actively leads it, and the decisive factor determining the economic force and the military force.

History shows that when the masses of people are not prepared politicoideologically and have not achieved unity and solidarity as one political force around the leader and the party, even if they have the power of a developed economy and the latest military technological means, they cannot go forward to independently carry out revolution and construction.

Only by thoroughly organizing and relying on a chuche-oriented political force is it possible to win and defend sovereign rights and insure independent politics for the sake of the masses of working people.

If a chuche-oriented political force is to be thoroughly organized, it is imperative to strengthen the party which is the guiding force of the revolution and achieve the unity and solidarity of all of the people based on worker-peasant alliance with the working class as the nucleus. What is most important here is firmly uniting all of the people around the party and the leader. The party and the people, when they have achieved unity and solidarity as one political force, can display an inexhaustible strength and win victory in revolution and construction.

As enunciated in the thesis, in order to insure the independent stand and attitude in politics, it is imperative next to have one's own guiding thought and self-dependently decide the line and policy in accordance with one's own determination, and carry them through.

It is an important requirement in insuring the politically independent stand and attitude to have one's own guiding thought. Only if one has a guiding thought of one's own, can one set a clearly defined direction and goal of revolution and construction, formulate a correct line and policy, and go forward to step up revolution and construction with a firm faith in victory.

Inasmuch as the actual conditions of each country are different, the guiding thought of the party of one country, however admirable, cannot suit another country exactly.

The revolutionary thought of the working class, the contemporary guiding thought which has universal significance to all countries, only when applied to suit the specific conditions of each country, becomes the genuine guiding thought of the party of the country concerned.

Therefore, only by having one's own guiding thought which is congruent with the specific conditions of one's country and capable of victoriously pushing ahead with the revolution and construction of one's country, is it possible, with it as the measuring stick, to differentiate what is correct and incorrect in all areas of the activities of the party and the state, and firmly maintain the politically independent stand and attitude.

In order to insure the politically independent stand and attitude, it is imperative to not only have one's own guiding thought but self-dependently decide the line and policy in accordance with one's own determination and carry them through.

As enunciated in the thesis, the basics of politics are determining the policy and executing it. The reason the guiding thought has important significance is because it makes it possible to properly determine the policy and line and go forward to precisely carry them through.

The party of each country and the government of the state, only if they determine all lines and policies based on their guiding thought and execute them, can firmly insure the independent stand and attitude in politics.

Under the sagacious leadership of the great leader Comrade Kim Il-song our party, holding the immortal chuche ideology as the unitary guiding thought, has determined and executed all lines and policies to suit the interests of our people and the realities of our country, and because of that, has always been able to win brilliant victory in revolution and construction.

Next, in order to insure the independent stand and attitude in politics, it is imperative to exercise complete sovereign right and equal right in external relations.

One of the basic questions arising in maintaining the independent stand and attitude of the party and the state is that of thoroughly exercising the sovereign right and equal right in external relations.

This is so because above all the independent stand and attitude of the party and the state is expressed, in the final analysis, in external relations. It is one of the basic characteristics of the independent activities of the party and the state to exercise the sovereign right and equal right in external relations. The party and the state realize the independent stand and attitude in external terms through exercising the sovereign right and equal right.

The reason it arises as a basic question in maintaining the politically independent stand and attitude of the party and the state to exercise the sovereign right and equal right in external relations is also because the sovereign right is a sacred right of all parties, all countries or nations.

Even though in the world exist big parties and small parties, big countries and small countries, economically developed nations and backward nations, all of the parties, all of the countries or nations are equal and independent. Among the fraternal parties there could be no such thing as a higher party and a lower party, a guiding party and a guided party; and no party may demand a privileged position in the international communist movement. All of the parties on a mutually equal footing must respect other parties and maintain comradely relations with one another.

All nations are equal and have the sacred right of national self-determination to work out their destinies on their own. Any nation, only if it realizes complete political self-determination and exercises its right, holding it in its own hands, can insure independence and freedom and achieve happiness and prosperity.

Therefore, no one may violate the sovereign right of others or tolerate the violation of one's own sovereign right.

All of the parties, all of the countries, all of the nations, only if they practically exercise their independent right, can implement genuine independent politics.

The reason it arises as a basic question in maintaining the politically independent stand and attitude of the party and the state to exercise the sovereign right and equal right in external relations is also because the independent stand and attitude constitutes the basis for strengthening internationalism.

As Comrade Kim Chong-il, an esteemed member of the Standing Committee of the Political Bureau of the Central Committee of the Korean Workers Party and an esteemed secretary of the Party Central Committee, has enunciated in his historic thesis, the independent stand and attitude not only is not in conflict with internationalism but constitutes the basis for strengthening it.

Just as the world revolution is unthinkable apart from the revolution of one's country, there could be no internationalism apart from the independent stand and attitude.

Internationalist unity must essentially be an independent and equal one. Only if based on the independent stand and attitude, internationalist unity, too, can begin to become a voluntary and equal one, a sincere and solid one.

In the thesis is graphically enunciated the basic content of the independent external policy of our party based on the independent stand and attitude.

This is a precious historical experience proved through the practical struggle of the masses of people for the independent stand and attitude.

As enunciated in the thesis, self-support in the economy constitutes a clamant requirement in firmly insuring chuche in ideology, self-dependence in politics, and self-reliance in national defense.

In order to thoroughly embody the socialist constitution in state and social life, it is imperative above all to strengthen indoctrination in the observance of law among functionaries and working people and make them voluntarily observe the laws and regulations of the state such as the constitution.

All the laws and regulations of our country are ones that have been created by the masses of working people themselves, and contained in them are their aim and demand for protecting and realizing an independent, creative life. In consequence, to voluntarily observe the laws and regulations of the state and establish a revolutionary law-abiding ethos societywide is altogether a task for the sake of the masses of working people, and a task they themselves must carry out.

Inasmuch as what governs all activities of people is their ideological consciousness, to enhance the law-abiding consciousness of working people constitutes an important factor in making them, with a correct stand and attitude toward law, voluntarily observe the laws and regulations of the state such as the constitution.

Party organizations and government organs, substantially conducting the explanation and propaganda work and the indoctrination work for nurturing a voluntary law-abiding consciousness among functionaries and working people, must make them approach the laws of the state with solemnity and voluntarily observe them.

It is one of the important requirements in thoroughly embodying the socialist constitution and establishing law and order to strengthen supervision and control work for the execution of law.

The task to establish law and order cannot be resolved all by law-abiding indoctrination alone. Under conditions that the dregs of old ideas and old life customs such as individualism and egoism still remain in people's heads and the class struggle continues, we cannot afford to weaken legal control. Only by exercising legal control together with steadfast ideological indoctrination is it possible to strengthen the law and order and discipline of the state and step up the process of people's revolutionization, working classization.

Government organs and law organs, conducting on a routine basis supervision and control work for the execution of law, must see to it that no phenomena of violation of law occur in all branches, at all units.

In order to thoroughly establish the law and order of the state, carrying through the socialist constitution, it is also important to enhance the role of the Socialist Legal Life Guidance Committee.

The bureaucratic work style which is surfacing from among the functionaries constitutes a significant factor disturbing law and order, and violation of law, a form of expression of bureaucratism.

The Legal Life Guidance Committee, with a unified grip on indoctrination work and legal struggle for establishing a revolutionary law-abiding ethos societywide, must exercise its organizational guidance, and in particular, must commendably conduct the task to prevent the bureaucratic work style from surfacing from among the functionaries.

In order to embody the socialist constitution in state and social life and thoroughly establish the law and order of the state, the guidance functionaries must be familiar with the laws and regulations and become a model in observing them.

The guidance functionaries are not only each a member of the citizenry who must faithfully observe the laws and regulations of the state but shoulder the heavy responsibility to directly organize and execute the work of establishing the law and order of the state in their relevant branches and units. Only if the guidance functionaries become a model in observing the laws and regulations of the state, can they faithfully discharge their duty as citizens and lead by practical example the masses in precisely observing the laws and regulations.

The guidance functionaries, by respecting more than anyone else the laws and regulations of the state such as the constitution and thoroughly obeying the laws and by conducting all tasks and life in accordance with the demands of the laws and regulations, must become a model in establishing the revolutionary ethos societywide.

All of the functionaries and working people, by thoroughly embodying the socialist constitution in all aspects of state and social life, shall further hasten the victory of the cause of converting the whole society to the chuche ideology.
