EXTRACT FROM THE DECISION OF THE COUNCIL OF MINISTERS
ON THE ESTABLISHMENT OF DOMESTIC AIR TRANSPORTATION RATES

[The following extract is taken from Colectia de Hotariri si Dispozitii ale Consiliului de Ministri al RPR (Collection of Decisions and Provisions of the Council of Ministers of the Rumanian People's Republic), Bucharest, No. 20, 6 June 1960, pages 533-539.]

The Council of Ministers of the People's Republic of Rumania decides:

1. It approves the rates for domestic passenger air transportation provided in the annex which forms an integral part of the present decree.

2. Children under 3 years of age enjoy an 85 percent reduction and those between the ages of 3 and 10 a 50 percent reduction of the applicable passenger rates.

Rates for the transportation of excess passenger baggage is set at 1 percent per kilogram of the rate for transportation of passengers. An amount of baggage that exceeds 10 kilograms per passenger is considered excess baggage. Children between the ages of 3 and 10 have the right to free transportation of 10 kilograms of baggage. Children up to 3 years of age do not have the right to free transportation of baggage.

The rate for the transportation of goods is set at 0.8 percent per kilogram of the rate for transportation of passengers.

These rates shall apply both to regular scheduled flights and extra flights.

The Ministry of Transportation and Telecommunications is authorized to adapt or modify in part, with the concurrence of the Price Committee, the rates approved by the present decision, insofar as it appears that the modification or adaptation is necessary for using air transportation capacity and to increase passenger traffic.

2. The Ministry of Transportation and Telecommunications is authorized to establish:

a) rates per hour of flying time, for special passenger flights, for special goods flights and for utility aircraft by categories of services rendered.

Rates shall be established in amounts between the level of variable costs (fuel, lubricants, flight premiums and contributions for

these, a part of the cost of the various materials consumed and other expenses incurred during the flight) and the level of the annual planned hour of flying time for each type of aircraft;

b) rates for services auxiliary to public air transportation, such as: loading-unloading charges, charges for handling goods on the ground, etc.;

c) rates, computed per hour of flying time, for technical aeronautic services rendered by the Directorate of Air Transportation in connection with the activity of utility aircraft of other ministries or socialist units equipped with their own aircraft such as: technical maintenance of aircraft, periodical checks, flight preparation and air navigation protection, use of hangars and substructures, etc.;

d) rates reduced to the level of variable costs (fuel, lubricants, flight premiums and contributions for these, part of the costs of various materials consumed and other expenses incurred during flight) per hour of flying time for pleasure flights.

4. The Ministry of Transportation and Telecommunications shall draw up instructions for applying the provisions of the present decision.

5. The provisions of the present decision shall become effective on 10 June 1960.

On said date, Decision of the Council of Ministers No. 1454 of 30 December 1950, as also any other contrary provisions, are abrogated.
