## **Documentation of the SETTLE Module for ADDAMS: Design of Confined Disposal Facilities for Solids Retention and Initial Storage**

### **Purpose**

This technical note documents the SETTLE computer program which facilitates the design of a confined disposal facility (CDF) to retain solids, provide initial storage, and meet effluent discharge limitations for suspended solids during a dredged material disposal operation. Detailed information can be found in Engineer Manual 1110-2-5027, "Confined Dredged Material Disposal" (Office, Chief of Engineers (OCE), U.S. Army 1987). Thackston, Palermo, and Schroeder (1988) describes further refinements to these procedures which are used in this module. SETTLE is a part of the Automated Dredging and Disposal Alternatives Management System (ADDAMS).

### **Background**

Confined disposal facilities (CDFs) must be designed to retain and store sediment dredged from navigation channels, estuaries, lakes, and other waterways. Conventional dredging processes add large volumes of water and result in a fluid slurry of solids being discharged into the CDF. Hydraulic dredging operations add this water to facilitate pipeline transport; hydraulically pumped dredged material slurries typically contain sediment concentrations between 50 and 200 g/L depending upon sediment and dredge characteristics. Mechanical dredging operations entrap water during dredging and tend to have higher solids concentrations, usually in the range of 200 to 500 g/L. The disposal of dredged material from either dredge type requires that the CDF provide sufficient hydraulic retention time for removal of suspended solids to meet local, state, and Federal effluent water quality standards.

Water quality certification must be obtained from the state in which the CDF discharge occurs in accordance with Section 401 of the Clean Water Act (U.S. Environmental Protection Agency (EPA) 1980). The certification may specify water quality standards which the effluent from the CDF must meet. State water quality certification usually includes specific concentration limits for water quality constituents of concern and should specify geometric limits for a mixing zone outside of which these concentrations limits may not be exceeded. *Environmental Effects of Dredging Technical Notes EEDP-04-5* (MacIntyre 1987) describes methods for estimating dilution and mixing zone size for discharges into riverine and estuarine environments. Applying these dilution factors to the state water quality certification limits yields maximum allowable concentration levels in the CDF effluent. Engineer Manual 1110-2-5027 (OCE 1987) provides guidance for designing a CDF for the removal and storage of solids; the SETTLE module described in this technical note implements these procedures along with some refinements of these procedures described by Thackston, Palermo, and Schroeder (1988). *Environmental Effects of Dredging Technical Notes EEDP-04-1 through EEDP-04-4* (Palermo 1985) present techniques for predicting other constituent concentrations in the CDF effluent. Additional treatment beyond primary clarification within the CDF may be required to meet the effluent standards for some constituents.

## **Computational Procedures**

### **Design for Initial Storage**

A CDF designed for a single dredging project must be capable of storing the dredged material for a particular disposal activity at its largest volume. This occurs just as disposal ends and is commonly referred to as the initial storage volume. The initial storage volume for the dredged material depends upon many aspects of the dredging project, including sediment characteristics (primarily the fraction of fines versus the fraction of sands), settling characteristics of the material, volume of sediment to be dredged, and disposal rate. The required CDF volume, however, is significantly larger than just the initial volume of sediment to be dredged, particularly for hydraulic dredging transport or disposal projects. The CDF must also include additional depth for ponding to allow sedimentation during the final, and most critical, stage of dredging and dike freeboard above the highest anticipated water surface.

SETTLE determines the average concentration of settled solids within the CDF at the end of disposal, referred to as the design concentration, using the compression settling test data. The design concentration is used to calculate the initial storage requirements for the fine-grained (smaller than No. 200 sieve) fraction of the dredged material. Coarse-grained (larger than No. 200 sieve) material behaves independently and much differently. Thus, the storage volume required for the coarse-grained material is determined based upon the input data and then added to the volume of fine-grained material to yield the minimum initial storage required. The volume is not an estimate of the long-term needs for multiple-disposal activities; it is the volume required for the single disposal project under consideration.

Because of siting, construction, and permitting complications, CDFs are frequently sized to receive multiple disposals. The number and frequency of disposals depend upon the location and dredging projects being served. Under these circumstances, initial storage volume will likely become a constraint only as the CDF ends its service life. Estimates for long-term storage capacity can be made using the consolidation and dewatering (PCDDF) module of AD-DAMS (Poindexter-Rollings and Stark 1989).

Initial storage volume can be the controlling design factor regardless of the settling behavior exhibited by the material. In the unusual case that the material exhibits compression settling at a concentration at or below the expected inflow concentration, the design for initial storage might well be the only design consideration required.

### **Design for Clarification**

Sediments containing saline pore water (> 3 ppt salt concentration) frequently settle as a tightly formed soil matrix restricted by the upward flow of water through the matrix. The result is a clarified supernatant above a well defined soil-water interface which continuously settles downward at a slow rate. This is commonly referred to as zone settling. Besides occurring in salt-water sediments, zone settling may occur in freshwater sediments if solids concentrations are high enough or if the particle surface characteristics are flocculent enough.

If the dredged material exhibits zone settling behavior at the expected inflow concentration, the zone settling test results are used to calculate the required ponded surface area in the CDF for effective zone settling (clarification). This surface area is the minimum area required to remove suspended solids from the surface layers at a rate sufficient to form and maintain a clarified supernatant that can be discharged.

Flocculent settling occurs in the supernatant water above the interface and controls the quality of the supernatant. Suspended solids concentration in the clarified supernatant varies widely between sediments but is generally on the order of 50 to 500 mg/L. Additional calculations using flocculent settling data for the solids remaining in the ponded supernatant water are required to

design the CDF for a specific effluent quality standard for suspended solids. These calculations are identical to those described below.

### **Design for Effluent Quality**

The concentration of effluent suspended solids depends on the flocculent settling characteristics of the sediment, the depth from which fluid is withdrawn at the weir, and hydraulic retention time within the CDF. Because of the low viscosity of the supernatant water and the high flow rates commonly found in CDFs, the withdrawal depth is essentially equivalent to the ponded water depth. SETTLE uses the average ponded depth to estimate the residence time and compute the average solids concentration in the discharge. A minimum average ponded depth of 2 ft is usually recommended for the design; greater depths of ponding reduce the surface area required for adequate solids removal. For most cases, constant ponded depth can be maintained by raising the weir crest and, hence, water surface elevation as settled material accumulates in the CDF.

CDFs constructed in a rectangular shape with sides as near the same length as possible minimize the dike length required for a given surface area or storage volume. This typical shape combined with point source inflows result in an actual hydraulic retention time considerably less than the theoretical retention time. Thus, calculating the effluent suspended solids concentration requires correcting the theoretical retention time for hydraulic inefficiencies. Actual mean hydraulic retention time and hydraulic efficiency for a given flow rate, design area, and ponding conditions and the theoretical residence time can be estimated using the DYECON module (Hayes and Schroeder 1992).

### **Calculating Weir Length**

The fact that withdrawal depth is essentially the ponded water depth at the weir does not minimize the importance of determining the necessary weir length. The weir must be long enough that the overflow rate does not attempt to draw water from depths greater than the depth of the free water surface pond. The settled solids layer is loosely compacted and scouring begins at very low velocities. High overflow rates may cause enough scouring of settled solids to violate effluent water quality standards. SETTLE calculates the weir length necessary to avoid this entrainment of solids for slurries that underwent either zone or flocculent settling.

## **SETTLE Application of ADDAMS**

### **Introduction**

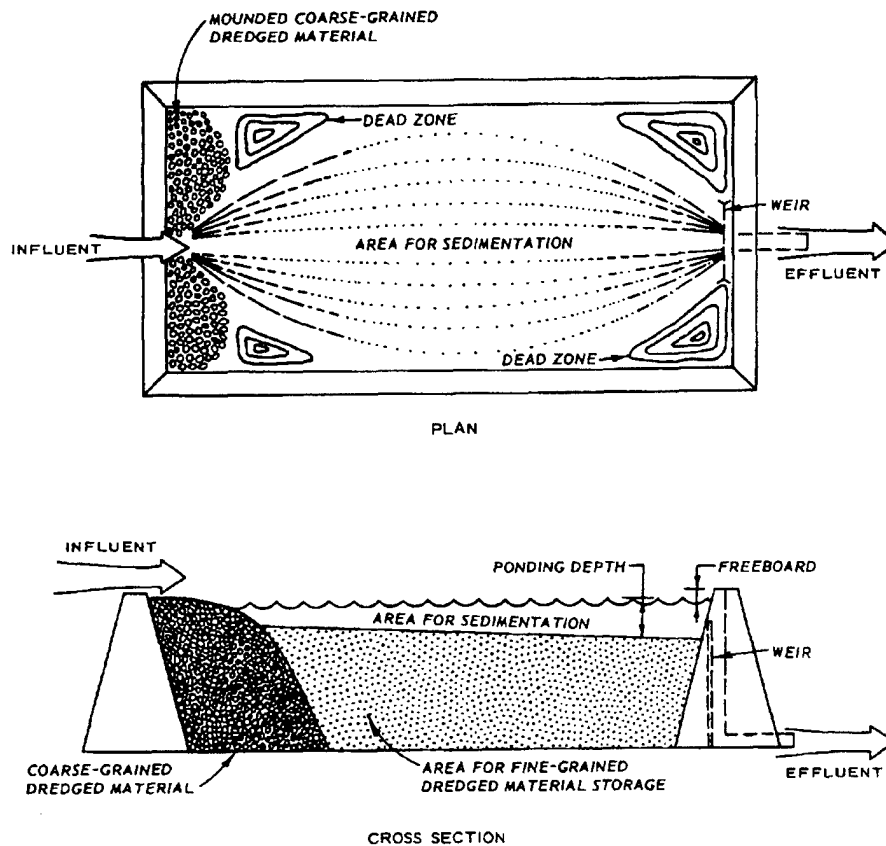


Figure 1. Schematic of a confined disposal facility

A properly designed CDF removes solids from the dredged material slurry sufficiently to meet state water quality certification and safely provides temporary or permanent storage for the retained solids. A schematic of a CDF is shown in Figure 1. The quality of water discharged from a CDF is a

significant environmental concern associated with dredging, especially in areas where the dredged material may contain contaminants of concern. Thus, it is important to size and operate the CDF in such a manner that the best practicable solids and contaminant removal occurs. This is accomplished by designing the CDF for solids removal during the most critical stage of the disposal operation; the most critical stage usually occurs during the final days of disposal when the ponded volume is the least. Designing for this critical stage ensures adequate removal during the entire dredging operation.

CDF design, however, is not simply determining the surface area required for solids removal and initial volume required to store the freshly deposited dredged material. Surface area, free water ponded depth, hydraulic efficiency, weir length, inflow rate, and inflow concentration all affect solids removal efficiency in a CDF. Large surface area and storage volume requirements combined with land acquisition difficulties usually make overconstruction economically prohibitive. Thus, the design of a CDF requires careful evaluation of these design variables in conjunction with design constraints. For example, land constraints can substantially restrict the area available for construction of the CDF. The CDF design must then focus on controllable design aspects

which affect effluent water quality such as ponded water depth, inflow rate, and weir length. If the allowable range of modification for these parameters cannot meet state water quality certification requirements, additional treatment may be required before discharging the CDF effluent into the receiving body.

### **Capabilities**

SETTLE is a computer program and module of the ADDAMS. The general goal of ADDAMS, an interactive computer-based design and analysis system for dredged material management, is to provide state-of-the-art computer-based tools that will increase the accuracy, reliability, and cost-effectiveness of dredged material management activities in a timely manner. *Environmental Effects of Dredging Technical Notes EEDP-06-12* (Schroeder and Palermo 1990) describes ADDAMS in more detail.

SETTLE implements CDF design procedures described in Engineer Manual 1110-2-5027 (OCE 1987) and refinements described by Thackston, Palermo, and Schroeder (1988). It performs CDF design calculations based on data from laboratory settling tests, information on the dredging project, anticipated dredged volumes, dredged material characteristics, expected hydraulic efficiency of the CDF, and desired effluent quality. SETTLE can consider constraints on the CDF design such as dike height and surface area limitations in the design calculations and provides the capability to consider all CDF design alternatives. A user should gain a working knowledge of EM 1110-2-5027 prior to running SETTLE.

The SETTLE module of ADDAMS has the following specific capabilities:

- Analyze and reduce laboratory settling test data required for CDF design.
- Size a CDF for solids retention and initial storage of dredged material.
- Compute the weir length required to prevent resuspension and excessive discharge of suspended solids.

### **Availability**

SETTLE, as well as other modules of ADDAMS, is available through the Information Technology Laboratory of the U.S. Army Engineer Waterways Experiment Station. See Appendix A for an order form.

### **Using SETTLE**

SETTLE may be started from the ADDAMS executive shell by selecting the SETTLE program (option 1) or started separately by typing SETTLE at the DOS prompt. The method of starting SETTLE should be chosen based upon familiarity with the DOS operating system, available RAM, system configuration, and the existence of other ADDAMS modules. It is primarily a matter of personal preference, however, since SETTLE operates the same regardless of how it is initiated. Users of the ADDAMS executive shell may receive a DOS error

message (Table 1) indicating insufficient RAM available to run SETTLE (or other ADDAMS modules). This happens because too much RAM is being used for other applications by your computer while you are trying to execute the SETTLE executable module. If this occurs, the user should increase the available RAM by modifying the CONFIG.SYS and the AUTOEXEC.BAT files. The DOS manual explains how to modify these files to increase available RAM. Common depletion of available RAM is caused by DOS requirements, engagement of a network, mouse, print buffer, menu or terminate and stay resident (TSR) programs.

### General Operation

SETTLE operates in a user-friendly, menu-driven environment and facilitates data entry and editing by using a full-screen editor approach. A central menu, called the *SETTLE Activity Selection Menu*, allows the user to select the desired operation such as enter/edit settling test data or dredging project data, perform file management operations, perform design calculations based on user-entered settling test data or settling data for typical or conservative small projects, and set the hardware configuration for the SETTLE graphics. All menu selections are numbered and may be selected by pressing the number of the desired option. The user may also choose to cycle through the menu options using the up arrow (↑) or down arrow (↓) key and then select the highlighted option by pressing the ENTER key.

Each option, except the enter/edit settling data option, provides the user with a full screen editor for data entry and editing. Most editing screens describe several required data items with the current value for the data item displayed. Editing focuses on the highlighted data item or question. Descriptions of the data item and options are usually located to the left of the cell; units are displayed to the right of the cell. The user may enter a new value in the cell or modify the value in the cell. Moving to another data item on the current screen requires pressing either the ENTER key, the TAB key, or one of the vertical arrow keys. Page Down and Page Up keys display the next and previous screens, respectively. The enter/edit settling data option provides a similar menu to the *SETTLE Activity Selection Menu* containing menu options for entering or editing specific settling test data.

SETTLE presents the results of design computations on descriptive screens similar to the full-screen data editor. Results are often displayed in tabular

format and include relevant assumptions, equations used, and controlling factors so the user can appropriately assess the design results. SETTLE will also print the results to ASCII output files or directly to the printer.

## **Getting Started**

The user should establish the proper hardware configuration prior to any other use of SETTLE. Hardware configuration can be established or modified by selecting menu item 8, perform hardware configuration for graphics. SETTLE uses the stored configuration to display and print graphics and other output. Modifications to the hardware configuration are not required after the initial setup unless the available hardware changes or the configuration data file is lost.

After the initial hardware configuration, later uses of SETTLE should begin by selecting (or making "active") the desired data file. SETTLE initially recalls the data file from the previous session and makes it the "active" data file. A different data file or new data file can be activated by using the ADDAMS File Manager. The File Manager is initiated by selecting menu item 7, perform data file selection and operation. The ADDAMS File Manager and its operation are discussed in detail by Schroeder and Palermo (1990). When the File Manager returns control to SETTLE, the active data file, if it exists, is read and values assigned to appropriate variables. Note that SETTLE does not offer an option to change the name of the active data file after it has been read. Thus to modify an existing data file and retain the original file, the user must change the active file name to the desired name for the modified file before saving the data. This operation is performed using the ADDAMS File Manager, but must be done before modifications are saved to prevent loss of the original data.

## **On-line Help**

On-line comprehensive help messages are available to SETTLE users by pressing F1 or Alt-F1. Pressing the F1 key provides general assistance on the current menu and information regarding choices the user needs to make. Detailed assistance for the currently highlighted data item is available on-line by simultaneously pressing the Alt and F1 keys. These context-sensitive messages provide detailed information about the user's options at the current position and/or describe data to be entered or edited at the current cursor position. Help messages may also provide default values or typical ranges.

## **Hardware Requirements**

SETTLE requires a MS-DOS based personal computer with at least 640 kilobytes of RAM, a hard disk with 2 megabytes of free space, and a CGA, EGA, or higher resolution color video card and compatible monitor.

## CDF Design Using SETTLE

Designing a CDF consists of sizing for initial storage of the slurried dredged material and adequate clarification to meet effluent quality standards through solids removal. While sizing for initial storage is relatively straightforward, solids removal depends on a combination of surface area, ponded water depth, hydraulic efficiency, average inflow rate, and weir length. The final CDF design must satisfy both storage and effluent quality criteria within the physical constraints placed upon the site. Design calculations in SETTLE are based upon the procedures described in EM 1110-2-5027 (OCE 1987) and require laboratory settling test data and dredging project data which reflect the anticipated use of the CDF. A series of SETTLE runs should be used to evaluate an array of design alternatives and select the most appropriate design balancing requirements for storage and effluent quality.

### Data Requirements

Various settling processes begin immediately once dredged material is discharged into the CDF. A properly designed CDF facilitates these settling processes to enhance solids removal, compaction, and fractional retention of solids. Dredged material slurries exhibit either flocculent or zone settling, depending on the slurry concentration, particle type, and salinity of the carrier water. Slurries with salinity greater than 3 ppt usually exhibit zone settling because the dissolved ions act as a coagulant. Freshwater slurries typically exhibit flocculent settling but may exhibit zone settling if solids concentrations are high enough or if the particle surface characteristics exhibit low stability forces.

Regardless of whether the upper layers of the settling material in the CDF exhibit flocculent or zone settling, the bottom layers of settled material will exhibit compression settling or thickening. As settled solids accumulate, the concentration of settled solids in the bottom layers increases. Settled solids begin to rest on and be supported by the bottom of the disposal area. Successive layers of settled solids then rest on each other. The point at which the bottom begins to provide some physical support, compression settling begins. The change from flocculent or zone settling to compression settling occurs at a concentration of approximately 200 to 300 g/L for most dredged material slurries.

Sedimentation characteristics can vary widely between sediments. Thus, laboratory test data reflecting the settling properties of the dredged material planned for disposal must be available to appropriately design the CDF. Data requirements for a complete design analysis include laboratory results from a flocculent settling test, a 15-day compression settling test, a zone settling test, when zone settling occurs, disposal area information, dredge information, and physical and engineering properties of the dredged material; specific requirements for each data type are described below. SETTLE runs can be made using data from a partial set of settling tests; however, this provides only design information based on the results of those tests.

## Entering/Editing Settling Test Data

Option 1 of the *SETTLE Activity Selection Menu*, enter/edit settling data menu, activates the *Settling Data Selection Menu* which allows the user to enter data for any of the three specific types of settling tests. Selecting a settling test type from this menu initiates a sequence of full screen data entry menus tailored specifically for that settling test. These screens describe the data being requested, provide graphics where applicable, and display results of the reduced settling test data. If settling data has previously been entered for the active file, the user may edit the existing data on these same screens. SETTLE automatically reduces the data and recomputes all coefficients prior to the results or graphics screens. Once the series of menus for the selected test are completed, SETTLE returns to the *Settling Data Selection Menu*. Pressing the Esc key at that point returns control to the *SETTLE Activity Selection Menu*.

**Compression Settling Data.** Data entry for the compression settling option consists of two data input screens plus one results screen and an optional graphical display of the test results. Table 2 lists the necessary input parameters from the compression settling tests and their corresponding units. From the interface height and initial solids concentration data, SETTLE computes the settled solids concentration at each time the interface height was measured. The settled solids concentration versus time data are fitted (using the least-squares technique) to a power curve of the form:

$$C = aT^b \quad (1)$$

where

C = settled solids concentration, g/L

T = time since disposal, days

a,b = regression coefficients

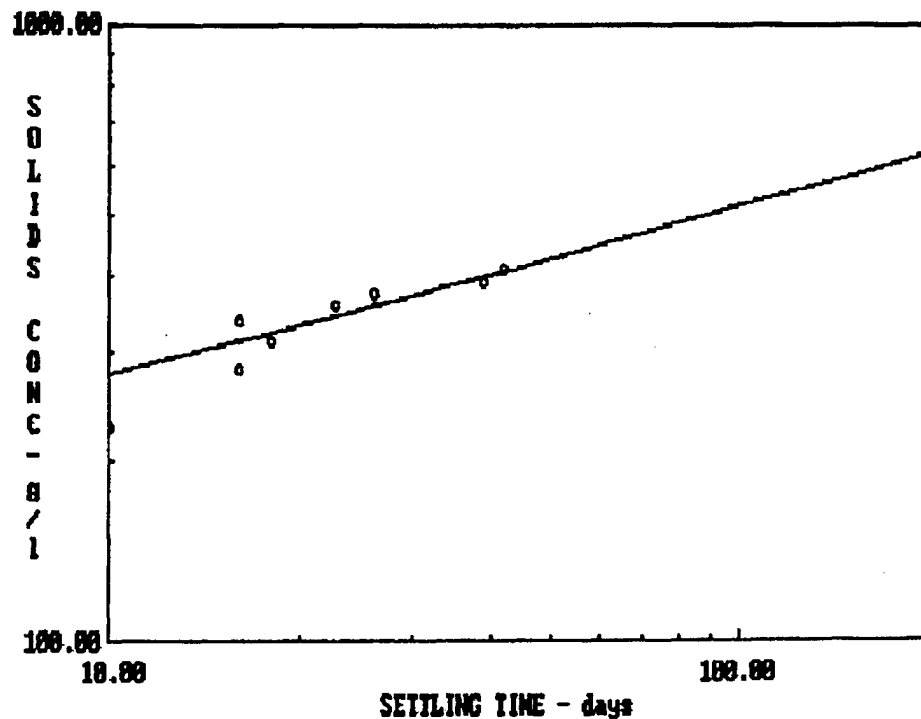


Figure 2. Example plot of compression settling data

The results screen shows the computed power function and its coefficient of determination. The user can choose to view a graph of the data and fitted curve, to examine for goodness-of-fit, outliers and typographical errors in data entry. The graph can also be sent to the printer or plotter specified in the hardware configuration file. See Figure 2 for an example plot.

**Flocculent Settling Data.** Flocculent settling data entry consists of three data input screens, three data reduction results screens, and one graph of the flocculent settling data. Table 3 lists the input parameters with their corresponding units. From the raw flocculent settling data which is entered in the first three screens, SETTLE computes the percent of the initial suspended solids concentration remaining in suspension for each sample. It displays the results on screen in a matrix of sampling times (rows) and port heights (columns). Power curves of the suspended solids concentration as a function of depth from the surface are fitted (using the least-squares technique) for each sampling time. The curves are of the form

$$C_T = a'D^{b'} - C'_T \quad (2)$$

where

- $C_T$  = suspended solids concentration, mg/L
- $D$  = depth from water surface, ft
- $C'_T$  = suspended solids concentration at the surface, mg/L
- $T$  = time since disposal, hr
- $a', b'$  = regression coefficients

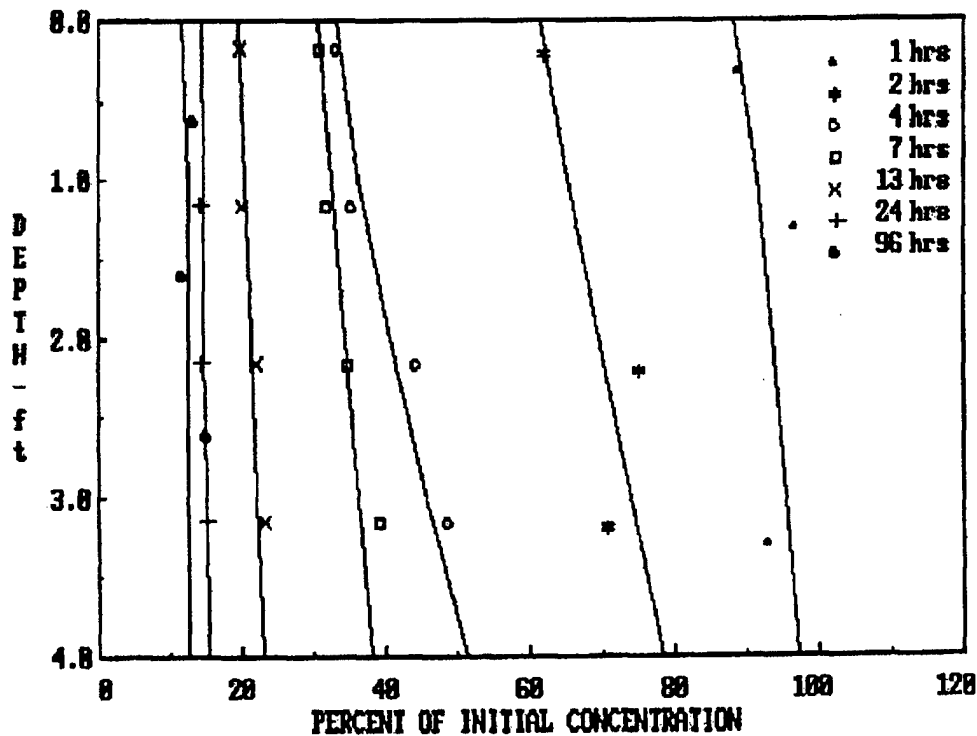


Figure 3. Example plot of flocculent settling data

SETTLE displays the regression equations and their coefficients for each time. Regression coefficients are not displayed since each curve results from only a small number of data points (usually 2 to 4) and the values would have little significance. A number of constraints are placed upon the regression results to ensure reasonable curves when using only a small number of data points. An option to allow the user to modify these coefficients to better fit the data may be added at a later time. A graphical display of the flocculent settling data and the fitted curves is available so the user can visualize the regression results. An example plot is shown in Figure 3.

SETTLE uses the regression equations to compute the suspended solids removal percentages as a function of the sampling times for user-specified withdrawal depths. Solids removal increases with time and decreases with increasing depths of withdrawal. The computed values are displayed for the user to evaluate.

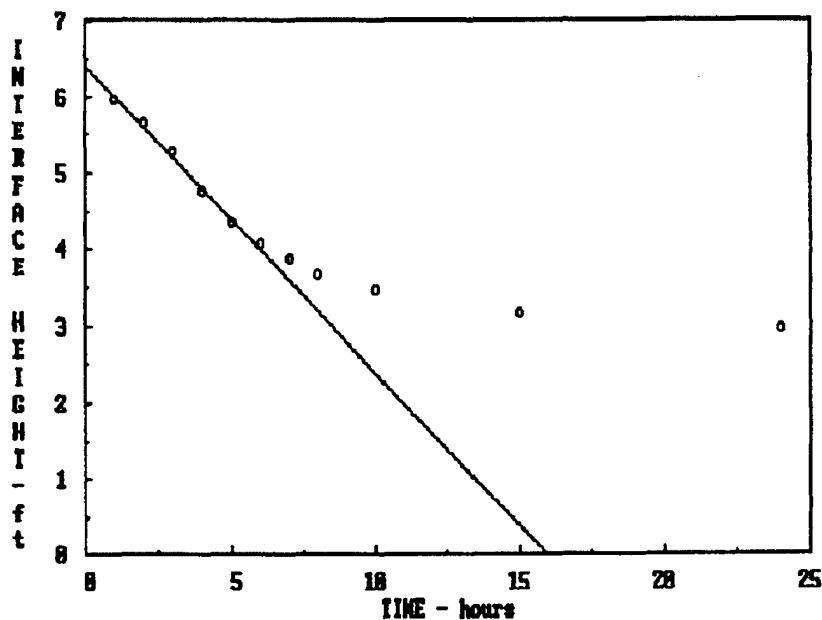


Figure 4. Example plot of zone settling data

**Zone Settling Data.** Zone settling data entry consists of only one screen for the interface height versus time data; Table 4 describes the input data along with their corresponding units. A second screen displays the zone settling velocity computed as the maximum negative slope separating two points in time at least 2 hr apart. The screen also displays its point of tangency. Unfortunately this is not a perfect criteria for determining the zone settling velocity. Thus, an option for viewing the data and zone settling velocity line is also provided and the program permits the user to enter his own zone settling velocity. The graph displays the user-defined zone settling velocity and point of tangency. The user should try several values of zone settling velocity, viewing each on the graph provided, to determine the zone settling velocity which should be used. The user-defined zone settling velocity is used in all design calculations. An example plot of the zone settling data is shown in Figure 4.

## Entering/Editing Project Data

Selecting option 2, enter/edit project data, from the *SETTLE Activity Selection Menu* initiates the entry and editing process for data describing the dredging project. Table 5 lists the required project data and appropriate units. Close inspection of the list in Table 5 indicates some apparent overspecification. For example, it appears that the inflow rate, pipe velocity, and pipe diameter are required input data; actually, the user only needs to input any two of these parameters and SETTLE computes the third. Similarly, the input for several project data parameters can be expressed in alternative ways; in situ sediment solids concentration can be expressed in terms of water content or void ratio and specific gravity. SETTLE allows the user to enter the data either way and then calculates the value for the other. Some of the input parameters may also be the focus of design calculations. Although they are not required, entering them does not affect the design calculations. For example, if you wish to determine the minimum area and volume required for storage given the dike height, depth of ponding, and freeboard, the interior area for storage need not be specified because it will be the result of the analysis as opposed to a variable used in the analysis.

The project data are entered through four data input screens. The first two screens request information about the sediment to be dredged — dredging volume, percent fines, specific gravity, and settled sands concentration. The third screen asks for dredge production data such as pipe diameter, inflow concentration, inflow rate, and pipe velocity. Disposal area configuration constraints are entered in the final screen. These constraints include maximum dike height, minimum depth of ponded water, maximum total and ponded surface area considering effects of sloped dikes, minimum dike freeboard, minimum hydraulic efficiency, and maximum effluent solids concentration.

### Program Execution using Laboratory Settling Data

Once the settling test and dredging project data have been entered, SETTLE is ready to determine the desired parameters by performing design calculations for the CDF. Design calculations using laboratory settling data are initiated by selecting option 3, execute using laboratory settling data, from the *SETTLE Activity Selection Menu*. Selecting this option provides the user with a screen containing available design options (Table 6) for initial storage, clarification, and effluent quality. The user must select the design parameter (for example, surface area, ponded depth, and dike height) to be calculated for each criteria. The design parameters for each criteria are fully independent; the user may select the same or different design parameters for each criteria.

One of four design parameters can be calculated based on the compression settling data; two based on the zone settling data; and three based on the flocculent settling data. Compression settling data may be used to compute either the initial storage volume required given the disposal duration, the minimum dike height required to provide adequate storage volume given the surface area of the disposal facility and the disposal duration, the maximum influent flow rate that permits compression settling to reduce the storage requirements

to the available volume of the disposal facility, or the minimum storage area required to provide adequate storage volume given the dike height and the disposal duration.

Zone settling data may be used to compute either the minimum area required for effective zone settling given the influent flow rate or the maximum influent flow rate permitted for effective zone settling given the ponded surface area of the disposal facility.

Flocculent settling data may be used to compute either the effluent suspended solids concentration given the ponded water depth, ponded area and influent flow rate; the minimum surface area required to achieve the desired effluent suspended solids concentration given the depth of ponding and influent flow rate; the maximum influent flow rate permitted to achieve the desired effluent suspended solids concentration given the ponded depth and ponded area; or the minimum depth of ponding to achieve the desired effluent suspended solids concentration given the ponded area and the maximum influent flow rate. The actual minimum ponded depth must be great enough to prevent scouring and resuspension.

Once the user has decided upon the design parameters to be computed and presses the Page Down key, SETTLE performs the design calculations. If data are missing for any of the three analyses requested, the program will list the types of data missing and then performs the calculation for those analyses where all data requirements had been satisfied. The following screen summarizes the results by settling type. If flocculent settling results are available, the user may view a graph of effluent concentration versus retention time for up to three withdrawal depths specified by the user. Additional screens follow which present the equations upon which the design for compression settling, zone settling, and flocculent settling are based. These screens include variable definitions and limiting assumptions for each equation. SETTLE can also print the results to a connected printer.

### **Using Typical and Conservative Small Project Data**

Some small dredging projects do not warrant the expense and delay involved in conducting the laboratory settling tests. SETTLE provides two options to performing design calculations for these small projects. Schaefer and Schroeder (1988) compiled results from a number of settling tests and developed representative settling test data sets for use in small projects. One data set was developed corresponding to anticipated or typical settling characteristics. A second data set corresponding to conservative settling characteristics was also developed. SETTLE provides these sets of settling data for small projects under option 4, Execute using typical small project data, and option 5, execute using conservative small project data, of the *SETTLE Activity Selection Menu*.

SETTLE presents design results for the small project data in the same manner as described for the laboratory settling test data, substituting default

settling characteristics for the laboratory settling test results. These options should only be as a last resort for small projects or planning.

### **Calculating Weir Length**

SETTLE calculates the weir length necessary to avoid entrainment of solids for either zone or flocculent settling under option 6, perform weir length design, of the *SETTLE Activity Selection Menu*. Selecting this option displays a screen allowing the user to select weir length design for either flocculent or zone settling and showing the current withdrawal depth and design flow rate. The user may enter or edit the desired withdrawal depth or design flow rate and SETTLE will recalculate the weir length.

### **File Operations and Hardware Setup**

File operations (Option 7) and hardware configuration for graphics (Option 8) are described earlier in the section entitled "Getting Started." Graphics are an integral part of the design process using SETTLE. As a minimum, the user should specify the proper type of video display adapter and monitor to display graphics. Similarly, users should become familiar enough with file operations to save their data in a file or retrieve/read their data from a file previously saved.

### **Applying SETTLE Results**

SETTLE calculates design parameters based on laboratory settling test data and dredging project data. It provides CDF sizing calculations based on the three types of settling which are likely to occur in a CDF--compression settling, zone settling, and flocculent settling. The SETTLE user must understand the differences in these settling characteristics and be capable of determining which controls the design for the project of interest.

In cases where the effluent quality restrictions include parameters other than suspended solids concentration, the ADDAMS module EFQUAL (Palermo and Schroeder 1991) should be used in conjunction with SETTLE to design the CDF.

### **Summary**

SETTLE is another ADDAMS tool which facilitates proper dredged material management by providing an effective and efficient means of performing CDF design calculations. SETTLE is easy to use and encourages the evaluation of an array of design alternatives. It does not, however, preclude the need for laboratory settling tests on the dredged material to be placed in the CDF. These tests will continue to be required until reliable relationships between sediment characteristics and settling properties can be established.
