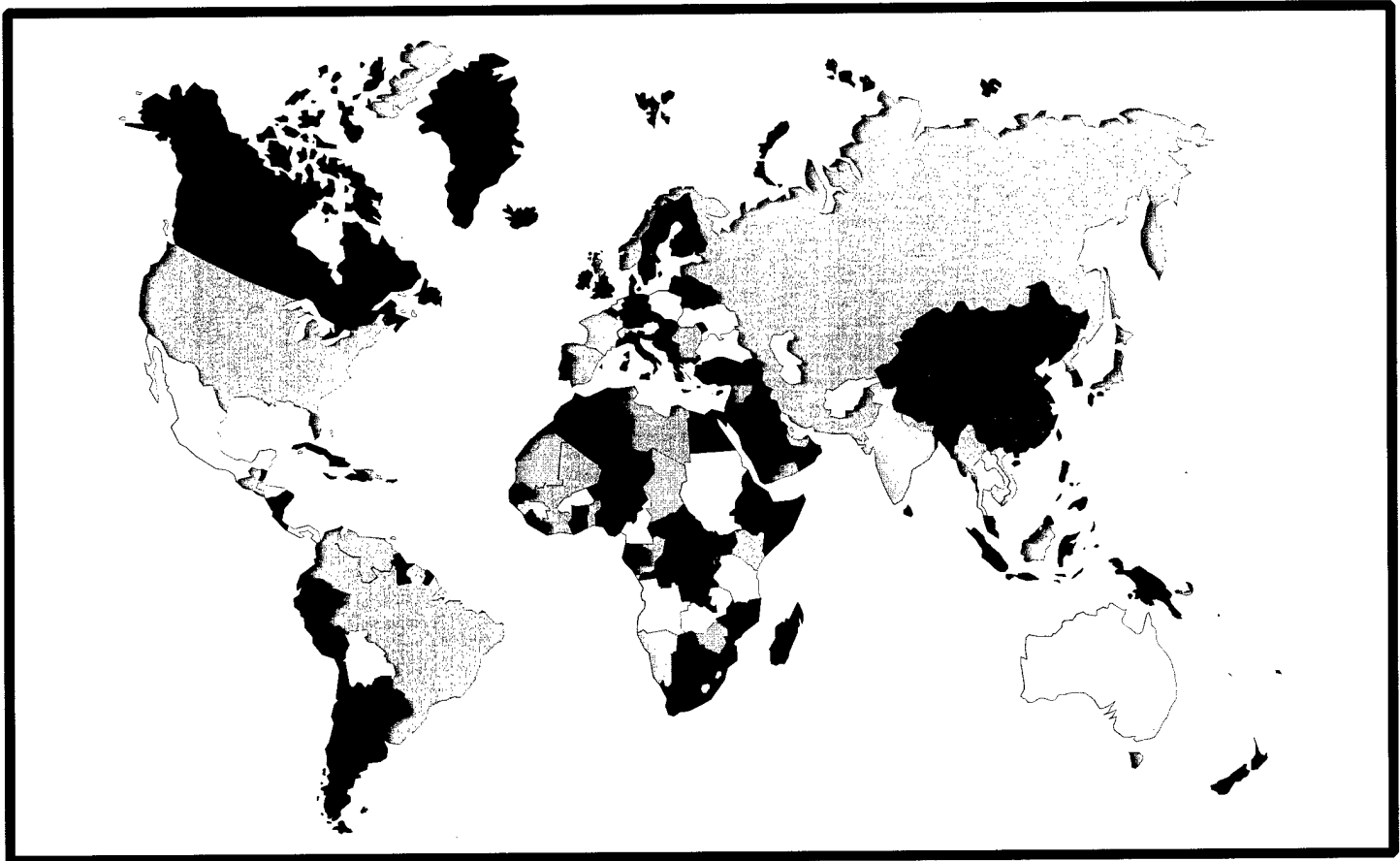

PREFACE

Multinational operations. A collective term to describe military actions conducted by forces of two or more nations, usually undertaken within the structure of a coalition or alliance.

— *Joint Pub 3-16 Glossary*

As this bibliography goes to press, in the aftermath of the devastating 11 September 2001 terrorist attacks on the United States, our nation's leaders are working to forge a multinational coalition to combat terrorism. Therefore, it seems appropriate to begin with a sampling of recent citations about the broad global alliance which is now forming.

Compiled to support the curriculum's Multinational Operations AY02 special theme, the main part of the bibliography focuses on the special challenges of multinational operations such as command arrangements, interoperability, intelligence sharing, and cultural diversity. It does not include general descriptions of multinational operations and exercises. Most of the items listed have publication dates of 1995 to the present.

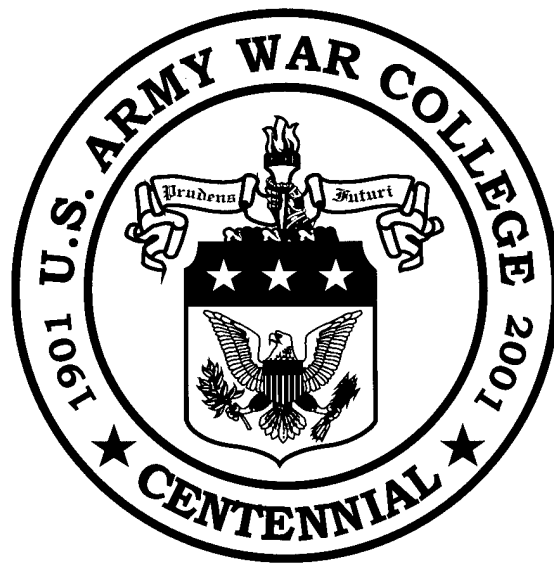
