1. Purpose. To identify approved Department of Defense (DoD), Department of the Army (DA), interagency, and HQ TRADOC reports which TRADOC staff, organizations, and activities are preparing agency(ies); and HQ TRADOC monitoring staff offices.

2. References. Required and related publications are listed in appendix A.

3. Explanation of abbreviations, terms, and codes. The glossary contains abbreviations, terms, and codes used in this pamphlet.

4. Monitoring information reporting requirements. Within their area of primary interest, the HQ TRADOC monitoring staff offices identified in appendix B--

TRADOC Pam 25-53

a. Ensure all TRADOC, DoD, DA, and interagency reports prepared by HQ TRADOC and command elements are correctly identified in this pamphlet (app C) unless exempt. Exemptions from management information control are cited in the prescribing directive. Uncontrolled (those without a requirement control symbol) reports need to be brought to the attention of the proponent of this pamphlet.

b. Provide the proponent of this pamphlet with all directives, both HQ TRADOC and non-TRADOC, which create, change, supersede, or rescind reports.

5. Assignment of requirements control symbols (RCS).

a. The designated Management Information Control Officer (MICO) with jurisdiction assigns the RCS to approved management information requirements (see AR 335-15). The proponent for this pamphlet is the HQ TRADOC and command MICO.

b. The prefix will be changed when proponenty for a report is transferred to another activity or upon reorganization after the prescribing directive is changed.

6. Listing of information reporting requirements by monitoring staff office (see app C).

7. Alphanumeric index of approved recurring information requirements (see app D).

8. Numerical listing of reporting forms (see app E).

Requirement control symbol

A symbol assigned to an approved reporting requirement by the initiating agency.

Requiring directive

Official directive which creates or changes the reporting requirement; states who will submit the data; and provides procedures, definitions, forms, and information sources.


