ABSTRACT (Maximum 200 Words) Winston-Salem State University (WSSU) a designated Historically Black College and University (HBCU) is committed to resolving some of the economic, social and health problems in the community in which the university is located. Breast cancer deaths and complication occur disproportionately in minority women than majority women within this community. This proposal is designed to develop a sustainable breast cancer training program at WSSU. Four faculty post docs from the School of Health Sciences are developing research skills by engaging in breast cancer research with professors at Johns Hopkins University who are experts in this area. In order to accomplish this project an interdisciplinary committee of doctors, nurses, educators, researchers and professors who have engaged in breast cancer research led by the researchers from JHU, are guiding the faculty through this development. The objectives of this training program are to allow the trainees the opportunity to develop fundable research proposals, to conduct successful clinical research projects, and to publish and to train other WSSU researchers. The faculty post docs will be able to apply their knowledge to assist minority elderly women to learn how to discover signs of cancer before the cancer becomes hard to treat. The knowledge gained will allow these researchers to participate in the training of other researchers in the area of breast cancer. Consistent with year 1 objectives, the four faculty post docs have completed two research courses, received approval of their pilot study by the interdisciplinary team and are preparing a manuscript on breast cancer for publication.

Introduction

This 4-year training program is designed to prepare four faculty members in the School of Health Sciences (SOHS) to conduct research in the area of breast cancer. The program is intended to lay the groundwork for additional faculty to engage in breast cancer research by enhancing the research infrastructure in the SOHS. The four faculty members currently involved in the program represent nursing, clinical laboratory sciences, occupational therapy and physical therapy. Each of these faculty members is paired with a mentor from Johns Hopkins University School of Nursing (JHUSON) who is conducting breast cancer research. The JHUSON mentors are co-investigators on the project. Four academicians and practitioners from Wake Forest University Baptist Medical Center (WFUBMC) who are involved in providing health care to breast cancer clients or in conducting breast cancer research serve as consultants. These consultants represent the disciplines of gerontology, epidemiology, geriatrics and oncology. Two faculty members at WSSU serve as advisors and consultants to the four faculty post docs. The project also includes a biostatistician, housed at JHUSON (See Appendix F), and a research assistant (See Appendix J), housed at WSSU. These persons assist the four faculty members/post docs to meet the goals of the program. In addition, the research assistant assists in establishing a research center at WSSU. The Principal Investigator, Dr. Sylvia Flack, has administrative oversight of the project.

Reportable Outcomes

Meetings to Develop Infrastructure

Several meetings were held to discuss the infrastructure and procedures for the training program. Two interdisciplinary team meetings, which included with researchers, clinicians and educators from WSSU, JHUSON and WFUBMC, have been held. The first meeting was held on August 6, 2001 and the second on July 30, 2002 (See Appendix B). The PI and JHU Project Director met separately in November 2001 to further refine procedures and guidelines. Interactions between the PI and the JHU project director have been on going.

Design Training Program and Begin Training

Formal and informal interactions between the mentors and trainees have been on going through email, telephone conferences, and face-to-face meetings. Initial discussions included identifying needs of the trainees. Based on those discussions, the JHU faculty designed a weeklong course. The course was held January 14-18, 2002. Course content included instruction on research design and methods, including use of SPSS (See Appendix C). Post docs also received dyadic assistance with conceptualizing their research problems for the pilot studies and for the secondary analysis study. (The post docs are using breast cancer data compiled by their mentors to conduct secondary analyses and to develop a manuscript for publication). An outcome of the course was the completion of a written assignment that included a literature review and a conceptual framework for the secondary analysis study.

A second course was held at JHU August 5-9, 2002. Important outcomes of the course included: a) identification and refinement of variables in both the pilot study and the secondary analysis study and b) clear, definitive research questions for pilot study and secondary analysis study (See Appendix C).

The training program of the post docs also has included seminars by WSSU and WFUBMC consultants and advisors. These are opened to all faculty. Seminars have been presented on the following topics:

- Geriatrics for the non-Physician
- The ABC's and D's of Epidemiology: Principles and Examples
- Breast Cancer Management and Therapies
- Identification of Prognostic Markers in Breast Tumors
- Writing for Publication
- Conducting Research on Geriatric Participants
- Developing a Program of Research

Employed Biostatistician and Research Assistant

In month three of the project a biostatistician was hired to assist the post docs to conceptualize the research model for their pilot project and the secondary data study and to run data analyses on the secondary data set. Trainees had three face-to-face meetings with the biostatistician (twice at JHU and once at WSSU). The research assistant position was filled in month 6 of the project. (Prior to filling the RA position, each faculty post doc had a graduate assistant who was instrumental in assisting him/her with literature searches and retrieval of publications).

Research Center

The RA has been instrumental in assisting with establishing the research center in the SOHSs. The research center will be housed in the addition to the current SOHS' building. We are expected to occupy the addition in 31 October 2002. Resources for the research center have begun to be collected. Below is a list of item that has been obtained.

- Approximately 500 articles on breast cancer and related topics have been obtained and are ready to be filed.
- Bibliographic software has been purchased for each of the faculty post docs. In addition, the software will be loaded on a computer in the Research Center that will contain references on each of the articles on file
- All grants submitted in the School of Health Sciences have been placed in notebooks for faculty review
- Guidelines and application for IRB approval are on file
- Internal processing forms for external grant submissions are on file
- Research design books have been purchased
- Computers, which will store quantitative and qualitative statistical packages, have been purchased

In addition, a list of books identifying potential funding sources has been submitted to the WSSU for purchase.

Pilot Studies

The four faculty post docs have received approval on their pilot studies from the Interdisciplinary Team. The following are the approved research questions for each of the 4 pilot studies.

Pilot Study 1:

What is the extent of knowledge of breast cancer tumor markers among patients with breast cancer?

What are the effects of knowledge of breast cancer tumor marker results on anxiety, depression, stress, quality of life, patient behavior, coping and fatigue?

What is the relationship between extent of knowledge about breast cancer tumor marker results and extraneous factors (tumor size, tumor stage, metastasis, treatment history and type, general health status, fatigue, and selective demographics)?

What is the relationship between the extent of knowledge about breast cancer tumor marker results and anxiety, depression, stress, quality of life, coping and fatigue?

Pilot Study 2:

What are the predictors of functional status in older minority women who have been treated for the breast cancer?

Pilot Study 3:

What is the relationship between hand and upper extremity function, and tactile sensitivity of the fingers in the ability of elderly minority women to detect breast tumor size?

Pilot Study 4:

What are the relationships among stress, knowledge of Breast Self Exams (BSE), coping, tumor size (cancer stage) and adherence to breast cancer screening activities?

Does stress and knowledge of breast self examination effect adherence to BSE?

What is the relationship between tumor size and adherence to breast screening activities?

Which of the following variables: tumor size, stress, knowledge of BSE and coping are predictive of adherence to breast screening activities?

Staffing Changes

We have found it necessary to include a project director to assist the PI in the project's implementation. Specifically, the project director directs the activities of the research assistant, assists in creating a research infrastructure in the SOHS, assists the post docs in their achieving the goals of the program, assists SOHS' faculty in securing grant funds and plans and conducts research seminars. Dr. Lenora Campbell is serving as the project director. Dr. Campbell is a professor in the Department of Nursing and holds the Bertha L. Shelton Endowed Chair. Dr. Campbell has conducted funded research in the areas of child health, focusing specifically on health disparities among minority youth. (See Appendix D). Dr. Campbell devotes 10% of her time to this role; her time on the project is donated by the university.

Two advisors and one consultant have resigned from WSSU and WFUBMC and, thus, have left the project. Ms. Carol Boles, the Director of the Community Family Practice and Wellness Center (formerly University/Community Wellness Center) resigned from the university in April 2002 to pursue doctoral study. Rodger Melton is the new director

and has assumed the role of securing sites for data collection (See Appendix I). Dr. Electra Paskett resigned her position at WFUBMC in Fall 2001. Dr. Sharon Jackson, also of the School of Public Health at Wake Forest University, has replaced Dr. Paskett. Dr. Jackson is an Epidemiologist and is the Acting Director for the Maya Angelou Research Center on Health (See Appendix E). Dr. Richard Bennett went on Medical leave in November 2001. He has since returned to WSSU but is unable to participate in the training program. Dr. B. Lee Stackhouse, Chairperson of the Biology Department, agreed to replace Dr. Bennett. Dr. Stackhouse has extensive experience in studying markers in breast tumors (See Appendix G). Finally, Dr. Todd Watson, the faculty post doc from the Department of Physical Therapy, resigned from the university in April 2002. Dr. Hamdy Radwan, Associate Professor in the Department of Physical Therapy, has since joined the training program. Dr. Radwan has extensive experience in physical therapy with a focus on orthopedics, acute care and geriatric specialties (See Appendix H).

Key Research Accomplishments

- Two post docs presented a poster presentation at the Era of Hope Breast Cancer Conference in Orlando Florida, entitled "Psychological distress, fatigue, burden of care, and quality of life in primary caregivers of breast cancer ABMT patients." September 24-28, 2002.
- Dr. Sylvia Flack, PI, presented a poster session entitled "Developing a Training Program in Breast Cancer Research to Decrease the Disparity of Morbidity and Mortality in Underserved/Minority Women" at the Era of Hope Breast Cancer Conference in Orlando Florida.
- The PI and the four post docs presented a seminar on conducting multidisciplinary research at the Clinical Laboratory Conference in Greensboro, North Carolina, April 2, 2002.
- The post docs presented a poster session at the WSSU research day conference entitled "Developing a training program in breast cancer research to decrease the disparity of morbidity and mortality in underserved/minority women," in April 2002.
- All post docs and the PI attended the Era of Hope Breast Cancer Conference in Orlando, Florida September 24-28, 2002.
- The Project Director received funding from the Susan G. Komen Foundation to implement a breast cancer prevention and early detection program for low-income minority women.
- The PI and Project Director have submitted other non-cancer related proposals to enhance post doc faculty involvement in research.
- One of the post docs (with the project director and other nursing faculty) submitted an abstract to the Oncology Nursing Society's National Conference.
- Dr. Bobbie Reddick (post doc) presented a poster at the WSSU Research Day entitled "A Woman's Touch."

- Dr. Reddick attended the Cancer Prevention and Early Intervention Institute for HBCU/MI Nurse Educators in Ft. Lauderdale, Florida on March 2, 2002.
- The faculty post docs presented their secondary data at the Interdisciplinary Team Meeting on July 30, 2002.
- WSSU was featured on UNC-TV's "NOW" program for the DOD and Komen breast cancer projects.

- Design and implement breast cancer pilot studies
- Develop and submit grant applications
- Submit at least one research abstract to the CDMRP and for a presentation in scientific conference
- Begin designing the training program for future WSSU researchers
- Evaluation by interdisciplinary committee at the end of the 2nd and 3rd year, Lead by the PI
- Prepare and submit annual report at the end of year 2 and 3, Lead by the PI

Phase 3: Project Completion and Evaluation (Year 4)

- Analysis and interpretation of data gathered, 2nd quarter of the year.
- Complete the design of the training program for future researchers, by the end of the fourth year
- Submit research grant proposals for future research funding, by end of fourth year.
- Submit research articles by each trainee for publication in scientific literature, by end of fourth year.
- Submit one collaborative article for publication in scientific literature by end of fourth year.
- Evaluation of the project processes and outcomes by interdisciplinary committee at the end of year 4
- Begin to solicit applications for the next trainee rotation by the end of the fourth year.
- Complete summative evaluation lead by PI.

- Prepare and submit reports summarizing the outcomes of the collaborative training and research studies; any publications will be submitted to the CDMRP lead by PI.

Purpose and Relevance of Project

Dr. Flack discussed the University's mission as teaching, research and service. According to Dr. Flack Forsyth County leads the state in many health care problems. The School of Health Sciences began to address some of these issues by establishing the University/Community Wellness Center that has the potential to serve 33,000 underserved residents of public housing. Breast cancer was selected as a research focus because minority women, African-Americans in particular, experience less occurrences of the disease but have a higher mortality. Because Winston-Salem State University (WSSU) does not have the infrastructure to proceed with clinical research in this area, a partnership with Johns Hopkins University (JHU) was established.

Overall Project Plan

The training grant provides postdoctoral experiences for four faculty in the School of Health Sciences, representing four of the five departments. Faculty members will be paired with mentors from JHU based on their interest and the expertise of mentors. In addition, faculty from Wake Forest University Medical Center (WFUMH) with expertise in the areas of study will provide support to the post docs. The precise role of the consultants from WFUMC will be determined when mentors meet with post docs and refine research questions. The interdisciplinary committee will meet biannually in Winston-Salem for the length of the grant (four years). Post docs will communicate with mentors via 2 meetings/year at JHU and via telephone, email and fax.

A part-time biostatistician and research assistance will be hired to work with the post docs and to facilitate the research process at both sites. The biostatistician will be located at JHU (in order to work with data sets available to the post docs but located at JHU). The research assistant will be located at WSSU to assist the post docs with the day-to-day research needs and to create the research center. Both will help in facilitating the research process at both sites. Post docs will have 30% release time the first year and 25% release time during years 2-4 to complete the training.

Overview: Training Program Plan

Dr. Fannie Gaston-Johansson identified the 3 components of the research infrastructure to be developed at WSSU:

- Faculty development within WSSU
- Building research center

▪ Interdisciplinary team and using resources at WSSU, WFUMC & JHU

Faculty development of post docs will be based on their specific interest and a needs assessment (including their educational needs and research needs). Pending these assessments, a more clearly delineated plan for consultation by WFUMC faculty, the University/Community Wellness Center and Dr. Bennett will be developed. WFUMC faculty requested that the plan be in writing. The written document, then, will become a part of the evaluation plan to be submitted with the continuation application to the Department of Defense (DOD). A pivotal component of faculty development will be biannual meetings between the post docs and their mentors. The first 5-day meeting will be in November at JHU. Prior to that meeting, post docs are to write/email mentors outlining their research question, educational and research needs, etc. Post docs should consider their needs for course work and consultation in areas such as oncology, gerontology, research design, statistical methods and measurement and research ethics. They may consider group study. Mentors and consultants will help select materials significant to research questions relevant courses already in place at WSSU and WFUMC. A training plan for each post doc must be in writing as well as the written pilot proposal (due by the end of the year). This will be brought back to the interdisciplinary committee for review at the end of the first year). Dr. Gaston-Johansson reminded Dr. Ryman that she will be in the US for the November meeting but prior to that she will be in Sweden. She reminded the post docs that their ability to engage in independent study would be critical. There will be a lot of reading and synthesis of materials. WSSU needs to create a research environment for post doc.

Publishing is an important aspect of the training. During year 1, post docs will be working with secondary data provided by mentors to gain experience in writing and publishing. This is a necessary process for applying for independent funding at NIH or other funding agencies. Pilot studies also are necessary and should serve as the basis for a full research project. Research abstracts and presentations are important as well. An outcome of the grant is for each of the post docs to submit a proposal for funding.

Additional outcomes of the grant are a functional Research Center and a functional interdisciplinary team. DOD must know that everyone is participating and there must be evidence of this in writing.

Some areas that require discussion are:

- How do you define the initial diagnosis of breast cancer? There are complications in how this is defined
- How to get sample?
- What is an adequate sample size?
- How to define elderly?
- The validity and reliability of Measures

Annual Report/Evaluation submitted to DOD must include what has been done:

- Different mile stones
- When the research began
- When the training is completed
- When are the pilot studies up and running

IRB approval must be sought prior to implementing pilot study (year two). IRB approval will be obtained from both WSSU and JHU. Seeking IRB approval in year 2 will give time for pilot study plan to developed and approved by interdisciplinary. Also in second year post docs will start their pilot study; start looking at funding application; based on data collected secondary analysis, send in a abstract to present at conference; begin designing plan for future researchers.

Interdisciplinary committee will meet and identify milestones that have been met. This will assist us in keeping on tract in relation to evaluation

In year 4, post docs should have completed the pilot study and the data analysis and submitted research articles for publication and a grant for future funding. The highlight of fourth year is the development and submission of funding proposal.

Major outcomes of research include:

- Infrastructure in place
- Post –docs are prepared
- Functioning Interdisciplinary team
- Functioning Research Center
 - File cabinet of instruments
 - Physical layout plan
 - Support for publishing papers and research grants
- Post doc Development
 - Presented at conference
 - Submission of Article
 - Submission of Proposal
 - Research results documented

To accommodate the needs of post docs, Dr. Flack indicated that she would come up with other ways to provide additional time if needed. Dr. Flack also indicated that in addition to training additional faculty, i.e., submitting for funding to train additional faculty, we should also branch out to other health disparities.

Questions were raised re: Dr. Kasper's data set, i.e., it includes animals not humans. According to Dr. Flack, if we use animals in any form, we have to go back to the DOD and obtain permission. We have only identified human subjects. WSSU does have approval to conduct research on animals. Dr. Flack reminded the group to bring up for discussion any questions that arise to ensure that activities are consistent with DOD protocol.

The following question about the research were raised:

Feasibility of community-based screening to get an adequate sample size to conduct the four studies was discussed. Given the statistics of 13 per 100,000 get breast cancer (white); 10 per 100,000 get breast cancer (African-American), we may need to screen a very large number of

women to get adequate sample. Discussion ensued re: other possible sites for getting women with newly diagnosed breast cancer. The following ideas were discussed:

- Downtown health clinics – underserved population
- Women center of excellence
 - Population of women different from downtown
 - What is the population?
- Do we stay within Forsyth County – may need to expand – 302 were diagnosed in Forsyth County majority are white
- Should sample be limited to elderly women?
- Should we include women who have already been diagnosed?
 - (Study may be biased if women already knows that they have cancer i.e. doing depression scales of women dilemma getting prescreening and costly of getting the number of individuals with cancer)

Aims of study – underserved elderly minority women – does it mean only African Americans? Could we use any minority? Need to define “minority”

Defining the elderly as persons 65 and older may delimit the sample too much.

Cancer society uses 50 as the designation for elderly

Cancer morphology is similar at ages 40, 50 , 60

Probably no one would define 40 as elderly

Decision was made for 50 to be the cut off

Should participants be provided incentives for participating? This was not written into the budget. Residents of the Wellness Center receive a number of benefits already and incentives might compromise the existing relationship with nursing.

Dr. Gaston-Johannson indicated that the activities of the Center are separate from those of the research and that distinction should be clearly communicated to residents invited to participate. It should be clear to them that this is research and their consent or refusal to participate will not interfere with what they currently receive from the Center.

Presentation of Research Questions – Project Post-Docs

Dr. Denny Ryman

Dr. Denny’s research will explore the CA15-3/CA27.29 antigen which is produced by the tumor itself and is being used now after surgery and/or treatment to see if cancer comes back but not for diagnosis. He would like to focus on the correlation of tumors of the breast and cancer tumor markers; ultimately using these markers in much the same way as other cancer markers are used. Sensitivity levels are too low for initial diagnosis but other studies indicate that CA27.29 is sensitive enough for initial diagnosis of breast cancer with metastasis. There has been a lot of study with animals; but not for initial diagnosis. Some studies have been conducted in Ireland and Sweden. The initial study must compare size and levels. Questions were raised regarding

why tumor size is chosen rather than other indices? (Tumor size does not always determine the treatment modality.) Perhaps other areas could be used such as polidy; Most of research support is for more sensitive instrumentation. Questions were also raised as to why this research hasn't been done (if in fact that is the case). Dr. Ryman has researched 200 articles – only 2 studies focus on CA27.29 as initial diagnosis – everything else is used for monitoring treatment. There is a void there – not much correlation studies between the activity of the tumor and the quantitiveness of cancer marker. Questions were raised as to how the comparisons will be made? For the Control group, get a sample population who are negative and do marker for them - this is information of people who do not have breast cancer at the time; their levels are considered as negative----then take those identified with cancer and do cell marker and compare? Samples will be obtained from drawing blood or taking saliva sample – samples will be sent out for testing. Question was also raised as to the relationship of signal of the marker and the tumor size. The literature appears to indicate 30% cut off where tumor cannot detect; 70% certain level directly detect. Dr. Gaston-Johansson indicated that this is an exciting project. She cautioned, however, that it is important to look for all the facts before gathering any data. High sensitivity is an important determination to identify. It is important to have something simple that will identify need for further investigation of problem.

Dr. Lynda Baldwin

Dr. Baldwin has been reviewing breast cancer literature dealing with psychosocial and biochemical factors. In the literature, pain, fatigue, and depression appear to be common reactions to treatment, but no information concerning history of depression prior to diagnosis. Literature on stress and coping (i.e., concentration camps, loss of a spouse) indicated that depression is common during times of severe stress and that this may be associated with increased risk of cardiovascular disease and cancer. Dr. Baldwin is interested in behavioral and biochemical factors present at the time of diagnosis of breast cancer. She would also like to look at history of depression and a behavior cognitive component; orientation to life in an attempt to understand more about factors that proceed and possibly contribute to the development of breast cancer. She is also interested in women's ability to cope with stressors and methods used for coping. Are these methods any different than those used by women who do not develop breast cancer. She is also interested in determining if there is relationship of Orientation to Life/Sense of Coherence breast cancer;

Sense of coherence is a term used by Aaron Antonovsky to describe a global orientation to life that measures a person's ability to see life as comprehensible, manageable, and meaningful. Suggs suggested including a spirituality component. For example, is there a belief that God determines what happens to an individual therefore there is no need to prevent or is there a partnership with God and the individual has responsibility. There are some good recent studies. Examining biomarkers prior to diagnosis may prove problematically; Mock has done extensive work with exercise and breast cancer (these have been in relation to treatment not prevention). Need to be careful, however, exercise in and of itself may confound the results of the study. May also examine coping strategies studies by Gaston-Johannson .

Dr. Bobbie Reddick

Dr. Reddicks's interest is prevention, especially with the elderly. She is specifically interested in identifying factors that keep the elderly from doing self-breast examinations or going to the doctor for screening; What are the attitudes and practices to get minority women to participate in breast self examining at an earlier time? Spirituality may be an important issue; it may be both negative and positive. Do ministers and leaders in churches play a role in preventive practices of parishioners? Other reasons for lack of early detection practices may be fear of finding out. Merle Michele's work on Uncertainty might be helpful.

Q &A

Gaston-Johansson raised concerns about the cost of mammograms. We need to get statistics about how many people are needed to screen to identify a breast cancer – WFUMC has a lot of this data and will share.
