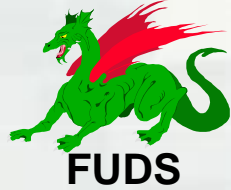

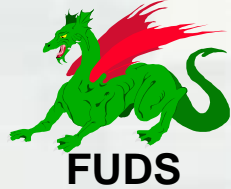

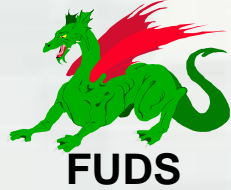
Program Objectives



- USACE initiated the FUDS Nationwide MMRP SI Program in FY05
- Program Objectives
 - ▶ Collect appropriate information necessary to:
 - Eliminate from further consideration those releases that pose no significant threat to public health or the environment
 - Determine potential need for removal action
 - Collect or develop additional data, appropriate for Hazard Ranking System (HRS) scoring by EPA; and
 - Collect data, as appropriate, to characterize release for effective and rapid initiation of remedial investigation and feasibility study (RI/FS)
 - ▶ Collect data to complete the Munitions Response Site Prioritization Protocol (MRSPP)



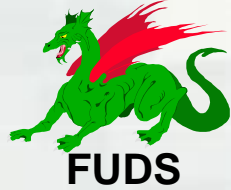

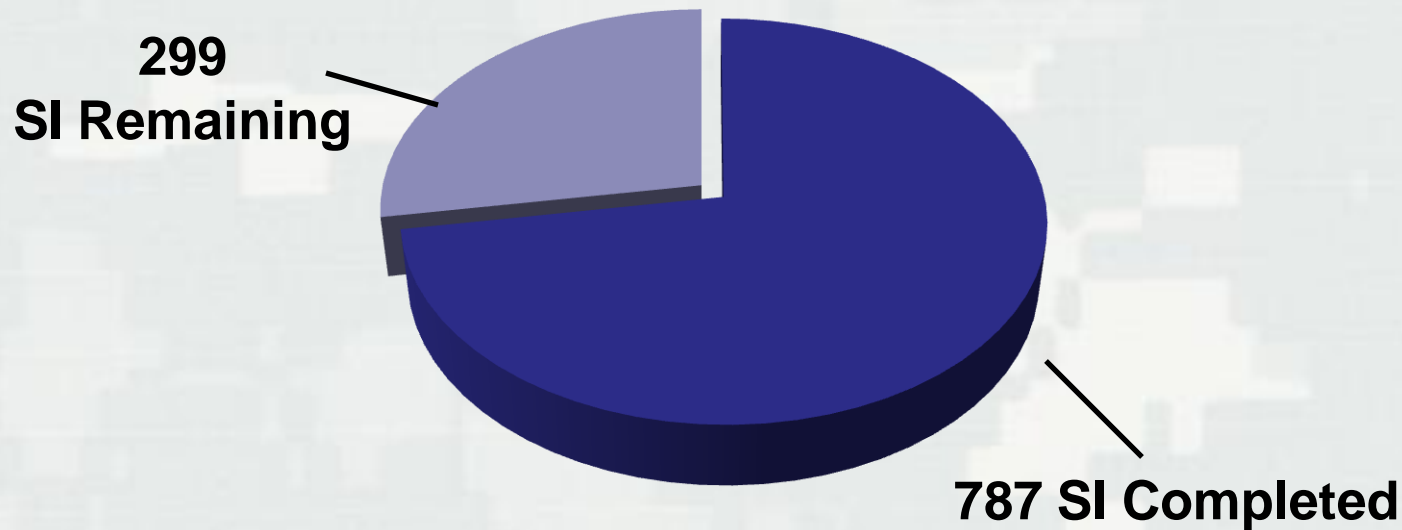

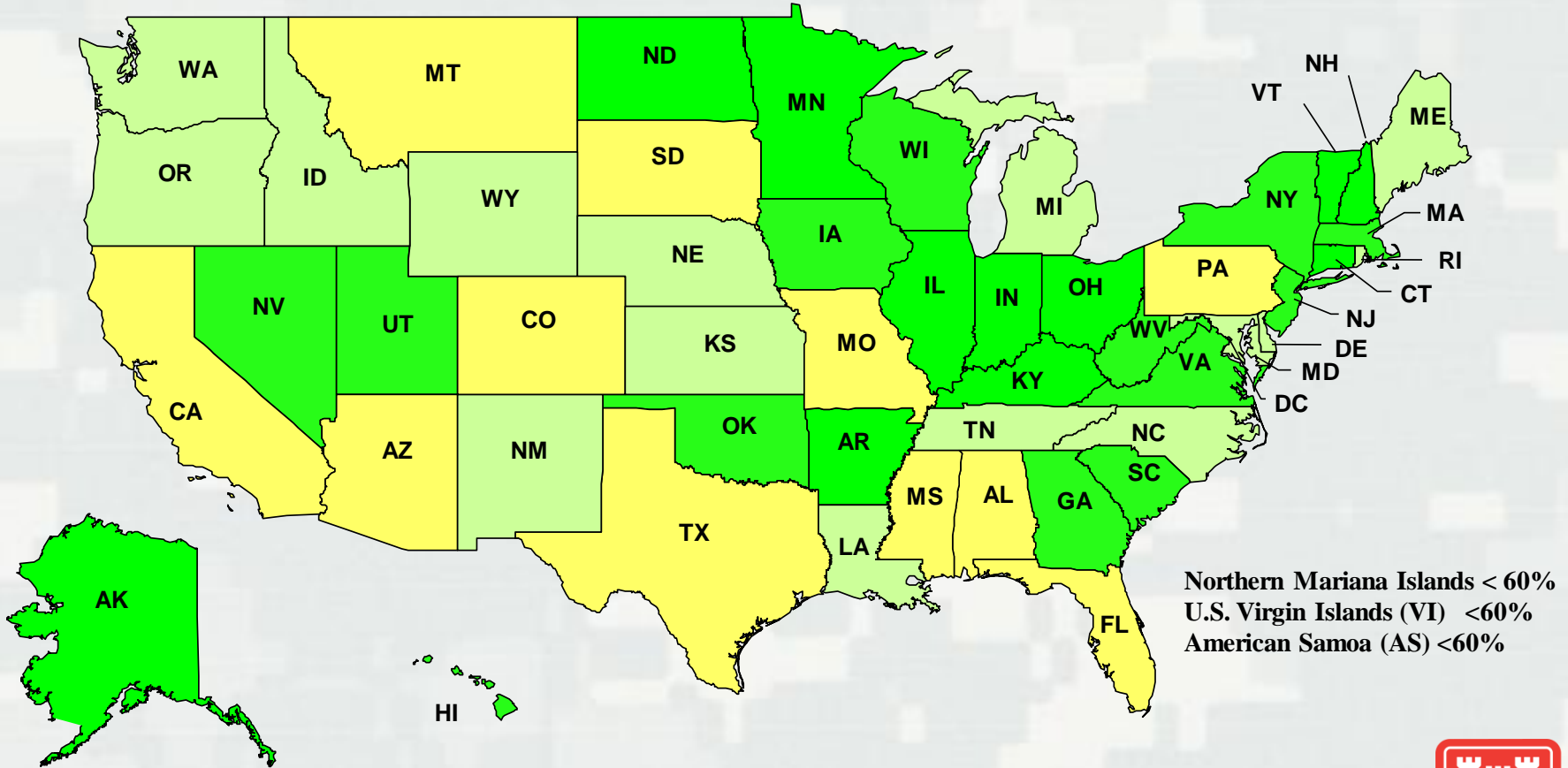


MMRP SI Program Status by State



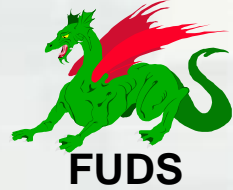

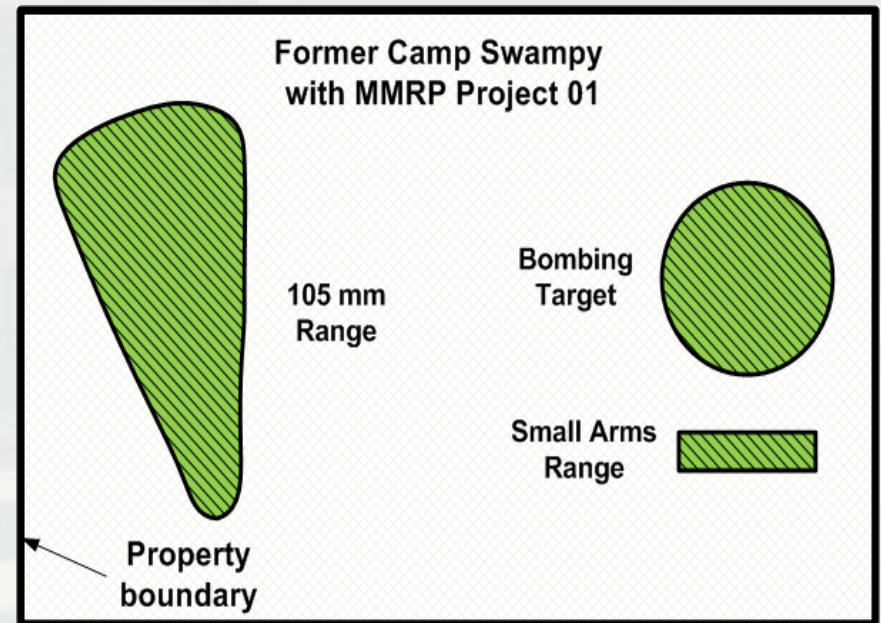
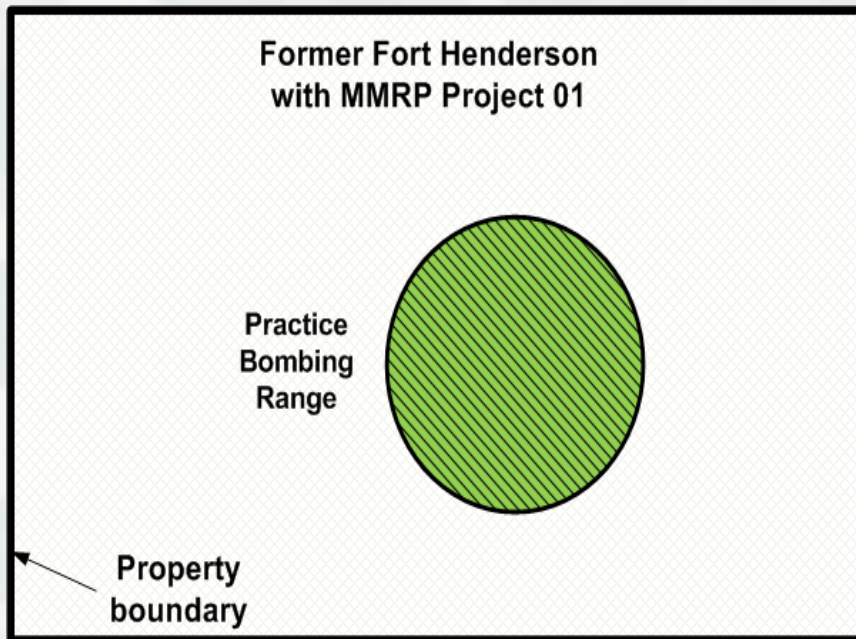

FUDS MMRP Project vs. MRS

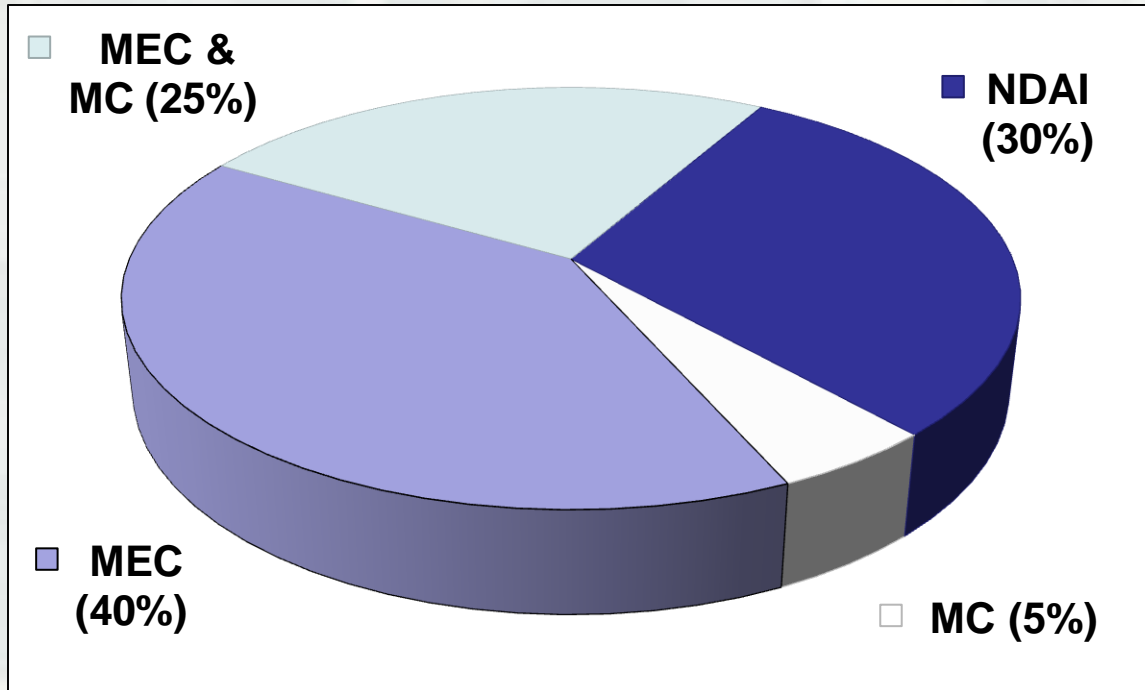
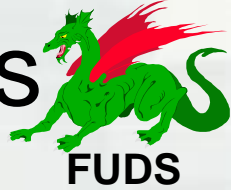


- Each project includes an average of ~2.0 Munitions Response Sites (MRS)

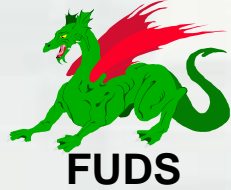

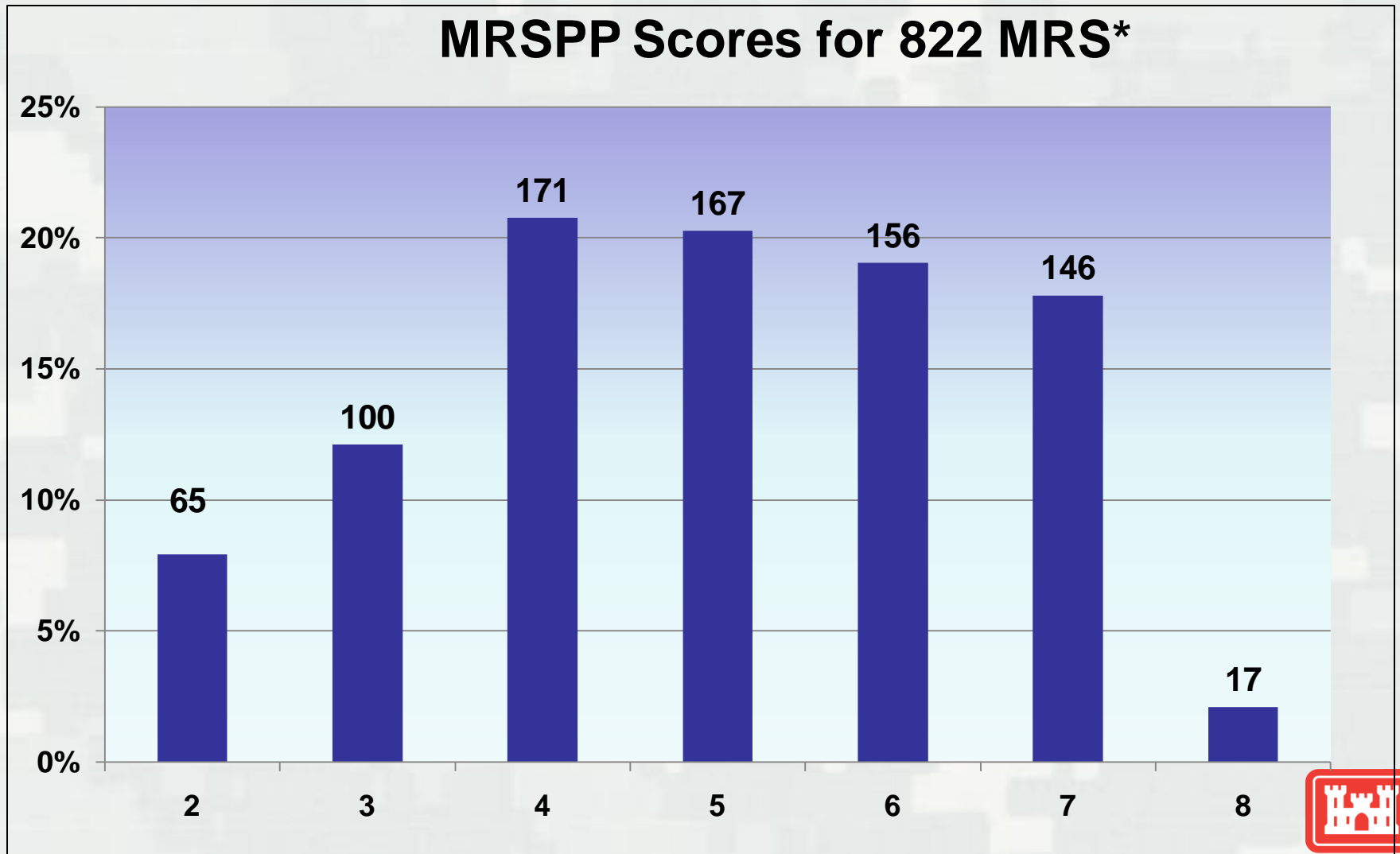


- Final Rule on 5 October 2005, codified in 32 CFR Part 179
- The Protocol is the methodology developed by the DoD to assign a relative priority (MRSPP score) to defense sites known or suspected of containing unexploded ordnance (UXO), discarded military munitions (DMM), or munitions constituents (MC).
- The Protocol provides the Components a framework to use with stakeholders to determine the relative risks posed at each MRS within its MRS Inventory.
- MRSPP score will be used to determine project sequencing (other factors also considered).

(70% of 1175 = 822 MRS with recommendations of 'Post SI Action')

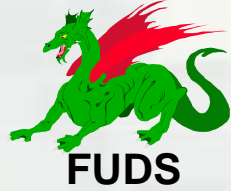

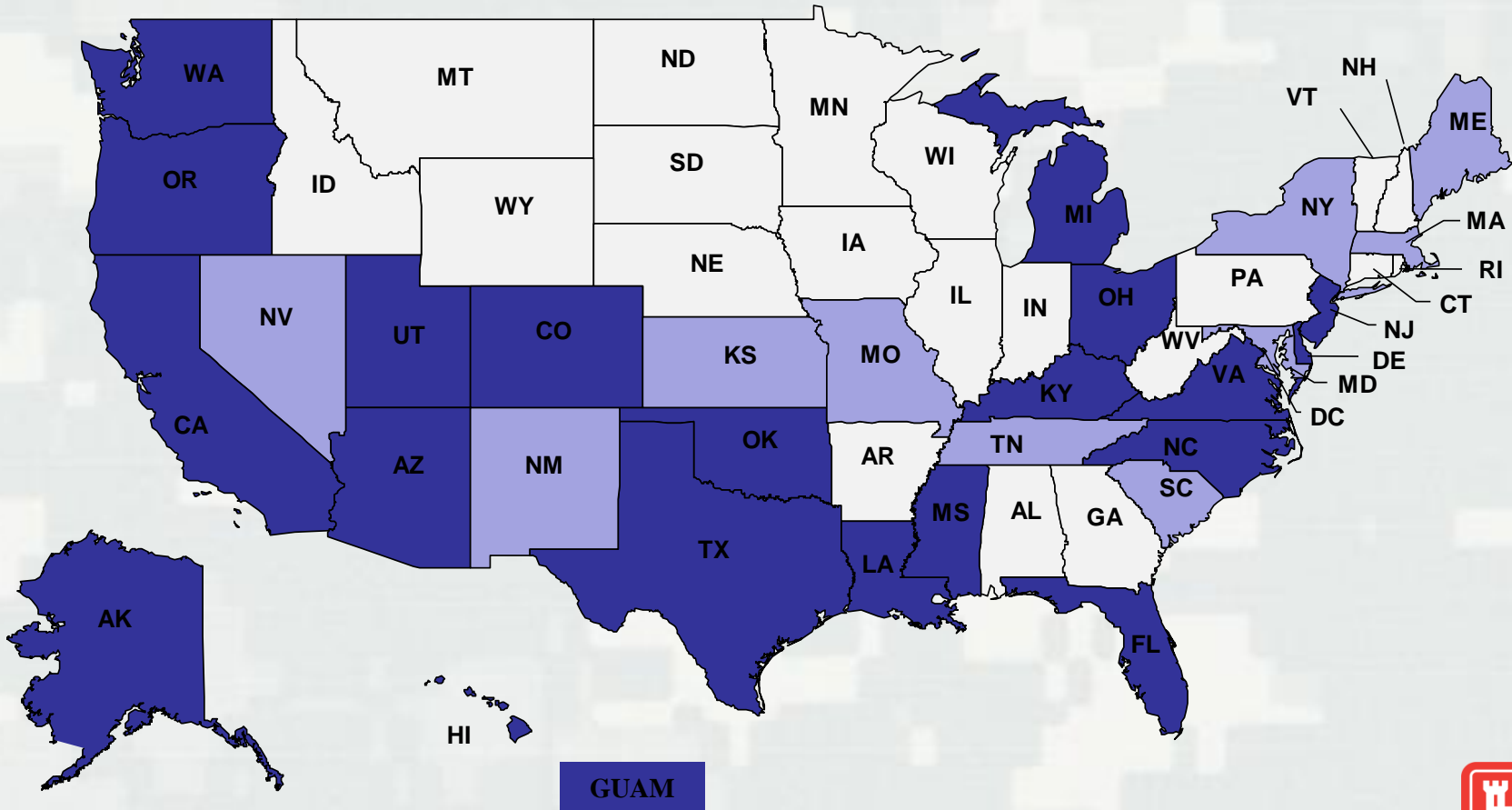

MRSPP by State



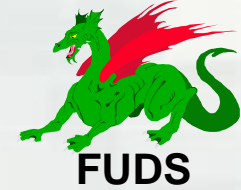
Dark Blue = MRSPP 2 Light Blue = MRSPP 3 Grey > = MRSPP 4

MRSPP Score of 2 & 3 by State



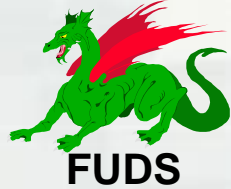

Program Summary

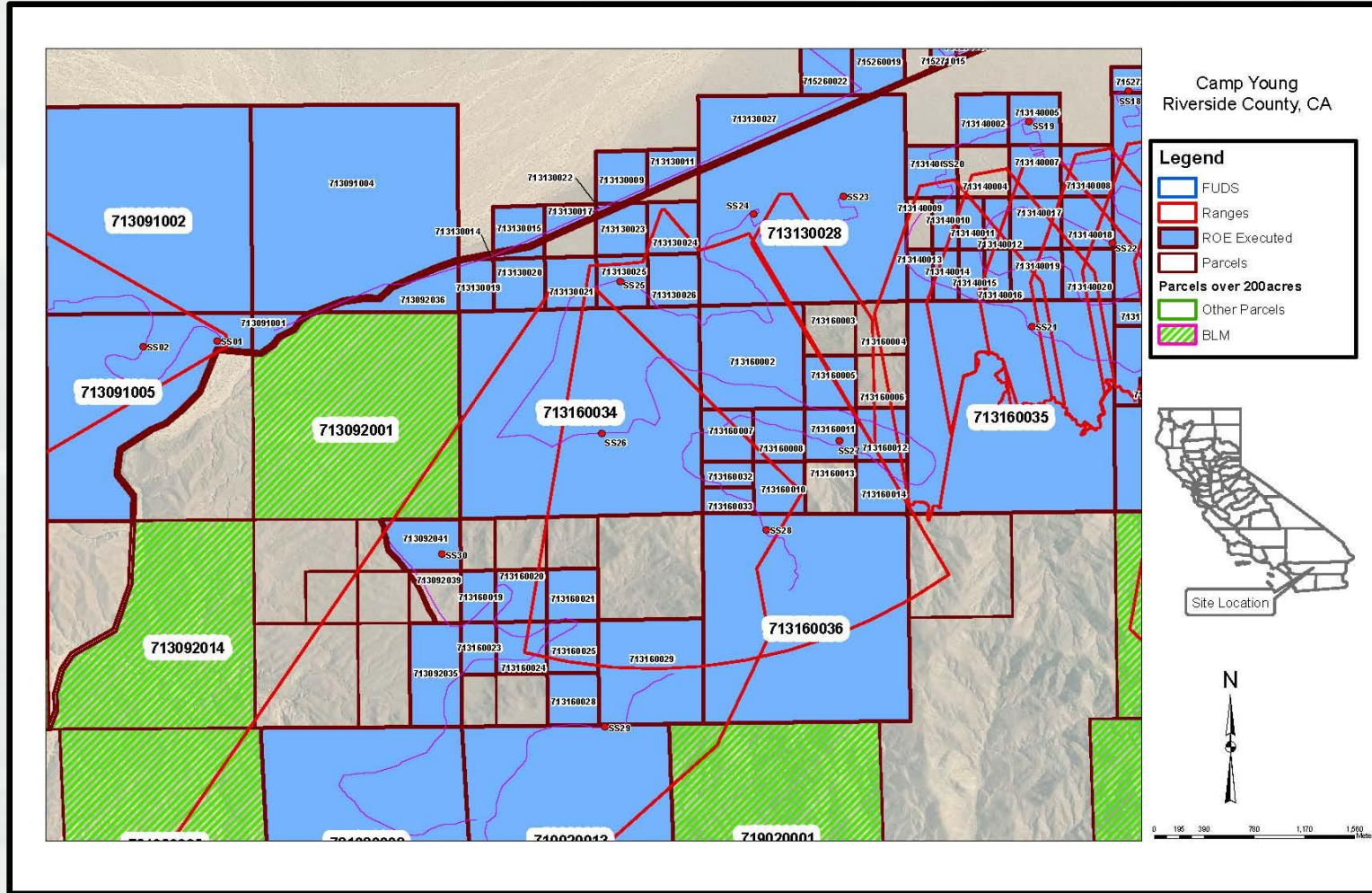


- USACE anticipates SIs for 1086 projects (765 completed by FY10)
 - ▶ Over 1800 MRSs
- Completed over 7800 miles of Qualitative Reconnaissance (QR)
 - ▶ Average 15 miles QR per project
- Taken over 8000 samples
- NDAI recommendations for ~ 30% of MRSs
- NDAI'd ~ 45% of MRS land acreage
- Funding of ~\$150 M for FY05-FY10

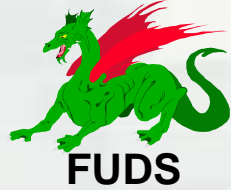

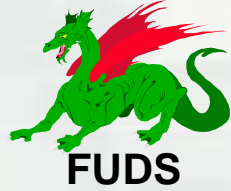
