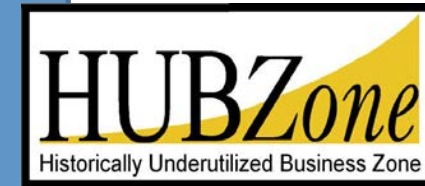

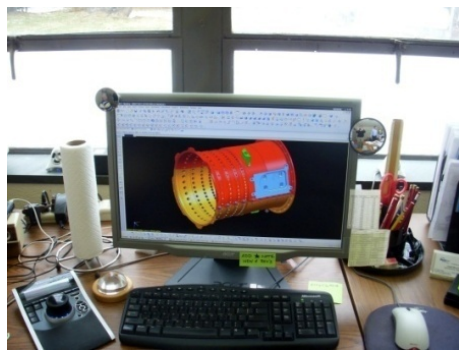

Have an established history of manufacture of like items or actual items for either the Primes, or other Government activities, (Army) (Air Force) (Navy) (DLA).

Have a current Quality Manual in custody

Ability to provide manufacturing, inspection and material documentation to the Engineering Support Activity (ESA), and the cognizant Basic Design Engineer (BDE) upon request.

Participate in a Site Survey to review manufacturing ability and quality assurance compliance

Have access to all required Manufacturing drawings and specifications:

Ability to provide a viable timetable to provide samples for First Article inspection and finished delivered product.



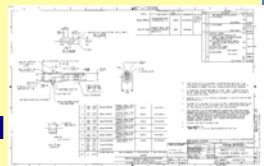

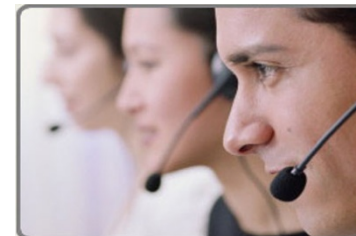
