- It's just plain HARD

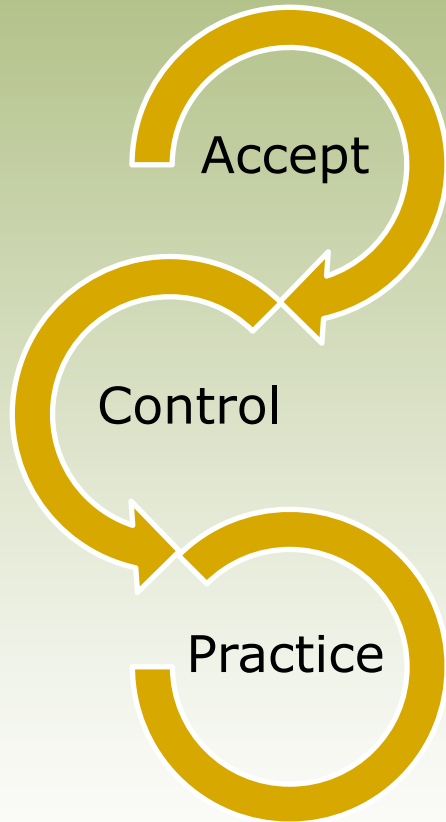
SOMEBODY SHOULD DO SOMETHING!
