## **Executive Summary**

The purpose of this report is to shed light on the poorly understood role that Yunus Khalis played in modern Afghan political history. This research is based on an analysis of several under-studied primary sources in Pashto and Persian that offer unique insight into Khalis's life and work. Although he was an author, teacher and the leader of the Hizb-e Islami (Khalis) mujahidin political party during the Soviet Afghan War, today Yunus Khalis is most often discussed in the context of his personal relationships with Jalaluddin Haqqani and Usama bin Ladin. There is little doubt that Khalis was on friendly terms with these two men. However, Haqqani had a far more visible effect on the growth of al-Qa`ida than Khalis, and the latter apparently had major political disagreements with Bin Ladin. This report will argue that Yunus Khalis's historical impact is better found in his work as an activist intellectual and his refusal to take sides in the Afghan Civil War than in his relatively peripheral contact with Usama bin Ladin.

According to the available sources, Yunus Khalis did not play a major role in the Haqqani Network's diversification as a financial, criminal and terrorist enterprise, and he also had little direct role in al-Qa`ida's growth after the Battle of Zhawara. Even so, the Khalis biographies fill some of the gaps in other sources about Bin Ladin's arrival in Nangarhar in 1996. This helps pinpoint with increasing confidence the identity of the Afghan mujahidin commanders who were most closely involved in the return of the al-Qa`ida leadership to Afghanistan. Additionally, these biographies offer hitherto unknown details about the history of Khalis's base at Tora Bora and the critical role that Haqqani played in helping Khalis to begin an organized fight against the Soviets.

Since so little is known about Yunus Khalis's life and career, the first section of this report will draw together the most important available details of his biography. This will provide the proper context for the discussion of Khalis's contact with Bin Ladin, Haqqani and Mullah Omar in the second section. The main details from these two sections and the implications associated with this report are briefly summarized below.

### **Yunus Khalis's Life and Career up to the Soviet-Afghan War**

- Yunus Khalis was a prolific writer in Pashto and Persian who published dozens of books and articles, and edited and wrote for several journals and magazines during

the 1950s and 1970s. Most of his work was on religious and political themes, and included translations of books by Sayyid Qutb, Ibn Taymiyya and Gustave Le Bon.

- Khalis was more closely involved with the frontline fighting during the Soviet Afghan War than any other Afghan leader of equivalent rank. He apparently took a small group of fighters with him to begin resisting the Soviets in Nangarhar before he had even formed his political party. Instead of providing weapons to the men who would eventually become his commanders, Khalis was initially dependent upon supplies he received from Jalaluddin Haqqani and Mati'ullah Khan.
- Khalis's political party was first formed when Jalaluddin Haqqani, Mati'ullah Khan and (possibly) Jamil al-Rahman agreed to begin fighting together and form a party called Hizb-e Islami under Yunus Khalis's leadership.
- The Tora Bora base in Pachir aw Agam District was the third Nangarhari base occupied by Hizb-e Islami (Khalis) in the late 1970s, and it became one of the party's most important regional hubs. In spite of later events, there is no evidence that Tora Bora played a significant role in the early development of al-Qa`ida in the late 1980s.

#### **Yunus Khalis's Personal Ties to Bin Ladin, al-Qa`ida and Mullah Omar**

- Nangarhar Province was not free from the factional violence that eventually led to the Afghan Civil War from 1992 to 1996, but the province was able to avoid the worst ravages of that violence under the leadership of the Eastern Shura in Jalalabad, potentially as a result of direction that Khalis provided.
- When Khalis returned to Afghanistan from Peshawar, Pakistan, in the mid-1990s, he created a new housing development on the south side of Jalalabad. This development was initially called Najm al-Jihad in reference to its proximity to the tomb of the famed Mullah of Hadda, Najm al-Din Akhundzada. This large neighborhood is now variously known as "Khalis Families" and "Khalis Colony," and it was here that Khalis hosted Bin Ladin for a brief period during 1996.
- When Bin Ladin was exiled from Sudan in early 1996, he gave Khalis so much credit for his willingness to help host al-Qa`ida's leadership that he called Khalis "the Father Sheikh." Noteworthy as this may be, many of Khalis's followers referred to him in a similar fashion as a sign of respect, and there is no available evidence that Khalis ever acted as a mentor to Usama bin Ladin.

- Three important Nangarhar-based commanders were apparently instrumental in bringing Usama bin Ladin to Jalalabad when he was exiled from Sudan in 1996. These men were Engineer Mahmud of Hizb-e Islami (Khalis), Haji Saz Nur of the Ittihad-e Islami party, and Fazl al-Haq Mujahid of Hizb-e Islami (Gulbuddin). Although their assistance was briefly essential to the al-Qa`ida leader's return to Afghanistan, it is helpful to remember that Haqqani maintained a close operational relationship with al-Qa`ida camps in Paktia and Khost throughout the 1990s.
- Available evidence suggests that Bin Ladin agreed to go to Jalalabad when he was exiled from Sudan in a large part because the area controlled by his closest ally in Afghanistan, Jalaluddin Haqqani, was already under Taliban command. Nangarhar was still free from the Taliban in early 1996, and Bin Ladin's decision to go there appears to have been made in part because he did not yet trust the Taliban.
- Khalis was initially favorable to the Taliban, and he advised Jalaluddin Haqqani not to fight when their forces arrived in Paktia. However, Khalis disagreed with many of the Taliban's more extreme policies, and his attempts to negotiate a settlement between the Taliban and the Northern Alliance after 1996 were ignored. There is little information about Khalis's interactions with Mullah Omar, but the scant available evidence indicates that these two were neither friends nor political allies.
- Various sources attest that Yunus Khalis strongly disagreed with Bin Ladin's plan to declare a jihad against the Saudi Kingdom and the American forces stationed there in 1996. One source even relates that Khalis tried to broker negotiations between Bin Ladin and the Saudi government, but these talks apparently fell through because of the unacceptable preconditions that Bin Ladin set for a normalization of relations.

## **Implications**

Contrary to the commonly held view that al-Qa`ida has been based exclusively in the most unstable and weakly governed areas, Usama bin Ladin and his lieutenants returned to Nangarhar in 1996 primarily because the area around Jalalabad was both calm and under the control of a relatively strong political body that was mostly uninterested in al-Qa`ida's operational agenda. This raises uncomfortable questions about the minimum conditions required for a terrorist organization like al-Qa`ida to maintain a presence in Afghanistan. Nangarhar offered Usama bin Ladin an attractive



combination of relative peace, active support from friendly regional leaders like Engineer Mahmud and Haji Saz Nur, and a local governing body in the Eastern Shura that was more focused on maintaining security and trade in the province than harassing extremist groups like al-Qa`ida.

If that combination of a limited but loyal local support network and lack of interference from nearby governing bodies is any indication of what it takes for a major terrorist organization to find a safe haven in Afghanistan, then it may be wise to take pronouncements of the imminent destruction of al-Qa`ida or affiliated organizations with a grain of salt. Leaving aside the question of the current operational capacity of al-Qa`ida, the findings in this report serve as a warning to any who suppose that a moderate level of security and government presence is sufficient to prevent al-Qa`ida or a similar organization from maintaining safe havens in Afghanistan.

Although elements of the Taliban are now more openly hostile to al-Qa`ida, the Afghan central government is unable to project a strong security and governance presence in all of the districts in eastern Afghanistan. In places like Giro District of Ghazni Province, the current local government has essentially no capacity to influence what happens outside the walls of the district compound. In that kind of permissive environment, all al-Qa`ida might need to survive in the area is a reliable local partner.

It may not be possible for al-Qa`ida to thrive in Afghanistan as it did in the days before 9/11, but the threshold required for the organization's continued existence may be lower than is commonly suspected. Clearly, the international community must continue to focus on eroding the diminishing military and operational capabilities of al-Qa`ida and similar movements. However, the primary sources about Yunus Khalis's life remind us that even when al-Qa`ida's leadership was managing a period of significant transition, Usama bin Ladin's organization was able to survive locally with little more than help from a few friends in Nangarhar and Loya Paktia, and a distracted or disinterested local governing body in Jalalabad.

## Introduction

The year 1996 was a watershed moment for Usama bin Ladin. It was a time of transition in which he fled Sudan in exile, returned to Afghanistan with the leadership of al-Qa`ida and wrote a letter (*risala*) declaring war against the Saudi Kingdom and the United States. Prior to publishing his *risala* in August of that year,<sup>1</sup> Usama bin Ladin sought legal backing for a declaration of jihad against the ongoing American presence in Saudi Arabia from prominent religious scholars (*'ulama*) including Yunus Khalis.<sup>2</sup> The scant available evidence suggests that at that time Bin Ladin and Khalis had a friendly relationship dating back to the days of the anti-Soviet jihad, when Yunus Khalis had led one of the most important mujahidin political parties in eastern Afghanistan.<sup>3</sup> In fact, Bin Ladin was probably staying in a residence at Khalis's Najm al-

Jihad neighborhood shortly before he issued a call for support for his forthcoming declaration of jihad.<sup>4</sup> But if Bin Ladin was hoping for a positive response on the basis of his personal connection to Khalis, he was to be disappointed.<sup>5</sup>

In his answer to Usama bin Ladin, Khalis reasoned that as long as the lawful government in Riyadh continued to allow the Americans to stay as guests, then no jihad was permissible.<sup>6</sup> Additionally, Khalis argued that it was foolish to work for the overthrow of the Saudi government since any replacement would probably be a less enthusiastic supporter of Islamic law (*shari'a*).<sup>7</sup> In other words, Khalis apparently rebuked Usama bin Ladin's extremist ideology at the precise moment when the al-Qa`ida leader had chosen to publicly declare an international jihad against the Saudi Kingdom and its American allies.

'Abd al-Kabir Talai<sup>8</sup> expands on this anecdote by explaining that Yunus Khalis had initially attempted to mediate between the Saudi government and Usama bin Ladin after the relationship between the two parties soured earlier in the 1990s.<sup>9</sup> According to Talai's account, Khalis was able to get the Saudis to agree to negotiate with Bin Ladin, but the talks fell through because the al-Qa`ida leader set unacceptable conditions for a normalization of relations.<sup>10</sup> Even though Bin Ladin apparently appreciated Khalis's friendship and personal support enough to refer to him as "the Father Sheikh,"<sup>11</sup> the

only known primary sources relate that every time Khalis offered Bin Ladin political advice, the al-Qa`ida leader ignored him.<sup>12</sup>

These episodes, never before reported in the secondary literature, come from a group of several previously unstudied primary sources in Pashto on the life of Yunus Khalis, which form the basis of this report.<sup>13</sup> These sources are an excellent starting point for a critique of the current literature on Khalis's connection to al-Qa`ida, in part because they depart so radically from the currently dominant depictions of Yunus Khalis as an ultraconservative sexual predator<sup>14</sup> who became the key al-Qa`ida supporter in Nangarhar when Bin Ladin fled Sudan.<sup>15</sup>

Scholars should exercise caution in accepting the entirety of the newly available biographical accounts of Yunus Khalis's life and politics, in part because such accounts have been written by sources who are highly favorable to him. To control for some of this possible bias, it is necessary to compare the relevant portions of the biographies with the other available primary sources about al-Qa`ida and the Afghan mujahidin. The results of such an analysis are surprising and underline how little is known about the ideology and relationships that helped fuel the growth of al-Qa`ida and the Haqqani network. Most important of all, the current sources provide no evidence for the assertion that Yunus Khalis was ever the key operational facilitator for al-Qa`ida in Nangarhar or anywhere else.

If authors such as Michael Scheuer,<sup>16</sup> Mary Anne Weaver<sup>17</sup> and Thomas Lynch<sup>18</sup> are correct in their assessment that the relationship between Usama bin Ladin and Yunus Khalis was critical to al-Qa`ida's supposed transition to Afghanistan in 1996,<sup>19</sup> then one could expect an investigation of this period of Khalis's life to underline the importance of his enthusiasm for al-Qa`ida. But according to the biographies considered here, Khalis's material support for al-Qa`ida was an extension of his personal relationship with Bin Ladin and remained limited to providing the al-Qa`ida leader with a place to stay for a short time in 1996.<sup>20</sup> Beyond this act as a host there is no evidence that Khalis facilitated al-Qa`ida operationally. On the other hand, there are various sources indicating that Khalis disagreed with the organization's politics. While his biographers may have political reasons for suppressing this connection, various sources linked to al-

Qa`ida, which are less likely to have any such qualms, tell essentially the same story. Together these accounts suggest that support from provincial-level commanders such as Jalaluddin Haqqani, Haji Saz Nur, Engineer Mahmud and Fazl al-Haq Mujahid had a much more tangible effect on Usama bin Ladin's operations leading up to 1996 than that of the aging Khalis.<sup>21</sup>

The new Pashto material on Khalis helps to add precision to the discussion of Bin Ladin's flight from Sudan to Afghanistan in 1996, but it also emphasizes Khalis's importance as a writer and historical figure before the Soviet-Afghan War. The biographies are often amusing and readily confirm what Peter Tomsen has called Khalis's "famous sense of humor."<sup>22</sup> This material also clearly shows that Khalis must be included amongst the most significant political and intellectual figures of 20th century Afghanistan. He published dozens of articles and books in poetry and prose,<sup>23</sup> was involved in some of the earliest Afghan journalistic publications,<sup>24</sup> and hosted a

show on Kabul Radio for several years.<sup>25</sup> His various protégés and commanders from the Soviet jihad remain among the most powerful men still living in eastern Afghanistan, and Khalis continues to be a relevant figure in his home province of Nangarhar even after his death in 2006.<sup>26</sup> As a prominent and highly literate member of a society in which illiteracy is still pervasive, Khalis's life and writings give us a window into the otherwise almost illegible world of the political elite in the eastern Pashtun tribes around Nangarhar. And as his biographies reveal, in the mid-1990s the life of this political elite was dominated by the Eastern Shura based in Jalalabad.

In the midst of the Afghan Civil War, there were small pockets of relative quiet. Due to the admittedly self-interested efforts of the Eastern Shura, the area around Jalalabad was one of the safest and most prosperous in all Afghanistan during this period. Paradoxically, it was this relative peace in Nangarhar Province that allowed Usama bin Ladin to contemplate Jalalabad as a region of refuge when he fled Sudan. Yunus Khalis and his former commanders such as 'Abd al-Qadir played essential roles in creating and maintaining a relatively peaceful environment in Nangarhar in the 1990s. An investigation of Khalis's life offers a unique perspective on the way that former mujahidin leaders based in Jalalabad used a multilateral shura to negotiate peaceful resolutions to certain regional conflicts during one of the darkest and most violent periods in the region's history.

Ultimately, the Eastern Shura was able to keep Nangarhar Province "open for business,"<sup>27</sup> but it also appears to have had little interest in pursuing and eliminating

violent jihadist organizations such as the one that killed four UN officials in an ambush near Jalalabad on 1 February 1993.<sup>28</sup> And as Dipali Mukhopadhyay has demonstrated in her work, the intense rivalries held in check by the Eastern Shura until late 1996 burst into the open again after the fall of the Taliban in 2001.<sup>29</sup> By improving our understanding of Yunus Khalis we can begin to historicize one of the most persistent myths of al-Qa`ida's connection to the Afghan mujahidin while filling the gaps in our knowledge of how political power has been managed in the strategically vital region around Nangarhar Province. In the process insights can be gained into the fascinating life of an important east Afghan political and intellectual figure who was intimately involved in Afghanistan's reactions to and negotiations with modernity. There is too much at stake in the world's understanding of recent Afghan history for us to continue to ignore the available primary sources about politics in the Afghan frontier. With that in mind, this analysis will begin with a discussion of what these sources say about Yunus Khalis's life up to the beginning of the Soviet-Afghan War in 1979.

## Yunus Khalis's Life and Career up to the Soviet-Afghan War

### *Khalis's Education and Early Years*

The man best known today as Yunus Khalis (d. 2006) was born Muhammad Yunus in a village near Gandamak in Nangarhar Province to a family of the Khugiani tribe in 1920.<sup>30</sup> Yunus Khalis was home schooled, and after his father's death he began to take lessons from his uncle 'Abd al-Razeq.<sup>31</sup> He continued his education at local towns such as Kami, but before long his studies sent him further afield to Jalalabad, and eventually, to the famous Dar al-'Ulum Deoband with his elder brother.<sup>32</sup> While there, Khalis's brother became sick, and an acquaintance recommended that they travel back north to study with a Deoband graduate who was then teaching at Akora Khattak near Peshawar.<sup>33</sup> They followed this advice, and thus Khalis became a student of Mawlana 'Abd al-Haq Haqqani, the founder of the Dar al-'Ulum Haqqaniyya.<sup>34</sup>

Western sources rarely discuss Khalis's education, but when it is mentioned, authors usually focus on his attendance at the now infamous Dar al-'Ulum Haqqaniyya.<sup>35</sup>

Unfortunately, this is not quite historically accurate. It is true that Yunus Khalis studied with 'Abd al-Haq Haqqani at Akora, but Khalis completed his education in 1941 and returned to Afghanistan before 'Abd al-Haq Haqqani founded the Dar al-'Ulum Haqqaniyya in 1947.<sup>36</sup> While it is known that Yunus Khalis studied the sayings of the prophet Muhammad (*hadith*) under 'Abd al-Haq Haqqani,<sup>37</sup> his education in the frontier appears to have been far broader than this.

Khalis traveled throughout Swat and Buner districts and the Bajaur and Dir tribal agencies to learn from the most famous frontier 'ulama of the time.<sup>38</sup> He received a traditional education in logic, rhetoric, grammar, philosophy, religious law (*fiqh*) and the interpretation of the Qur'an (*tafsir*).<sup>39</sup> It is implicit in all of this that he learned Arabic. Not all students of the private madrasa system in South Asia graduate with a proficiency in this language beyond what is absolutely necessary for liturgical and ritual purposes.<sup>40</sup> However, Khalis translated books from Arabic,<sup>41</sup> wrote some of his original work in Arabic<sup>42</sup> and spoke it well enough to converse without an interpreter.<sup>43</sup>

This education in the private madrasa system set Khalis apart from many of the other men who eventually became leaders in the mujahidin movement<sup>44</sup> and connected Khalis with a group of Haqqaniyya alumni who would become critical to his fight against the Soviets later in life. But these links would only become militarily relevant much later, and when Yunus Khalis returned to Afghanistan around 1941 he spent his

time studying, giving sermons and teaching unofficially at the Najm al-Madaris school in Nangarhar beginning in 1943.<sup>45</sup> The year 1949 proved to be a time of dramatic change for Khalis, and by the end of it he was married<sup>46</sup> and had moved to Kabul to teach at a professional school for future judges called the Dar al-Quza.<sup>47</sup> Yunus Khalis would remain on the faculty there for two years until he was hired by the government in 1952 to run a new show on Kabul Radio interpreting the Qur'an.<sup>48</sup>

### *Khalis's Political Awakening and Media Activity*

It was during his long tenure at Kabul Radio that the first hint of Khalis engaging in an act of political resistance emerges. When the Suez Crisis erupted in 1956, Yunus Khalis took the opportunity while on the air to call on all Muslim nations to "stand with the people of Egypt" against the aggression of Britain, France and Israel.<sup>49</sup> Khalis' boss, under pressure from his superiors in the government, cut the transmission without even informing Khalis that he had gone off the air. This is certainly a colorful story, but it seems more likely to have been an isolated incident than evidence of Khalis' taking an active stand against the government in Kabul in the 1950s. After all, he still had his show at Kabul Radio for at least two years after the Suez Crisis, and in 1958 he was appointed by the Ministry of Information and Culture to be the director of what may have been Afghanistan's first Islamic magazine, *The Message of Truth (Payam-e Haq)*.<sup>50</sup>

The Suez Crisis was partially a result of Egypt's 1956 nationalization of the Suez Canal, and it resulted in a major diplomatic and military loss for Britain and France. Presumably, King Zahir Shah's government did not want to stir up trouble for Afghanistan's Western allies and shut off Khalis's radio broadcast in an effort to keep him from causing too much trouble.

Khalis's involvement in print journalism marked an important shift in his professional life, but he was not a newcomer to other print media and would return to publishing repeatedly in the years after he left his job at *The Message of Truth*. Around 1954 he published a book of his own called *Religious Pearls* and a translation of a book by the 19th century French social psychologist Gustave Le Bon under the title *Religion and Human Society*.<sup>51</sup> Khalis's publication credits would eventually include works in a large variety of genres. He published books for use by students such as *The Spirit of Islam* and *The Explanation of the Creed of al-Tahawiya*, and he apparently developed a system to help young children learn to read the Qur'an.<sup>52</sup> He also wrote volumes of poetry,<sup>53</sup> and at least one translation of Sayyid Qutb's work.<sup>54</sup> Of course, it is hard to know how widely circulated these books really were. They were generally printed in small runs,<sup>55</sup> but this tells us almost nothing about their possible impact since popular books disseminated in hand-written copies to the right readers can have an enormous influence compared

with state-sponsored books printed in large quantities.<sup>56</sup> That is partly what makes Khalis's role as the head of *The Message of Truth* and other journals so interesting. This kind of work may have increased his exposure to the writings of his contemporaries and vice versa, and it also helps to make his professional and intellectual connections more easily visible to us today.

While directing *The Message of Truth*, Khalis received articles and letters from professors, teachers, and students in Herat, Kunduz, Mazar-e Sharif, Nangarhar, and Kabul.<sup>57</sup> Through his involvement with this explicitly Islamic publication, Khalis was developing a network of connections to 'ulama and writers throughout the late 1950s. His role as curator of the intellectual output of many of his peers was made all the more important and sensitive because of the interest that the government censors took in publications like *The Message of Truth* that could be a potential source of political resistance to Kabul.<sup>58</sup> His efforts to balance this delicate position must have been at least partially successful; he was soon placed in charge of a second publication called *The Beam of Light* (*Wrangah*) operated out of Gardez in Paktia Province.<sup>59</sup>

Khalis left journalism temporarily when a serious illness prevented him from working, but by 1960 he was already back in Kabul teaching at the Dar al-'Ulum 'Arabi.<sup>60</sup> In the 1960s Khalis's political views began to come under increasing scrutiny by the government, and he was repeatedly fired and sent to teach at progressively less prestigious and more peripheral schools.<sup>61</sup> At some point he tired of the transfers and

ideological interference, and he quit teaching at government schools entirely.<sup>62</sup> While the primary sources are silent about Khalis's activities during most of the 1960s, the narrative thread of his life can be picked up again in 1966, when Khalis helped to form an "Islamic group" in Nangarhar.<sup>63</sup> Although it is unknown if this is the same group that Khalis cofounded with the journalist Minhajuddin Gahiz, it seems likely that these two men were already connected by this point.<sup>64</sup>

### *The Growth of an Islamic Political Opposition in Afghanistan*

There was a flurry of quiet Islamist organizing activity led by 'ulama, professors and students in all of the major population centers of Afghanistan in the 1960s. In Kabul, much of this activity centered around Professor Ghulam Niazi, who had returned to Afghanistan in the 1950s to teach after receiving a Master's Degree from the famous al-Azhar University in Egypt.<sup>65</sup> Professor Ghulam Niazi founded an underground Islamic organization in 1965,<sup>66</sup> and by 1969 this group had given birth to the "Muslim Youth" and prepared the way for what would become the first mujahidin political party in the 1970s.<sup>67</sup>

It is important to keep in mind that the focus on Professor Niazi in many histories of the earliest stages of the mujahidin movement is in part a reflection of the later fame and influence of several important leaders who were involved in his circles in Kabul. These men included the world-famous Panjshiri commander Ahmad Shah Massoud; Burhanuddin Rabbani of the Jami'at-e Islami party; 'Abd al-Rab Rasul Sayyaf who eventually led the Ittihad-e Islami party; and Gulbuddin Hekmatyar, whose clashes with Massoud were one of the main drivers of the devastation of the Afghan Civil War. Of these, Rabbani and Hekmatyar struggled directly over the question of who was best suited to follow in Niazi's footsteps and lead the Islamist movement in Afghanistan.<sup>68</sup> But aside from the clearly justifiable interest in tracing the intellectual and political histories of these four important leaders, scholars also tend to focus on Professor Niazi's circles at least partially because there is so little available information about the activists from this period who were not based in Kabul.<sup>69</sup> However, this reasoning may focus too much on scholars and their impact on readings of history without accounting for the tremendous efforts made by the various Afghan actors to warp depictions of the history of 20th century Afghanistan to fit their own political agenda.

The Jami'at-e Islami and Hizb-e Islami (Gulbuddin) parties were highly successful at shaping accounts of the origins of the mujahidin movement to advance their own interests. These two parties split dramatically along ethnic and generational lines and

thus mirror larger divisions within the mujahidin. Jam'iat-e Islami became the only Sunni mujahidin party to include a high proportion of non-Pashtun members, while Gulbuddin Hekmatyar's Hizb-e Islami was formed from the core membership of the Muslim Youth. Hekmatyar's following was generally younger, more politically radical and more willing to take sometimes foolish risks in the early days of the mujahidin movement.<sup>70</sup> It should be no surprise that Rabbani and Hekmatyar's efforts to lay claim to the legacy of Professor Niazi have produced a group of sources for Western scholars, which emphasize Niazi's importance to the development of the mujahidin movement in Afghanistan.

Niazi has an important role to play in any history of the mujahidin, but his group at Kabul University was not the only politically active Islamic organization in Afghanistan in the late 1960s. The primary sources abound with stories of clandestine meetings of activists where leaders such as Yunus Khalis, sometimes joined by the Sufi leader Sibghatullah Mujaddidi,<sup>71</sup> would discuss Islam, socialism and politics with teachers, professionals and young people.<sup>72</sup> Sibghatullah Mujaddidi would eventually go on to create his own mujahidin political party by mobilizing his contacts in Afghan Sufi networks.<sup>73</sup> Certainly, some of the gatherings attended by Khalis and Mujaddidi took place at Kabul University, however these kinds of informal groups also met in Kunduz, Nangarhar and many other locations.<sup>74</sup>

Even while they were distinct from the Kabul Islamists to some extent, their purpose appears to have been the same: to awaken the population to socialism's threat to their way of life, to give attendees useful rhetorical tools to help combat leftists in their schools and towns and, as the movements developed, to help organize and connect the

members.<sup>75</sup> Surprisingly enough, some of these early gatherings actually included socialist activists and thinkers such as Suleiman Layeq.<sup>76</sup> Of course it quickly became impossible to have meetings in which Islamists and Leftists both took part: Gulbuddin Hekmatyar served a jail sentence for murdering a Maoist student in 1972.<sup>77</sup> As these discussion groups spread to different cities and radicalized, they gave birth to different kinds of organizations with similar political goals. Two of the most interesting of these organizations were the short-lived Hizb al-Tawabin of Nangarhar and the aforementioned Muslim Youth, created at Kabul University from among the younger members of Professor Niazi's circles.

The history of the Muslim Youth and Gulbuddin Hekmatyar's involvement with it are well known. The creation of the Muslim Youth in 1969 merely made explicit some of the previously hidden divisions in Niazi's circles between students like Hekmatyar and professors like Sayyaf and Rabbani.<sup>78</sup> Many of these activists would later go on to become the leaders of separate mujahidin political parties. But in spite of their already sharpening ideological differences, many of the most important members of the nascent mujahidin movement were writing under pseudonyms for the same Hizb al-Tawabin publication, a journal named *Gahiz* (Dawn).<sup>79</sup>

Minhajuddin Gahiz created an organization called the Hizb al-Tawabin in 1965,<sup>80</sup> which would go on to publish the *Gahiz* journal from 1968 to 1972.<sup>81</sup> Yunus Khalis was a

founding member of the Hizb al-Tawabin,<sup>82</sup> and he was involved in the publication of *Gahiz* from the very beginning.<sup>83</sup> Although the Hizb al-Tawabin never became a well-known political party, it evidently played an important role in connecting some of the most important mujahidin leaders to one another. In 1984, when Burhanuddin Rabbani wished to conduct some important political business with Qazi Hussain Ahmad,<sup>84</sup> he brought Yunus Khalis to the meeting with him on the basis of Khalis's old connection to Hussain Ahmad through the long-defunct Hizb al-Tawabin.<sup>85</sup>

The level of involvement in the Hizb al-Tawabin's *Gahiz* journal by the men who would eventually become leaders of the various mujahidin political parties is striking: Minhajuddin Gahiz apparently turned to Sibghatullah Mujaddidi for the financial support needed to get his publication off the ground, and Burhanuddin Rabbani supported *Gahiz* from the beginning.<sup>86</sup> Hekmatyar himself admitted to submitting several articles for publication in *Gahiz* under various pseudonyms even though he claimed that the journal was not very popular among young people.<sup>87</sup> It is not yet known whether the three other future Sunni mujahidin party leaders (Sayyid Ahmed Gailani, Sayyaf and Muhammad Nabi Muhammadi) had any involvement in *Gahiz*. Even so, it is remarkable that four of the seven eventual party leaders contributed articles or funds to an Islamic magazine at a time when the splits between the various factions were making it increasingly difficult for some of them to even sit together in the same room.

Yunus Khalis was busy with a variety of projects during the time in which he collaborated with Minhajuddin on the *Gahiz* publication. In the space of two years he

went on the Haj,<sup>88</sup> wrote at least one new book,<sup>89</sup> remained publicly active enough to speak out in defense of destitute mullahs before an assembly in Nangarhar<sup>90</sup> and took a position conducting research at a media group in Kabul.<sup>91</sup> He did all of this while regularly contributing articles to *Gahiz*. During the 1970's, the Afghan state's security apparatus dramatically tightened its control over anti-government political activity. With that increased attention from the government, the period of relative government tolerance for the various Islamic organizations and resistance movements would not last much longer.<sup>92</sup> Around the time in 1972 that Burhanuddin Rabbani took control of the nascent Jami'at-e Islami<sup>93</sup> from Professor Ghulam Niazi, Minhajuddin Gahiz was killed.<sup>94</sup> Soon after Gahiz's assassination,<sup>95</sup> Muhammad Daoud Khan staged a coup and overthrew Muhammad Zahir Shah—the last king of Afghanistan.

### *Daoud Khan's 1973 Coup and the Movement of Mujahidin Leaders to Pakistan*

The consequences of Daoud's leftist coup in 1973 have been far-reaching, but the immediate result was a dramatic crackdown on the Islamic resistance. Within a year many activists had been arrested, including Professor Ghulam Niazi and Yunus Khalis's eldest son, Mawlawi Muhammad Nasim.<sup>96</sup> Muhammad Nasim had evidently drawn attention to himself by publicly denouncing a leftist sermon delivered by the governor of Balkh during a Friday prayer service in 1973, and within a few days Nasim was arrested.<sup>97</sup> Both he and Professor Ghulam Niazi would eventually die in prison.<sup>98</sup> Unsurprisingly, Yunus Khalis was also being hunted by the government, and he fled to Peshawar in 1974.<sup>99</sup>

David Edwards reports that Yunus Khalis kept a low profile in his initial years around Peshawar.<sup>100</sup> Khalis was probably careful as long as his son was alive in prison and much of his family remained in Afghanistan, but the case for his lack of political activity at the time can be overstated. While he did not make a play for leadership of Jami'at-e Islami or the Muslim Youth, Khalis was an active participant in one of the first gatherings of the key mujahidin leadership in exile.

In 1974 Burhanuddin Rabbani invited a group of mujahidin leaders to his home in a suburb of Peshawar for a conference.<sup>101</sup> The list of leaders in attendance is impressive: Gulbuddin Hekmatyar, Yunus Khalis, Mawlawi Jamil al-Rahman,<sup>102</sup> Qazi Amin

Waqad,<sup>103</sup> Mawlawi Nasrullah Mansur,<sup>104</sup> Mawlawi Jalaluddin Haqqani,<sup>105</sup> Mati'ullah Khan Wali Khel,<sup>106</sup> and Haji Din Muhammad.<sup>107</sup> Khalis showed up to the meeting with nothing but a shawl and a hand ax,<sup>108</sup> and apparently asked uncomfortably specific questions about what sort of leadership and planning goals the group was prepared to put forward.<sup>109</sup> Din Muhammad eventually became the deputy chief of Khalis's political party. In his account of this meeting, Din Muhammad ascribes an uncannily prophetic line of reasoning to his former boss. Khalis allegedly asked the gathering "if Daoud Khan gave the government into your hands, who would be the leaders?" The response was laughter, and a fuming Yunus Khalis supposedly responded that if the group could not agree on this issue now, then the nation would be bathed in blood when they came into power.<sup>110</sup>

There are good reasons to be doubtful of this sort of hagiographical account; it appears designed to make Khalis look prescient in the face of the civil war of the 1990s.<sup>111</sup> True or not, the picture that Din Muhammad paints is clear and can be taken as representative of what a close confidante of Khalis thought about the mujahidin leadership in 1974. Din Muhammad claims that Khalis opposed the “wait and see” approach of many other mujahidin leaders and that he was suspicious of their unwillingness to directly address the leadership question.

### *The Failed Attempts to Unite the Mujahidin into One Political Party*

Whatever Khalis’s political approach might have been, he did not seek a leadership role in the evolving organizational infrastructure of the Afghan Islamist exiles.<sup>112</sup> Instead, he worked as the prayer leader (imam) in a mosque in the town of Bara.<sup>113</sup> Before long, he began teaching at the nearby Hadiqa al-‘Uloom madrasa and prepared a series of lectures for the massive number of university students who were taking refuge in Pakistan. Khalis eventually collected these lectures for publication in his book *The Spirit of Islam*.<sup>114</sup> Although Khalis was definitely not politically inactive during this period, David Edwards is right to point out that he kept a low profile compared with the other major mujahidin leaders.<sup>115</sup>

There had long been tension between Burhanuddin Rabbani and Gulbuddin Hekmatyar, but the premature revolt in Afghanistan that Hekmatyar helped to plan in 1975 may have permanently soured his relationship with Rabbani and other mujahidin

leaders.<sup>116</sup> It did not help that Hekmatyar, “almost alone among the party’s student leaders,”<sup>117</sup> had chosen to remain in safety in Pakistan when the uprising took place. The rebellion may have resulted from an attempt by the hotheaded younger mujahidin of the Muslim Youth to sidestep their more cautious elders in the mujahidin (like Rabbani), but it ended in a near complete disaster that dealt a massive blow to the developing resistance movements. In the wake of this defeat, it became apparent to many people involved with the mujahidin leadership that serious action had to be taken to unify the various factions before a fight against the government in Kabul could take place.

In his book *Before Taliban*, David Edwards describes how Qazi Amin and others who were attempting to mediate between Hekmatyar and Rabbani came to Khalis to enlist his help in unifying the movement.<sup>118</sup> The ethnic and generational differences between the factions of Rabbani and Hekmatyar were increasingly significant, and it may not have been possible at that point to create a working union of their parties. In any event, Khalis was not interested. There may have been several attempts to recruit him to this cause, and Din Muhammad gives a unique perspective on this political jockeying in his biography of Khalis. In his version of events, Jamil al-Rahman, Mawlawi Ghulam Rabbani and Mawlawi Rahmat Khan came from Kunar Province, and Nasrullah Mansur and Jalaluddin Haqqani from Loya Paktia<sup>119</sup> to encourage Khalis to take charge of a new unified mujahidin political party that could heal the split between Burhanuddin Rabbani and Gulbuddin Hekmatyar.<sup>120</sup> Many of these men would eventually become his close associates and commanders, and Khalis gave the project serious consideration. According to Din Muhammad, Khalis spoke separately with both Hekmatyar and Rabbani, telling them that he would perform this duty as leader of a unity party only if they were willing to submit completely to his conditions. This was apparently unacceptable, and Khalis’s name was withdrawn from consideration.

Events would unfold dramatically over the next three years with a succession of attempts to patch the growing rifts among the various factions of mujahidin. All would ultimately fail, but the way that they failed is instructive. The Islamist factions of Gulbuddin Hekmatyar and Burhanuddin Rabbani seem to have done the most damage to any prospects for a more permanent union of Sunni mujahidin. The animosity between these two leaders exerted a centrifugal force on the Islamist movement in Afghanistan that helped to overwhelm the repeated attempts to unify and then reunify the mujahidin. However, it seems clear in retrospect that Pakistan's willingness to spread funding across an increasing number of Sunni parties played an important role in fracturing the mujahidin. Forming a separate party allowed a faction to express important differences in ideology and to mobilize distinct affinity groups, but it also meant direct access to funding and war matériel from the Pakistani government. At a minimum, Pakistan's initial openness to funding new Sunni parties may have encouraged leaders like Sayyaf and Nabi Muhammadi to maintain control of their political organizations even after they failed in their original purpose of uniting the mujahidin in one camp.

Whatever the initial motivations may have been for forming different parties in the first years of the jihad, these splits allowed ethnic, generational, confessional and other affinity-group distinctions to increasingly characterize the mujahidin political parties. The clerical parties of Nabi Muhammadi and Yunus Khalis thus developed a somewhat distinct group of clients and commanders from the Sufi parties of Gailani and Mujaddidi or the Kabul Islamists like Hekmatyar and Rabbani.<sup>121</sup> But it was far from clear in the mid-1970s that this eventual articulation of party affiliation along clerical/Sufi/Kabul Islamist lines was inevitable. In fact, many governments and leaders expended enormous political capital in the 1970s to prevent precisely that kind of development.

In May 1976 Qazi Amin was named the leader of the new party that would supposedly unify the partisans of Hekmatyar and Rabbani.<sup>122</sup> Amin was well liked and, in the

words of David Edwards, he was viewed as a “fundamentally decent person.”<sup>123</sup> The new unity party was named simply “the Islamic Party” (Hizb-e Islami), and the former political organizations were theoretically disbanded with its creation. Unfortunately, this did little to bridge the gaps among the various factions of mujahidin, and Qazi Amin was soon replaced as party head by Mawlawi Sakhidad Faiz.<sup>124</sup> Faiz fared no better, and he submitted his resignation after a week.

Whether because of outside pressure or their own determination, mujahidin efforts to unify the fractured movement continued even in the wreckage of the first Hizb-e Islami. After Faiz’s resignation, Nasrullah Mansur, Hekmatyar and others went to Muhammad Nabi Muhammadi in the hope that he might be willing to lead a new unity party.<sup>125</sup> Nabi Muhammadi accepted, and “the Movement of the Islamic Revolution” (Harakat-e Inqilab-e Islami) was formed. It is important to note here that the first Hizb-e Islami party was formally dissolved with the creation of Harakat. Although Nabi Muhammadi and others appealed to Khalis directly to join Harakat, Khalis apparently had a low opinion of Nabi Muhammadi’s leadership ability, and he never joined the new party.<sup>126</sup> Apparently, even some of those who joined Harakat soon had second thoughts.

Before long, the tentative alliance of Rabbani and Hekmatyar under Harakat-e Inqilab fell apart again when Rabbani took a trip to Saudi Arabia and created “the National Salvation Front” (Jebha-ye Nejat-e Milli) with Sibghatullah Mujaddidi.<sup>127</sup> Rabbani himself would soon abandon this Sufi party to resurrect the old Jami’at-e Islami. By this point, Yunus Khalis was probably already considering forming his own group, and the availability of the well-known Hizb-e Islami name must have made this option even more tempting. It seems that he expressed reservations about whether Harakat-e Inqilab could last much longer, and he disliked the political maneuvering that

distracted the mujahidin from directly engaging the foe.<sup>128</sup> In theory, he could have thrown his support behind Hekmatyar, but David Edwards rightly points to Khalis's "resentment at being subordinate to younger and less experienced men."<sup>129</sup>

His exact motivations may never be clear, but at some point Khalis created his own Hizb-e Islami, and Hekmatyar eventually left Harakat and did the same.<sup>130</sup> These parties would become so radically different in structure and membership that it is hard to imagine that Khalis and Hekmatyar could ever have worked in the same chain of command, and it is little more than ironic that their parties bore the same names.

Surprisingly enough, even as all these leaders fled Harakat-e Inqilab, the party persisted. This could be because unlike Qazi Amin, Nabi Muhammadi was a practiced politician who longed for the advantages offered by a prominent leadership position. He had been a member of parliament and had famously come to blows with Babrak Karmal during a parliamentary session.<sup>131</sup> When Harakat began to hemorrhage support, Nabi Muhammadi simply reinvented it as his own political party instead of disbanding it. In the midst of this chaos, Sayyid Ahmed Gailani came to Peshawar and created what was to be the second Sufi party, and sixth party overall; "the National Front" (Mahaz-e Milli).<sup>132</sup>

The seventh and final official mujahidin party was the inadvertent result of a third attempt to unite the mujahidin under the banner of the "Islamic Union for the Liberation of Afghanistan" (Ittihad-e Islami Baraye Azadi-ye Afghanistan).<sup>133</sup> This time 'Abd al-Rab Rasul Sayyaf was chosen to lead the organization.<sup>134</sup> Like the first Hizb-e

Islami and Harakat-e Inqilab before, Ittihad-e Islami failed to realize its lofty goals of binding the different mujahidin factions together in one political organization. If Sayyaf was disappointed he kept it to himself, and when Ittihad-e Islami ceased to function as a union, Sayyaf converted it into his own personal political party.

It is easy to imagine that these political parties coalesced relatively quickly once they were declared by their respective leaders, but the primary sources tell a more complex story. Urgent military necessity and the need to access money through official channels helped to crystallize the various parties to a certain degree. But whereas all of the parties would scramble to quickly achieve the proper status to secure international funding, it is not clear how quickly their structures evolved. As explored below, some of Khalis's earliest military forays into Afghanistan had a disorganized and almost desperate character because the system for distributing weapons and materiel in the late 1970s was in a state of flux. By contrast, Hekmatyar and Rabbani both represent a somewhat special case: they inherited a cadre of activists who were informed by their political awakening within the Kabul Islamist movement.

Hekmatyar quickly turned Hizb-e Islami into "a political party in the modern and specifically Leninist sense,"<sup>135</sup> and although Rabbani never created such a centralized organization, he benefited from the common political experience that many of his commanders shared with one another. However, it is less clear whether Sayyaf's organization ever had such cohesion,<sup>136</sup> and there is relatively little information about how effective the Sufi parties of Gailani and Mujaddidi were at transferring Sufi spiritual networks directly into a chain of command for the mujahidin. Lastly, Khalis apparently moved into Afghanistan to fight even before he formally declared the creation of his political party. Although the primary source accounts have a clear mythologizing element to their description of this first movement of Khalis's group into Afghanistan, the biographical narratives provide a unique window into this little-understood time.

### *Khalis's Attempts to Cultivate Jihad, and the First Days of his Political Party*

Before the seven official Sunni parties had taken shape, a large meeting of elders took place near Peshawar. Khalis met with this group of supporters of the jihad, the majority of whom were Nangarharis like him.<sup>137</sup> According to Din Muhammad, these were Khalis's words to the group:

The active jihad must begin. Within two days I am departing for Nangarhar, and everyone who is prepared to fulfill the duty of jihad may accompany me.<sup>138</sup>

In Din Muhammad's account, the members of the assembly seemed to think that Khalis was joking and laughed at him as they responded, "You don't have any weapons or ammunition."<sup>139</sup> Khalis failed utterly to gain support at this gathering, but he left for Nangarhar anyway. Din Muhammad claims: "I was the only person present from this meeting who went together with him to Nangarhar; we did not wait for weapons and ammunition."<sup>140</sup> True or not, this does not seem like the expected mythology of an organization on the verge of becoming one of the premier military forces of the frontier war.

These sources would have us believe that it was far from a foregone conclusion that Khalis's group would become a powerful political and military force. In fact, rather than claim that the group was well equipped and supported, Din Muhammad states that their first mission against the government in Kabul was an attack on a local telephone line executed with the small ax that Khalis carried.<sup>141</sup> After this, Din Muhammad says they came to an agreement with Jamil al-Rahman, Jalaluddin Haqqani and Mati'ullah Khan to begin an "active" jihad together,<sup>142</sup> and to name their group

Hizb-e Islami.<sup>143</sup> Apparently, the creation of this party was not the result of Khalis's own political maneuvering, nor was it the direct descendant of an older formal organization like the Muslim Youth or one of the other Kabul Islamist groups. According to the biographical sources, Hizb-e Islami (Khalis) came about because a small group of leaders in adjacent provinces wanted to band together to fight. Khalis was far older and better known than the other men, and he may have become their leader simply by default.<sup>144</sup> The ethnic divisions that took place in the mujahidin movement relatively early in the 1970s were largely entrenched by the time that Khalis had risen to a position of prominence, and his party was almost entirely made up of eastern Pashtuns.

The effect of reading Din Muhammad's version in tandem with Ahmadzai's account of the same events is to underscore how dangerous and tentative Khalis's initial days in Afghanistan actually were. Insofar as there is a mythic component to these accounts, it is located in the authors' depiction of the precarious early state of the jihad. According to Ahmadzai, when Khalis went into Nangarhar Province in 1979, he brought only seventy men, twenty weapons, and twenty-seven blankets.<sup>145</sup> This was scarcely enough equipment to defend them from government attacks and to keep away frostbite, much less for conducting offensive operations. When Khalis's group moved into the Luy Wali Valley after running out of ammunition, food had become so scarce that "a boiled egg

was shared between three men.”<sup>146</sup> Instead of offering to help, the local people sent a letter threatening the mujahidin with war if they did not decamp.<sup>147</sup> This may help to explain why the Nangarhari elders had laughed at Khalis when he invited them to join his jihad a few days before.

Beyond a doubt, these narratives were designed to underscore the toughness and endurance of the early fighters, and in this goal Din Muhammad and Ahmadzai succeeded. But they also give us a window into the earliest stages of the jihad, when matériel and funding were not yet readily available from the Pakistani government. In this context, the assets that mujahidin were able to seize from government forces were critical. The only reason that Khalis entered Nangarhar with military equipment at all was because Jalaluddin Haqqani and Mati’ullah Khan had raided a depot in Ziruk District the year before.<sup>148</sup>

Rather than operating as the independent commander of his own jihadi force, Khalis comes across in these early narratives as a poorly equipped leader of a medium-sized element who had to depend on his connections with a handful of important people to survive. At this point in the fight Hizb-e Islami (Khalis) did not yet effectively exist, and Khalis’s seventy fighters were little more than a local nuisance to the authorities in Nangarhar. Over the course of a few weeks however, Khalis was able to draw volunteers to his camp from all over Nangarhar,<sup>149</sup> and what began as discrete localized rebellions eventually joined together to span the most important provinces in the eastern Afghan frontier.

But before that could happen, Khalis needed effective support. Only when a major group of already important commanders chose him as their leader did his “active jihad” become anything more than a rhetorical device. The course of history is often unpredictable, and some of the people connected to Khalis such as Jalaluddin Haqqani and Usama bin Ladin were destined to become many times more famous than Yunus Khalis himself. We will now turn to the relationships that Khalis developed with these

men, some of whom are among the best known and most controversial jihadi leaders of the age.

# Evaluating Yunus Khalis's Personal Ties to Bin Ladin and Mullah Omar

## *The Mythos of Yunus Khalis and Bin Ladin*

In the 1990s, interest in Yunus Khalis was largely confined to his role as a leader in the Soviet-Afghan War.<sup>150</sup> That changed when the 9/11 attacks dramatically increased international interest in Usama bin Ladin and the history of al-Qa`ida. Suddenly Khalis's relatively peripheral relationship with Bin Ladin was deemed newsworthy.<sup>151</sup> In fact, however, very little direct contact between these two men is visible in the primary sources.<sup>152</sup> We can state with some confidence that Khalis hosted the al-Qa`ida leader at the housing development near Jalalabad known as Najm al-Jihad.<sup>153</sup> There is also little question that later in the same year Bin Ladin took control of Khalis's old mujahidin base at Tora Bora.<sup>154</sup> But in spite of the relative clarity on these two points,

the conclusions that can be drawn about Khalis's relationship with Bin Ladin based on these interactions in 1996 are far from obvious.

In the absence of more easily accessible information about al-Qa`ida's activities in Nangarhar, Khalis's role as a host attracts much attention. It is difficult to evaluate assertions about the critical importance of Usama bin Ladin's relationship with Yunus Khalis, but two recently released interviews from sources close to Bin Ladin and the wealth of material in the Khalis biographies add important new layers to our understanding of the surprising connections between the relative calm in parts of eastern Afghanistan in the 1990s and the spread of al-Qa`ida to those regions.<sup>155</sup> The results tend to de-emphasize the operational importance of Yunus Khalis as an al-Qa`ida facilitator while dramatically underlining the significance of provincial-level commanders to the growth of Bin Ladin's organization in 1996.

Unfortunately, the provincial level leaders such as Engineer Mahmud and Haji Saz Nur who figure prominently in numerous primary sources<sup>156</sup> about al-Qa`ida in Nangarhar are still relatively poorly studied in the West. Their obscurity may help to explain the proliferation of a set of historical traditions linking Bin Ladin's arrival in Jalalabad and the expansion of his organization in Afghanistan to his relationship with the well-known mujahidin leader Yunus Khalis. The first step in this analysis will be to examine the most commonly cited components of the received wisdom about Yunus Khalis's connections to Usama bin Ladin and, by extension, to Mullah Omar.

In general, these historical traditions focus on the arrival of the al-Qa`ida leadership in Nangarhar in 1996, and the organization's eventual establishment of relations with the

Taliban. In the absence of more information about the variety of connections that Bin Ladin maintained with provincial leaders in the province, most authors tend to cite Khalis as the critical figure who provided Usama bin Ladin with a place to stay at Najm al-Jihad in 1996, when Khartoum ejected al-Qa`ida under pressure from the United States.<sup>157</sup> This tradition is based in fact, but it tells us little about Khalis's actual connection to al-Qa`ida and obscures the significant role played by provincial commanders in bringing Bin Ladin to Nangarhar. Additionally, given the cultural context of eastern Afghanistan, Yunus Khalis's willingness to act as a host can be read as little more than a fulfillment of his tribal obligations as a good Pashtun to provide housing to a friend in need.

Many also add that the al-Qa`ida leader took over Khalis's old base complex at Tora Bora soon after his arrival in Jalalabad,<sup>158</sup> but this assertion is of even less analytical value than the above since it is not clear whether Tora Bora was in use at this time or if Khalis had anything to do with the transfer of the base to Bin Ladin's control. The al-Qa`ida leader's decision to live at Tora Bora in the fall of 1996 says more about his personal desire for seclusion than it does about his relationship with Yunus Khalis. At most, knowledge of Bin Ladin's movement to Khalis's old base in 1996 can help explain why the al-Qa`ida leadership fled to Tora Bora during the NATO invasion of Afghanistan in 2001.

In addition to making general claims about Yunus Khalis's involvement with the arrival of the al-Qa`ida leadership in Jalalabad in 1996, some authors seek to establish a deep personal connection between Khalis and Usama bin Ladin. A few go so far as to say that

Khalis acted as a father figure to Bin Ladin,<sup>159</sup> and there are periodic assertions in the secondary literature that Khalis and/or his son Anwar al-Haq Mujahid helped Bin Ladin escape from Tora Bora in 2001.<sup>160</sup> As previously mentioned, Talai's 2012 biography of Khalis is the only primary source to confirm that Usama bin Ladin referred to Khalis as "the Father Sheikh," but there are numerous examples of Afghans referring to Yunus Khalis as "Papa Khalis" in the Pashto sources.<sup>161</sup> Leaving aside any questions this may raise about how unique or important Bin Ladin's choice of nickname for Khalis may have been, Bin Ladin's use of this term of endearment seems to have been rooted in Khalis's willingness to accept him as a friend even after the international community had turned against al-Qa`ida.<sup>162</sup> Affection and reverence notwithstanding, this personal relationship certainly does not seem to have guaranteed that Khalis and Bin Ladin saw eye to eye politically.<sup>163</sup>

The final major component of these historical traditions in the secondary literature involves Yunus Khalis's alleged role in connecting Usama bin Ladin with Mullah Omar. Many Western authors claim that the Taliban leader was a member of Hizb-e Islami (Khalis) during the Soviet-Afghan War<sup>164</sup> and, more important, that Khalis introduced Bin Ladin to Mullah Omar in 1996 or 1997.<sup>165</sup> It may be true that Mullah Omar fought under Hizb-e Islami (Khalis) at some point in the 1980s, but he almost certainly had no

direct contact with Yunus Khalis during the jihad. And significantly, no solid evidence that Yunus Khalis had a role in introducing Usama bin Ladin to the Taliban leader yet exists. In sum, these historical traditions in the secondary sources seek to give Yunus Khalis a critical role in both the “return” of al-Qa`ida to Afghanistan and the highly charged, albeit widely misrepresented, interactions between al-Qa`ida and the Taliban.

We can confirm that Yunus Khalis helped to host Usama bin Ladin for a brief period in 1996, that Bin Ladin moved some of his followers to Tora Bora soon after his arrival in Jalalabad and that Mullah Omar had some level of involvement with Hizb-e Islami (Khalis) during the Soviet-Afghan War. However, even though these particular elements of the Khalis-tradition are true, there is still great uncertainty about the overall analytical value of the broader historical mythos of Yunus Khalis. Unfortunately, the almost unqualified reiteration of both the true and the tendentious portions of the Khalis tradition has obscured the complexity of his politics and the identities of the actors who *were* actually closely involved in the development and growth of al-Qa`ida.<sup>166</sup> This leads in turn to a consistently warped account of Khalis’s activities after the Soviet-Afghan War and serves to put him in a kind of mythical “quaternion of jihad” together with Mullah Omar, Usama bin Ladin and Jalaluddin Haqqani.

### *Khalis's Relationship with Bin Ladin: a Number of Views*

Such a distortion of Khalis's historical role invites scholars and analysts to make bold assumptions about his connections to the Taliban movement and his support for Bin Ladin's increasingly violent post-1996 agenda. Unfortunately, assumptions like this fly directly in the face of the (admittedly scant) available evidence.<sup>167</sup> This confusion about the nature of Yunus Khalis's connections and politics might be of relatively minor concern if its effect were confined to investigations of him and his political party. However, our understanding of Khalis has consequences for larger issues such as the current reconciliation efforts in Afghanistan that hope to convince certain insurgent groups to permanently renounce their ties to al-Qa`ida.

Thomas Lynch suggests that the personal relationships between top leaders like Khalis, Bin Ladin and Jalaluddin Haqqani are the most important points of connection among their respective jihadi organizations. This leads him to conclude that the death of Yunus Khalis in 2006 and Usama bin Ladin in 2011 might unravel the relationship between al-Qa`ida and certain jihadi organizations active in eastern Afghanistan.<sup>168</sup> But it is not clear that these personal relationships between Bin Ladin and top Afghan leaders constitute the best way to analyze the inter-organizational dynamics of the Afghan mujahidin and al-Qa`ida. And even if they were, one should remember that al-Qa`ida was not significantly deterred when several of their most important Afghan operational

facilitators were killed in late 1996.<sup>169</sup> The reality is that there is still a lack of clarity regarding who Usama bin Ladin's most important contacts in Afghanistan were. However, the prevalence of information about the operational connections between al-Qa`ida and Jalaluddin Haqqani,<sup>170</sup> Engineer Mahmud<sup>171</sup> and Haji Saz Nur<sup>172</sup> suggests that these men were demonstrably far more significant to the development of Usama bin Ladin's organization than "the Father Sheikh" Yunus Khalis.

In a bizarre twist, the secondary material written in English about Khalis and Bin Ladin gives a much more detailed and enthusiastic account of their relationship than the material produced by al-Qa`ida or Hizb-e Islami (Khalis). The al-Qa`ida leader Ayman al-Zawahiri stated in a recently taped interview that "the most striking aspect of this relationship was that Shaykh Yunus Khalis harbored Shaykh Usama Bin Ladin in Jalalabad when the Sudanese Government, may it get what it deserves from God, ejected him."<sup>173</sup> Al-Zawahiri makes no argument that Khalis acted as a mentor to the former al-Qa`ida leader and never mentions Mullah Omar. Instead he expresses his surprise and approval at Khalis's willingness to host Bin Ladin in a time of need. While not too much should be made of what is absent from al-Zawahiri's interview, his special emphasis on Khalis as a host matches up well with other sources. In all likelihood, this willingness to invite Bin Ladin into his home during a difficult time was what inspired the affection that Talai claims the al-Qa`ida leader felt for Khalis.

Din Muhammad, who was recently nominated as the minister of tribal and border affairs by the government in Kabul, has a clear personal stake in downplaying Yunus Khalis's connection to Bin Ladin. So it is doubly intriguing that Din Muhammad's account agrees very closely with al-Zawahiri's, both in the discussion of Bin Ladin's stay with Khalis and in Khalis's response to criticism over his decision to host the al-Qa`ida leader.<sup>174</sup> These and other available primary sources never purport that the two men had a mentor-pupil relationship. Instead they make relatively modest claims that Khalis helped to provide Bin Ladin with a place to stay in spite of his infamy,<sup>175</sup> and they suggest that Khalis urged the al-Qa`ida leader not to declare jihad against Saudi Arabia.<sup>176</sup> The two men were doubtless acquainted with one another, and according to Bin Ladin's son Omar, they enjoyed reminiscing together in Jalalabad in 1996.<sup>177</sup> However, there is nothing in the available texts to suggest that this amicable relationship was operationally critical to al-Qa`ida, much less that Yunus Khalis became the principal al-Qa`ida facilitator in Nangarhar when Bin Ladin arrived in 1996.

Of course, not everyone agrees with the interpretation that Khalis and Bin Ladin were little more than old jihadi acquaintances from the days of the Soviet-Afghan War. The best known evidence in favor of a claim that the two had a particularly close relationship comes from a brief citation from a book written by Abu Musab al-Suri, a strategist and trainer who consulted on behalf of al-Qa`ida:

I heard something incredible from Yunis Khales ... during a meeting [...] He said to Abu Abdallah [Bin Ladin], in his thickly accented but proficient Arabic, "I have nothing but myself, and it is very dear to me. However, you are more precious to me, and your well-being is more important than my own. You are our guest, and no one can get to you. If anything happens with the Taleban, tell me. Though there is little I can do after they reach you, I will do all I can."<sup>178</sup>

At first glance this text can be seen as proof that Yunus Khalis was making an extraordinary offer of protection to Usama bin Ladin, which might support an assertion that the relationship between the two men was close enough to extend into ideological or operational cooperation. However, cultural and historical clues about the context of the conversation and signals in Khalis's wording argue against such a clear-cut interpretation.

### *The Context of Bin Ladin's Stay with Khalis in 1996*

When the aforementioned conversation occurred, Bin Ladin had recently arrived in Nangarhar as an exile from Sudan. It is worth asking at the outset why he chose Jalalabad as his safe haven instead of returning to the camps al-Qa`ida maintained near Jalaluddin Haqqani's Zhawara facility in Khost Province.<sup>179</sup> The most likely answer is that by the time Bin Ladin was under pressure to flee Sudan, Haqqani's territory in Paktia and Khost had come under Taliban control.<sup>180</sup> Since the al-Qa`ida leader was initially uncertain whether the Taliban were friends or foes,<sup>181</sup> he chose to relocate to Nangarhar where his contacts were still operating outside the Taliban's authority. However, Nangarhar would not remain outside the Taliban's reach much longer.

Although Khalis apparently extended his aegis to Bin Ladin in the above quotation by al-Suri, Khalis also stated that "there is little I can do after they reach you."<sup>182</sup> By 1996 it is questionable whether Khalis was in a position to defend the al-Qa`ida leader against

the Taliban with a military force. In that context, Khalis's parting words to Bin Ladin<sup>183</sup> may have referred more to a possible diplomatic intercession than to an armed intervention. According to al-Suri, Yunus Khalis wanted to reassure the al-Qa'ida leader by stating his good intentions, but Khalis also deftly signaled that Bin Ladin needed to manage his expectations for what could be done if he was ever captured by the Taliban.

Khalis's recognition of his limited influence was rooted in recent experience. Not long before this 1996 discussion with Bin Ladin, Yunus Khalis had been powerless to prevent the Taliban from abusing the brother of a close friend in Paktika,<sup>184</sup> and he would continue to have a troubled relationship with the Taliban in the coming years. Rather than being taken literally, this text should be seen as a tactful expression by Khalis of his desire to help a guest even as he frankly admits that his real capacity to offer assistance is limited. In addition, most accounts of the cultural norms of Pashtunwali emphasize the importance of *melmastia* (hospitality) for the reputation of a host in a community.<sup>185</sup> The available evidence indicates that Khalis genuinely cared about traditional aspects of Pashtun culture such as *melmastia*,<sup>186</sup> and in this context Khalis's offer of protection to Bin Ladin was actually rather unremarkable. The unique political environment of Nangarhar in early 1996 was probably a far more important element in Bin Ladin's decision to come to Jalalabad than his friendship with Yunus Khalis.

Many Western works on al-Qa`ida explicitly set out the goal of understanding Usama bin Ladin's relationship with Nangarhar Province through Tora Bora and Jalalabad.<sup>187</sup> It is widely known that Bin Ladin stayed near Jalalabad with Khalis, but there is continuing uncertainty about the specific circumstances of his arrival.<sup>188</sup> Similarly, the narrative that Usama bin Ladin escaped from Tora Bora in December 2001 drives many authors to investigate his connection to that famous Nangarhari mujahidin base. Yet there is surprisingly little *factual* information about Tora Bora available to Western readers.<sup>189</sup> While the Khalis biographies do not definitively settle these questions, they do provide critical background details about politics in Nangarhar and the histories of Tora Bora and the Najm al-Jihad housing development, where Khalis played host to Bin Ladin and many others. Understanding these contextual clues is the first step toward demystifying the complex intersection of Hizb-e Islami (Khalis), the Taliban, the Eastern Shura<sup>190</sup> and al-Qa`ida in the 1990s.

### *Khalis's "Retirement" in Nangarhar*

Of course, some of the most important contextual clues for an analysis of Khalis and his role in Nangarhari politics during this period have little to do with famous bases and housing schemes. The biographies remind us that Khalis was a frail man of seventy-six years of age when Bin Ladin arrived in Jalalabad. His health was failing so badly that he

was nearing the end of his working life,<sup>191</sup> and his political party had already effectively disintegrated.<sup>192</sup> Even in the earlier 1990s, Khalis had almost no direct hand in national or provincial governance during the Afghan Civil War.<sup>193</sup> In fact, Khalis seems to have had only a peripheral connection to his own erstwhile subordinate commanders and allies in the late 1990s, let alone to organizations like al-Qa`ida. According to the biographies, Khalis's chief role in the mid- to late 1990s seems to have been as a negotiator and adviser to other (younger) political actors, and even this did not guarantee him a sympathetic audience. Engineer Mahmud, who had been one of

Khalis's most important commanders and remained a supporter of Usama bin Ladin, openly flouted Khalis's advice to exercise caution as the Taliban arrived in Nangarhar in late 1996.<sup>194</sup> But there may be more to Khalis's disengagement from a direct leadership role in national politics than his age, ill-health and external political factors.

It is suggestive that after the fall of Najibullah's regime in Kabul in 1992, Yunus Khalis shifted his attention away from national politics toward more local and pietistic pursuits. His activities at Najm al-Jihad were closely connected with the history of the famous Mullah of Hadda through more than just the choice of a name for the neighborhood. In fact, Khalis's new housing development, which was theoretically built in part to provide housing to the destitute, was situated immediately west of the area where the Mullah of Hadda was known to host hundreds of people, including both Sufi adepts and the poor of Nangarhar.<sup>195</sup> Khalis's activities in this period could be characterized in many different ways based on the scant available sources, but there is little to suggest that he was an active participant in organizations like al-Qa`ida or even the Eastern Shura in Jalalabad. It seems clear that many recent books rely too heavily on Khalis to help explain the Nangarhar element in the growth of al-Qa`ida. However, other historical problems could be much more fruitfully approached through an investigation of Khalis's political influence on eastern Afghanistan.

In the 1990s, the power struggles among regional political elites in Afghanistan resulted in very different responses to the factional violence of the civil war, and, later, to the rise of the Taliban. After the Soviet-Afghan War ended, there was a kind of transition of control in Nangarhar from the hands of Dr. Najibullah's government to the Eastern Shura led by 'Abd al-Qadir.<sup>196</sup> The Eastern Shura was the main player in Nangarhar politics in the chaotic period between the fall of the Najibullah government in 1992 and the Taliban takeover of the province in September 1996. Although Khalis was not an active member of this body, Din Muhammad argues that he had a clear vision for the

Eastern Shura's role in keeping Nangarhar out of the civil war.<sup>197</sup> As Khalis's health and influence steadily declined, he continued to interfere episodically at critical points in national politics.<sup>198</sup> But in spite of these high-profile engagements, Khalis gradually became more involved in local concerns. We will begin our analysis of his connection to various major jihadi leaders by evaluating the histories of the two most important locations of his influence on Nangarhari politics: his base at Tora Bora and his housing development at Najm al-Jihad.

### *Tora Bora, and the Importance of Zhawara to the Birth of al-Qa`ida*

The Tora Bora base in Pachir aw Agam District was the third Nangarhari base occupied by Hizb-e Islami (Khalis) in the late 1970s.<sup>199</sup> The organization hurriedly abandoned the first fortification when ammunition and supplies ran out in the face of a major government attack,<sup>200</sup> and when its members moved to a new location in Luy Wali, the locals tried to eject them from the valley.<sup>201</sup> They overcame these tensions, and the Luy Wali base became known for its strong defenses, but it was so snowy there in the winter and so difficult to reach by foot that the mujahidin immediately began searching for a

new position.<sup>202</sup> They found an ideal spot at a small village of the Suleiman Khel tribe in an area near Spin Ghar<sup>203</sup> called Tora Bora. After consultation with Khalis, the locals decided that their homes “would be given out of their own free taste and satisfaction as a charitable trust [waqf] to the jihad for the sake of God.”<sup>204</sup> Apparently, they voluntarily moved out of the area, and in 1979 their village became the mujahidin base of Tora Bora.<sup>205</sup>

Tora Bora may have achieved great fame through its connection to Usama bin Ladin from 1996 to 2001, but it was neither the only permanent base built by Hizb-e Islami (Khalis) on Afghan soil during the war nor was it closely tied to the development of al-Qa`ida in the late 1980s. Khalis’s party maintained three other major bases in Afghanistan throughout the jihad: Jalaluddin Haqqani’s Zhawara base, Mati’ullah Khan’s Ziruk base and a base near Nazyan district of Nangarhar Province.<sup>206</sup> Little is known about the significance of the Ziruk and Nazyan fortifications.<sup>207</sup> On the other hand, Zhawara has since become famous<sup>208</sup> as one of the most important logistical hubs of the entire resistance effort in eastern Afghanistan.<sup>209</sup> Ironically, when the Soviets

made a massive push to overwhelm Zhawara in 1986, they set in motion a sequence of events that helped give rise to a new Arab mujahidin movement separate from ‘Abdullah ‘Azzam’s long-established Maktab al-Khidamat.<sup>210</sup>

The Zhawara battle in 1986 was one of the largest of the entire Soviet-Afghan War. The combined Soviet and Democratic Republic of Afghanistan forces succeeded in collapsing the cave where Jalaluddin Haqqani was taking cover, and the communists even pushed the mujahidin out of Zhawara for several hours at the height of the fighting.<sup>211</sup> Haqqani was forced to issue a call for help at the beginning of the long battle, and large numbers of mujahidin were mobilized in response. Many fighters arrived to assist in the defense of Zhawara, possibly including Arabs of the Maktab al-Khidamat, who had not frequently been involved in frontline fighting up to that point.<sup>212</sup> In fact, when Yunus Khalis arrived in Miranshah to help coordinate the defense, he sat together with a group of Arab mujahidin in Haqqani’s home to listen to news of Zhawara on the radio.<sup>213</sup>

The complex story of the Arab presence at the Battle of Zhawara has yet to be fully uncovered, and Vahid Brown cites Arab sources that both downplay and laud Maktab al-Khidamat’s involvement in the fighting.<sup>214</sup> Clearly some of the Arabs were more

satisfied with the experience than others were, and the battle appears to mark a split in the Arab mujahidin community of Maktab al-Khidamat. Some of the Arabs continued to follow 'Abdullah 'Azzam's policy of assisting the Afghan mujahidin parties relatively indirectly, while others followed Usama bin Ladin and helped him create his newly dubbed base "Ma'sadat al-Ansar" near Jaji in October 1986.<sup>215</sup> The Ma'sada base was to become one of the centers of a new kind of Arab mujahidin force designed to fight on the front lines, and it soon gained a nickname that must have seemed prosaic at the time: "al-Qa'ida al-'Askariyya" (the Military Base).<sup>216</sup>

Ma'sada's logistical and operational ties to Haqqani's base at Zhawara were deep. Brown and Rassler describe an interlocking network of preparatory training and leadership cadre that was shared between the proto-al-Qa'ida organization and Haqqani's forces beginning in the late 1980s. They argue that "to join the nascent al-Qa'ida ... meant first training with the Haqqani network."<sup>217</sup> Tora Bora was much closer to Bin Ladin's base than Zhawara was, but there is currently no evidence that Khalis or Tora Bora played any direct role whatsoever in the early development of Bin Ladin's new organization, and Talai directly denies that Khalis had any significant relationship with Bin Ladin during the Soviet-Afghan War.<sup>218</sup> Khalis granted a large degree of operational autonomy to major commanders such as Haqqani and 'Abd al-Haq, and generally did not centralize decision making in his party.<sup>219</sup> Therefore, although Haqqani probably informed Khalis of some of his plans, it cannot be assumed that Haqqani was acting under direct orders to foster a strong relationship with Arab mujahidin such as Bin Ladin.<sup>220</sup>

Haqqani had obvious financial reasons for building his own patronage and support networks and appears to have worked diligently to find links to the Persian Gulf.<sup>221</sup> However, Haqqani was also engaged in the fabulously profitable business of collecting and selling scrap metal gleaned from abandoned materiel after the end of the Soviet-Afghan War. In fact, he became so well known for this trade that one of his most famous nicknames in eastern Afghanistan is still “Haqqani Kabarri” (Haqqani the Junkman). This scrap-metal business helped give Haqqani the financial wherewithal to remain largely independent from Khalis and other national leaders during the turbulent early 1990s. So, while it is clear that Jalaluddin Haqqani had a strong relationship with Yunus Khalis, there is no reason to believe that Haqqani’s activities at Zhawara were being controlled or funded by Khalis.

There are abundant sources attesting to Bin Ladin’s connections to Zhawara and other bases in Khost during the 1980s, but nothing available from this period suggests that the al-Qa`ida leader had significant operational ties to Tora Bora.<sup>222</sup> That only changed when Bin Ladin fled from Sudan to Jalalabad in 1996. In fact, Anand Gopal’s interview with Sheikh Muhammad suggests that Bin Ladin’s first meeting with a representative of the Taliban took place at Tora Bora.<sup>223</sup> This is supported by Omar Bin Ladin’s brief account of his father’s first meeting with a Taliban messenger.<sup>224</sup> However, few clues exist about how or even if Tora Bora was being used from the fall of Najibullah’s government in 1992 until Bin Ladin’s arrival in 1996. Based on what is known of Khalis’s political activities during this time period, land management at Tora Bora seems unlikely to have been a pressing priority for the Hizb-e Islami leader.

## *Khalis and the Afghan Civil War*

For part of the early 1990s Yunus Khalis was still an active national-level political figure in Afghanistan. He was the interior minister in the Afghan Interim Government, and he even threatened to run for leadership of the country in opposition to Sayyid Ahmed Gailani at one point.<sup>225</sup> However, according to Din Muhammad, Khalis spent much of his diminishing political capital in the 1990s by trying to convince Rabbani, Hekmatyar and others to stop fighting one another.<sup>226</sup> One cannot naively ascribe an unassailable moral authority to Yunus Khalis on this basis,<sup>227</sup> but discussions of his actions during the civil war are notably absent from most Western accounts of the period. In Din Muhammad's view, Khalis eventually became convinced that the mujahidin government was part of the problem, and he counseled his commanders not to take the official positions they were offered.<sup>228</sup>

Unfortunately, while Din Muhammad gives us some idea of Khalis's activities after he "returned" to Nangarhar in 1994,<sup>229</sup> there is very little in the biographies to tell us about Khalis's activities in Peshawar during this period. This is unfortunate, in part because it is known that around 1992 Usama bin Ladin was working from Peshawar to mediate between the belligerent parties in Afghanistan,<sup>230</sup> and it is unlikely that Khalis was unaware of these efforts. Other than Talai's description of Khalis's attempts to mediate between the Saudi government and Bin Ladin, little is known about Khalis's activities

during this period,<sup>231</sup> but there are isolated clues that might prove to be fruitful ground for future investigations. If nothing else, it must be noted that in 1991 both Yunus Khalis and Jalaluddin Haqqani penned statements of support for a jihad in Sudan,<sup>232</sup> not long before many of Bin Ladin's followers would move to Khartoum. Even though this certainly raises questions about why there is so little information in the biographies about Khalis's activities in Peshawar in the early 1990s, the letter has no direct bearing on the broader primary source narrative that Khalis was not involved in the civil war.

In fact, to the extent that Din Muhammad's biography of Khalis makes a consistent argument, it is that Khalis was not one of the culpable parties in the devastating violence of the Afghan Civil War.<sup>233</sup> Although this should not be blindly accepted, Din Muhammad makes several thought-provoking points about Khalis's involvement in a kind of "Nangarhari exceptionalism" that helped to keep the civil war out of the province.<sup>234</sup> This discussion of regional politics is less obscure than it may seem at first blush. Although it is too early to state this claim definitively, the unique political situation in Nangarhar in the 1990s likely had a direct bearing on Bin Ladin's decision to seek refuge there.

Given Din Muhammad's obvious pro-Khalis bias, the continued search for evidence that offers a different interpretation of Khalis's activities in this period is essential. For better or worse, however, all of the currently available evidence indicates that Khalis and his commanders went out of their way to avoid direct involvement in the Afghan Civil War.<sup>235</sup> This was not a guarantee that they shunned their contacts with al-Qa'ida and other foreign terrorist groups however, and so the next stage in this analysis will examine the details about Usama bin Ladin's arrival in Jalalabad in 1996.

### *Usama bin Ladin's Arrival in Nangarhar in 1996*

Bin Ladin's arrival in Nangarhar in 1996 is a difficult puzzle to unravel. The movement was intended to be secret,<sup>236</sup> and there are still many open questions about the chain of events that led him to Jalalabad. Various authors note the comments made about Bin Ladin's movement to Afghanistan by valuable sources like Wahid Muzhda,<sup>237</sup> Abu Musab al-Suri,<sup>238</sup> Abu al-Walid al-Masri,<sup>239</sup> and Abu Jandal.<sup>240</sup> These are excellent

sources, but they tend to discuss different aspects of the story. This diverging focus has made it difficult to piece together the chain of events and the actors who were involved in Bin Ladin's move from Sudan. It is known that Sudan was under enormous pressure from the United States to expel the al-Qa`ida leader in the mid-1990s,<sup>241</sup> and when Khartoum ultimately yielded to Washington's wishes, Bin Ladin had few options for relocation. A much clearer picture of this chaotic time emerges by including in our analysis Anand Gopal's recent interview with Sheikh Muhammad,<sup>242</sup> and Din Muhammad's account of Bin Ladin's exile from Sudan in his biography of Khalis.<sup>243</sup>

In analyzing all of the available sources simultaneously, three people immediately stand out: the Hizb-e Islami (Khalis) commander Engineer Mahmud,<sup>244</sup> the Ittihad-e Islami commander Haji Saz Nur,<sup>245</sup> and the Hizb-e Islami (Gulbuddin) commander Fazl al-Haq Mujahid.<sup>246</sup> These are the individuals most frequently cited together in the primary sources for involvement in bringing Bin Ladin to Jalalabad. They flew to Sudan early in 1996, possibly under the invitation of the government in Khartoum to attend a

celebration of Sudanese independence, and presented the overtures that eventually convinced Bin Ladin to come to Jalalabad later that year.<sup>247</sup> Sources offer different suggestions about who met Bin Ladin when he arrived in Nangarhar, but these same three commanders are consistently associated with the al-Qa`ida leader's arrival and initial stay in Jalalabad.<sup>248</sup>

Evidence strongly suggests that these three were directly involved in bringing Bin Ladin to Nangarhar, but it is not known to what degree they acted on their own initiative in this undertaking. It is tempting to conclude that this group, made up of one commander from each of the three main parties in Nangarhar, may have been sent by the multilateral Eastern Shura. It would not necessarily have contradicted the Eastern Shura's anti-civil war politics to invite Bin Ladin to their province, and Gopal's interview with Sheikh Muhammad seems to suggest that the shura was involved.<sup>249</sup> Din

Muhammad addresses this question directly by claiming that these three commanders acted without the permission of their parties or the permission of the Eastern Shura when they traveled to Sudan and brought Usama bin Ladin home to Nangarhar in their wake.<sup>250</sup> But given the tight control over the Jalalabad Airport exercised by the shura, it seems unlikely that these three leaders would have been able to leave for Sudan without permission from the governing authorities in Jalalabad.<sup>251</sup> In a conversation with Roy Gutman, Din Muhammad apparently provided a tidy answer for this oddity by pointing out that his brother 'Abd al-Qadir was the leader of one faction within the shura, and it was the other faction led by Engineer Mahmud and Haji Saz Nur that actually invited Bin Ladin.<sup>252</sup>

Some important individuals in charge of the different factions represented in the shura were certainly involved in bringing Bin Ladin to Nangarhar, but it is doubtful that the entire shura was involved in such a plan, since 'Abd al-Qadir is almost never mentioned in connection with al-Qa`ida's movement from Sudan. In fact, it is entirely possible that the three major commanders who left for Sudan in early 1996 were the most powerful figures in Nangarhar who had any prior knowledge of Bin Ladin's impending arrival. Even so, there is some evidence that members of Rabbani's government in Kabul were also aware of the plan to bring the al-Qa`ida leader back to Afghanistan. Wahid Muzhda makes a strong argument against Amrullah Saleh, who allegedly claimed that Bin Ladin came to Afghanistan without the knowledge or consent of Ahmad Shah Massoud.<sup>253</sup>

Although Muzhda admits that he has no firsthand knowledge of such private discussions between Massoud and others, he points out that the presence of 'Abd al-Rab Rasul Sayyaf as a representative of Rabbani's government at the airport in Jalalabad to greet Bin Ladin makes it highly unlikely that the operation to transfer the al-Qa`ida leadership to Nangarhar was conducted without the prior knowledge of the most important elites in Kabul. Even so, it is not yet possible to determine the degree to which the invitation extended to Bin Ladin was originally a Kabul- (i.e., Rabbani-)

initiated project,<sup>254</sup> and there is evidence that not all of the factions in the Eastern Shura were equally thrilled about the arrival of the al-Qa`ida leadership in Nangarhar. Whatever the case may be for or against the Eastern Shura's complicity in Bin Ladin's flight to Afghanistan, Khalis was not an active member of the shura, and he became visibly involved in this affair only when he invited the al-Qa`ida leader to be his guest at Najm al-Jihad upon arrival.

### *The History of Najm al-Jihad; Yunus Khalis's Housing Development*

When Khalis moved home to Nangarhar from Peshawar in 1994,<sup>255</sup> the governing shura offered him a home in Jalalabad. He rejected their offer and instead built the aforementioned Najm al-Jihad housing development near the southern edge of the city.<sup>256</sup> Najm al-Jihad has evidently gained a reputation in the intelligence community as an al-Qa`ida compound,<sup>257</sup> but the original reason that Khalis built the new development almost certainly had nothing to do with Bin Ladin.<sup>258</sup> Instead, the creation of Najm al-Jihad offers insight into how the aging Hizb leader intended to maintain some degree of political relevance in Nangarhar as he retired and convalesced.

Khalis created the Najm al-Jihad housing development on an empty plain immediately south of a former Soviet collective farm.<sup>259</sup> This project was officially named the sixth region (*nahia*) of Jalalabad,<sup>260</sup> but the provision of food and water, the construction of streets and other services were initially arranged by Khalis himself.<sup>261</sup> In fact, Din Muhammad goes out of his way to describe Najm al-Jihad as a humanitarian project. He places the history of the housing development under a section of his book about community service, and he says that Khalis created it for “the families of martyrs and orphans, disabled people and the helpless.”<sup>262</sup> Almost as an afterthought, Din Muhammad offers insight into the name of the neighborhood by tying it to the history of the famous jihadi leader known as the Hadda Mullah, whose actual name was Najm al-Din Akhundzada.<sup>263</sup>

Theoretically, Najm al-Jihad was a community built around Khalis’s new private home in which people who had lost everything in the recent war could start a new life. The entire Najm al-Jihad project presupposed that Nangarhar was a safer place to live than the rest of the country, and the creation of this new community became part of Khalis’s political argument for the alternative to fighting Hekmatyar and others in the civil war. As Hekmatyar assaulted a series of Hizb-e Islami (Khalis) bases in 1995, Yunus Khalis ordered his commanders to surrender their posts and invited them to settle with him in Jalalabad.<sup>264</sup>

It is impossible to discern Khalis's precise intentions for making this new community. But the creation of Najm al-Jihad had the effect of shifting Khalis's base of support to a new civilian community within Jalalabad at the precise time when his former mujahidin commanders were becoming increasingly independent from him and his ill health was limiting his political activity. Although Najm al-Jihad was the original name of the community, as Din Muhammad notes, it is more commonly referred to as "Khalis Camp or Town."<sup>265</sup> The presence of Khalis Town in Jalalabad has become an enduring reminder of Khalis's ongoing influence on the region. It can be argued that irrespective of the original purpose of this community, there was an association between al-Qa`ida and Najm al-Jihad that can be traced to Bin Ladin's arrival in Jalalabad in 1996. Omar Bin Ladin offers an intriguing suggestion about how this connection may have come about.

According to Bin Ladin's son, a mysterious "Mullah Nourallah," who was then the leader of the province, presented Usama bin Ladin with a large piece of land in Jalalabad, saying, "Build yourself a compound."<sup>266</sup> Various clues suggest that "Mullah Nourallah" was a pseudonym for Haji Saz Nur,<sup>267</sup> further cementing Saz Nur's status as a key al-Qa`ida facilitator in Nangarhar. The location of the plot of land that Nourallah supposedly gave Bin Ladin is unknown, but Najm al-Jihad is the most likely candidate since it is the only named site of a Nangarhari al-Qa`ida compound in the available sources. Abu Jandal describes how the al-Qa`ida "complex" at Najm al-Jihad was

converted to a guesthouse when Bin Ladin moved to Kandahar.<sup>268</sup> But even if the al-Qa`ida leader created a permanent presence at Najm al-Jihad that included several buildings,<sup>269</sup> the vast majority of the thousands of residents of the community had little or nothing to do with Bin Ladin's organization.

This distinction between *part* (al-Qa`ida compound) and *whole* (Khalis's residential community) appears to be lost in some accounts; Guantánamo documents released by the U.S. government indicate that at least part of the U.S. intelligence community believes that "Nejim al Jihad [sic] was an al Qaida housing compound owned by Usama Bin Ladin that is occupied by al Qaida members and their families."<sup>270</sup> It is possible that analysts made this assessment based on information that is unavailable to scholars, but on the surface it seems as though the larger history of Najm al-Jihad is simply not well-known in the intelligence community. In the event that the equation of al-Qa`ida's compound at Najm al-Jihad with the entire community is accidental, then it is easy to imagine how any one of thousands of residents of the neighborhood could be construed as an al-Qa`ida operative or facilitator on the basis of this mistaken analytical synecdoche.

The trouble is that although Khalis's neighborhood is no longer commonly referred to as Najm al-Jihad, it is not clear when the Jalalabad community ceased to use that name. If the locals stopped calling the housing development by its original name soon after ground was broken in construction, then perhaps the only part of the area known as Najm al-Jihad in 1996 *was* the al-Qa`ida compound. Unlikely as this may be, only further investigation can uncover the way that this name was actually used in reference to Khalis's town and the al-Qa`ida compound that apparently existed within its boundaries.

No matter what people may call the neighborhood, it would be naive to ignore the political dimensions to the creation of Khalis's new community. However, his housing

development had relatively little in common with the more explicitly radicalized refugee camps in Pakistan that he and other mujahidin leaders had created during the Soviet-Afghan War.<sup>271</sup> Unlike those wastelands of human suffering and political radicalization, Najm al-Jihad and other postwar urban housing developments were intended to be permanent settlements. Khalis, Sayyaf and other Afghan leaders made various attempts to develop periurban property with mixed results.<sup>272</sup> There is no suggestion in any available source that Najm al-Jihad was linked to Afghan mujahidin training camps before the arrival of al-Qa`ida in 1996. In fact, indirect evidence suggests that by 1996 Khalis was no longer the direct commander of a military force.<sup>273</sup> If this is the case, he had less clear need to continue indoctrinating and recruiting new jihadi fighters than other leaders who were still contesting control of large portions of the countryside, such as Gulbuddin Hekmatyar and Ahmad Shah Massoud. Bin Ladin did stay in Yunus Khalis's community at some point in 1996,<sup>274</sup> and he also left a guesthouse there after he moved to Kandahar. However, the al-Qa`ida leader himself did not remain very long at Najm al-Jihad in the summer of 1996 before he travelled southwest to the mountains of Tora Bora.

Omar Bin Ladin was with his father in Jalalabad at this time, and he claims that they moved to Tora Bora within two months of arrival.<sup>275</sup> He attempts to clear the confusion about how they came to occupy the old base by claiming that Mullah Nourallah *gave* Tora Bora to Usama bin Ladin.<sup>276</sup> To be sure, Omar was a child at the time and may have missed some of the details of this transaction, but the value judgment that he transmits about the relative importance of his father's relationship with Mullah Nourallah/Haji Saz Nur is unmistakable. It is known that Haji Saz Nur, Engineer Mahmud and Fazl al-Haq Mujahid were closely involved with bringing al-Qa`ida to Nangarhar. Omar Bin Ladin's account serves to underscore that these relationships, especially with Saz Nur, continued to have far greater practical importance to Bin Ladin after he fled Sudan than his contacts with former party leaders like Yunus Khalis did. This account also reminds us that the al-Qa`ida leader's position became very precarious when Engineer Mahmud and Haji Saz Nur were both killed in an ambush in the fall of 1996 by Haji Shah Wali's forces.<sup>277</sup>

Luckily for Bin Ladin, his worst fears about the Taliban forces that were then arriving in Nangarhar were to prove unfounded. The al-Qa`ida leader's first meeting with the Taliban appears to have taken place at Tora Bora soon after the death of Mullah Nourallah/Haji Saz Nur.<sup>278</sup> The Taliban immediately sought to reassure Bin Ladin that they would protect him. The words of the Taliban representative(s) appear to parallel

the content, if not the tone and expressiveness, of Yunus Khalis's much touted remarks to Bin Ladin earlier in the year.<sup>279</sup> This marked the beginning of Bin Ladin's relationship with the Taliban, and at Mullah Omar's invitation he would soon move to Kandahar, leaving only a skeleton al-Qa`ida presence behind in Jalalabad.<sup>280</sup> In spite of Khalis's absence from these accounts of the first meeting between al-Qa`ida and the Taliban, some authors continue to claim that it was Khalis who introduced Usama bin Ladin to Mullah Omar.<sup>281</sup> Those assertions appear to be loosely based on the idea that Khalis was on relatively friendly terms with the Taliban leadership,<sup>282</sup> but the reality of Khalis's interaction with the Taliban was much more complicated.

### *Yunus Khalis's Relationship with Mullah Omar and the Taliban*

Claims about Khalis's relationship with Mullah Omar are frequently discussed as part of a larger argument about Usama bin Ladin,<sup>283</sup> and yet there is no solid evidence linking the three men together organizationally. After the Soviet-Afghan War, Khalis's former commanders took divergent paths. Some of them would become leaders in the Taliban movement, while others such as Jalaluddin Haqqani, 'Abd al-Qadir and Engineer Mahmud became powerful provincial-level leaders. These latter individuals faced a difficult transition in 1995 and 1996 when the Taliban moved north and east out of Kandahar. Some of them, like Jalaluddin Haqqani, decided to work with the Taliban in the hope of maintaining some degree of autonomy.<sup>284</sup> In Nangarhar there was a much more varied reaction to the Taliban's approach.

'Abd al-Qadir left for Pakistan when it became clear that the Taliban would enter his province, but Engineer Mahmud and other former Hizb-e Islami (Khalis) commanders remained and attempted to find a middle path between fighting the Taliban and surrendering the province.<sup>285</sup> By this time, the imperfect systems that were put in place by the Eastern Shura for controlling and preventing violence in Nangarhar were falling apart, and Engineer Mahmud, Haji Saz Nur and many others were killed in the chaotic final days before the Taliban took complete control of the province.<sup>286</sup>

Khalis's position on the Taliban was complex and appears to have wavered between tentative support, disassociation and open criticism. In one conversation in the early days of the Taliban movement, Khalis even congratulated Mullah Omar for his good work.<sup>287</sup> Khalis apparently did not hold this sanguine opinion for very long, and he was able to have a more neutral relationship with the Taliban partly because he was not directly contesting their growing authority as they marched into the east. His former commanders were in an entirely different position, and so Khalis's advice to Engineer

Mahmud to avoid acting until “the situation becomes clearer”<sup>288</sup> went unheeded. Engineer Mahmud was soon killed, and by the time that the Taliban consolidated their control in Nangarhar, Khalis’s view of the movement was already souring.

The vignettes recounted by Din Muhammad depict an increasingly acrimonious and poisonous relationship between Khalis and various Taliban leaders. Din Muhammad recalls several incidents of the Taliban reneging on agreements with Khalis,<sup>289</sup> and he claims that Khalis broadly critiqued the Taliban’s heavy-handed enforcement of conservative interpretations of various religious and cultural traditions.<sup>290</sup> True, Din Muhammad is not the best source for unbiased information about the Taliban; his family is well-known for its anti-Taliban politics.<sup>291</sup> And even Din Muhammad notes that Khalis was frequently consulted by the Taliban<sup>292</sup> and that many of Khalis’s acquaintances and friends were members of the movement.<sup>293</sup> But these connections and consultations did not guarantee agreement, and Khalis was not a supporter of such Taliban policies as enforcing beard length or interrupting critical agricultural work during the call to prayer.<sup>294</sup> Although details about the nature of Khalis’s interactions with Mullah Omar are slim, all of the available evidence indicates that the two men were neither friends nor did they see eye to eye politically.<sup>295</sup>

In contrast, Khalis was probably on relatively good terms with Usama bin Ladin; Omar Bin Ladin clearly supports this idea in his account of his father's reminiscences with Khalis in 1996,<sup>296</sup> and Talai states that Bin Ladin pronounced Khalis's name with a weighty, reverent tone.<sup>297</sup> But this tells us nothing of the operational and ideological significance of the contact between these two men, and Omar bin Ladin unequivocally states that the most important local facilitator for al-Qa`ida operations in Nangarhar was probably Haji Saz Nur.<sup>298</sup> Khalis contributed significantly to the development of networks of armed resistance in eastern Afghanistan, but the emerging picture of his politics does not support the argument that he was a close ideological or operational supporter of the Taliban or al-Qa`ida. Understanding the development of al-Qa`ida's relationship with eastern Afghanistan requires us to be far more precise about the boundaries and limitations of Usama bin Ladin's connection with Yunus Khalis.

Al-Qa`ida undeniably had an important connection to Nangarhar, but this province was never as important to the organization as Loya Paktia. Some of al-Qa`ida's members fled to Nangarhar from Sudan in 1996, and it seems that they gathered near Jalalabad again as NATO invaded Afghanistan in 2001. However, al-Qa`ida maintained at least three camps operating near Zhawara in Khost throughout the 1990s even after Bin Ladin had left Afghanistan.<sup>299</sup> There is no evidence whatsoever that Usama bin Ladin had a similarly close tie to the camp infrastructure in Nangarhar.<sup>300</sup> Furthermore, Bin Ladin's organization mediated actual operations far more through provincial-level

commanders like Haji Saz Nur, Jalaluddin Haqqani and Engineer Mahmud than through Yunus Khalis or other mujahidin party leaders.<sup>301</sup> After all, even though Rabbani and other party leaders may have attempted to lure Bin Ladin to Afghanistan before mid-1996 because of a misguided belief in his stupendous wealth,<sup>302</sup> they ultimately failed. This was an age of declining influence for the former mujahidin party leaders, no less so for Yunus Khalis than for the others. Khalis received Bin Ladin warmly as a guest, but it would be a mistake to draw the conclusion that the aging Hizb-e Islami leader was the most meaningful al-Qa`ida ally in Nangarhar Province, much less in Afghanistan as a whole.

Moreover, al-Qa`ida's early development and growth as an organization in Nangarhar seems to have been mostly confined to their participation in the disastrous battle of Jalalabad in 1989.<sup>303</sup> After Bin Ladin returned to Jalalabad in 1996, most of those who followed him from Sudan apparently stayed in Nangarhar for less than a year.<sup>304</sup> Throughout this period, however, al-Qa`ida's training camps in Khost continued their operations. Therefore, Nangarhar's importance to the al-Qa`ida organization is based on little more than Bin Ladin's need for refuge when the Sudanese government ejected him in 1996. This refuge was made possible because of the relative peace of the province during the tumultuous civil war of the 1990s, the absence of the Taliban from the province in the early summer of 1996 and Bin Ladin's strong relationships with an apparently small group of former mujahidin commanders. There is still much to learn about how Nangarhar stayed "open for business"<sup>305</sup> during this period, and there is too little information available about Engineer Mahmud, Haji Saz Nur and Fazl al-Haq Mujahid for us to fully assess the extent of their involvement in al-Qa`ida prior to mid-

1996. But the evidence assessed for this report cannot support claims that Usama bin Ladin's personal relationship with Yunus Khalis was the essential element in the movement of the al-Qa`ida leadership to Jalalabad from Sudan or in the establishment of a connection between al-Qa`ida and the Taliban.

There is more at stake in the historical adjustment suggested by this analysis than Yunus Khalis's reputation. To be sure, he was a complex figure well known for his avid anti-Shi'a views, and he was much reviled in the West for his marriage to a seventeen-year-old girl in the 1980s when he was over sixty years of age.<sup>306</sup> But irrespective of his controversial religious and gender politics, an investigation of Yunus Khalis as an individual says very little about the development and expansion of al-Qa`ida. Instead, such historical work reveals that Khalis's impact on Afghan politics is measured in his status as a major mid-20th-century Afghan intellectual and a national-level mujahidin commander who helped give rise to both the Haqqani Network and the Eastern Shura. The international community's understanding of the path to peace in Afghanistan today can be significantly enriched by demythologizing al-Qa`ida's connection to certain Afghan leaders such as Khalis. This allows scholars and analysts to more fully engage the complex ideological, political and economic incentives that led men like Yunus Khalis, 'Abd al-Haq, 'Abd al-Qadir and Jalaluddin Haqqani to avoid participation in the Afghan Civil War, and later, to either embrace or reject the involvement of NATO in Afghanistan after 2001.

## Conclusion

As the United States and its NATO allies prepare to withdraw from Afghanistan in 2014, many analysts have begun to uncomfortably discuss the possibility of a return to the Afghan civil war of the 1990s.<sup>307</sup> This necessarily involves a comparison between the current conflict and the final days of the Soviet-Afghan War. But even though appeals to history sometimes offer a welcome insight into today's events, they can also distort the details of past experience beyond recognition when used improperly, leaving us no wiser about what may happen after Kabul's political transition in 2014.<sup>308</sup>

This report has sought to underline the need for dramatically increased precision in our historical analysis of Afghanistan by pointing out the major gaps in our understanding of figures like Yunus Khalis and the specific nature of his connection with Usama bin Ladin and al-Qa`ida. The new sources investigated in this analysis offer a valuable insight into the life and thought of Yunus Khalis, but more important, they suggest an

unexpected connection between the relative peace in Nangarhar during the 1990s and the presence of al-Qa`ida and other militant groups near Jalalabad toward the end of the Afghan Civil War.

The different accounts of the Eastern Shura's role in the fratricidal conflict and Yunus Khalis's involvement in al-Qa`ida's arrival in Nangarhar in 1996 can be misleading if they are read in isolation or out of context. As Frances Brown has recently suggested, the misuse of isolated contemporary anecdotes about the progress of the counterinsurgency campaign in Afghanistan has already had a detrimental effect on U.S. policy implementation.<sup>309</sup> However, the lesson is not that history has no place in improving our comprehension of the current conflict, but rather that precision is necessary in order to make good use of historical comparisons. In fact, if it is applied *accurately*, historical analysis provides one of the best tools for understanding otherwise hidden factors in the spread of political violence.

In the case of Yunus Khalis and Nangarhar, there are two important lessons that deserve increased scrutiny in the future. First, Khalis's rejection of the factional conflict of the early 1990s appears to have been supported both by figures that embrace the Karzai government, such as Haji Din Muhammad, and leaders like Jalaluddin Haqqani and Usama bin Ladin who are almost never thought of for their role as peace negotiators.<sup>310</sup> Ideally, further investigations will elucidate why Haqqani, Khalis and

other leaders were motivated to end the civil conflict of the early 1990s.<sup>311</sup> Although the U.S. Department of State has apparently indicated that it does not plan to negotiate with Haqqani,<sup>312</sup> officials and scholars who are interested in ongoing efforts to negotiate with the Taliban can still benefit from an understanding of why Haqqani and certain other leaders chose to halt major military operations soon after Najibullah's Soviet-backed government fell in 1992. Second, and somewhat more surprisingly, the fact that the Eastern Shura was able to maintain a relative degree of peace in Nangarhar during the civil war never prevented al-Qa'ida and other groups from operating there.<sup>313</sup>

Various sources attest that Yunus Khalis, Jalaluddin Haqqani and Usama bin Ladin actively attempted to prevent the spread of the violence in the Afghan Civil War in the early 1990s,<sup>314</sup> but clearly this was not a manifestation of general pacifism on their part. The fact that so many of Yunus Khalis's commanders and associates rejected the fight for Kabul after 1992 indicates that they may have had dramatically different political goals than more familiar figures from the civil war such as Gulbuddin Hekmatyar, Ahmad Shah Massoud and Burhanuddin Rabbani. It is critical to understand why the different desired outcomes for these figures led some of them to destroy Kabul and others to focus on consolidating their control over their home provinces. By unraveling Yunus Khalis's political views and his effect on the politics of the Eastern Shura, we can approach the question of how different regional actors react to the potential of intra-

Afghan war with greater precision.<sup>315</sup> However, this renewed interest in the history of the Eastern Shura is fraught with a variety of other difficulties.

The Eastern Shura was a multilateral body that negotiated Nangarhar's transition out of the Soviet-Afghan War and into the era of the Taliban. According to the known sources, which are admittedly likely biased in favor of the shura, this organization elected to pursue a path that kept the worst of the Afghan Civil War's violence out of Nangarhar.<sup>316</sup> This alone should be impressive enough to encourage scholars of Afghanistan and civil war conflicts to learn more about the shura and other similar institutions in other parts of eastern Afghanistan. However, eastern Afghanistan is a difficult place to administer even in the best of circumstances, and it should not surprise us that the Eastern Shura was limited in its ability to actually "govern" Nangarhar. There was relatively little institutional or physical infrastructure undamaged by the previous wars,<sup>317</sup> and although the area around Jalalabad was more peaceful than Kabul at the time, the shura was not necessarily interested in actively preventing foreign jihadi organizations from taking root on its soil.

Al-Qa`ida took advantage of the combination of relative peace and light governance to build a short-lived presence in Nangarhar in 1996, and they may not have been alone as they did so. If the ambush against the four UN officials in 1993 is any indication, there may have been an extremist presence in the province throughout the 1990s.<sup>318</sup> This must serve as a warning to anyone who remains under the illusion that achieving a reasonable level of security in Afghanistan is sufficient to prevent the return of al-Qa`ida or other terrorist organizations to the more lightly governed districts of the outlying provinces. Ultimately, we have only begun to scratch the surface of Yunus Khalis's considerable historical interest, and the revelations from these new primary sources represent only a fraction of the material that is still undiscovered. If the

materials discussed so far are any indication, a renewed interest in Khalis, the Eastern Shura and other neglected Afghan political figures will likely lead to surprising and fruitful discoveries about the negotiation of radical politics and civil conflict by leaders in the critically important region of eastern Afghanistan.

## Biographical Appendix:

### *Khalis Family Members or Hizb-e Islami (Khalis) Affiliated*

**‘Abd al-Haq:** ‘Abd al-Haq was ‘Abd al-Qadir and Haji Din Muhammad’s brother and a major commander in Hizb-e Islami (Khalis). ‘Abd al-Haq mostly operated in and around Kabul, and like many other commanders in Khalis’s party, he apparently withdrew from the fight for Kabul before the struggle led to civil war. He was killed in late 2001 after he entered Afghanistan with a small group to build an anti-Taliban movement from among the local people.

**‘Abd al-Qadir:** Little is known about ‘Abd al-Qadir’s conduct during the Soviet-Afghan War, but he was connected with Hizb-e Islami (Khalis). He is also a brother to ‘Abd al-Haq and Haji Din Muhammad. After the end of the war, ‘Abd al-Qadir became a major leader in the Eastern Shura based in Jalalabad. He fled the city when the Taliban took Nangarhar Province in 1996. He was killed soon after he was installed as the governor of Nangarhar by the Karzai government.

**Anwar al-Haq Mujahid:** Yunus Khalis’s eldest surviving son. Anwar al-Haq was a leader in the “Tora Bora Front” for several years until his 2009 arrest in Pakistan took him out of operation. He was released from prison in Pakistan in late 2012 with a group of other important Taliban prisoners as part of a Pakistani effort to restart peace talks with the group.

**Engineer Mahmud:** Mahmud was one of the most important Nangarhar-based commanders in Hizb-e Islami (Khalis) and a member of the Eastern Shura during the 1990s. Engineer Mahmud was relatively close to Usama bin Ladin, and traveled with Haji Saz Nur and Fazl al-Haq Mujahid to speak with the al-Qa`ida leader in Sudan in early 1996. As a result of this embassy, the al-Qa`ida leadership chose to come to Jalalabad after being exiled from Sudan. Engineer Mahmud was killed in late 1996 along with Haji Saz Nur.

**Haji Din Muhammad:** Haji Din Muhammad was the deputy chief of Hizb-e Islami (Khalis) during the Soviet-Afghan War. His family is staunchly anti-Taliban, and he

wrote a biography of Yunus Khalis that is one of the more important primary sources for this study. He was the governor of Nangarhar and then Kabul Province after the fall of the Taliban in 2001.

**Mawlawi Jalaluddin Haqqani:** One of the most important commanders in Hizb-e Islami (Khalis) during the Soviet-Afghan War. Haqqani was central to both the evolution of Khalis's mujahidin party and, later, the movement that became al-Qa`ida. He is the founder of the Haqqani network, and is often referred to in eastern Afghanistan as "*Haqqani Kabarri*" (Haqqani the Scrapman) because of his involvement in selling scrap-metal after the end of the Soviet conflict. He took the nickname (*takhalus*) "Haqqani" after he graduated from the Dar al-'Ulum Haqqaniyya in Akora Khattak near Peshawar, Pakistan.

**Mati'ullah Khan Wali Khel:** Although he is not well known today, Mat'iullah Khan was one of the most important commanders in Hizb-e Islami (Khalis). He was based out of the Ziruk base in modern day Paktika, and was one of the founding commanders of the Hizb-e Islami (Khalis) party.

**Mawlawi Muhammad Nasim:** Muhammad Nasim was Yunus Khalis's eldest son. He was arrested for speaking out against the government soon after Daoud Khan's 1973 coup. Muhammad Nasim was killed while in the custody of the Kabul government around 1978.

**Muhammad Yunus Khalis:** Yunus Khalis was educated in pre-Partition India, including lessons he took from the founder of the Dar al-'Ulum Haqqaniyya, 'Abd al-Haq Haqqani. Khalis held a variety of jobs in journalism, education, and other fields, and he became involved with the anti-leftist Islamic opposition to the Kabul government in the 1960s. He would eventually become the leader of the Hizb-e Islami (Khalis) mujahidin political party. His commanders included Jalaluddin Haqqani, 'Abd al-Haq, Mati'ullah Khan, and Engineer Mahmud. Khalis was neutral during the Afghan Civil War, and in 1996 he hosted Usama bin Ladin for a brief time in Jalalabad. Tora Bora was Khalis's principal base in Nangarhar Province.

### *Other Mujahidin Party Leaders/Commanders*

**‘Abd al-Rab Rasul Sayyaf:** Sayyaf was a professor at the Faculty of Islamic Law at Kabul University when the nascent mujahidin movement began to take shape under Professor Ghulam Niazi in the late 1960s. Sayyaf is a gifted Arabic speaker and used his linguistic skill to great effect on fundraising trips to Saudi Arabia during the 1980s. He became the leader of a party known as “the Islamic Union” (Ittihad-e Islami), and is still a major political figure in Afghanistan.

**Ahmad Shah Massoud:** Massoud was a Panjsheri mujahidin commander for Jami’at-e Islami. He became a great enemy of Gulbuddin Hekmatyar and the power struggle between these two after 1992 contributed greatly to the destruction of the Afghan Civil War. Massoud was killed on 9 September 2001 during an attack which appears to have been executed at the instigation of al-Qa`ida.

**Burhanuddin Rabbani:** Rabbani was a lecturer at the Faculty of Religious Law at Kabul University and became involved with Professor Ghulam Niazi’s political group in the 1960s. He eventually became the leader of the Sunni mujahidin political party that included the highest percentage of non-Pashtun members: “the Islamic Society” (Jami’at-e Islami). Rabbani had a large number of Tajik and Uzbek commanders, including the famous Ahmad Shah Massoud.

**Fazl al-Haq Mujahid:** A major Nangarhar-based commander of Hizb-e Islami (Gulbuddin) and a member of the Eastern Shura during the 1990s. He traveled with Engineer Mahmud and Haji Saz Nur to speak with Usama bin Ladin in Sudan in 1996.

**Gulbuddin Hekmatyar:** Hekmatyar was a student when Niazi’s political discussion groups at Kabul University began to take on structure in the 1960s. Hekmatyar became active in the student circles connected to these Kabul Islamist discussion groups, and rose in the ranks of the Muslim Youth organization (Zawanan-e Musulman). He eventually went on to lead the Hizb-e Islami (Gulbuddin) political party. He became an implacable foe of Ahmad Shah Massoud, and their struggle for supremacy with several other mujahidin leaders after 1992 was one of the major causes of the destruction of the

Afghan Civil War. Hekmatyar is a prolific author and has written dozens of books in Pashto on diverse topics in politics, religion, grammar, and history.

**Haji Saz Nur:** Haji Saz Nur was a major commander for Ittihad-e Islami in Nangarhar and a member of the Eastern Shura in the 1990s. Saz Nur was relatively close to Bin Ladin and figures prominently in several primary sources for the help that he gave the al-Qa`ida leader in 1996. He traveled with Engineer Mahmud and Fazl al-Haq Mujahid to speak with Usama bin Ladin in Sudan in 1996.

**Mawlawi Jamil al-Rahman:** Jamil al-Rahman was an important mujahidin leader from Kunar Province. He studied at the Panj Pir Madrasa in Pakistan, which had a strong Salafi orientation. Sources differ in their accounts of Jamil al-Rahman's alignment during the Soviet-Afghan War, but he appears to have been affiliated with either Yunus Khalis or Gulbuddin Hekmatyar. Around 1984 he apparently broke with all of the mujahidin factions, and returned home to Kunar. Later he would found a Salafi party called the "the Society of Invitation to the Sunnah and the Qur'an" (Jama'at al-Da'wa ila al-Sunna wal-Qur'an), which contested control of Kunar with several different mujahidin factions. These groups eventually held elections, and in 1991 Jama'at al-Da'wa declared the creation of an independent state of Kunar. Jamil al-Rahman was assassinated that same year.

**Mawlawi Nasrullah Mansur:** Nasrullah Mansur was a mujahidin leader from Zurmat District of Paktia Province. He was one of several influential eastern clerics who took part in a series of abortive attempts in the late 1970s to find a leader who could unite the various mujahidin factions. He became a commander in the Harakat-e Islami party and was a fierce enemy of the Hizb-e Islami (Gulbuddin) party. Although Nasrullah Mansur is now dead, the group he founded, known as the Mansur network, is still actively fighting against the government in Afghanistan.

**Minhajuddin Gahiz:** A writer and political activist who founded an obscure group known as the Hizb al-Tawabin together with Yunus Khalis and several other leaders. Gahiz also founded an Islamic political publication under his own name ("gahiz" means "dawn" in Pashto). Many of the eventual leaders of the seven Sunni mujahidin political parties published articles in *Gahiz*. Gahiz was killed in 1972.

**Muhammad Nabi Muhammadi:** Nabi Muhammadi was a graduate of the Dar al-'Ulum Haqqaniyya. Nabi Muhammadi was chosen as a compromise leader to unite the squabbling mujahidin factions in the late 1970s with the creation of the Harakat-e Inqilab-e Islami. This unity party failed in its original purpose, but Nabi Muhammadi continued on as the leader of Harakat throughout the war.

**Professor Ghulam Niazi:** Niazi left Afghanistan to be educated at al-Azhar in Egypt, where he was exposed to the ideas of the Muslim Brotherhood (Ikhwan al-Muslimin). He began holding political discussion group meetings in the 1960s, which later evolved into some of the first anti-leftist mujahidin political movements in Afghanistan. Both Gulbuddin Hekmatyar and Burhanuddin Rabbani looked to Niazi as a political and spiritual leader.

**Sayyid Ahmed Gailani:** Gailani was the leader of one of the largest networks of Sufis in Afghanistan at the start of the Soviet-Afghan War. He used this network to help create "the National Front" (Mahaz-e Milli), one of the two Sufi mujahidin political parties.

**Sibghatullah Mujaddidi:** Mujaddidi was the leader of one of the largest and most politically influential Sufi networks in Afghanistan during the 1960s and 1970s. He eventually founded "the National Salvation Front" (Jebha-ye Nejat-e Milli). This was one of the two Sufi mujahidin political parties.

#### *Al-Qa`ida Affiliated Individuals or Relatives of Usama bin Ladin*

**Abu Musab al-Suri:** Al-Suri (whose real name is Mustafa bin 'Abd al-Qadir Setmariam Nasar) was a strategist and trainer with ties to al-Qa`ida. He wrote about some of his experiences with Usama bin Ladin, and gives a brief account of a meeting between Yunus Khalis and the al-Qa`ida leader in 1996. After spending several years in detention in a number of countries following 9/11, he is rumored to have been released from Syrian custody during the 2011 to 2012 timeframe.

**Ayman al-Zawahiri:** The former head of Egyptian Islamic Jihad and a key al-Qa`ida member and propagandist, al-Zawahiri has served as the leader of the latter group

since the death of Usama bin Ladin in Abbottabad, Pakistan. While not much is known about al-Zawahiri's relationship with Yunus Khalis, al-Zawahiri provides a very brief description of the assistance that Khalis gave to Usama bin Ladin in 1996.

**Nasir al-Bahri:** Al-Bahri (also known by his kunya Abu Jandal) played multiple roles for al-Qa`ida and served for a period during the 1990s as Osama bin Ladin's bodyguard. He provides insight into how the al-Qa`ida "complex" at Najm al-Jihad was converted to a guesthouse when Bin Ladin moved to Kandahar.

**Omar bin Ladin:** A son of Usama bin Ladin, Omar provides a first-hand account of some of his father's relationships with Afghan commanders in Nangarhar and the time his father spent in both Nangarhar and Tora Bora.
