14. ABSTRACT
Development and fielding of the F-35A represents one of the priority defense programs for the U.S. The F-35 program was initiated in the early 1990s to provide the premier strike fighter aircraft to the Air Force, Marine Corps, and Navy, as well as international partners for the next several decades. Currently, the Air Force is scheduled to acquire and field over 1,700 F-35As over the next several decades; this basing action is only a part of the Air Force's program to assure availability of combat-ready pilots and maintenance personnel in the most advanced fighter aircraft in the world. This Environmental Impact Statement focuses on the analysis of alternative locations for and the Records of Decision for the Air Force's initial operational wing locations.

Dear Nicholas Germanos:

Thank you for accepting my testimony on the F-35 making its base in Chittenden County, Vermont.

I am concerned for the Vermont residents who will be exposed to adverse living conditions as base activity negatively impacts the quality of life of this densely populated area. I have spoken with many people who are very upset with the plans to site the F-35 in such a peaceful residential zone. I am aware that some citizens patently accept decisions of the military no matter what but many of these supporters do not live near the base. The choice to expand military operations in such a livable area doesn't make sense to me in today's world. Siting the F-35 in a more remote location is a more sensible approach.

The process has also been disturbing as the arrangements seem to have been secured in an advantageous political deal. It would appear that siting the F-35 in Vermont is a previously sealed "done deal" and that consideration of public comment is dubious at best. This is disturbing when one considers the basic tenets of democracy. Also, reports of flaws and inefficiencies of the F-35 itself make ordinary citizens wonder what is really going on with military operations. The real reasons for this initiative are clouded by political and social fanfare while doubts and misgivings of the public are being treated as a nuisance. Knowledge-based opinions are conflicting and the level of public confidence is low. At least there is some notable resistance to the proposal but discussions for possible alternatives are few. I have heard from many individuals who have completely lost respect and confidence in Vermont's political leaders.

The road to peace is not through weapons escalation. If the modern war machine must prevail, why not at least keep it in more remote areas. Such sites exist in this region, for example, the abandoned air fields in Plattsburgh, NY. I personally do not find the roar of these jets to be the sound of freedom. To me, it's another sign of man vs. nature (or man vs. man) and ultimately, this is a losing battle. The potential destruction of our environment and of fellow man that can be wreaked by our military might is fearful at best. If civilian well-being can be so rashly overlooked in the quest for a weapons technology home base, I can not help but worry about the fate of our alleged enemies. In the meanwhile, we are fully equipped to destroy our habitat and ourselves in the process.

Paul Fleckenstein wrote the following note to you which sums up my feelings perfectly. Please consider his opinion mine in this matter:

"Dear Mr. Germanos,

I oppose the basing of the F-35 at Burlington's airport. The hundreds of important comments on the EIS to date opposing the basing indicate how destructive and dangerous the basing would be. Residents close to the airport are overwhelmingly opposed.

But unfortunately no one can participate in this comment process with confidence that the Air Force is seriously concerned with environmental impacts, or that impacts will affect the basing decision. The very fact that Burlington remains a preferred basing location despite the EIS finding that 8,000 adults and children, renters, and modest income homeowners will be forced to live in an area deemed unsuitable for residential use because of extreme noise levels erases confidence in the process. The Boston Globe reported that the Vermont Air Guard falsified initial scoring data to discount obvious negative environmental impacts of the basing. The single hearing held in 2012 on the EIS was scripted by the Air Force into a public relations event front loaded with Congressional spokespersons and commercial representatives who will economically benefit from the basing and future Pentagon contracts with Vermont industry. Both groups were oblivious to the content of the EIS and this further confirms the illegitimacy of the process.

The current revised EIS, while acknowledging health damage to people, continues to downplay the effects of a warplane that is at least 2-4 times as loud as the F-16 on take off and landing. The revised EIS ignores recent research on airport noise and health.

The World Health Organization, based on the research of the last ten years, finds that people chronically exposed to F-35 noise levels will suffer increased risk of high blood pressure and heart attack, and that 50% of the children will suffer cognitive impairment. Significantly, the Air Force, Vermont Air Guard, and Vermont's political establishment view the EIS process as a bothersome but obligatory exercise that apparently has less weight in the basing decision than the unexamined claims by the government about the mission of the F-35. Given the U.S.'s global military dominance and lack of military competitor, and given the warplane's design--as F-16 designer Pierre Sprey stated, the F-35, like the F-16, will only function well as a high altitude bomber--the plane's use will be as an offensive, first-strike weapon carrying thousands of pounds air-to-ground weaponry. In Iraq, the F-16 was used to bomb as part of a horrific war and occupation based on lies that has left the country in shambles. By 2006, just three years into the occupation, the British medical journal The Lancet estimated that the war was responsible for the deaths of over 650,000 Iraqis, many of those victims of bombing. This type of mission stokes bitterness and hatred toward U.S. rulers and policies that may result in yet more violence.

The F-35 will not defend anyone, but will increase the risks of violence and terrorism. There is no justification, no public benefit to counterbalance the negative effects of the warplane

basing in Burlington. This is yet another reason the F-35 program should be eliminated and the hundreds of billions of dollars now going to military contractors should be redirected to useful public programs that contribute to the well being of our communities and planet.

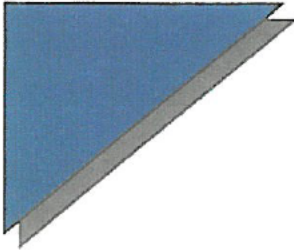

Thank you for the opportunity to provide comments on the Air Force's Revised Draft F-35A Operational Basing Environmental Impact Statement ("Revised Draft EIS"). I am providing comments on behalf of the School Board for the South Burlington School District.

In a May 14, 2012, letter to the Air Force, the School Board submitted comments to the Draft F-35A Operational Basing Environmental Impact Statement. That letter and the Air Force's responses thereto are included in the appendix to the Revised Draft EIS. (Comment Letter M111). In the May 14 letter, our comments focused on concerns regarding the completeness of the Draft EIS's consideration of the noise impacts on the South Burlington School District of basing 18 or 26 F-35As at the Burlington Air Guard Station. Specifically, we raised issues related to the Draft EIS's consideration of direct noise impacts on the District's schools, the indirect or cumulative impacts on the community from an increased noise level, and mitigation measures.

As addressed below, we continue to have concerns regarding the Air Force's disclosure and consideration of the impacts of basing F-35As at the Burlington Air Guard Station.

I. Consideration of Noise Impacts on the District's Schools

In our May 14, 2012, letter, we noted that "the Draft EIS does not provide an appropriately detailed examination of the actual impacts this noise interruption would have on classroom learning and student health, relying instead on generalizations related to noise impacts on learning and cognition and health effects on the affected population. Draft EIS at C-20 to C-23, C-30 to C-32[; Revised Draft EIS at C-18 to C-20, C-28 to C-30]. A more detailed analysis specific to this situation is necessary." The Air Force's reply to our concern is non-responsive. (See Revised Draft EIS, Vol. II, Response Number NS-17).

The Revised Draft EIS takes an insufficiently hard look at potential deleterious impacts to children, relying on dated information from 2002 and earlier. Although the Air Force does address effects on learning and cognitive abilities, it has either overlooked or ignored other available literature related to noise impacts on cognition of children. For

example, the World Health Organization's recent publication "Burden of disease from environmental noise," discusses studies related to environmental noise and cognitive impairment in children, suggesting, among other conclusions, a linear association between aircraft noise exposure and impairment of reading comprehension. The Revised Draft EIS does not sufficiently address whether the noise from the F-35As would have such an effect on impacted children who attend South Burlington schools. Further, the EIS's consideration of impacts to children with special needs who may be more vulnerable to noise is inadequate. A full, specific analysis of potential impacts to the school children of South Burlington should be highly relevant to the public and to those making a decision as to the future location of the F-35As.

In our May 14, 2012, letter, we also explained that the Draft EIS fails to address the impacts of the noise on Chamberlin students who are outdoors during recess or lunch, when they would be subjected to far higher noise levels than they encounter in classrooms with the windows closed. In response, the Air Force states that "[t]he relevant guidelines for assessment of classroom learning interference is geared towards indoor classrooms." Revised Draft EIS, Vol. II, Response Number NS-18. The response further states that the EIS provides information (outdoor Leq values) that can be compared to a speech interference criterion of 60 db. *Id.*

The Air Force's consideration of impacts to Chamberlin students who are outdoors is too narrow. The Air Force should take a hard look at more than interference to speech in that situation. It should examine whether the noise from the F-35As will impact the health or cognition of students who are exposed to a higher level of noise while outdoors. Such impacts should not be left unaddressed or addressed with generalities in the EIS.

Before the Air Force makes a decision on the basing of the F-35As, it should take a hard look at the foregoing issues and disclose, in detail, potential impacts, if any, that its decision may have to the school children of South Burlington and other surrounding communities.

II. Indirect and Cumulative Impacts on the School District

In the May 14, 2012, letter, we expressed the concern that "[s]hould the noise contour used in the FAA's Part 150 Noise Compatibility Program become coextensive with the F-35A scenario noise contours set forth in the Draft EIS, a significant increase in the households in South Burlington as well as Winooski would be subject to that program and could be slated for purchase and destruction." We explained that the Draft EIS mentions but does not analyze the cumulative impacts of the bed down combined with the FAA Part 150 Noise Compatibility Program. Draft EIS at BR4-88, Revised Draft EIS at BR4-93 to 95. We explained that "it is foreseeable that the expanded 65 dB zone that would result from the bed down of F-35As at the Burlington Air Guard Station would lead to a decrease in the number of households and associated population in South Burlington, a resultant decrease in the tax base that funds the District's schools, and a decrease in enrollment in the District's schools."

The Revised Draft EIS does not sufficiently consider these foreseeable impacts. The Air Force explains in response to this concern that it does not have authority over the buyout and redevelopment around Burlington IAP, and thus does not take a hard look at this foreseeable impact. Revised Draft EIS, Vol. II, Response Number SO-6. Because these are foreseeable impacts of the Air Force's proposed action, the Air Force is still obligated to consider the impact, whether or not it has final authority over the buyout program. See 40 CFR s 1508.7 (a cumulative impact is "an impact on the environment which results from the incremental impact of the action when added to other past, present, and reasonably foreseeable future actions regardless of what agency (Federal or non-Federal) or person undertakes such other actions"). Moreover, although it may not have authority over the program, the Air Force states that it will "[c]ontinue to work with Burlington IAP and City of South Burlington to support purchase and relocation through the part 150 process. . ." Revised Draft EIS at 2-51. Because the Air Force will have involvement with the program, it should consider the program's impacts in conjunction with its basing decision.

In short, the Air Force should identify the foreseeable reduction in the number of households and associated population in South Burlington should the bed down of F-35As occur at Burlington Air Guard Station.

III. Mitigation Measures

The Revised Draft EIS also continues to provide an inadequate discussion of the mitigation measures that could be used to decrease the impacts on the South Burlington School District. The Air Force's response to our concern merely reiterates that the "Burlington AGS would continue to undertake the voluntary restrictions outlined in the Burlington Noise Compatibility Program Update." Revised Draft EIS, Vol. II, Response Number NS-11.


As stated in our May 14, 2012, letter, the Draft EIS suggests that land use for educational services in noise zones of 65-69 or 70-74 dB is "generally compatible with Noise Level Reduction. However, measures to achieve an overall noise level reduction do not necessarily solve noise difficulties and additional evaluation is warranted." Revised Draft EIS at C-17 – C-18. The Revised Draft EIS contains the same statement. Revised Draft EIS at C-14 – C-15. The Revised Draft EIS does not, however, provide any additional evaluation, as we requested and as it suggests is warranted. It does, however state, as it did in the initial Draft EIS, that "design and use of berms and barriers can help mitigate outdoor exposure." C-15. The Air Force should explain further whether such berms and barriers would be practical at the Burlington IAP and should provide information as to the level of noise mitigation that could be reasonably achieved using such measures. It should also explain what noise mitigation measures could be implemented at Chamberlin School that would reduce the impacts to learning and cognitive abilities from basing the F-35As at the Burlington Air Guard Station.

In addition, as requested in our May 14, 2012, letter, the Air Force should further elaborate how mitigation measures could reduce the need to expand the scope of the Part

150 purchase and relocation program. To the extent that noise mitigation measures would limit the Part 150 program, the adverse impact to the School District of a contraction of the city's tax base and decreasing enrollment in District schools could be reduced. The EIS should include specific information regarding this issue.

We appreciate the opportunity to provide further comments on the Air Force's Draft EIS and we look forward to having our concerns and questions addressed. The School Board and the District's Administration continue to be available to provide additional information to the Air Force for its consideration of the impacts of its proposed action.

Dear Mr. Germanos and the US Air Force,

I am writing to you in *very strong opposition* to the proposal to deploy the new F-35A aircraft to Burlington, Vermont. Given that none of the other basing options are located in residential neighborhoods, I find it *outrageous* that the Air Force would choose to locate these planes in the most densely-populated area of our entire state.

I am a professor of Philosophy, and I have specialized in Theoretical and Applied Ethics for my entire educational training and career. Respectfully, I find this basing proposition to be a *radically unethical, unjust imposition upon citizens*. Even in the crudest utilitarian analysis of cost vs. benefit, I cannot see how this basing would be justified. As “benefit”, there is honor for our Air Guard, little to no benefit to our local economy, and whatever *unexplained* mission capabilities are apparently overriding the *incredible cost* to our neighborhoods and community members.

Those costs are tremendous. When we seek to determine the greatest good for the greatest number of people, human DIGNITY must be weighed more heavily than anything else. This basing, I believe, will result in a violation of the DIGNITY of 7,700 people. That should halt this basing. While that might sound exaggerated, in Ethics, dignity is all about the human being's inherent worth or value. The people who will be affected have worked their whole lives to secure a small piece of what is supposed to be the promise of the American dream – a modest home, a safe environment for their children, and a reasonable quality of life. Do we not deserve to enjoy what we have long-labored to create? The lives that we have built for ourselves are worth *protecting*, while this basing threatens them. It *runs counter to the very mission of the military to protect the well-being of American citizens*. Indeed, this basing reduces the impacted population to casualties of war – to beings who can be sacrificed for the sake of military might.

Please understand that, if this basing were taking place miles and miles away from our residential areas, I would likely not be objecting. I understand that the F-35 program will move forward. *But I believe that it belongs in a remote location.*

In what follows, I wish to explain the many aspects of this basing proposition that I believe violate the rights and dignity of Vermont citizens. Many people tell us that our comments and feedback will have no effect on this decision. But, as I discuss with my Global Studies students, democracy depends on both citizen participation and the willingness of our leaders to listen to us, and to serve our best interests, rather than their own. I hope the Air Force will choose to *serve the interests of citizens*.

My opposition to the F-35A deployment in Vermont is fourfold:

(1) POPULATION AND OUR HOMES:

The Air Force is asking Vermonters to allow the military to locate these aircraft directly in THE MOST POPULATED AREA OF OUR ENTIRE STATE. These planes will be literally 5 minutes outside of our greatest city! As the Rev.DEIS states, up to 7,700 people will live with noise that registers above 65dB DNL, in homes that will be designated by the FAA, HUD, and other federal agencies as “not compatible with residential use.” This is 3,000 more people than are currently affected in this way. Our own calculations suggest that this is STILL an underestimate of the population within this zone. **I ask the Air Force to re-examine these numbers.** The Rev.DEIS clearly indicates that the F-35 is 3-4 times louder than the F-16, but the F-16 is already almost unbearable. The Air Guard, in fact, denies that the planes are any louder than the F-16, contrary to the Rev.DEIS.

There is no discussion of compensation for what will be lost in terms of the value of our homes, even though in our modest neighborhoods, these homes are our lifesavings and our retirement. I don't understand how this is anything but an **unreasonable seizure of our property, and a radically unjust violation of our rights.** The Rev.DEIS dismisses studies (in the Appendices) that suggest that homes will lose value, even though careful analysis of real estate studies – and even just common-sense – tells us that homes that are “not compatible with residential use” will not sell for the same prices as homes that are not so designated. We have found dozens of real estate studies that conclude that property values decrease when noise reaches such levels and homes are designated “not compatible with residential use.” These studies have been reviewed, and confirmed as reliable, by economists and statisticians in our local area. **How can the Air Force, in good conscience, deny that our homes will be less valuable once the noise level is 3-4 times what it is now?** Who would buy such a home? I will ABSOLUTELY move from this neighborhood if the F-35's are deployed here.

(2) WINOOSKI – OUR TOWN & OUR DIVERSITY & OUR STRUGGLES

I live in Winooski, where approximately ¾ of the homes lay within the predicted 65 + dB DNL level. This will destroy our city. We are already the lowest-income community in the Burlington area, but what this means in Vermont is that we are the only city near Burlington where young families, young professionals, new Americans, retirees, etc. can afford to purchase a home. Please understand that there are not very many cities or towns directly around Burlington. Winooski and South Burlington are closest. The only other towns or cities close by are Essex, Shelburne, and Williston. After that, all towns are at least 25 minutes by car. **It is not okay to render ¾ of the houses in 1 of the 5 cities/towns directly surrounding Burlington “not compatible with residential life.”**

The Rev. DEIS says (as did the previous DEIS) that low-income and minority populations are disproportionately negatively affected by this basing. This is a vulnerable community, where many people already struggle to make ends meet. This basing would not be favored by our Congressional delegation, Air Guard, or local business elites, if it were going to affect Shelburne or Essex – where they live – the way it is affecting Winooski. The wealthy citizens in those towns would be outraged, as we are outraged. Again, as an Ethicist, I see this as **a radical environmental injustice**, where

the disempowered will have no choice but to live with the negative effects of this basing. These folks cannot move, because they rely on affordable housing, bus-lines, and stores and schools within walking distance. Those with the means to move away will do so. And the City of Winooski will suffer greatly.

Another aspect of the devastating effect on Winooski is that our city has invested, in only the last decade, millions of dollars into a development strategy for our awesome downtown. We have *really* superb restaurants with outdoor seating, a gorgeous boardwalk and park area along the historic Winooski River (named this by the Abenaki native community), and brand new luxury waterfront condos and townhouses. ***ALL OF THE DOWNTOWN area falls within the “not compatible with residential use” zone.***

Finally, Winooski is ***THE MOST DIVERSE CITY IN THE WHOLE STATE OF VERMONT.*** We are proud of our diversity, and we have welcomed new Americans from countries all over the world, from Sudan to the Democratic Republic of Congo to Nepal to Bosnia, etc. Over 20 languages are spoken in Winooski. Many of these new Americans came here through our outstanding Refugee Resettlement Program. They are arriving in our neighborhoods from war-torn countries, and they find the present F-16's a real challenge to life with. We have more people of color in our 1-square-mile City than any other town or City in Vermont. Again, because this basing places $\frac{3}{4}$ of Winooski in the “not compatible with residential use” zone, this is ***an environmental injustice***, this time because it ***impacts racial minorities*** to a far-greater degree than others.

(3) HEALTH, SAFETY, AND OUR CHILDREN:

The Rev.DEIS states that scientific research demonstrates that noise at the level that will be produced by the F-35s in our area has been shown to cause cognitive and developmental impairment or delay in children. ***THIS FACT, ALONE, SHOULD STOP THIS BASING.*** There are at least 1,000-1,500 children living and going to school in the noise zone. And yet, there has been no discussion of soundproofing our schools to protect our children. In fact, proponents of the basing (including our Air Guard, Senator Leahy, and Senator Sanders) actively DENY that there is any harm done by exposure to excessive noise (at this level). ***How can the Air Force deploy a plane to a basing location where 1,500 children will be harmed? This is reprehensible.***

Further, The Rev.DEIS fails to acknowledge other health effects (for children and adults) that are well-documented in scientific research. For example, there is no mention or citation of the ***World Health Organization's 2011 Report, entitled, “The Burden of Disease from Environmental Noise.”*** How is it that such a document is not considered in an Environmental Impact Study where the greatest environmental impact comes from noise? ***I request that the Air Force include studies such as this one, and other research conducted in most recent decade.*** Of course, the housing designation (“not compatible with residential use”) is motivated by the attempt to prevent harm to people living in areas exposed to noise. These health concerns, according to scientific analysis that is much more RECENT than studies used in the Rev.DEIS, include high blood pressure, increased risk of heart attack, hypertension, hearing loss, and many other effects. Even if the Air Force is not convinced that harm will be done, the ***mere possibility*** that 7,700 people would suffer health effects from the basing should prevent deployment to

Burlington, given that NONE of the other 5 locations have this kind of impact, and many have DECREASED NEGATIVE NOISE IMPACT ON RESIDENTIAL HOUSEHOLDS?

In addition, it is known that military aircraft, in their first years of operational basing are far more likely to CRASH than those same aircraft in later years of operational basing. *It is absolutely unreasonable that Burlington AGS would use Commercial crash zones instead of Military crash zones, when operating military aircraft. Please explain why they are not required to use Military crash zones when they are flying military aircraft on military drills.* Again, this aircraft should be deployed to a location where residents do not have to live, work, and go to school in the crash zone, at least until the F-35 has a more extensive flight history.

Finally, and significantly, if the F-35 fleet is located in *only a few places* in the country, doesn't that make us *a TARGET for attack*? If a country (China?), or even a terrorist organization, were to launch an attack on the United States, would they not try to cripple our air defense? *Is the Air Force turning Burlington into a target for attack?*

(4) DECEPTION IN THE PROCESS:


Burlington AGS was awarded points on the initial scoring sheet that we did not deserve. That Scoring Sheet indicated that there were ZERO homes in the crash zone and the noise zone. In reality, there are THOUSANDS of homes in those zones. Numerous FOIA requests have been essentially rejected. Vermonters do not trust that this basing decision has not been infected by political game-playing and deal-making. This suspicion is not likely to fade. **I urge the Air Force to remove Burlington AGS from consideration in this first round of basing. People are not going to stop questioning the legitimacy of this basing decision. There has been too much deception and lack of transparency so far.**

As the Revised DEIS clearly says, Burlington AGS is NOT the environmentally-preferred alternative. I understand that there are other considerations that are overriding the environmental concerns, but I think it is *shameful* that *environmental JUSTICE* warrants only 10 points in the overall assessment of the appropriateness of a basing location. *The ends do NOT justify the means, when the "means" requires harm to individuals, the destruction of a community, and the injustice of targeting low-income and minority groups. Please deploy the F-35 in a place where citizens are not harmed.*

Dear Mr. Germanos,

I am writing you today to voice my personal opposition to the basing of F-35s at the Burlington International Airport/VTANG.

In 2008 I moved to Vermont from North Carolina, the place I had grown up. With me, my partner Elizabeth, we took a giant leap of faith that we could put down roots in a state that socially and culturally supported our values, and provided us endless opportunities to "play outside" in the amazing natural beauty of Vermont. We are both graduates from the University of North Carolina Chapel Hill, and we were also looking forward to the start our professional careers. In between our decision to move to Vermont and our arrival, the economic meltdown known as the Great Recession began. Not only were businesses no longer hiring, but we learned our applications were being considered beside massively-over-qualified applicants who had recently become unemployed themselves. I submitted 74 applications to professional jobs ranging from legal secretary to restaurant manager. In one interview for a restaurant job, I was told the position had over 200 applicants...the pay was \$24,000 - an amount barely sufficient to live in our area. For months, I hand delivered applications, called for follow-up interviews, and did everything I could to try to set my application apart. In the end, with my \$125,000 education in hand, I took a job at a cell phone store making minimum wage. Four months later, that job eventually gave way to a cooking position at a restaurant making \$9.00 an hour, at a business where my paychecks regularly bounced upon deposit. Mr. Germanos, I fought. I fought as hard as I could to stay here and make Vermont my home. I swallowed my pride, rolled back my sleeves, and worked any job that would help me make the next month's rent. Eventually, I got a break in the form of a position at a community development financial institution. Not only did the job offer a tremendous professional opportunity, but it was a job that was focused on helping my community, and providing opportunities for others to financially succeed. Since that time, I am happy to say my career has excelled; and along with my partner we are fortunate to live a very comfortable and stable life. We have worked very hard. I could have turned my back at any time, and left Vermont for an area with more jobs, or returned to a community we were more familiar with...but we fought.

In Winooski, we quickly found that we had stumbled on a unique community. The city has a tremendous sense of "self" and "place". Since the time of the Abenaki Indians, Winooski's history has been shaped by its relationship with the large river that feeds Lake Champlain; but even more so by the people who have worked so hard to ensure its survival. We became involved in the community before we were even residents; and bought a home here two years ago. We found a community full of life, vitality, and a strong spirit. Behind the excitement that we and other newer residents felt for the community, were the older generations that had seen Winooski rise and fall - only to transform itself again. The community had seen the fall of the American textile industry, leaving behind an empty core of abandoned Mill buildings and a quickly dilapidating municipal, housing, and business infrastructure. On the backs and with the vision of those Winooski generations that came before us, the city was rebuilt with millions of dollars of investment from public and private sources. For Vermont, it was the largest redevelopment project ever undertaken. The people of Winooski fought, Mr. Germanos, they fought to keep their community viable. They fought to make it a place where young families could see a future and older families could still walk to the church of their ancestors on Sundays. They fought so we could dream of a safe community where we could grow, enjoy our home, and maybe one day start a business.

I have fought to be where I am. I have fought to own my home. I have fought to make my community a better place. I have fought for Winooski, and so have thousands of other residents. Now I see my neighbors fighting against the installation of a plane. I wonder what we could achieve, if the decision making process for basing the F-35 passed the test of reason, and all of my neighbors spent that time/energy fighting against a plane used that energy on hunger, poverty, or crime.

For the men and women who wear our nation's Military and National Guard uniforms, I know that they fight in a different way, sacrifice in a different way than most of us do. I am so grateful for what our nation's military does on a daily basis to keep our country safe, and protect our interests both at home and abroad. But as a citizen, I still see our military as representatives of our country. I wish to see a military that acts with the American values we all hold so dear, and I am rarely disappointed. The idea that, in America, we could all fight so hard to be part of a community that we care for, only to have our environment, health, and well-being jeopardized by an aircraft that, by any test of reason, has no business in the densely populated and economically active area of ANY state is simply wrong. It is against the principles and values upon which our nation is built. I am a patriot. I believe in sacrifice. Dear Sir,

I am writing to voice my opposition to basing the F-35 in Burlington, Vermont. These planes will fly over thousands of affordable homes. The FEIS notes that the homes in the 75 (and up) dba zone will NOT be eligible for federal mortgage loan guarantees, and the homes in the 65-75 dba zone will have these mortgage loan guarantees only at the discretion of the guarantor. Since the 65 dba zone will be increasing, this will negatively affect one of the larger sources of affordable homes in the Burlington area.

Personally I can attest to the fact that homes there are lower in value due to the added uncertainty of the f-35 basing. I am looking for a home and decided that I cannot purchase in this area due to the potentially added dba levels. I am concerned this noise will negatively affect both my quality of life and the value of my property.

It sounds like there is some disagreement about whether the F-35 will have higher decibel levels than the current F-16 planes. That may depend on the use of afterburners or not. However clearly if the afterburners are part of the plane, and there is a functional reason to use them -- after they are already based here -- they will be used, even though today the air force may be saying they will "rarely" use them.

The only way to put this question to rest would be to fly an F-35 here, and compare to the F-16 with decibel meters on the ground. I understand that is not possible due the the plane not being functional yet, which is another good reason to revisit or at least delay the decision.

I understand there are better, alternative sites in more sparsely populated areas. I encourage the air force to explore these options more and realize that the F 35s are not a good fit for Burlington, Vermont.

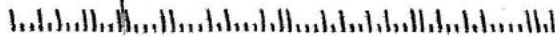

Mr. Germanos,

I wish to register my position in opposition to basing the F-35 combat aircraft at Burlington International Airport. Having been a resident of both Winooski and the Old North End of Burlington, I have experienced the deafening noise from the existing F-16s for years.

In Winooski, the noise level halts all conversation. We have two young children, one 6 and the other 4. Living within the flight-path and noise impact zone of the F-16s is already intolerable. To live in the same locations with an aircraft of 2-3 times the volume in frequent use would be impossible as an environment in which to raise healthy children, maintain an efficient and professional home office, much less a relaxing evening with one's family.

I am further disturbed that by siting the F-35 here, the Air Command would be effectively decimating the equity held by so many residents who own their homes. Since home ownership is the greatest asset in most American families, the loss of value in their homes may set folks back a generation in terms of wealth accumulation. I am further distressed that the neighborhoods most impacted by these decisions are largely poor. By the EIS's own accounting, the Burlington International Airport is not a suitable location for the Operational Basing of the F-35 aircraft. The airport is in some of the most densely populated communities in the state. The noise of the aircraft will disproportionately impact low income, senior, minority, and other vulnerable communities.

Most disconcerting, to me, is that in several locations the document falsely claims overwhelming general support of the basing of the F-35s in Burlington. This is patently untrue, and the repeated statement taints the reception of the rest of the document.

Lastly, although Burlington is clearly not the Environmentally Preferable Alternative, it was selected as the Preferred Alternative. However, the EIS does not give relative weights to how the mission components of the scoring impacts overruled the Environmental Components. The EIS still does not answer: How much is our environment worth? At what cost do we sacrifice the peace of our community for a strategic or political decision?

I oppose the basing of F-35A's in Burlington.

I grew up in, and live in Winooski, where approximately ¼ of the homes lay within the predicted 65 + dB DNL level. This will destroy our city. We are already the lowest-income community in the Burlington area, but what this means in Vermont is that we are the only city near Burlington where young families, young professionals, new Americans, retirees, etc. can afford to purchase a home. Please understand that there are not very many cities or towns directly around Burlington. Winooski and South Burlington are closest. The only other towns or cities close by are Essex, Shelburne, and Williston. After that, all towns are at least 25 minutes by car. It is not okay to render ¼ of the houses in 1 of the 5 cities/towns directly surrounding Burlington "not compatible with residential life."

The Rev. DEIS says (as did the previous DEIS) that low-income and minority populations are disproportionately negatively affected by this basing. This is a vulnerable community, where many people already struggle to make ends meet. This basing would not be favored by our Congressional delegation, Air Guard, or local business elites, if it were going to affect Shelburne or Essex - where they live - the way it is affecting Winooski. The wealthy citizens in those towns would be outraged, as we are outraged. Again, as an Ethicist, I see this as a radical environmental injustice, where the disempowered will have no choice but to live with the negative effects of this basing. These folks cannot move, because they rely on affordable housing, bus-lines, and stores and schools within walking distance. Those with the means to move away will do so. And the City of Winooski will suffer greatly.

Another aspect of the devastating effect on Winooski is that our city has invested, in only the last decade, millions of dollars into a development strategy for our awesome downtown. We have really superb restaurants with outdoor seating, a gorgeous boardwalk and park area along the historic Winooski River (named this by the Abenaki native community), and brand new

luxury waterfront condos and townhouses. ALL OF THE DOWNTOWN area falls within the "not compatible with residential use" zone.

Finally, Winooski is THE MOST DIVERSE CITY IN THE WHOLE STATE OF VERMONT. We are proud of our diversity, and we have welcomed new Americans from countries all over the world, from Sudan to the Democratic Republic of Congo to Nepal to Bosnia, etc. Over 20 languages are spoken in Winooski. Many of these new Americans came here through our outstanding Refugee Resettlement Program. They are arriving in our neighborhoods from war-torn countries, and they find the present F-16's a real challenge to life with. We have more people of color in our 1-square-mile City than any other town or City in Vermont. Again, because this basing places ¾ of Winooski in the "not compatible with residential use" zone, this is an environmental injustice, this time because it impacts racial minorities to a far-greater degree than others.
